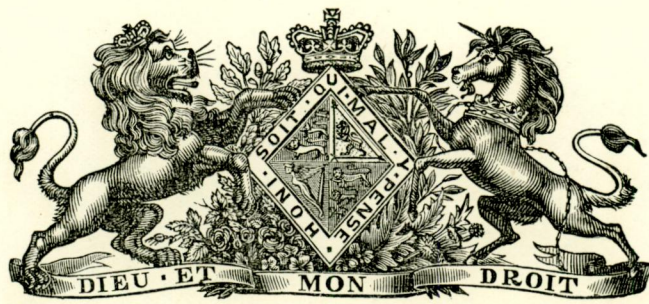

An Act to correct an erroneous date in the 213th section of the "Sydney Corporation Act of 1879."

WHEREAS by reason of an erroneous date in the two hundred Preamble. and thirteenth section of the "Sydney Corporation Act of 1879" the duration of the endowment therein referred to is in terms inconsistent with the date of the first quarterly payment of such endowment and it is expedient to correct such erroneous date Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

- 10 1. The two hundred and thirteenth section of the "Sydney Corporation Act of 1879" shall be read as if the words "Thirty-first day of March in the year one thousand eight hundred and seventy-nine" had been therein inserted instead of the words "Thirtieth day of June next." Correction of date of first quarterly payment under sec. 213 of Sydney Corporation Act.
- 15 2. This Act may be cited as the "Sydney Corporation Act Short title. Amendment Act of 1883."

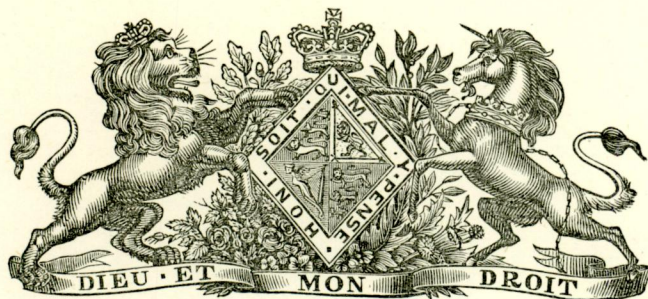
