HEREAS by a grant from the Crown bearing date the fourteenth Preamble. day of January one thousand eight hundred and forty-eight Her Majesty Queen Victoria did grant unto the Right Reverend William Grant Broughton the then Lord Bishop of Sydney and his 5 successors Bishops of Sydney for ever All that piece or parcel of land containing by admeasurement two roods be the same more or less situated in the county of Cumberland and parish of Petersham at Camperdown commencing at the Cook's River Road at the corner of Senate and Throne streets and bounded on the south by Senate-street being a 10 line bearing south seventy-eight degrees west two chains fifty links on the west by a line at right angles to Senate-street two chains on the north by a line parallel with Senate-street two chains fifty links and on the east by Throne-street being a line at right angles to Senate-street two chains to the corner at the Cook's River Road as aforesaid (advertised 15 as number one hundred and five in the Government notice dated the thirteenth day of December one thousand eight hundred and forty-Upon trust for the appropriation thereof as the site of a dwelling-house garden and other appurtenances for the clergyman duly appointed to officiate in the Church of the United Church of England 20 and Ireland as by law established erected at Camperdown and now 549 known

- 25 sale or to rescind or vary the terms of any contract for sale and to resell and when sold to convey and assure the premises or any part or parts thereof in fee-simple to the purchaser or purchasers thereof his her or their heirs or assigns freed and discharged from all the trusts affecting the same created by the said grant or otherwise and the
- 30 receipt in writing of the Right Reverend Alfred Barry or his successors for any money arising from such sale or sales shall be an effectual and absolute discharge to the purchaser or purchasers of the said land or any part or parts thereof and shall exonerate him or them from seeing to the application of any proceeds of such sale or sales 35 and from all liability as to the mis-application or non-application

2. The said Right Reverend Alfred Barry and his successors Disposal of proceeds. shall stand possessed of all moneys arising from each and every such sale or sales as aforesaid Upon trust after payment thereout of the 40 expenses of such sale or sales and of this Act to apply the same in or towards the purchase of other premises situated in the said parish of Saint Stephen's suitable for a parsonage or residence for the clergyman for the time being duly appointed to officiate in the said church of Saint Stephen's or in the purchase of another piece or pieces of land in

45 the said parish of Saint Stephen's as a site for the erection thereon of a dwelling-house or parsonage for the said clergyman and to apply the remainder of the said moneys (if any) which shall not be required for the purposes last aforesaid in or towards the erection improvement or repair of a dwelling-house or parsonage for the said clergyman upon

50 the said land or lands to be purchased as aforesaid and the receipts of any person or persons to whom any moneys shall be paid under the provisions of this Act shall be valid and complete discharges to the said Right Reverend Alfred Barry and his successors for such moneys.

Disposal of proceeds.

The said Right Reverend Alfred Barry and his successors shall stand possessed of all moneys arising from each and every such sale or sales as aforesaid Upon trust after payment thereout of the expenses of such sale or sales and of this Act to apply the same in or towards the purchase of other premises situated in the said parish of Saint Stephen's suitable for a parsonage or residence for the clergyman for the time being duly appointed to officiate in the said church of Saint Stephen's or in the purchase of another piece or pieces of land in the said parish of Saint Stephen's as a site for the erection thereon of a dwelling-house or parsonage for the said clergyman and to apply the remainder of the said moneys (if any) which shall not be required for the purposes last aforesaid in or towards the erection improvement or repair of a dwelling-house or parsonage for the said clergyman upon the said land or lands to be purchased as aforesaid and the receipts of any person or persons to whom any moneys shall be paid under the provisions of this Act shall be valid and complete discharges to the said Right Reverend Alfred Barry and his successors for such moneys.

Short title.

3. This Act may be cited as "Saint Stephen's Church of England Parsonage Camperdown Sale Act 1886."
