A BILL

To amend the "Prince Alfred Hospital Act" and the "Prince Alfred Memorial Hospital Site Dedication Act" in certain particulars.

[DR. MACKELLAR;—9 September, 1886.]

WHEREAS it is advisable that the Honorary Medical and Surgical Officers of the Prince Alfred Hospital shall be entitled to be represented by one of their number on the Board of Directors of the said Hospital And it is also advisable that the appointment and removal of the resident and paid Medical and Surgical Officers shall be vested solely in the Board of Directors of the said Hospital Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows :—

1. The Honorary Medical and Surgical Officers of the said Prince Alfred Hospital shall henceforth be entitled to be represented on the Board of Directors of the said Hospital by one of their number to be elected for that purpose as hereinafter provided.

2. Such representative member shall be elected at a meeting of the Honorary Medical and Surgical Officers to be held in the month of January of each year and to be convened by order of the Board of Directors of the said Hospital in such manner as the said Board shall

by regulation in that behalf direct and such representative member shall upon being elected in manner aforesaid be and become a Director of the Prince Alfred Hospital for the current year for which he shall be so elected. Provided always that such addition to the Board shall not affect the quorum fixed by sections four and nine of the "Prince Alfred Hospital Incorporation Act." 5

Proceedings not to be affected by non-election of representative member.

3. Notwithstanding anything herein contained the acts or proceedings of the Board of Directors of the said Hospital shall not be called in question or be taken or construed to be invalid or illegal by reason of the Honorary Medical and Surgical Officers failing to elect a representative member as aforesaid or by reason of any informality in the election of such representative member and the Board of Directors shall for all purposes be deemed to be duly constituted without such additional member. 10

Provision for future appointment of resident and paid Medical and Surgical Staff.

4. Notwithstanding anything contained in the "Prince Alfred Memorial Hospital Site Dedication Act" the appointment and removal of the resident and paid Medical and Surgical Officers of the said Hospital shall henceforth cease to be vested in the Joint Board consisting of the Senate of the University and the Directors of the said Hospital as in and by the said Act provided and shall be vested in and made by the Board of Directors of the said Hospital for the time being alone and the appointments of such officers shall be for such periods and upon such terms and conditions and subject to such regulations as the Board of Directors shall at any time and from time to time determine. 20 25

Short title.

5. This Act may be cited as the "Prince Alfred Hospital Acts Amendment Act 1886."
