An Act to authorize the Payment to Members of the Legislative Assembly of an annual allowance as reimbursement for expenses incurred in the discharge of their Parliamentary duties.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :-

- 1. This Act may be cited as the "Parliamentary Representatives Short title and 5 Allowance Act," and shall come into force upon the day on which the commencement of Act. writs for the next General Election of Members to serve in the Legislative Assembly held after the passing of this Act shall be made returnable.
- 10 2. Every Member of the Legislative Assembly elected to serve Allowance therein on or after the day on which this Act shall come into force shall, to Members of upless he is one of the personal encited and for the personal states of unless he is one of the persons specified or referred to in the next Assembly. following section, be entitled to receive by way of reimbursement for expenses incurred by him in the discharge by him of his Parliamentary
