ANNO QUINQUAGESIMO SECUNDO

VICTORIÆ REGINÆ.

An Act to enable the Council of the Borough of Parramatta to purchase or rent lands either within or without the borough for use as Stone Quarries in connection with the Municipal Works within the said borough, and to purchase lands within the said borough for the purpose of amending the alignment of Church-street in the vicinity of Albert-street, and for the other purposes hereinafter mentioned.

WHEREAS it would be for the public benefit within the Borough of Parramatta that the Council of the said borough should be empowered to lease or purchase lands containing stone suitable for municipal works of the borough, and to purchase also certain lands on the eastern side of Church-street, near Albert-street, in the said borough, for amending the alignment of the said street by removing the obstructive angles now existing thereon. Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same as follows:—

1. After the passing of this Act it shall be lawful for the Council of the Borough of Parramatta and its successors from time to time, out of the general or other available funds of the said borough, to purchase or lease for any term, and at such prices or rents as they shall

shall deem reasonable of and from the persons entitled to lease or sell the same, all or any part of the lands adjacent to or abutting upon the stone quarries, Parramatta North, presently being worked by the said Council, and any other lands either within or without the said borough, 5 but not exceeding three miles from the boundary of the same, containing suitable metal or stone, for the purpose of providing a sufficient supply of the stone or metal required for carrying on of the public works within the said borough, and to hold the said lands for the purposes aforesaid, and open and work quarries thereon; and to resell, and 10 dispose of, and convey, and assure to the purchaser or purchasers thereof any of such lands, and to purchase other lands in place of those so sold or disposed of as they shall from time to time deem necessary or expedient; and also to make by-laws, rules, and regulations for the use, government, and management of such lands or the stone quarries 15 thereon; and in any such by-law to fix maximum and minimum penalties for the neglect or breach thereof; and such by-laws shall have the force of law when confirmed by the Governor, and published in the *Government Gazette* in manner provided in regard to municipal by-laws by the "Municipalities Act of 1867" or other the Acts in 20 force in the said Colony for the time being in that behalf, but subject to the like conditions and qualifications as contained in the said Act or Acts respectively, provided always that no such penalty shall exceed fifty pounds.

2. The production of the *Government Gazette* containing such 25 by-laws shall be sufficient evidence thereof in any proceedings at law or in equity whatsoever. Proof of by-laws.

3. It shall also be lawful for the said Council, out of such 30 general funds as aforesaid, to purchase of and from the persons entitled to sell the same such portions of the lands fronting the eastern side of Church-street, in the vicinity of Albert-street, within the said borough, as the Council shall deem expedient for the purpose of amending the alignment of the said eastern side of the said street by straightening the same, and removing the angles and irregularities existing in the said street as at present aligned. Council may purchase certain lands to improve alignments.

4. This Act may be cited as the "Parramatta Municipal 35 Quarries Act of 1888." Short title.
