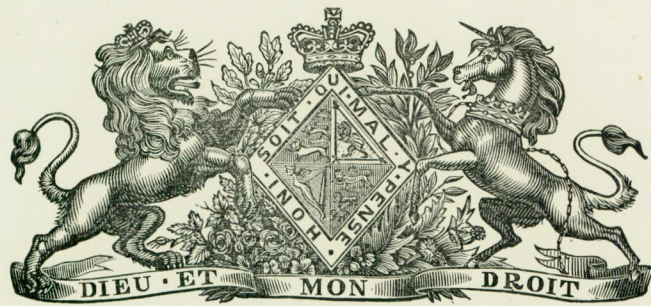

An Act to alter the designation of the Municipal District of West Botany.

WHEREAS it is expedient to alter the designation of the Municipal District of West Botany. Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Preamble.

1. From and after the passing of this Act the designation and name of the Municipal District of West Botany shall be, and the same hereby is, altered to the designation and name of the Municipal District of Rockdale.

Alteration of name

2. This Act may be styled and cited as the "Rockdale Municipality Re-naming Act of 1887."

An Act to alter the designation of the Municipal District of West Botany.

WHEREAS it is expedient to alter the designation of the Municipal District of West Botany. Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. From and after the passing of this Act the designation and name of the Municipal District of West Botany shall be, and the same hereby is, altered to the designation and name of the Municipal District of Rockdale. Alteration of name Municipality of West Botany to Municipality of Rockdale.
2. This Act may be styled and cited as the "Rockdale Municipality Re-naming Act of 1887." Short title.

An Act to amend the Municipal District of New South Wales.

WHEREAS the provisions of the Municipal District of New South Wales, in relation to the disposal of refuse and the cleaning of streets, are insufficient to meet the requirements of the Public Health Act, 1903, and it is expedient that the said provisions should be amended accordingly; **ENACTED**, that the provisions of the Public Health Act, 1903, shall be amended in relation to the disposal of refuse and the cleaning of streets, in the City of New South Wales, in accordance with the provisions of this Act.
