### An Act to amend the "Silverton Tramway Act of 1886."

HEREAS it is desirable to amend the "Silverton Tramway Act Preamble. of 1886." Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament 5 assembled, and by the authority of the same, as follows (that is to say) :-

1. This Act may for all purposes be cited as the "Silverton short title. Tramway Amending Act," and shall be deemed to be incorporated with and construed as part of the "Silverton Tramway Act of 1886."

2. #### Silverton Tramway Amending.

3. In the construction of the said tramway it shall be lawful to Deviation of Silver-deviate from the line of tramway described in the Schedule to the ton Tramway Line.
