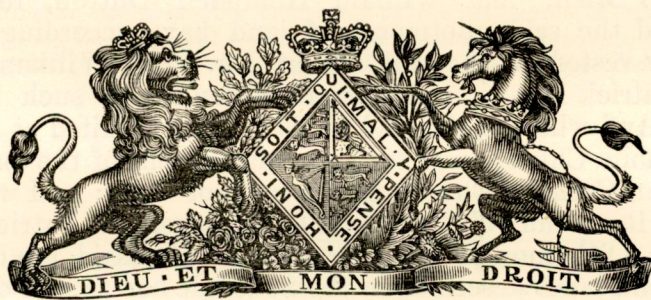

An Act to enable the Right Reverend William Lanigan, the Reverend Patrick Dunne, and Morgan O'Connor, trustees of certain allotments in the town of Yass, granted to Henry O'Brien and others, as trustees of the Roman Catholic Church at Yass, to sell the said lands, and to provide for the application of the proceeds thereof.
