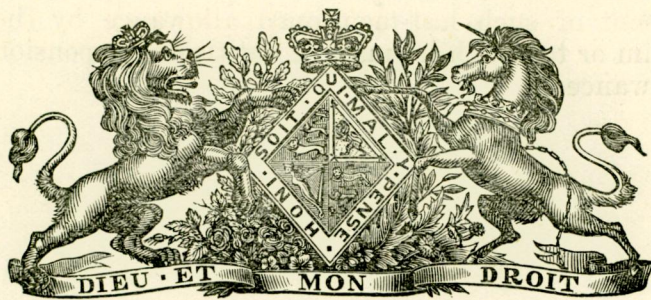

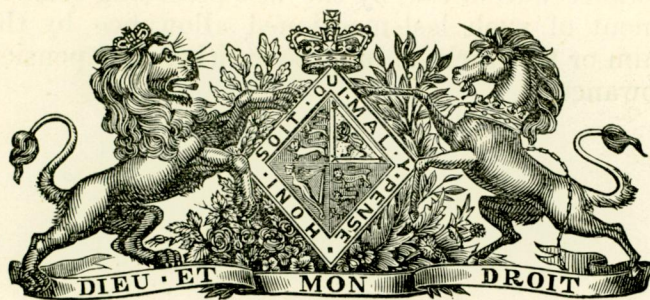

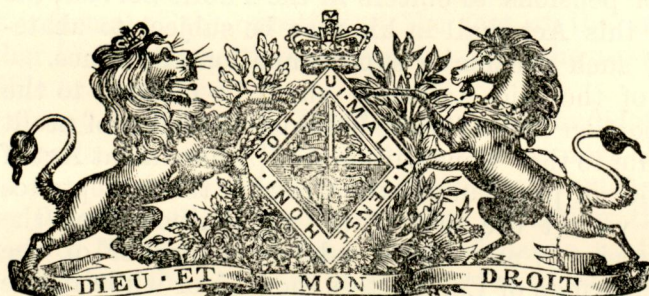

And the Returning Officer shall supply to the Presiding Officer of each polling-place so many of such ballot-papers as shall be fully equal to the number of electors likely to vote at such polling-place. 4. Subject to the provisions of this Act all the requirements and provisions of the "Electoral Act of 1880," prescribing or referring to the procedure to be observed at elections held thereunder shall apply

 20 of such Member or Members, call for a show of hands by the electors in favour of or against the payment of Members as aforesaid, and shall forthwith declare the result of such show of hands. Where no contest, show of hands to be taken.

7. Each Presiding Officer shall in manner provided by the fortieth section of the said Electoral Act count the affirmative and  
 25 also the negative votes shown on each ballot-paper in addition to counting the votes given for candidates, and the Returning Officer shall on declaring the poll declare also the number of votes given on the ballot-papers in the affirmative and the number in the negative, and so far as respects such answers such declaration shall be final and  
 30 conclusive. Provided always that the numbers of such votes, as well as the result of the show of hands at any election where there has not been a contest, shall be endorsed on the writs by the Returning Officers when returning the same to the Governor. Procedure for ascertainment of answers.

8. The Governor, on receipt of the writs for the whole Colony,  
 35 shall cause enumeration to be made of the result of the voting on the question of the Payment of Members. The calculation shall be as follows:—When the voting for any Electorate, either taken by ballot or a show of hands, shall indicate that there was an affirmative vote, the number of Members returned for that Electorate shall be counted as  
 40 the number for that Electorate in favour of the Payment of Members, and when such voting shall show that the majority was against such payment the number of Members returned shall be counted as the number against such payment. And the Governor shall declare, by notice in the Gazette, the general result of such enumeration; and if  
 45 such result shall show that there was an affirmative vote then this Act shall come into operation, but not otherwise. Governor to cause enumeration of votes to be made, and to notify the same.
