An Act to revest certain land in the Australian Agricultural Company.

WHEREAS by notification in the Gazette, the Governor, with the Preamble. advice of the Executive Council, under the provisions of the "Newcastle Sand-drift Reclamation Act," resumed certain land described in the Schedules to the said notification; and whereas it is 5 expedient that the land described in the Schedules hereto (being part of the land so resumed as aforesaid), which at the time of resumption was the property of the Australian Agricultural Company, should revest in the Australian Agricultural Company: Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice 10 and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. The land described in the Schedules hereto shall vest in the Land to vest in Australian Agricultural Company as fully and effectually as if the Australian Agricultural Company.

15 "Newcastle Sand-drift Reclamation Act" had never been passed, and the notification of resumption under the provisions thereof had never been made.

2. The powers of resumption conferred upon the Governor by Powers of resumpsection two of the "Newcastle Sand-drift Reclamation Act" are, in tion revoked and repealed.
