

An Act to empower the Council of any Municipality in the Metropolitan District of Sydney to make by-laws for regulating the driving of Cattle and Sheep, and to repeal an Act passed in the sixteenth year of Her present Majesty's reign, numbered twenty-three, to prevent Cattle being driven through populous towns and places, except within certain hours, as far as the same relates to the Municipalities in the Metropolitan District of Sydney.

**W**HEREAS it is deemed expedient to repeal the Act of Council Preamble.  
passed in the sixteenth year of Her present Majesty's reign,  
numbered twenty-three, to prevent cattle being driven through  
populous towns and places, except within certain hours, so far as the  
5 same relates to the Municipalities in the Metropolitan District of Sydney  
only: And whereas it is expedient, for the safety of the public and  
the better protection of the Municipalities within the Metropolitan  
District of Sydney, to prevent the driving of cattle and sheep  
intended for sale, slaughter, or shipment into or through any part of  
10 any Municipality in the Metropolitan District of Sydney, except along  
such roads, streets, lanes, or other public thoroughfares as the Council  
of any such Municipality may determine: Be it therefore enacted by  
the

the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

- 5       1. That the said recited Act, so far as the same relates to the Municipalities within the Metropolitan District of Sydney, shall be and is hereby repealed. Repeal of part of 16 Vic. No. 23.
- 10       2. No cattle or sheep intended for sale, slaughter, or shipment shall be driven into or through any part of any Municipality within the Metropolitan District of Sydney, except between the hours of twelve o'clock midnight and seven o'clock in the morning; and every person who shall drive or cause to be driven any such cattle or sheep as aforesaid into any part of any such Municipality at any other hour shall, on conviction before two or more Justices of the Peace, forfeit 15 and pay any sum not exceeding twenty shillings for each and every head of cattle, and five shillings for each and every head of sheep, so driven. Penalty.
- 20       3. No cattle or sheep intended for sale, slaughter, or shipment shall be driven into or through any part of any Municipality within the Metropolitan District of Sydney, except along such streets, roads, lanes, or other public thoroughfares as the Council of any such Municipality may determine by any by-laws to be made for that purpose. Cattle to be driven along specified streets only.
- 25       4. The Council of any Municipality within the Metropolitan District of Sydney may from time to time make by-laws for regulating the driving of cattle or sheep, as mentioned in the third section hereof, and may from time to time by other by-laws alter or repeal any such by-laws so made. By-laws may be made.
- 30       5. In the construction of this Act the word "cattle" shall extend to and include bulls, cows, oxen, heifers, and steers; and in the construction also of this Act the word "sheep" shall extend to and include rams, ewes, hoggets, wethers, weaners, and lambs. Interpretation of word "cattle."
6. This Act may be styled and cited as the "Metropolitan Municipalities Cattle and Sheep Driving Act of 1892." Short title.

No cattle or sheep intended for sale, slaughter, or shipment shall be driven into or through any part of any Municipality within the Metropolitan District of Sydney, except between the hours of twelve o'clock midnight and seven o'clock in the morning; and every person who shall drive or cause to be driven any such cattle or sheep as aforesaid into any part of any such Municipality at any other hour shall, on conviction before two or more Justices of the Peace, forfeit 15 and pay any sum not exceeding twenty shillings for each and every head of cattle, and five shillings for each and every head of sheep, so driven. Cattle not to be driven through streets except during certain hours. Penalty.

No cattle or sheep intended for sale, slaughter, or shipment shall be driven into or through any part of any Municipality within the Metropolitan District of Sydney, except along such streets, roads, lanes, or other public thoroughfares as the Council of any such Municipality may determine by any by-laws to be made for that purpose. Cattle to be driven along specified streets only.
