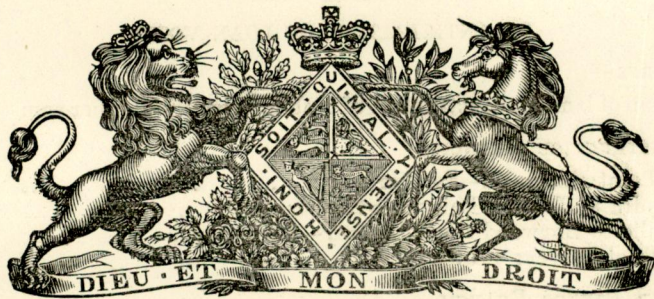

An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales for Services to be hereafter provided for by Loan. [Assented to, 9th October, 1894.]

WHEREAS we Your Majesty's most dutiful and loyal subjects Preamble. the Members of the Legislative Assembly of New South Wales in Parliament assembled, have resolved to grant to Your Majesty the sum of Two hundred and one thousand two hundred and fifty pounds, for the Services set forth in the Schedule hereto annexed : And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum so granted to Her Majesty : Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. Out of the Consolidated Revenue Fund of New South Wales £201,250 may be issued out of the Consolidated Revenue Fund. there shall and may be issued and applied for or towards making good the supply so resolved to be granted to Her Majesty the sum of Two hundred and one thousand two hundred and fifty pounds, for the Services specified in the Schedule hereto annexed.

The Treasurer shall issue and pay the said sum for the Services aforesaid in such manner and in such proportions as the Governor, by Warrants or Orders in writing under his hand, and directed to the said Treasurer, shall from time to time order and direct. And the payments so to be made shall be charged upon and payable out of the Consolidated Revenue Fund of the Colony.
