And he further declared that the nomination of youths as scholars should be vested in the Protestant Bishop of Sydney for the time-40 being after such examination as the said Bishop should direct: And whereas by an indenture bearing date the fifteenth day of February, one thousand eight hundred and eighty-seven, made between the said Sir William Westbrook Burton of the first part, the said Sir Charles Nicholson of the second part, and the Most Reverend Alfred Barry, 45 Doctor of Divinity, D.C.L., Bishop of Sydney, of the third part. After reciting the matters hereinbefore stated, and reciting that the said Charles Campbell had then in his hands the sum of one thousand nine hundred pounds, representing the said sum of one thousand pounds and accumulations thereon, and that the said Charles Campbell was 50 desirous of retiring from the trusts of the said sum and of handing the same over to a trustee or trustees to be held upon the trusts thereinafter declared concerning the same; and that by a deed poll, dated the thirty-first day of December, one thousand eight hundred and seventy, under the hand and corporate seal of Frederic Barker, the then Bishop 55 of Sydney, it was amongst other things thereby declared that the general government and management of The King's School aforesaid, and all matters relating thereto, should thenceforth be vested in a body of persons to be called the Council of The King's School;

and that the Bishop of Sydney had consented to act as trustee, and hold the said sum of one thousand nine hundred pounds upon the trusts thereinafter declared, and that the said sum, or the securities representing the same, had been paid over or transferred into the

5 name of the said Bishop of Sydney. It was thereby witnessed that, with the consent and approval of the said Sir William Westbrook Burton and Sir Charles Nicholson, it was among other things declared that the said Bishop should stand possessed of the said sum of one thousand nine hundred pounds and the annual income and

10 accumulations thereof upon trust to invest the same in manner therein provided, and of the income thereof upon trust to provide thereout from time to time funds for Scholarships to be awarded to boys who had been bona fide pupils for twelve months and upwards at The King's School aforesaid, at Parramatta, or at any other place to which

15 the said school might be removed, and who should be desirous of proceeding with their education at Saint Paul's College, Sydney, with a view to taking Holy Orders in the Church of England, and it was further declared that such Scholarships should be awarded by the said Council to such persons as the Head Master of the said School should

20 approve, in such sum not being less than thirty pounds, for such periods not exceeding four years, and subject to such conditions, rules, and regulations as the said Council should from time to time appoint: And whereas by a private Act of Parliament made and passed in the fifty-sixth year of the reign of her present Majesty, intituled "An Act to

25 incorporate the Council of The King's School, and to vest certain lands and other property in such Council, and to confer certain powers thereon, and upon the Bishop of Sydney, and for other incidental purposes," after reciting, among other things, that by virtue of the hereinbefore recited indenture of the fifteenth day of February, one thousand eight

30 hundred and eighty-seven, the sum of money by the said indenture mentioned and assigned was vested in and held by the Bishop of Sydney and his successors, upon trust, for the endowment and maintenance of a Scholarship in connection with the said school, known as "The Burton Scholarship" it was enacted among other things that

"The Burton Scholarship," it was enacted, among other things, that 35 it should be lawful for the Bishop of Sydney, for the time being, by deed under the episcopal seal, to assign and transfer the said Burton Scholarship endowment funds, and any accumulations and investments thereof, unto the said Council (which, by the same Act, was constituted a body politic and corporate by the name of "The Council of the

40 King's School"), and that thereupon the said Scholarship endowment funds, accumulations, and investments, so assigned and transferred, should become vested in the said Council and its successors upon the trusts and for the purposes declared by the hereinbefore recited indenture of the fifteenth day of February, one thousand eight hundred

45 and eighty-seven: And whereas by a deed poll under the hand and corporate seal of the Most Reverend William Saumarez Smith, Bishop of Sydney for the time being, dated the third day of August, one thousand eight hundred and ninety-three, in pursuance of the hereinbefore recited Act of Parliament, fifty-sixth Victoria, the said William

50 Saumarez Smith did thereby assign and transfer unto the Council of The King's School, and its successors, the said Burton Scholarship Endowment Fund, mentioned and comprised in the said indenture of the fifteenth day of February, one thousand eight hundred and eighty-seven, and all accumulations and investments thereof, upon the trusts

55 and for the purposes declared by the said indenture: And whereas it is believed that the said Sir William Westbrook Burton and Sir Charles Nicholson had no power in law or equity to alter or vary the trusts of the said Scholarship, as declared by the said Sir William Westbrook Burton upon its creation, in or about the year one thousand

eight hundred and thirty-nine, as they have purported to do by the said deed poll of the twenty-first day of October, one thousand eight hundred and sixty-nine, and by the said indenture of the fifteenth day of February, one thousand eight hundred and eighty-seven, but it has become impossible to apply to the Court of Equity for relief in 5 consequence of the passing of the said Act: And whereas the said Council, pursuant to the said Act, have become possessed of other Scholarships for the benefit of the said School: And whereas it is expedient to amend the said Act of Parliament, fifty-sixth Victoria, to enable the said Council of The King's School to hold the said 10 trust funds and to apply the income thereof upon the trusts and for the purposes declared by the said Sir William Westbrook Burton in or about the year one thousand eight hundred and thirty-nine, and to declare the trusts upon which such trust funds shall henceforth be held, and the purposes to which the income arising therefrom shall be 15 applied, and to enable the said Council from time to time to make and alter regulations for carrying out the trusts of all the said Scholarships and of all Scholarships which may hereafter become vested in the Council: Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council 20 and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :-

1. From and after the passing of this Act the Council of The King's School shall stand possessed of the endowment funds, accumulations, and investments of the Burton Scholarship upon the trusts and 25 for the purposes declared by Sir William Westbrook Burton upon the creation thereof in or about the year one thousand eight hundred and thirty-nine; that is to say, upon trust to lay out the same upon some good and sufficient security of real property in New South Wales, or upon Government debentures or Government stock, and to apply the 30 interest thereof towards affording a sound religious education in the principles of The Church of England at The King's School to one youth or more being a pupil or pupils of such school or desiring to enter as pupil or pupils, or proceeding from the said school to pursue his or their studies at Saint Paul's College within the University of Sydney 35 as the Council may from time to time by resolution determine, subject to the regulations of the Council, and not upon the trusts or for the purposes declared by the said indenture of fifteenth day of February,

one thousand eight hundred and eighty-seven.

2. The Council of The King's School shall have power from 40 time to time to make and frame regulations for the purpose of carrying out the trusts of all or any of the scholarship funds now held or hereafter to be held in connection with the said School.

3. This Act may be cited as "The King's School Council Act Amendment Act of 1894."
