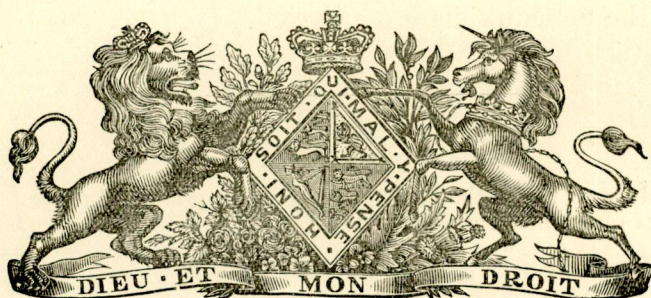

An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Services of the Year 1895-6. [Assented to, 26th October, 1895.]

**W**HEREAS we Your Majesty's most dutiful and loyal subjects Preamble. the Members of the Legislative Assembly of New South Wales in Parliament assembled, have resolved to grant to Your Majesty the sum of Eight hundred and sixty-three thousand four hundred and eight pounds, that is to say,—

The sum of Five hundred and sixty-three thousand four hundred and eight pounds, being the sum required to defray the expenses of the various Departments and Services of the Colony for the month of October, or following month, of the financial year ending thirtieth June, one thousand eight hundred and ninety-six. And

The sum of Three hundred thousand pounds, for the Service set forth in the Schedule hereto annexed.

And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum so granted to Her Majesty:

Majesty: Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

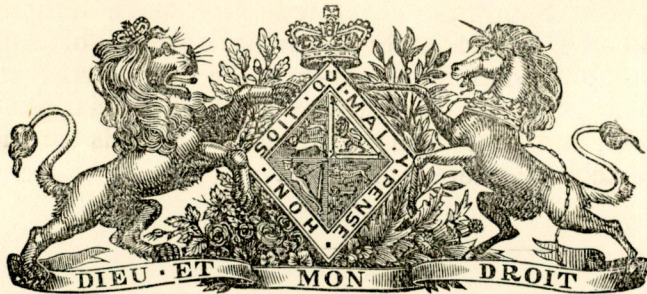

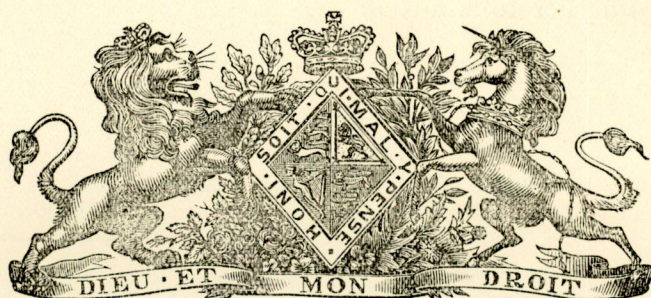
