WHEREAS it is expedient to alter and amend the provisions of Preamble. the Mining Act, 1874, as to the sums to be paid for miners' rights and mineral licenses respectively, and as to the periods for which the same may be issued : Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales

2. Notwithstanding anything to the contrary contained in the Alteration in price Mining Act, 1874, the sum to be paid for a miner's right or mineral license shall be five shillings for one year or two shillings and sixpence miners' rights and mineral licenses. for six months; and such miner's right or mineral license shall be and continue in force for one year or for six months, as the case may be, from the date of issue.
