WHEREAS, in accordance with the provisions of the Public Preamble Works Act of 1888, the Legislative Assembly did, by resolution, declare that it was expedient that a certain work, namely, works of harbour improvements at Newcastle, as referred by the said Assembly to the Parliamentary Standing Committee on Public Works, should be carried out with such of the modifications recommended by the said Committee as the said Assembly might thereafter determine : And whereas on the passing of the said resolution a statutory duty was by the said Act imposed on the Secretary for Public Works to introduce a Bill into the said Assembly to sanction the carrying out of the said work : Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :— 1. 3. The cost of carrying out the said work, estimated at one hundred and forty thousand pounds, may be defrayed from such Loan Votes as are now or may hereafter be applicable to that purpose, and shall not under any circumstances exceed the estimated cost by more than ten per centum.

4. This Act may be cited as the "Newcastle Harbour Improvements Act, 1895.'
