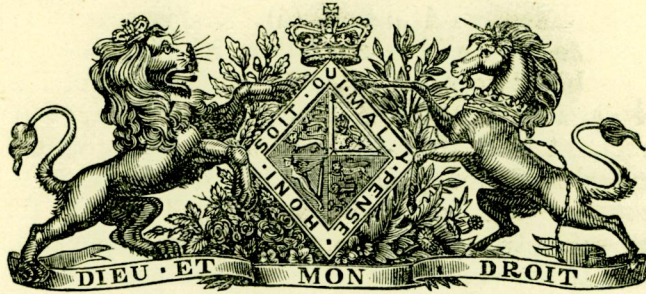

Act No. 58, 1900.

An Act to vest certain land in the Metropolitan Board of Water Supply and Sewerage, and to vest certain other land in the Municipal Council of Sydney for the purpose of constructing and opening thereon a public way, with certain powers to sell and lease the said lands; and to include the said lands within the city of Sydney. [Assented to, 30th November, 1900.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Boundary-street Act, 1900." Short title.
2. The land described in Schedule One is hereby vested for an estate in fee simple in the Metropolitan Board of Water Supply and Sewerage, and such board shall, in respect of the said land, have the same Land in Schedule One vested in Water and Sewerage Board.

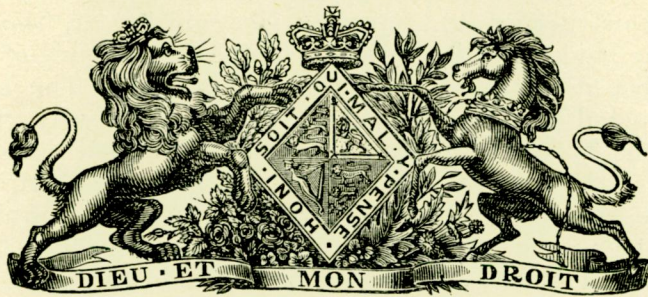
