- (d) has attained the age of twenty-one years, and shall have been a pupil or apprentice of a registered dentist for a period of two years, and shall have been such pupil or apprentice for a period of six months before the commencement of this Act; or
- (e) has obtained a diploma or degree in dentistry from a university in Australia;
