An Act to sanction the construction of a deep-water harbour at Port Kembla.

WHEREAS, in accordance with the provisions of the Public Preamble. Works Act of 1888, the Legislative Assembly did, by resolution, declare that it was expedient that a certain work, namely, the construction of a Deep-water Harbour at Port Kembla, as referred by 5 the said Assembly to the Parliamentary Standing Committee on Public Works, should be carried out by constructing the eastern breakwater, as recommended by the said Committee : And whereas on the passing of the said resolution a statutory duty was by the said Act imposed on the Secretary for Public Works to introduce a Bill into the 10 said Assembly to sanction the carrying out of the said work : Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the

hereby authorised to undertake and carry out the said work subject to the provisions of this Act, and for that purpose shall be, and shall have the powers and duties of, a Constructing Authority within the meaning of the Public Works Act of 1888: Provided that the con-5 struction of the said work shall not be commenced until an Act has been passed imposing a charge per ton on all coals shipped at the port.

2. The plan of the said work is the plan marked "Port Kembla," Plan of work. signed by the Secretary for Public Works and countersigned by the

Engineer-in-Chief for Public Works, and deposited in the public office 10 of the said Secretary.

3. The cost of carrying out the said work, estimated at two costs how to be hundred thousand pounds, may be defrayed from such Loan Votes as ^{defrayed}. may hereafter be applicable to that purpose, and shall not under any circumstances exceed the estimated cost by more than ten per centum

circumstances exceed the estimated cost by more than ten per centum. 4. This Act may be cited as the "Port Kembla Harbour Act, Short title. 1897."

SCHEDULE.

The construction of a breakwater commencing on the foreshore near the eastern extremity of Port Kembla Bay and distant about eight hundred feet in an east south-20 easterly direction from the northern extremity of Mount Kembla Coal Company's coal shipping jetty, and extending thence in a northerly direction in a curved line a distance of two thousand eight hundred feet—being tinted red on deposited plan—and the necessary shipping appliances.
