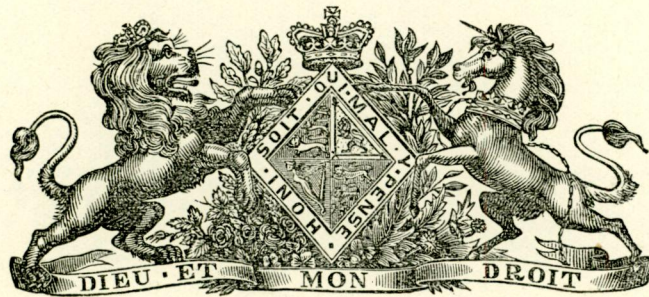

Act No. , 1901.

An Act to amend the Coal Mines Regulation Act of 1896.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

5 1. This Act may be cited as the "Coal Mines Regulation Short title.
(Further Amendment) Act, 1901," and shall be construed with the
Coal Mines Regulation Act, 1896, hereinafter referred to as the
Principal Act.

If any person acts as manager in contravention of this section,
such person and any owner of a mine who employs him as manager,
knowing that he is so acting in contravention of this section, shall be
liable to a penalty not exceeding fifty pounds.

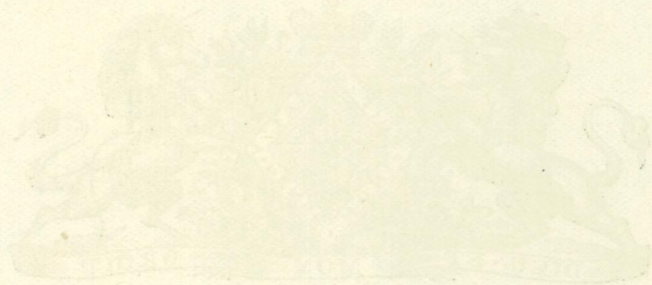

EDWARD THE SEVENTH

Act No. 1901

An Act to amend the Coal Mines Regulation Act of 1900.

Enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same as follows:

1. This Act may be cited as the "Coal Mines Regulation (Further Amendment) Act 1901," and shall be construed with the Coal Mines Regulation Act 1900, and any amendments referred to as the Principal Act.

2. No person shall be appointed as manager of two or more mines.

3. If any person acts as manager in contravention of this section, every person and any expert in a mine who employs him or her, knowing that he is so acting in contravention of this section, shall be liable to a penalty not exceeding five pounds.

4. After the commencement of this Act no certificate of approval shall be granted under section eight of the Principal Act.
