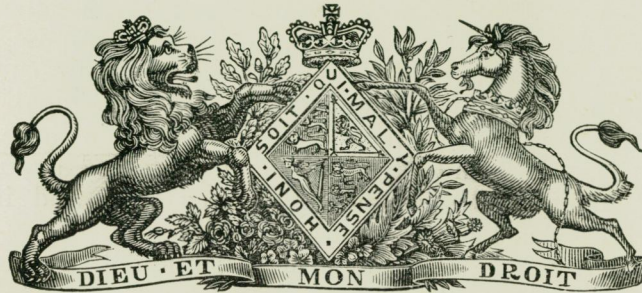

Act No. 47, 1901.

An Act to reduce the area of the Municipal District of Inverell. [Assented to, 12th November, 1901.]

WHEREAS the land described in the First Schedule to this Act Preamble. now forms the Municipal District of Inverell: And whereas the said municipal district and the ratepayers thereof have agreed that the area of the said municipal district shall be reduced from the area described in the said First Schedule hereto to the part of the said area as described in the Second Schedule hereto: And whereas it is for the interests of the said municipal district and the said ratepayers thereof that the area of the said municipal district should be reduced as aforesaid: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. From and after the passing of this Act the area of the Municipal District of Inverell shall be reduced to the area described Alteration of boundaries. in the Second Schedule to this Act, and the said Municipal District of Inverell

Inverell shall have the same powers and be subject to the same liabilities and shall as fully and effectually comprise the said area described in the said Second Schedule hereto and no more as if the said area had originally formed the said Municipal District of Inverell.

Existing rights not
to be affected.

2. Nothing herein contained shall affect any acts done or rights or liabilities accrued, incurred, or imposed by or against the said Municipal District of Inverell or any person or persons in respect of any act, matter, or thing done or commenced to be done before the passing of this Act. And all rates and taxes duly imposed or payable in respect of the property within the area described in the said First Schedule hereto for the present or any previous municipal year within the meaning of the Municipalities Act, 1897, section three, subsection two, may be recovered and payment thereof enforced by or on behalf of the said Municipal District of Inverell as fully and in the same manner as if this Act had not been passed.

Short title.

3. This Act may be cited as the "Municipal District of Inverell Reduced Area Act, 1901."

FIRST SCHEDULE.

Description of the original area of the Municipal District of Inverell.

Counties of Gough and Arrawatta: Commencing on the western boundary of the reserve on account of population of the town of Inverell at about one mile and eighteen chains from the south-west corner of that reserve at five chains northerly from the south-west corner of portion two hundred and eight, parish of Inverell; and bounded thence on the west by the western boundary of that reserve bearing north to Spencer's Gully; thence by that gully to the south-eastern corner of portion seventy-three, parish of Byron, county of Arrawatta; thence by the eastern boundary of that portion northerly to its north-east corner; thence by a line north to the centre of the road forming the western boundary of J. R. Fraser's three hundred and twenty acres conditional purchase, portion seventy-two, parish of Byron; thence by a line along the centre of that road northerly to Robroy Gully; thence on the north by that gully downwards to the M'Intyre River; and thence by that river south-easterly to the south-western corner of J. M'Gregor's conditional purchase of three hundred and twenty acres, portion three, parish of Wander, county of Arrawatta; and thence by the south boundary of that portion and J. M'Gregor's portion eighteen and its easterly prolongation bearing east, in all about five and one half miles to its intersection with the northerly prolongation of the western boundary of C. Campbell's ninety-seven acres, portion four, on M'Intyre River, parish of Elmsmore; thence on the east by a line bearing south about five miles and four chains to the north-west corner of that ninety-seven acres; and thence by the western boundary of that land bearing south to the M'Intyre River; and thence by a line crossing that river, and by the western boundary of A. M'Ilveen's two hundred acres conditional purchase, portion five, and the western boundary of portion twenty-two, parish of Elmsmore, southerly to the south-west corner of that portion; and thence on the south by a line bearing west about six miles and seventy chains, to the point of commencement.

County of Gough, parish of Inverell, ten thousand three hundred and seventy acres: Commencing at the north-west corner of portion numbered one hundred and fifty-four, containing fifty acres one rood, in the parish of Inverell, in the county of Gough; and bounded thence on the north by the north boundaries of portions numbered one hundred and fifty-four, one hundred and fifty-five, and one hundred and fifty-six, and their eastern prolongation, being a line bearing east three hundred and forty chains to the eastern boundary of the parish of Inverell; thence on the east by part of the eastern boundary of the parish of Inverell, being a line bearing south along the western boundaries of portions numbered one hundred and sixty-three, twelve, one hundred and fifty-one, and fifty-one, in the parish of Campbell, and portions numbered two hundred and forty-two, fifty-two, and two hundred in the parish of Elmsmore, three hundred and five chains to the existing south boundary of the said municipal district of Inverell; thence on the south by part of the existing south boundary of the said municipal district of Inverell, being a line west three hundred and forty chains to a point due south of the north-west corner of portion numbered one hundred and fifty-four; thence on the west by a line north, partly formed by the west boundaries of portions numbered eighty-eight, eighty-seven, eighty-six, seventy, sixty-nine and one hundred and fifty-four, three hundred and five chains, to the point of commencement.

Campbell's ninety-seven acres, portion four, on M'Intyre River, parish of Elmsmore; thence on the east by a line bearing south about five miles and four chains to the north-west corner of that ninety-seven acres; and thence by the western boundary of that land bearing south to the M'Intyre River; and thence by a line crossing that river, and by the western boundary of A. M'Ilveen's two hundred acres conditional purchase, portion five, and the western boundary of portion twenty-two, parish of Elmsmore, southerly to the south-west corner of that portion; and thence on the south by a line bearing west about six miles and seventy chains, to the point of commencement.

County of Gough, parish of Inverell, ten thousand three hundred and seventy acres: Commencing at the north-west corner of portion numbered one hundred and fifty-four, containing fifty acres one rood, in the parish of Inverell, in the county of Gough; and bounded thence on the north by the north boundaries of portions numbered one hundred and fifty-four, one hundred and fifty-five, and one hundred and fifty-six, and their eastern prolongation, being a line bearing east three hundred and forty chains to the eastern boundary of the parish of Inverell; thence on the east by part of the eastern boundary of the parish of Inverell, being a line bearing south along the western boundaries of portions numbered one hundred and sixty-three, twelve, one hundred and fifty-one, and fifty-one, in the parish of Campbell, and portions numbered two hundred and forty-two, fifty-two, and two hundred in the parish of Elmsmore, three hundred and five chains to the existing south boundary of the said municipal district of Inverell; thence on the south by part of the existing south boundary of the said municipal district of Inverell, being a line west three hundred and forty chains to a point due south of the north-west corner of portion numbered one hundred and fifty-four; thence on the west by a line north, partly formed by the west boundaries of portions numbered eighty-eight, eighty-seven, eighty-six, seventy, sixty-nine and one hundred and fifty-four, three hundred and five chains, to the point of commencement.
