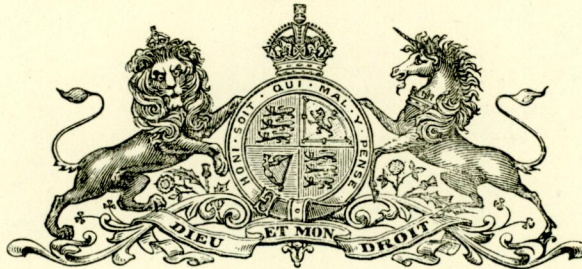

### Act No. 116, 1902.

An Act to alter the name of the Municipal District of Gladstone.  
[Assented to, 24th December, 1902.]

**B**E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. From and after the passing of this Act the name of the "Municipal District of Gladstone" shall be and the same is hereby altered to the name of the "Municipal District of Wrightville."

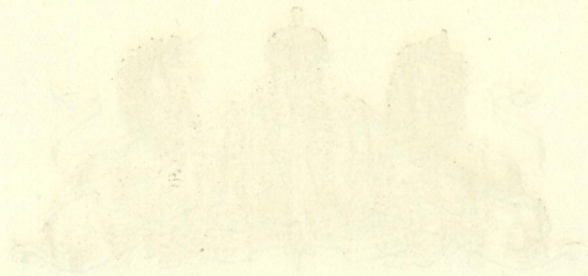

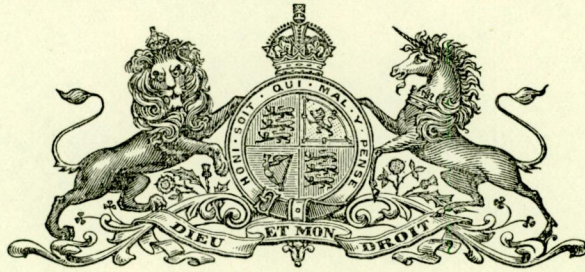

An Act to alter the name of the Municipal District of Gladstone.  
[Approved, 21st December, 1902.]

BE it enacted by the Senate and Assembly of the State of New York, in session assembled, and by the authority of the same as follows:

2. That the Municipal District of Westchester, in the County of Westchester, be and it is hereby altered to the name of the Municipal District of Gladstone.
