On the completion of the said work the Governor shall forthand Sewerage Board. with notify the same in the Gazette, and upon such notification the property in the said work shall, by virtue of this Act alone, be vested in the Board of Water Supply and Sewerage constituted under the Metropolitan Water and Sewerage Acts 1880-1889, for and on behalf of His Majesty.
