Act No. 13, 1902.

An Act to sanction the erection of a library within the grounds of the University of Sydney; and for other purposes. [Assented to, 21st January, 1902.]

Werks Act, 1900, the Legislative Assembly did, by resolution, declare that it was expedient to carry out a certain work, namely, the erection of a library within the grounds of the University of Sydney in connection with that University: And whereas on the passing of the said resolution a statutory duty was by the said Act imposed on the Secretary for Public Works to introduce a Bill into the said Assembly to sanction the carrying out of the said work: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice

advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "University of Sydney (Fisher

Library) Act, 1901."

Work sanctioned.

2. The carrying out of the said work (more particularly described in the Schedule to this Act) is hereby sanctioned; and the Secretary for Public Works, or the member of the Executive Council for the time being performing the duties of the said Secretary, is hereby authorised to undertake and carry out the said work, subject to the provisions of this Act, and for that purpose shall be, and shall have the powers and duties of, a constructing authority, within the

meaning of the Public Works Act, 1900.

Plan of work.

3. The plan of the said work is the plan marked "University of Sydney Fisher Library Additions Site Plan," signed by the Secretary for Public Works, and countersigned by the government architect, and deposited in the public office of the said Secretary.

Cost, how to be defrayed.

4. The cost of carrying out the said work, estimated at sixtyseven thousand five hundred pounds, may be defrayed from such loan votes as are now or may hereafter be applicable to that purpose, and shall not under any circumstances exceed the estimated cost by more than ten per centum.

The erection of buildings providing the following accommodation:

Library reading-room.

Book-stack (seven stories high) and fittings to same.

Cataloguing-room.

Bookbinding-room.

Unpacking-room.

Nicholson museum.

Museum for Greek and Roman antiquities.

Museum for Mediæval antiquities.

Students' dining-hall.

Caretaker's quarters.

Lavatories, &c.

Subject to such alterations as may be deemed necessary during the progress of the work.
