This Public Bill originated in the Legislative Council, and, having passed during the previous Session, is now ready for presentation to the LEGISLATIVE Assembly for its concurrence.

Act No. , 1902.

An Act to regulate the business of money-lenders, and to render penal the inciting infants to borrowing money.

DE it enacted by the King's Most Excellent Majesty, by and with D the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) Where proceedings are taken in any court by a money-Reopening of lender for the recovery of any money lent after the passing of this transactions of money-lenders. Act, or the enforcement of any agreement or security made or taken after the passing of this Act, in respect of money lent either before or after the passing of this Act, and there is evidence which satisfies the 10 court that the interest charged in respect of the sum actually lent is excessive, or that the amounts charged for expenses, inquiries, fines, bonus, premiums, renewals, or any other charges, are excessive, and that in either case the transaction is harsh and unconscionable, or is otherwise such that a Court of Equity would give relief, the court may reopen c 8-A the 99607

the transaction, and take an account between the money-lender and the person sued, and may, notwithstanding any statement or settlement of account, or any agreement purporting to close previous dealings and create a new obligation, reopen any account already taken between

5 them, and relieve the person sued from payment of any sum in excess of the sum adjudged by the court to be fairly due in respect of such principal, interest, and charges as the court, having regard to the risk and all the circumstances, may adjudge to be reasonable; and if any such excess has been paid, or allowed in account, by the debtor, may

10 order the creditor to repay it; and may set aside, either wholly or in part, or revise or alter, any security given or agreement made in respect of money lent by the money-lender, and if the money-lender has parted with the security may order him to indemnify the borrower

or other person sued.

(2) Any court in which proceedings might be taken for the recovery of money lent by a money-lender shall have and may exercise at the instance of the borrower or surety or other person liable the like powers as may be exercised under this section where proceedings are taken for the recovery of money lent; and the court shall have

20 power, notwithstanding any provision or agreement to the contrary, to entertain any application under this Act by the borrower or surety, or other person liable, notwithstanding that the time for repayment of the loan or any instalment thereof may not have arrived.

(3) On any application relating to the admission or amount 25 of a proof by a money-lender in any bankruptcy proceedings, the court may exercise the like powers as may be exercised under this section when proceedings are taken for the recovery of money.

(4) The foregoing provisions of this section shall apply to any transaction which, whatever its form may be, is substantially one

30 of money-lending by a money-lender.

(5) Nothing in the foregoing provisions of this section shall affect the rights of any bona-fide assignee or holder for value without notice.

(6) Nothing in this section shall be construed as derogating

35 from the existing powers or jurisdiction of any court.

2. (1) A money-lender, as defined by this Act,—

(a) shall register himself as a money-lender in accordance with money-lenders. regulations under this Act at an office provided for the purpose by the Registrar General under his own or usual trade name, and in no other name, and with the address, or all the addresses, if more than one, at which he carries on his

business of money-lender; and

(b) shall carry on the money-lending business in his registered name, and in no other name and under no other description, and at his registered address or addresses, and at no other address; and

(c) shall not enter into any agreement in the course of his business as a money-lender with respect to the advance and repayment of money, or take any security for money in the course of his business as a money-lender otherwise than in his registered name; and

(d) shall on reasonable request, and on tender of a reasonable sum for expenses, furnish the borrower with a copy of any document relating to the loan or any security therefor.

(2) If a money-lender fails to register himself as required 10 by this Act, or carries on business otherwise than in his registered name. or in more than one name, or elsewhere than at his registered address. or fails to comply with any other requirement of this section, he shall be liable on summary conviction to a fine not exceeding one hundred pounds, and in the case of a second or subsequent conviction to 15 imprisonment, with or without hard labour, for a term not exceeding three months, or to a fine not exceeding one hundred pounds, or to

both: Provided that if the offender be a body corporate or a company, that body corporate or company shall be liable on a second or subsequent conviction to a fine not exceeding five hundred pounds. (3) A prosecution under subsection (1) (a) of this section

shall not be instituted except with the consent of the Attorney-

General.

3. (1) The Registrar General, subject to the approval of the Regulations as to Governor, may make regulations respecting the registration of money-registration. 25 lenders, whether individuals, firms, societies, or companies, the form of the register, and the particulars to be entered therein.

(2) The registration shall cease to have effect at the expiration of three years from the date of the registration, but may be renewed from time to time, and if renewed shall have effect from

30 three years from the date of the renewal.

4. If any money-lender, or any manager, agent, or clerk of Penalties for false a money-lender, or if any person being a director, manager, or other statements and representations. officer of any corporation or company carrying on the business of a money-lender, by any false, misleading, or deceptive statement, 35 representation, or promise, or by any dishonest concealment of material facts, fraudulently induces or attempts to induce any person to borrow money or to agree to the terms on which money is or is to be borrowed, he shall be guilty of misdemeanour, and shall be liable on indictment

to imprisonment, with or without hard labour, for a term not exceeding 40 two years, or to a fine not exceeding five hundred pounds, or to both.

5. transaction involving the borrowing of money, or to apply to any person or at any place with a view to obtaining information or advice as to borrowing money, he shall be guilty of a misdemeanour, and shall be liable, if convicted on indictment, to imprisonment, with or 5 without hard labour, for a term not exceeding three months, or to a fine not exceeding one hundred pounds, or to both imprisonment and fine, and if convicted on summary conviction, to imprisonment, with or without hard labour, for a term not exceeding one month, or to a fine not exceeding twenty pounds, or to both imprisonment and fine.

(2) If any such document as above in this section mentioned 10 sent to an infant purports to issue from any address named therein, or indicates any address as the place at which application is to be made as to the subject matter of the document, and at that place there is carried on any business connected with loans, whether making or 15 procuring loans or otherwise, every person who attends at such place for the purpose of taking part in, or who takes part in or assists in the

carrying on of such business shall be deemed to have sent or caused to be sent such document as aforesaid, unless he proves that he was not in any way a party to and was wholly ignorant of the sending of 20 such document.

(3) Where in any proceedings under this section it is proved that the person to whom the document was sent was an infant, the person charged shall be deemed to have known that the person to whom the document was sent was an infant, unless he proves that he 25 had reasonable ground for believing the infant to be of full age.

6. If anyone, except under the authority of any court, solicits soliciting infant to an infant to make an affidavit or statutory declaration for the purpose make affidavit in connection with loan. of or in connection with any loan, he shall be liable, if convicted on summary conviction, to imprisonment with or without hard labour for 30 a term not exceeding one month, or to a fine not exceeding twenty pounds, or to both imprisonment and fine, and if convicted on indictment, to imprisonment, with or without hard labour, for a term not

exceeding three months, or to a fine not exceeding one hundred pounds. 7. who advertises or announces himself or holds himself out in any way as carrying on that business, but shall not include—

(a) any pawnbroker in respect of business carried on by him in accordance with the provisions of the Acts for the time being in force in relation to pawnbrokers; or

(b) any registered society within the meaning of the Friendly Societies Act of 1873 or 1899, or any society registered or having rules certified under either of those Acts; or

(c) any body corporate, incorporated or empowered by a special Act of Parliament, to lend money in accordance with such special Act; or

(d) any person or company bona fide carrying on the business of banking or insurance, or bona fide carrying on any business not having for its primary object the lending of money, in the course of which and for the purpose whereof money is lent.

9. This Act may be cited as the "Money-lenders and Infants short title.
