

Act No. 59, 1906.

An Act to make better provision for water conservation, water supply, irrigation, drainage, the prevention of floods, and the control of flood waters; to amend the Water and Drainage Act, 1902, the Water Rights Act, 1902, The Artesian Wells Act, 1897, and other Acts; and for other purposes consequent thereon or incidental thereto. [Assented to, 29th December, 1906.]

B it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

PART I.

PRELIMINARY AND GENERAL.

1. (1) This Act may be cited as the "Water and Drainage Short title. and Artesian Wells (Amending) Act, 1906," and is divided into Parts, as follows:—
