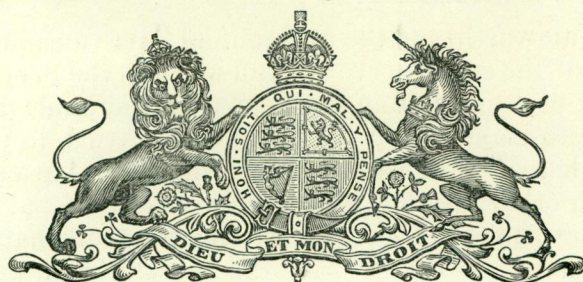

### Act No. 21, 1905.

An Act to amend the Tamworth Show-ground Act, 1899, and to authorise the expenditure of the proceeds of sale of the lands therein described otherwise than as therein provided ; and for other purposes. [Assented to, 20th October, 1905.]

**W**HEREAS by a resolution passed at a general meeting of members Preamble.  
of the Liverpool Plains Pastoral, Agricultural, and Horticultural Association, held subsequently to the passing of the Tamworth Show-ground Act, 1899, the name of the said association was changed to that of the Tamworth Agricultural Association: And whereas the said association has been unable to purchase any land suitable for the purposes of the said association in the town or in the vicinity of the town of Tamworth: And whereas the said association is desirous of obtaining the use for show purposes of certain lands in the town of Tamworth aforesaid, known as the town pump reserve, the oval recreation ground, and part of reserve number ten thousand and seventy-one, which lands are more particularly described in the Schedule hereto: And whereas the portion of the said lands known as the oval recreation ground is held by Charles Jeffries Britten, William Frederick Tribe, Nathan Cohen, Charles Regan, John Denning, and William Frederick Robey, as trustees under deed-poll or grant from the Crown, dated the sixteenth day of August, one thousand eight hundred and ninety-nine, and the said trustees have agreed to surrender the said grant to the Crown, subject to the payment by the said association of the overdraft of the said trustees at the Tamworth branch of the Commercial Banking Company of Sydney, Limited: And whereas the portion of the said lands known as the town pump reserve has been reserved for public purposes and placed under the control of the municipal council of the

borough of Tamworth, and the said council have consented to relinquish their control of the said reserve: And whereas the Secretary for Lands has approved of a grant from the Crown of the lands described in the Schedule hereto being issued to trustees upon trust, to permit the same or any part thereof to be used by the Tamworth Agricultural Association and such other persons, clubs, and associations, at such times and upon such terms and conditions as the trustees shall think fit and proper, as a show-ground for pastoral, horticultural, agricultural, and industrial shows, and a recreation and athletic sports ground: And whereas it is expedient that the proceeds of sale of the lands described in the Tamworth Show-ground Act of 1899 should be applied in paying off the overdraft of the trustees of the oval recreation ground, and in and towards effecting necessary improvements on the lands described in the Schedule hereto: Be it therefore enacted by the King's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Tamworth Show-ground (Amendment) Act, 1905."

Application of moneys arising from sale of Tamworth show-ground.

The trustees of the lands described in the Tamworth Show-ground Act, 1899, shall stand possessed of the moneys arising from the sale of the said lands upon trust to apply the said moneys in and towards the payment of the said overdraft of the trustees of the said oval recreation ground, and in and towards the erection of necessary improvements upon the lands described in the Schedule hereto. The trusts herein declared are in lieu of those contained in the fourth section of the said Act.

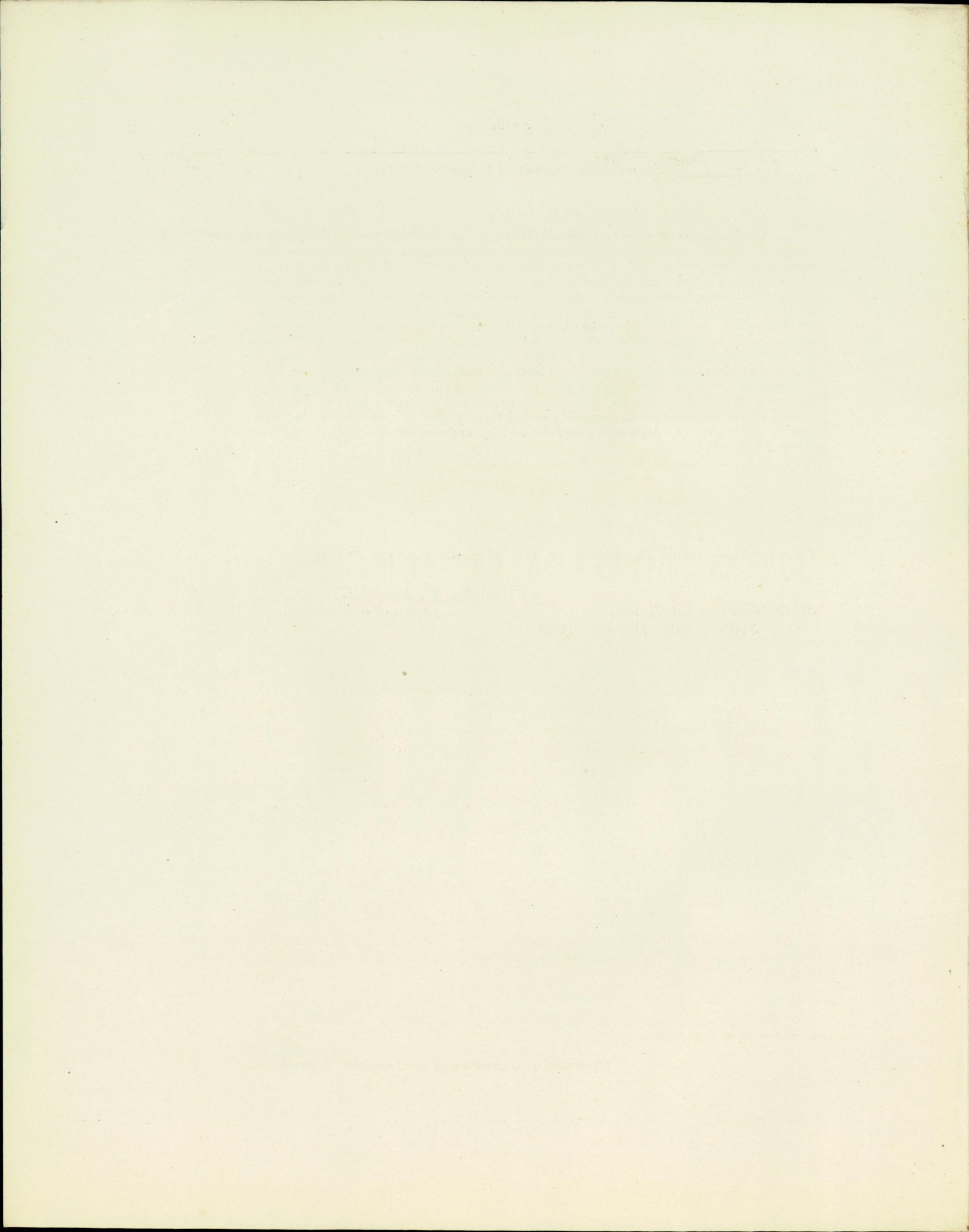

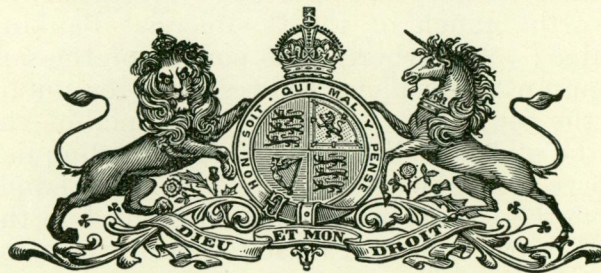
