An Act to apply certain sums out of the Consolidated Revenue Fund towards the Services of the Year 1908-1909; and out of the Public Works Fund; and for Services to be hereafter provided for by Loan. [Assented to, 1st October, 1908.]

WHEREAS we Your Majesty's most dutiful and loyal subjects, Preamble. the Members of the Legislative Assembly of New South Wales in Parliament assembled, have resolved to grant to Your Majesty the sum of Two million one hundred and twenty thousand pounds, that is to say:—

Out of the Consolidated Revenue Fund, the sum of One million nine hundred and seventy thousand pounds, being the amount required to defray the expenses of the various Departments and Services of the State during the months of October, November, and December of the financial year ending thirtieth

thirtieth day of June, one thousand nine hundred and nine; and the sum of Fifty thousand pounds for the Services set forth in Schedule A hereto annexed.

Out of the Public Works Fund, the sum of One hundred thousand pounds for the Services set forth in Schedule B hereto annexed:

And whereas we desire to make good out of the said Funds the sum so granted to His Majesty: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:-

£2,020,000 may be issued out of the Consolidated Revenue Fund.

Treasurer to have credit and receipts to discharge him.

4. The Treasurer shall in his accounts from time to time be allowed credit for all sums of money paid by him in pursuance of such Warrants or Orders. And the receipts of the respective persons to whom the same shall be so paid shall be full and valid discharges to the said Treasurer in passing his accounts for such sums as shall be therein mentioned, and he shall receive credit for the same accordingly.




