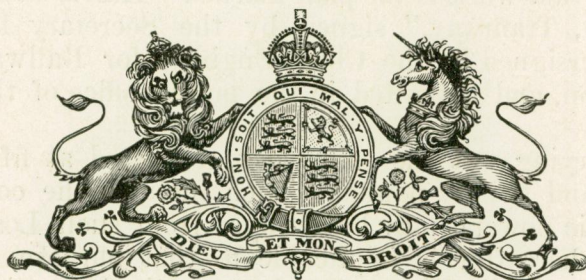

An Act to sanction the construction of an electric tramway from Harris-street, via Miller-street, Abattoir-road, Glebe Island Bridge, and Weston-street to Evans-street, Balmain; and for other purposes.

**W**HEREAS, in accordance with the provisions of the Public Works Act, 1900, the Legislative Assembly did, by resolution, declare that it was expedient to carry out a certain work, namely, the construction of an electric tramway from Harris-street, via Miller-street, Abattoir-road, Glebe Island Bridge, and Weston-street to Evans-street, Balmain: And whereas on the passing of the said resolution, a statutory duty was by the said Act imposed on the Secretary for Public Works to introduce a Bill into the said Assembly to sanction the carrying out of the said work: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent

Cost, how to be defrayed.	4. The cost of carrying out the said work, estimated at fifty thousand seven hundred and twenty pounds (which includes the cost 20 of rolling-stock and electric power), may be defrayed from such Loan Votes as are now or may hereafter be applicable to that purpose, or from appropriations of the Public Works Fund, or partly from such votes and partly from the said appropriations, and shall not under any circumstances exceed the estimated cost by more than ten per centum. 25

#### SCHEDULE.

THIS tramway commences at a point on the Harris-street tramway near the intersection of that street with Miller-street, Ultimo, and proceeds south-westerly along the latter street to Bank-street, north-westerly along that street and across Glebe Island bridge to Abattoir-road, along that road westerly to Weston-street, and generally north-westerly 30 along that street to Evans-street, where it ends by junctioning with the Balmain tramway, being a total distance of one mile thirty-five chains ; and subject to such deviations and modifications as may be considered desirable by the Constructing Authority.

**W**HEREAS, in accordance with the provisions of the Public Preamble.  
Works Act, 1900, the Legislative Assembly did, by resolution, declare that it was expedient to carry out a certain work, namely, the construction of an electric tramway from Harris-street, viâ Miller-  
5 street, Abattoir-road, Glebe Island Bridge, and Weston-street to Evans-street, Balmain: And whereas on the passing of the said resolution, a statutory duty was by the said Act imposed on the Secretary for Public Works to introduce a Bill into the said Assembly to sanction the carrying out of the said work: Be it therefore enacted  
10 by the King's Most Excellent Majesty, by and with the advice and consent

consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

30 Abattoir-road, along that road westerly to Weston-street, and generally north-westerly along that street to Evans-street, where it ends by junctioning with the Balmain tramway, being a total distance of one mile thirty-five chains ; and subject to such deviations and modifications as may be considered desirable by the Constructing Authority.

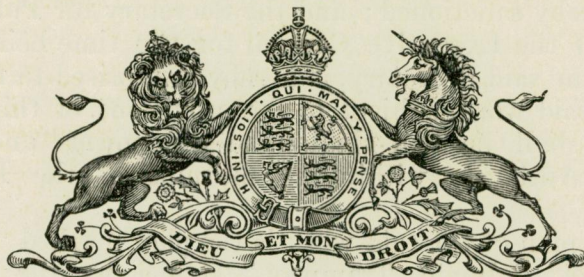

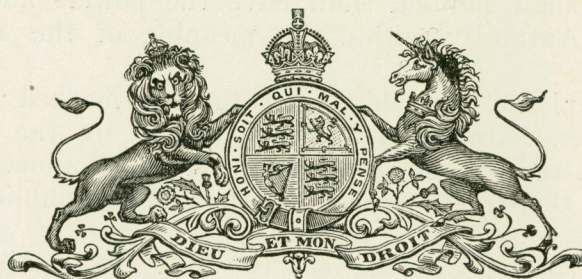
