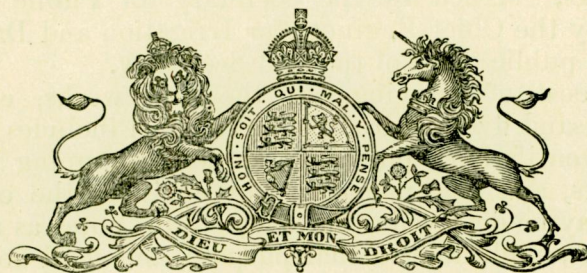

Act No. 19, 1909.

An Act to sanction the construction of a system of sewerage for the Municipality of Lithgow; and for purposes consequent thereupon or incidental thereto. [Assented to, 16th December, 1909.]

WHEREAS, in accordance with the provisions of the Public Works Act, 1900, the Legislative Assembly did, by resolution, declare that it was expedient to carry out a certain work, namely, the construction of a system of Sewerage for the Municipality of Lithgow: And whereas, on the passing of the said resolution, a statutory duty was by the said Act imposed on the Secretary for Public Works to introduce a Bill into the said Assembly to sanction the carrying out of the said work: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Preamble.

- 1. This Act may be cited as the "Lithgow Sewerage Act, 1909." Short title.

Lithgow Sewerage.

Work sanctioned.

2. The carrying out of the works, more particularly described in the Schedule to this Act, is hereby sanctioned, and the Secretary for Public Works, or the member of the Executive Council for the time being performing the duties of the said Secretary, is hereby authorised to undertake and carry out the said work, subject to the provisions of this Act, and for that purpose shall be and shall have the powers and duties of a Constructing Authority within the meaning of the Public Works Act, 1900.

Plan of work.

3. The plan of the said works is the plan marked "Lithgow Sewerage Works," signed by the Secretary for Public Works, and countersigned by the Chief Engineer for Irrigation and Drainage, and deposited in the public office of the said Secretary.

Cost, and how defrayed.

4. The cost of carrying out the said works, estimated at twenty-six thousand five hundred pounds (which includes the cost of pipe sewers, ventilation, pumping station, pumping machinery, treatment works, and contingencies, but excludes the cost of land resumption), may be defrayed from such Loan Votes as are now, or may hereafter be, applicable to that purpose, and shall not under any circumstances exceed the estimated cost by more than ten per centum.

SCHEDULE.

THE construction of fourteen miles thirty-four chains, more or less, of main and reticulating sewers, varying in size from six to eighteen inches in diameter, together with manholes, junctions, gullies, ventilating shafts and pipes, penstocks, intercepting and flushing chambers, and all works incidental thereto and necessary for the proper completion thereof. The construction of pumping station, rising main, and works for the bacteriological treatment of sewage, near Farmer's Creek.

The works above described are subject to such deviations and modifications, omissions, or extensions, as may hereafter be deemed necessary.

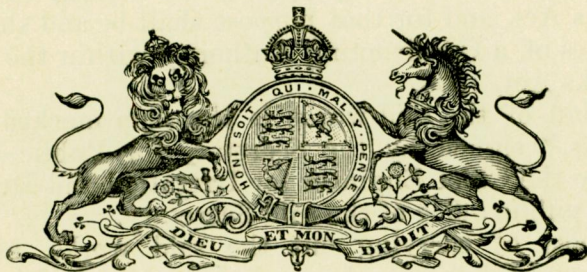

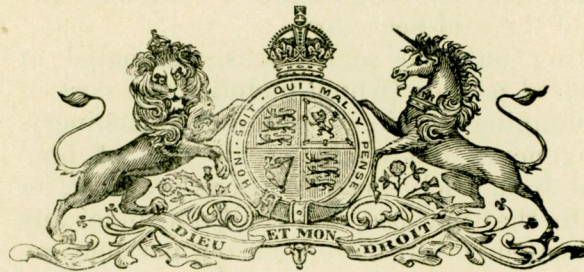
