### An Act to amend the Income Tax Act, 1911. [Assented to, 4th April, 1912.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

**1.** This Act may be cited as the "Income Tax (Amendment) Short title. Act, 1912."

**2**. This Act and the Income Tax Act, 1911, shall be construed Incorporation of with the Income Tax (Management) Act, 1912.

**3.** (1) Section eight of the Income Tax Act, 1911, is amended Amendment of ss. 8, by omitting the words "Principal Act and the Acts amending the 1911. same" and inserting in place thereof the words "Income Tax (Management) Act, 1912."

(2) Subsection two of the same section is omitted.


(3) Section nine of the said Act is repealed.




I have examined this Bill, and find it to correspond in all respects with the Bill as finally passed by both Houses.
