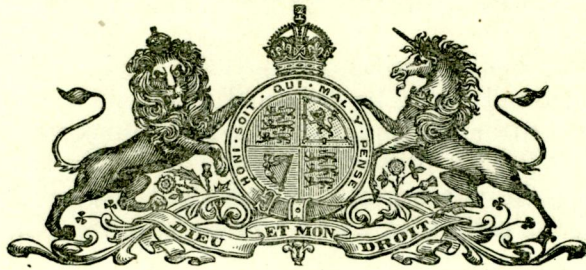

### Act No. 61, 1912.

An Act to sanction the extension of Newcastle Southern Breakwater ; and for purposes consequent thereon or incidental thereto. [Assented to, 20th December, 1912.]

**W**HEREAS in accordance with the provisions of the Public Preamble. Works Act, 1900, the Legislative Assembly did, by resolution, declare that it was expedient to carry out a certain work, namely, extending the Southern Breakwater, Newcastle Harbour Entrance: And whereas, on the passing of the said resolution, a statutory duty was by the said Act imposed on the Secretary for Public Works to introduce a Bill into the said Assembly to sanction the carrying out of the said work: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**1.** This Act may be cited as the "Newcastle Southern Breakwater Extension Act, 1912." **2.** Short title.

Work sanctioned.

**2.** The carrying out of the work, more particularly described in the Schedule of this Act, is hereby sanctioned, and the Secretary for Public Works, or the member of the Executive Council for the time being performing the duties of the said Secretary, is hereby authorised to undertake and carry out the said works, subject to the provisions of this Act; and for that purpose shall be and shall have the powers and duties of a Constructing Authority within the meaning of the Public Works Act, 1900.

Plan of work.

**3.** The plan of the said works is the plan marked "Newcastle Harbour, Extension of Southern Breakwater," signed by the Secretary for Public Works, and countersigned by the Chief Engineer for Public Works, Newcastle district, and deposited in the public office of the said Secretary.

Cost, and how defrayed.

**4.** The cost of carrying out the said works, estimated at fifty-four thousand pounds, may be defrayed from such loan votes as are now, or may hereafter be applicable to that purpose, or from appropriations of the Public Works Fund, or partly from such votes and partly from the said appropriations, and shall not, under any circumstances, exceed the estimated cost by more than ten per centum.

SCHEDULE.

THE construction of an extension of the existing Southern Breakwater beyond its present termination for a distance of 460 feet seawards, marked "Extension of Southern Breakwater" on plan aforesaid.

The Breakwater to be strengthened at its outer end by a round head 60 feet in diameter.

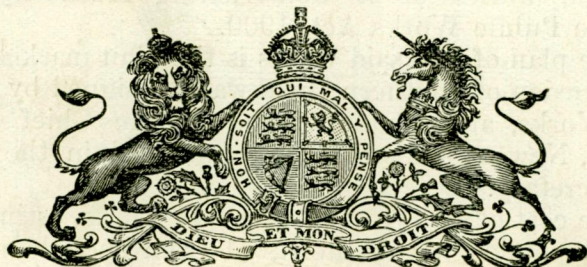
The whole of the above works to be subject to such modifications as may be considered desirable by the Constructing Authority.

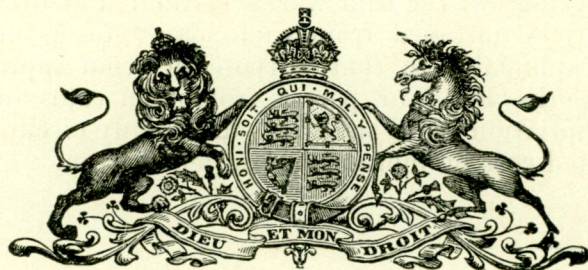
