Act No. 48, 1912.

An Act to sanction the erection of a building for the purpose of a Teachers' College; and for purposes consequent thereon and incidental thereto. [Assented to, 26th November, 1912.]

WHEREAS in accordance with the provisions of the Public Works Preamble. Act, 1900, the Legislative Assembly did, by resolution, declare that it was expedient to carry out a certain work, namely, the erection of a building for the purpose of a Teachers' College: And whereas, on the passing of the said resolution, a statutory duty was by the said Act imposed on the Secretary for Public Works to introduce a Bill into the said Assembly to sanction the carrying out of the said work: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Teachers' College Building Short title. Act, 1912." 2.

### Teachers' College Building.

Works sanctioned.

2. The carrying out of the works more particularly described in the Schedule to this Act is hereby sanctioned; and the Secretary for Public Works, or the member of the Executive Council for the time being performing the duties of the said Secretary, is hereby authorised to undertake and carry out the said works, subject to the provisions of this Act, and for that purpose shall be and have the powers of a Constructing Authority within the meaning of the Public Works Act, 1900.

Plan of works.

3. The plan of the said works is the plan marked "Training College for Teachers," signed by the Secretary for Public Works, and countersigned by the Government Architect, and deposited in the public office of the said Secretary.

Cost, and how to be defrayed.

4. The cost of carrying out of the said works, estimated at sixty-eight thousand four hundred and seventy-five pounds, may be defrayed from such Loan Votes as are now or may hereafter be applicable to the purpose, or from appropriations of the Public Works Fund, or partly from such votes and partly from the said appropriations, and shall not, under any circumstances, exceed the estimated cost by more than ten per centum.

#### SCHEDULE.

The building will form a rectangular block built around an inner court-yard, which is divided in the centre by an arcade forming an approach from the main entrance to the Assembly Hall.

It will consist of three storeys, and will be constructed of brick, with freestone dressings, reinforced concrete floors, and slated roof, and will harmonize in style with the adjoining buildings of the University.
