## Act No. 15, 1911.

An Act to sanction the carrying out of a scheme of Sewerage for the Municipality of Vaucluse; and for purposes consequent thereupon or incidental thereto. [Assented to, 15th November, 1911.]

WHEREAS, in accordance with the provisions of the Public Preamble. Works Act, 1900, the Legislative Assembly did, by resolution, eclare that it was expedient to carry out a certain work, namely, the carrying out of a scheme of sewerage for the municipality of Vaucluse: And whereas, on the passing of the said resolution, a statutory duty was by the said Act imposed on the Secretary for Public Works to introduce a Bill into the said Assembly to sanction the carrying out of the said work: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :--

1. This Act may be cited as the "Vaucluse Sewerage Act, Short title. 1911." 2.

I have examined this Bill, and find it to correspond in all respects with the Bill as finally passed by both Houses.
