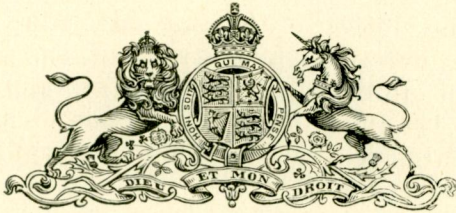

Act No. 16, 1915.

An Act to sanction the construction of a system of sewerage for the Municipality of Goulburn ; and for purposes consequent thereupon or incidental thereto. [Assented to, 20th February, 1915.]

WHEREAS in accordance with the provisions of the Preamble. Public Works Act, 1900, the Legislative Assembly did, by resolution, declare that it was expedient to carry out a certain work, namely, the construction of a system of sewerage for the Municipality of Goulburn : And whereas, on the passing of the said resolution, a statutory duty was by the said Act imposed on the Secretary for Public Works to introduce a Bill into the said Assembly to sanction the carrying out of the said work : Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. This Act may be cited as the "Goulburn Sewerage Short title. Act, 1915."

Goulburn Sewerage.

Work sanctioned.

2. The carrying out of the work (more particularly described in the Schedule to this Act) is hereby sanctioned; and the Minister for Public Works, or the member of the Executive Council for the time being performing the duties of the said Minister, is hereby authorised to undertake and carry out the said work, subject to the provisions of this Act, and for that purpose shall be, and shall have the powers and duties of, a Constructing Authority within the meaning of the Public Works Act, 1912.

Plan of work.

3. The plan of the said work is the plan marked "Goulburn Sewerage Works," signed by the Minister for Public Works and countersigned by the Chief Engineer for Irrigation and Drainage, and deposited in the public office of the said Minister.

Cost, and how defrayed.

4. The cost of carrying out the said work, estimated at sixty-six thousand six hundred pounds (including cost of land resumption), may be defrayed from such Loan Votes as are now or may hereafter be applicable to that purpose; and shall not under any circumstances exceed the estimated cost by more than ten per centum.

SCHEDULE.

THE construction of ten miles, more or less, of main and reticulating high-level sewers, varying in size from six to eighteen inches in diameter, and twelve and a half miles, more or less, of main and reticulating low-level sewers, varying in size from six to eighteen inches in diameter, together with man-holes, junctions, gullies, ventilating shafts and pipes, penstocks, intercepting and flushing chambers; and all works incidental thereto and necessary for the proper completion thereof.

The construction of pumping station and works for the bacteriological treatment of sewage, near the junction of Mulwarree Ponds with the Wollondilly River.

The works above described are subject to such deviations and modifications, omissions, or extensions as may hereafter be deemed necessary.
