Act No. 35, 1915.

An Act to amend section seventy of the Local Government Act, 1906. [Assented to, 18th November, 1915.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Local Government (Amendment) Act, 1915." Short title.
2. Paragraph (c) of section seventy of the Local Government Act, 1906, is hereby repealed, as from the fourth day of August, in the year one thousand nine hundred and fourteen. Amendment of s. 70.

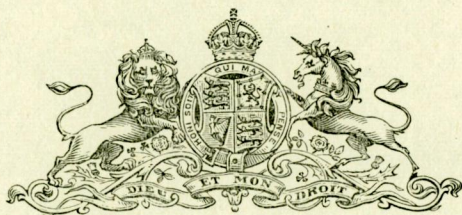
