## Act No. 35, 1916.

An Act to authorise the municipal councils of Petersham and Bankstown to close certain roads ; to provide for the disposal of the land in such roads ; and for purposes consequent thereon or incidental thereto. [Assented to, 5th September, 1916.]

**B**E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

**1.** (1) This Act may be cited as the "Petersham and Bankstown Road Closing Act, 1916." Short title.

(2) This Act shall be read with the Local Government Act, 1906, and with any Acts amending that Act.

Closing public road known as Horbury-terrace, Petersham.

**2.** (1) That portion of the public road known as Horbury-terrace in the municipality of Petersham, which is described in Schedule I of this Act, is hereby closed, and the dedication thereof as a public road is hereby cancelled, and the site of such road is vested in the council of the municipality of Petersham for an estate in fee simple with full rights in the soil below and in the air above.

Issue of certificate of title to council.

(2) The Registrar-General is hereby authorised to make all necessary notifications in connection with such vesting in the register book and in any certificate of title comprising the land referred to, and to issue to the council of the municipality of Petersham a certificate of title under the Real Property Act, 1900, to the land described in the said Schedule I, free of all dedications, reservations, and encumbrances whatsoever.

Power of sale.

(3) The said council is hereby authorised to sell the said land, and to apply the proceeds of such sale to the purchase of other land to be used for the extension, widening, straightening, deviation, or other improvement of Liberty-street, in the said Municipality, and to apply any balance of such proceeds for the purposes of the general fund, or to exchange such land for other land to be used for the above purposes: And the said council is hereby authorised to agree with the owner of any such other land so purchased or taken in exchange as aforesaid to remove and re-erect on the land, formerly known as Horbury-terrace, the stable-buildings and fencing now standing on such other land, or on land adjoining thereto; to remove the kerbing and guttering of the land formerly known as Horbury-terrace, and level such land; and to connect the drainage from the said owner's building situated on any land aforesaid with the water channel in the extension of Liberty-street aforesaid.

Closing portion of Marion-street, Bankstown.

**3.** (1) That portion of the public road known as Marion-street, in the Municipality of Bankstown, which is described in Schedule II of this Act, is hereby closed, and the dedication thereof as a public road is hereby cancelled, and the site of such road is vested in the council of the Municipality of Bankstown for an estate in fee simple with full rights in the soil below and in the air above.

(2) The Registrar-General is hereby authorised to make all necessary notifications in connection with such vesting in the register book and in any certificate of title comprising the land referred to, and to issue to the council of the municipality of Bankstown a certificate of title under the Real Property Act, 1900, to the land described in the said Schedule II, free of all reservations, dedications, and encumbrances whatsoever.

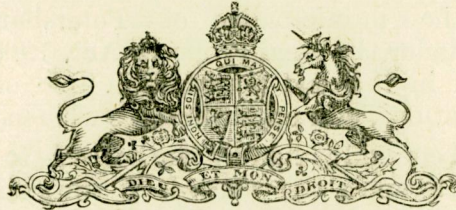
