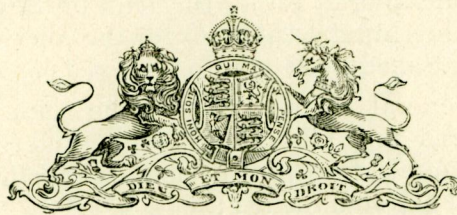

Act No. , 1914.

An Act to apply certain sums out of the Consolidated Revenue Fund towards the Services of the Year 1914-1915, and out of the Public Works Fund, and out of the General Loan Account for Services to be hereafter provided for by Loan.

**W**HEREAS we Your Majesty's most dutiful and Preamble. loyal subjects, the Members of the Legislative Assembly of New South Wales in Parliament assembled, have resolved to grant to Your Majesty the sum of One million five hundred and fifty-five thousand four hundred pounds, that is to say—

Out of the Consolidated Revenue Fund, the sum of Five hundred and thirty-four thousand pounds, being the sum required to defray the expenses

5 expenses of the various Departments and Services of the State during the month of October or following month of the financial year ending thirtieth day of June, one thousand nine hundred and fifteen; and the sum of Seven hundred and twenty-five thousand pounds for the Services set forth in Schedule A hereto annexed.

10 Out of the Public Works Fund, the sum of Seven thousand nine hundred pounds for the Services set forth in Schedule B hereto annexed.

15 Out of the General Loan Account the sum of Two hundred and eighty-eight thousand five hundred pounds for the Services set forth in Schedule C hereto annexed :

20 And whereas we desire to make good out of the said Funds and the General Loan Account the sum so granted to His Majesty: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

25 **1.** Out of the Consolidated Revenue Fund of £1,259,000 New South Wales there shall and may be issued and applied for or towards making good the supply so resolved to be granted to His Majesty, the sum of One million two hundred and fifty-nine thousand pounds, of which the sum of Five hundred and thirty-four thousand pounds is to be expended at the rates which 30 have been sanctioned for the financial year ended thirtieth day of June, one thousand nine hundred and fourteen, to defray the expenses of the various Departments and Services of the State during the month of October or following month of the financial year ending thirtieth 35 day of June, one thousand nine hundred and fifteen, subject to the rate of any reduction that may hereafter be made in the expenditure of the year 1914-1915, and the sum of Seven hundred and twenty-five thousand pounds is to be expended for the Services specified in 40 Schedule A hereto annexed.

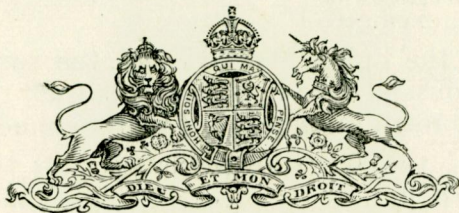

An Act to apply certain sums out of the Consolidated Revenue Fund towards the Services of the Year 1914-1915, and out of the Public Works Fund, and out of the General Loan Account for Services to be hereafter provided for by Loan. [Assented to, 2nd October, 1914.]

**W**HEREAS we Your Majesty's most dutiful and Preamble. loyal subjects, the Members of the Legislative Assembly of New South Wales in Parliament assembled, have resolved to grant to Your Majesty the sum of One million five hundred and fifty-five thousand four hundred pounds, that is to say—

Out of the Consolidated Revenue Fund, the sum of Five hundred and thirty-four thousand pounds, being the sum required to defray the expenses

**4.** The Treasurer shall issue and pay the said sums for the Services aforesaid in such manner and in such proportions as the Governor, by Warrants or Orders in writing under his hand, and directed to the said Treasurer, shall from time to time order and direct.
