This Private Bill originated in the Legislative Council, and, having this day passed, is now ready for presentation to the Legislative Assembly for its concurrence.

An Act to enable William Longworth and Thomas Longworth, of Sydney, in the State of New South Wales, to construct a railway from coal lands at Buttai, in the parish of Maitland, county of Northumberland, to the Great Northern Railway at Thornton, in the parish of Alnwick.

WHEREAS William Longworth and Thomas Preamble.
Longworth, both of Sydney, in the State of
New South Wales, are owners of coal mines upon the
lands situated at Buttai, in the parishes of Alnwick,
Maitland, and Stockrington, in the county of Northumberland, near Thornton, and in order to facilitate communication between the said coal mines and the Great
44207 C 290—A Northern

Northern Railway the said William Longworth and Thomas Longworth, hereinafter designated the promoters, are desirous of constructing a railway from their said coal mines to the Great Northern railway at or 5 about the Thornton railway station; but as part of such railway and sidings are intended to be made upon and pass through land believed to be the property of the Crown, bodies corporate, and private persons respectively, the same cannot be made without Legislative 10 authority: And whereas the said coal mines are likely to prove beneficial to the State, and the public are concerned in promoting such increase in and facilities for the supply of coal for local consumption, steam navigation, and export, as would result from the construction 15 of the said proposed railway and sidings, and traffic on the Great Northern railway would be increased thereby, it is therefore desirable to authorise by Legislative enactment the construction of the said railway and sidings, subject to the provisions hereinafter contained, upon 20 payment of compensation to the several parties through whose land the same shall pass for such portion of their respective lands as may require to be taken and occupied thereby: Be it therefore enacted by the King's most excellent Majesty, by and with the consent of the 25 Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same as follows:-

1. It shall be lawful for the said promoters to make Authority to and construct a railway which shall be of the same gauge construct railway and 30 as the Government Railways, namely, four feet eight connect same and a half inches, from a point commencing in the with Great lands of the promoters bearing north-east ten chains Railway. from the south-west corner of portion twenty-five in the parish of Maitland, county of Northumberland, and 35 bearing thence about north-east to a point about eight chains south from the north-east corner of the said portion, thence through lands of John Farrell, the trustees of the will of the late Henry Osborne, the trustees or beneficiaries in the estate of the late William

40 Fane de Salis, across the main northern road, Newcastle to Maitland, lands of said trustees or beneficiaries of the

late William Fane de Salis, and land of promoters, to a point on the Great Northern railway, connecting therewith at a point about fourteen miles north of Newcastle and adjacent to the Thornton railway station, and 5 which lands and route are particularly described in the

Schedule hereto, such railway to be in the direction described in the Schedule, but so that the same shall not occupy at any part thereof a greater space in breadth than sixty-six feet, and to make and construct such loop

10 lines, stations, and sidings as may be necessary for the safe and convenient use of the railways to be constructed as aforesaid, and to take and use so much of the lands of private persons mentioned in the Schedule as the promoters may require for their said railway, loop lines,

15 stations, and sidings, but so that the same shall not occupy at any part thereof a greater space in breadth than sixty-six feet. The said railway shall be constructed in a proper and workmanlike manner, to the satisfaction of the Director-General of Public Works and 20 the Chief Commissioner for Railways and Tramways.

2. The ground and soil of so much of the site of the railway and sidings as passes over or includes the lands of the said owners of lands, together with such rights of ingress, egress, and regress upon the adjacent land as

25 may be necessary for the making and repair of such railway shall, so far as is necessary for the purpose of this Act, be vested by virtue of this Act and without the necessity of any conveyance in the promoters for the purposes of the railway:

30 Provided that no lands vested in the Chief Commissioner for Railways and Tramways shall by virtue of this Act be vested in the promoters, and nothing herein contained shall prevent the said owners from carrying on any mining operations beneath the said railway

35 which shall not interfere with the safety of the said railway and the traffic thereon; and the promoters shall have no further rights to the soil of the said lands beneath the surface than shall be requisite for the formation and repairs of the said road by cutting, 40 embanking, sinking wells, or otherwise:

Provided that the said railway shall be constructed and brought into use within five years after the passing of

this Act, and that in default thereof, or if after its completion the said railway shall cease to be used for three years continuously, all the said lands and all the said promoters' interest and estate therein shall revert without any 5 conveyance to the original owners thereof, their heirs

and assigns respectively:

Provided also that if in the exercise of the powers hereby granted it be found necessary to cross-cut through, sink, raise, or use any part of any road so as to render it 10 impassable for or dangerous or inconvenient to the persons entitled to the use thereof, the promoters shall before the commencement of any such operations at their own expense cause a sufficient road to be made instead of any road interfered with, and shall at their own expense 15 maintain such substituted road in a state as convenient as

the road interfered with, or as nearly as may be. And the promoters before they use the said lands of the owners of the land for the purposes aforesaid, shall, if required so to do, separate the same by a sufficient fence from the

20 land adjoining thereto, with such gates as may be required for the convenient occupation of such land, and shall also to all private roads used by them as aforesaid, put up fences and gates in like manner in all cases, where the same may be necessary, to prevent the stray-

25 ing of cattle from or upon the lands traversed by such roads; and in case of any difference between owners or occupiers of such roads and lands and the promoters as to the necessity for such fences and gates, then the said promoters shall put up and erect such fences and gates

30 as any two justices of the peace after inquiry shall deem necessary for the purpose aforesaid on application being

made to them.

3. The railway shall be open to the public use for Railways the conveyance of coal and goods upon payment of a toll open to the public.

35 to the promoters for the conveyance of coal of a sum not exceeding one penny per ton per mile, with a minimum charge of threepence per ton in respect of every ton of coal for every transit, the person seeking transit supplying and loading his own trucks or on 40 Government waggons, and the promoters or Government supplying locomotive power, and all trucks when emptied shall be conveyed on their return free of charge:

Provided

Provided always that it shall not be compulsory on the promoters to supply locomotive power unless the party seeking the transit guarantee and bring one hundred tons at least during the twelve working hours, 5 and give notice of same at least twenty-four hours previously. The railway shall at all times be open to the public for the conveyance of coal and goods upon payment of a toll to the promoters for the conveyance of coal of a sum not exceeding one halfpenny per ton per 10 mile, with a minimum charge of twopence per ton in respect of every ton of coal for every transit and for goods of a sum not exceeding one penny halfpenny per ton per mile in respect of every ton of goods for every transit, if the party seeking transit supply the locomotive 15 power as well as the trucks and waggons:

Provided that so long as the promoters shall be willing to supply locomotive power no other person shall use locomotive power on the line other than the Chief Commissioner for Railways and Tramways:

Provided that if the railway shall be damaged by the parties who shall themselves use the railway for transit and supply locomotive power, the promoters shall be entitled to compensation for such damage, to be recovered either by action in the Supreme Court of New 25 South Wales, or, if such damage do not exceed the sum of twenty pounds summarily before two justices; and in estimating such damages the promoters shall be entitled not only to compensation for the cost of re-

pairing and restoring the railway, but to the conse-30 quential damage (if any) sustained by reason of the suspension of transit or otherwise.

4. It shall be lawful for the owners or occupiers of Branch the lands adjoining thereto or traversed by the said railways. railway to lay down upon their own lands any collateral 35 branches or railway to communicate with the said railway for the purpose of bringing carriages, trucks, and waggons to or from or upon the said railway, and the promoters shall, if required, at the expense of such owners or occupiers, make openings in the rails and 40 such additional lines of railway as may be necessary for effecting

effecting such communications in places where the communication can be made with safety to the public and without injury to the said railway and without inconvenience to the traffic thereupon, and the promoters 5 shall not take any rate, toll, or other moneys for the passing of any passengers, coal and goods, or other things along any branch so to be made by any such owner or occupier or other person. The promoters shall not be bound to make any such openings in any place 10 which they shall have set apart for any specific purpose with which such communication would interfere, nor upon any inclined plane or bridge nor in any tunnel, The persons making or using such branch railways shall be subject to all by-laws and regulations of the promoters 15 from time to time made with respect to passing upon or crossing the railway and otherwise; and the persons making or using such branch railways shall be bound to construct and from time to time as need may require to renew the off-set plates and switches according to the 20 most approved plan adopted by the promoters under the direction of their engineer.

5. For the purposes and subject to the provisions Power to hereinafter contained it shall be lawful for the pro-divertand moters, their deputies, agents, servants, and workmen, roads. 25 and all other persons by them authorised and empowered,

to divert or alter the course of any road or way crossing the railway or to raise or sink any road or way in order the more conveniently to carry the same over or under or by the side of the railway:

Provided always that any such work shall be carried out to the satisfaction of the Tarro shire council, and all such diversions, alterations, and crossings, and the approaches thereto, shall hereafter be maintained and repaired by the promoters at their own expense, and to 35 the satisfaction of the said Tarro shire council.

6. If the promoters do not cause another sufficient Penalty for road to be so made before they interfere with any such not substituting a road. existing road as aforesaid, or if they fail to maintain all such diversions, alterations, crossings, and the 40 approaches thereto, they shall forfeit twenty pounds for

every day during which such substituted road shall not be made after the existing road shall have been interrupted, or during which such diversions, alterations, crossings, or approaches shall remain in a state of disrepair, and 5 such penalty shall be paid to the said Tarro shire council, if a public road, and shall be applied for the purposes thereof, or, in case of a private road, the same shall be paid to the owner thereof; and every such penalty shall be recoverable, with costs, by action in any court of 10 competent jurisdiction.

7. It shall be lawful for and, at the request of the Rightto carry Chief Commissioner for Railways and Tramways, com-passengers. pulsory upon the said promoters, from time to time,

and at all reasonable times, to carry passengers, goods, 15 and live stock, upon the said railway, or any part thereof respectively, and to make, demand, take, receive, and recover such tolls or dues for carrying the same at such rate per mile, or other scale of charges, as shall be established from time to time by the promoters for or

20 in respect of all such passengers, goods, and live stock, which shall be conveyed or transported upon such railway, or any part thereof respectively: And the promoters are hereby authorised to make such by-laws and regulations not inconsistent with this Act, and

25 subject to the approval of the Chief Commissioner for Railways and Tramways, as may be necessary for the regulation of such traffic, and such by-laws or regulations shall be binding upon all persons using or travelling upon the said railway; and any persons offending against

30 such by-laws or regulations shall be liable to a fine not exceeding ten pounds for each offence, to be recoverable in a summary way before any two justices:

Provided always that if the rates, tolls, or dues that may be established as aforesaid, under and by virtue of 35 this Act, shall be found excessive, it shall and may be lawful for the Executive Council, on the petition of any person, to reduce the said rates, tolls, or dues, and to revise them in such a manner as may seem most proper and advisable.

40 8. If in the course of making the railway the Road repairs. promoters shall use or interfere with any road, they shall.

shall, from time to time, make good all damage done by them to such roads to the satisfaction of the said Tarro shire council; and if any question shall arise as to the damage done to any such road by the promoters or as 5 to the repair thereof by them, such questions shall be referred to the determination of two justices, and such justices may direct such repairs to be made in the state of the roads in respect of damage done by the promoters, and within such period as they may think reasonable, 10 and may impose on the promoters for not carrying into effect such repairs, any penalty, not exceeding ten pounds per day, as to such justices shall seem fit, and any such penalty shall be paid to the said Tarro shire council, if a public road, and be applied for the purposes of such 15 road, or if a private road the same shall be paid to the owner thereof.

9. Until the promoters shall have made the bridges owner's or other proper communications, which they shall, under crossing.

the provisions herein contained, have been required to 20 make between lands intersected and the railway, and no longer, the owners and occupiers of such lands, and any other person whose right of way shall be affected by the want of such communications and their respective servants, may at all times freely pass and repass with

25 carriages, horses, and other animals directly, but not otherwise, across any part of the railway made in or through their respective lands solely for the purpose of occupying the same lands or for the exercise of such right of way and so as not to obstruct the passage along

30 the railway or to damage the same. Nevertheless, if the owner or occupier of any such lands have in his arrangement with the promoters received or agreed to receive compensenation for or on account of any such communications, instead of the same being formed,

35 such owner, occupier, or those claiming under him shall not be entitled so to cross the railway.

10. If the railway cross any public highway or Provisions in parish road on a level, the promoters shall erect or construct and at all times maintain to the satisfaction of the crossed on a 40 said Tarro shire council, cattle-stops or good and sufficient level. gates across such railway on each side of the road where

the same shall communicate therewith, and shall employ proper persons to open and shut such gates, and such gates shall be kept constantly closed across such railway on both sides of the road, except during the time when 5 engines or railway vehicles, passing along the same, shall have to cross such road, and such gates shall be of such dimensions and so constructed as when closed to fence in the road and prevent cattle or horses passing along the road from entering upon the railway, and the person 10 entrusted with the care of such gates shall cause the same to be closed as soon as such engines or railway vehicles shall have passed through the same, under a penalty not exceeding forty shillings for every default therein, to be recoverable before any two justices in a 15 summary way.

11. In case of accidents or slips happening or being Power to apprehended to the cuttings, embankments, or other enter upon adjoining works of the said railway it shall be lawful for the lands to promoters and their workmen and servants to enter upon repair accidents subject 20 the land adjoining thereto at any time whatsoever for to certain

the purpose of repairing or preventing such accidents, restrictions. and to do such works as may be necessary for the purpose, but in every such case the promoters shall within forty-eight hours of such entry make a report to

25 the Secretary for Public Works specifying the nature of such accident or apprehended accident, and of the works necessary to be done, and such powers shall cease and determine if the said Secretary shall after considering the said report certifying that their exercise is not

30 necessary for the public safety or for the repair and maintenance of the said line:

Provided also that such works shall be as little injurious to the said adjoining lands as the nature of the accident or apprehended accident will admit of, and 35 shall be executed with all possible despatch, and full compensation shall be made to the owners and occupiers of such lands for the loss or injury or inconvenience sustained by them respectively by reason of such works, the amount of which compensation in case of any 40 dispute about the same shall be settled by arbitration in

the manner hereafter mentioned; and provided also

that no land shall be taken permanently for any such works otherwise than is herein provided with respect to the lands originally taken for the purpose of making the said railway.

12. Every bridge to be erected for the purpose of Construction carrying the railway over any road shall be built in of bridges conformity with the following regulations, that is to say:—

The width of the arch shall be such as to leave thereunder a clear space of not less than thirty feet, if the arch be over a public highway, and of twenty feet if over a parish road, and of twelve feet if over a private road.

The clear height of the arch from the surface of the road shall not be less than sixteen feet for space of twelve feet if the arch be over the main road, and fifteen feet for a space of ten feet if over a public carriage road; and in each of such cases the clear height at the springing of the arch shall not be less than twelve feet, the clear height of the arch for a space of nine feet shall not be less than fourteen feet over a private road.

The descent made in the road in order to carry the same 25 under the bridge shall not be more than one foot in thirty feet if the bridge be over a public highway, one foot in twenty feet if over a parish road, and one foot in sixteen feet if over a private road, not being a tramroad or railroad; or if the same be a tramroad or rail-30 road, the descent shall not be greater than the ruling

gradient of such tramroad or railroad:

Provided always that every such bridge shall be erected to the satisfaction of the Chief Commissioner for Railways and Tramways and the Director-General of 35 Public Works.

13. Every bridge erected for carrying any road over Construction the railway shall be built in conformity with the fol-of bridges lowing regulations, that is to say:—

There shall be a good and sufficient fence on each side of the bridge of not less height than four feet and on each side of the immediate approaches of such bridge of not less than three feet.

The road over the bridges shall have a clear space between the fences thereof of thirty-five feet if the road be a public highway, and twenty-five feet if a parish road, and twelve feet if a

private road.

the inclination hereinbefore required to be preserved by

the promoters, then the promoters may carry any such road over or under the railway, or may construct such altered or substituted road at an inclination not steeper than the said mean inclination of the road so to be 5 crossed, or of the road so requiring to be altered, or for which another road shall be substituted.

14. The promoters shall make, and at all times works for thereafter maintain, the following works for the accombine modation of the owners and occupiers of lands adjoining 10 the railway, that is to say:—

Such and so many convenient gates, bridges, arches, Gates, culverts, and passages over, under, or by the bridges, &c. sides of or leading to, or from the railway, as shall be necessary for the purpose of making good any interruptions caused by the railway to the use of the lands through which the railway shall be made. And such works shall be made forthwith after the part of the railway passing over such lands shall have been laid out or formed, or during the formation thereof.

All sufficient posts, rails, hedges, ditches, mounds, Fences. or other fences for separating the land taken for the use of the railway from the adjoining lands not taken and protecting such lands from trespass, or the cattle of the owners or occupiers thereof from straying thereon, by reason of the railway, together with all necessary gates made to open towards such adjoining lands, and not towards the railway. And all necessary stiles and such posts, rails, and other fences shall be made forthwith after the taking of any such land, if the owners thereof shall so require, and the said other works as soon as conveniently may be.

Also all necessary arches, tunnels, culverts, drains, prains. or other passages, either over or under or by the sides of the railway, of such dimensions as will be sufficient at all times to convey the water as clearly from the lands lying near or affected by the railway as before the making of the railway, or as nearly so as may be, and such works shall be made from time to time as the railway work proceeds.

Also proper watering places for cattle or compen-wateringsation in lieu thereof, where by reason of the places.

5 railway the cattle of any person occupying
any lands lying near thereto shall be deprived
of access to their former watering-places. And
such watering-places shall be so made as to be
at all times sufficiently supplied with water as
theretofore, and as if the railway had not been
made, or nearly so as may be. And the said
promoters shall make all necessary watercourses
and drains for the purpose of conveying water
to the said watering-places:

Provided always that the promoters shall not be required to make such accommodation works in such manner as would prevent or obstruct the working or using of the railway nor to make any accommodation works with respect to which the owners and occupiers 20 of the land shall have agreed to receive, and shall have

been paid compensation instead of the making of them.

15. If any person omit to shut and fasten any gate Penalty on set up either side of the railway for the accommodation persons of the owners or occupiers of the adjoining lands so soon fasten gates,
25 as he and the carriage, cattle, or other animals under his care have passed through same, he shall forfeit for every such offence a sum not exceeding five pounds, to be recoverable in a summary way before any two

justices.

30 16. The promoters shall not be entitled to any Minerals not minerals under any land whereof the surface is vested in to pass, them by virtue of this Act except only such parts thereof as shall be necessary to be dug or carried away in the construction of the works hereby authorised; and 35 such mines shall not be deemed to vest in the said

promoters.

17. If, within ninety days after the passing of this Appointment Act, the said persons through whose lands the railway of arbitrators. shall pass, or any of them, and the promoters shall not 40 agree as to the amount of compensation to be paid by them for the said lands belonging to the said parties, and any of them, or for any damage that may be sustained by them, or him, by reason of the execution of

the works, or if any other question as to compensation shall arise under this Act, the amount of such compensation shall be settled by arbitration in manner hereinafter mentioned, that is to say, unless both parties shall 5 concur in the appointment of a single arbitrator, each party on the request of the other party shall nominate and appoint an arbitrator to whom such dispute or other matter shall be referred, and every appointment of an arbitrator shall be under the hand of such party; and 10 such appointment shall be delivered to the arbitrator or arbitrators and shall be deemed a submission to arbitration on the part of the party by whom the same shall be made. And after any such appointment shall have been made neither party shall have power to revoke the 15 same without the consent of the other, nor shall the death of either party operate as a revocation. And if, for the space of fourteen days after any such dispute or other matter shall have arisen, and after a request in writing shall have been served by the one party 20 on the other party to appoint an arbitrator, such last mentioned party failed to appoint such arbitrator, then upon such failure it shall be lawful for the Attorney-General, on application of the party who has

himself appointed an arbitrator, to appoint such 25 arbitrator to act on behalf of both parties, and such arbitrator may proceed to hear and determine the matters which shall be in dispute; and in such case the award or determination of such single arbitrator shall be final

and conclusive.

30 18. If, before the matter so referred shall be deter- Vacancy of mined, any arbitrator appointed by either party shall die arbitrator. or become incapable or refuse or for fourteen days neglect to act as arbitrator, the party by whom such arbitrator was appointed may nominate and appoint in 35 writing some other person to act in his place. And if, for the space of seven days after notice in writing from the other party for that purpose, he fail to do so, the remainder or other arbitrators may proceed alone; and every arbitrator so to be substituted as aforesaid shall 40 have the same powers and authorities as were vested in the former arbitrator at the time of such his death,

refusal, neglect, or disability as aforesaid.

19. Where more than one arbitrator shall have been Appointment appointed, such arbitrators shall, before they enter upon of umpire. the matters referred to them, nominate and appoint by writing under their hands an umpire to decide any 5 matters on which they shall differ or which shall be referred to them under the provisions of this Act. And if such umpire shall die or refuse or for seven days neglect to act after being called upon to do so by the arbitrators, they shall forthwith, after such death, 10 refusal, or neglect, appoint another umpire in his place, and the decision of every such umpire on the matters so referred to him shall be final.

20. If in either of the cases aforesaid the arbitrators Attorneyshall refuse or for seven days after request of either General to appoint 15 party to such arbitration, neglect to appoint an umpire, umpire on it shall be lawful for the Attorney-General, on the neglect. application of either party to such arbitration, to appoint an umpire, and the decision of such umpire on the matters on which the arbitrators shall differ or which 20 shall be referred to him under this Act shall be final.

21. If when a single arbitrator shall have been in case of appointed, such arbitrator shall die, or become incapable, death of single arbior shall refuse, or for fourteen days neglect to act before trator matter he shall have made his award, the matters referred to to begin de novo. 25 him shall be determined by arbitration under the provisions of this Act in the same manner as if such

arbitrator had not been appointed.

22. If where more than one arbitrator shall have If either been appointed, either of the arbitrators shall refuse, or arbitrator refuse to act 30 for seven days neglect to act, the other arbitrator may the other to proceed alone, and the decision of such other arbitrator proceed exparts. shall be effectual as if he had been the single arbitrator appointed by both parties.

23. If where more than one arbitrator shall have If arbitrators 35 been appointed, and where neither of them shall refuse fail to make their award or neglect to act as aforesaid, such arbitrators shall fail within to make their award within twenty-one days after the twenty-one days, the day on which the last of such arbitrators shall have matter to go been appointed, or within such extended time (if any) to the umpire.

And such declaration shall be annexed to the award Penalty of when made, and if any arbitrator or umpire having misconduct. made such declaration shall wilfully act contrary 20 thereto, he shall be guilty of a misdemeanour.

26. All the costs of any such arbitration and Costs of incident thereto to be settled by the arbitrators, shall arbitration, how to be be borne by the promoters, unless the arbitrators shall borne. award the same or a less sum than shall have been 25 offered by the promotors, in which case each party shall bear his own costs incidental to the arbitration, and the cost of the arbitrators shall be borne by the parties in equal proportions, unless the amount awarded shall be one-fourth less than the amount claimed, in which case 30 the whole costs shall be paid by the claimant: Provided that if either party shall be dissatisfied with the costs

(1) any accident attended with loss of life or personal injury to any person whomsoever;

(2) any collision where one of the trains is a passenger train;

(3) any passenger train or any part of a passenger train accidentally leaving the rails;

(4) any accident of a kind not comprised in the foregoing descriptions but which is of such a kind as to have caused, or be likely to cause, loss of life or personal injury, and which may be specified in that behalf by any order to be made from time to time by the Chief Commissioner for Railways and Tramways,

the promoters shall send notice of such accidents and 25 loss of life or personal injury (if any) occasioned thereby to the Chief Commissioner for Railways and Tramways. Such notice shall be in such form and shall contain such particulars as the Chief Commissioner for Railways and Tramways may from time to time direct, and shall be

30 sent by the earliest practicable post after the accident takes place. The Chief Commissioner for Railways and Tramways may from time to time by order direct that notice of any class of accidents shall be sent to him by telegraph, and may revoke any such order. While such

35 order is in force notice of every accident of the class to which the order relates shall be sent to the Chief Commissioner for Railways and Tramways by telegraph immediately after the accident takes place. Failure to comply with the provisions of this section shall render

It shall be lawful for the promoters at any time Power to by any deed or instrument in writing to assign and assign. transfer all the rights, powers, privileges, benefits, and advantages conferred upon them by this Act to any 5 person or persons or to any duly registered company, and upon any such transfer or assignment being signed or executed the person or persons or duly registered company in whose favour such transfer or assignment is made shall then stand in the place of the said promoters, 10 and shall have all the rights, powers, benefits, privileges, and advantages conferred upon the said promoters by this Act.

36. Nothing herein contained shall alter, repeal, or Public Works otherwise affect the Public Works Act of 1912, or the Railways Act of 15 Government Railways Act of 1912, or any Act amending or repealed. the same.

A BILL

To enable William Longworth and Thomas Longworth, of Sydney, in the State of New South Wales, to construct a railway from coal lands at Buttai, in the parish of Maitland, county of Northumberland, to the Great Northern Railway at Thornton, in the parish of Alnwick.

(As amended and agreed to in Select Committee.)

WHEREAS William Longworth and Thomas Preamble.
Longworth, both of Sydney, in the State of
New South Wales, are owners of coal mines upon the
lands situated at Buttai, in the parishes of Alnwick,
Maitland, and Stockrington, in the county of Northumberland, near Thornton, and in order to facilitate communication between the said coal mines and the Great

Northern Railway the said William Longworth and Thomas Longworth, hereinafter designated the promoters, are desirous of constructing a railway from their said coal mines to the Great Northern railway at or about the Thornton railway station; but as part of such 5 railway and sidings are intended to be made upon and pass through land believed to be the property of the Crown, bodies corporate, and private persons respectively, the same cannot be made without Legislative authority: And whereas the said coal mines are likely 10 to prove beneficial to the State, and the public are concerned in promoting such increase in and facilities for the supply of coal for local consumption, steam navigation, and export, as would result from the construction of the said proposed railway and sidings, and traffic on 15 the Great Northern railway would be increased thereby, it is therefore desirable to authorise by Legislative enactment the construction of the said railway and sidings, subject to the provisions hereinafter contained, upon payment of compensation to the several parties through 20 whose land the same shall pass for such portion of their respective lands as may require to be taken and occupied thereby: Be it therefore enacted by the King's most excellent Majesty, by and with the consent of the Legislative Council and Legislative Assembly of New 25 South Wales in Parliament assembled, and by the authority of the same as follows:-

Authority to construct railway and with Great Northern Railway.

1. It shall be lawful for the said promoters to make and construct a railway which shall be of the same gauge connect same as the Government Railways, namely, four feet eight 30 and a half inches, from a point commencing in the lands of the promoters bearing north-east ten chains from the south-west corner of portion twenty-five in the parish of Maitland, county of Northumberland, and bearing thence about north-east to a point about eight 35 chains south from the north-east corner of the said portion, thence through lands of John Farrell, the trustees of the will of the late Henry Osborne, the trustees or beneficiaries in the estate of the late William Fane de Salis, across the main northern road, Newcastle 40 to Maitland, lands of said trustees or beneficiaries of the late

late William Fane de Salis, and land of promoters, to a point on the Great Northern railway, connecting therewith at a point about fourteen miles north of Newcastle and adjacent to the Thornton railway station, and 5 which lands and route are particularly described in the Schedule hereto, such railway to be in the direction described in the Schedule, but so that the same shall not occupy at any part thereof a greater space in breadth than sixty-six feet, and to make and construct such loop

10 lines, stations, and sidings as may be necessary for the safe and convenient use of the railways to be constructed as aforesaid, and to take and use so much of the lands of private persons mentioned in the Schedule as the promoters may require for their said railway, loop lines,

15 stations, and sidings, but so that the same shall not occupy at any part thereof a greater space in breadth than sixty-six feet. The said railway shall be constructed in a proper and workmanlike manner, to the satisfaction of the Engineer in chief-fer Railway Con-

20 struction Director-General of Public Works and the Railway-Commissioners Chief Commissioner for Railways and Tramways.

2. The ground and soil of so much of the site of the railway and sidings as passes over or includes the lands 25 of the said owners of lands, together with such rights of ingress, egress, and regress upon the adjacent land as may be necessary for the making and repair of such railway shall, so far as is necessary for the purpose of this Act, be vested by virtue of this Act and without 30 the necessity of any conveyance in the promoters for the

purposes of the railway:

Provided that no lands vested in the Railway Commissioner Chief Commissioner for Railways and Tramways shall by virtue of this Act be vested in the 35 promoters, and nothing herein contained shall prevent the said owners from carrying on any mining operations beneath the said railway which shall not interfere with the safety of the said railway and the traffic thereon; and the promoters shall have no further rights to the soil of 40 the said lands beneath the surface than shall be requisite for the formation and repairs of the said road by cutting,

embanking, sinking wells, or otherwise:

Provided that the said railway shall be constructed and brought into use within five years after the passing of

this

this Act, and that in default thereof, or if after its completion the said railway shall cease to be used for three years continuously, all the said lands and all the said promoters' interest and estate therein shall revert without any conveyance to the original owners thereof, their heirs 5

and assigns respectively:

Provided also that if in the exercise of the powers hereby granted it be found necessary to cross-cut through, sink, raise, or use any part of any road so as to render it impassable for or dangerous or inconvenient to the 10 persons entitled to the use thereof, the promoters shall before the commencement of any such operations at their own expense cause a sufficient road to be made instead of any road interfered with, and shall at their own expense maintain such substituted road in a state as convenient as 15 the road interfered with, or as nearly as may be. And the promoters before they use the said lands of the owners of the land for the purposes aforesaid, shall, if required so to do, separate the same by a sufficient fence from the land adjoining thereto, with such gates as may be 20 required for the convenient occupation of such land, and shall also to all private roads used by them as aforesaid, put up fences and gates in like manner in all cases, where the same may be necessary, to prevent the straying of cattle from or upon the lands traversed by such 25 roads; and in case of any difference between owners or occupiers of such roads and lands and the promoters as to the necessity for such fences and gates, then the said promoters shall put up and erect such fences and gates as any two justices of the peace after inquiry shall deem 30 necessary for the purpose aforesaid on application being made to them.

Railways open to the public.

3. The railway shall be open to the public use for the conveyance of coal and goods upon payment of a toll to the promoters for the conveyance of coal of a sum 35 not exceeding one penny per ton per mile, with a minimum charge of threepence per ton in respect of every ton of coal for every transit, the person seeking transit supplying and loading his own trucks or on Government waggons, and the promoters or Govern-40 ment supplying locomotive power, and all trucks when emptied shall be conveyed on their return free of charge:

Provided

Provided always that it shall not be compulsory on the promoters to supply locomotive power unless the party seeking the transit guarantee and bring one hundred tons at least during the twelve working hours, 5 and give notice of same at least twenty-four hours previously. The railway shall at all times be open to the public for the conveyance of coal and goods upon payment of a toll to the promoters for the conveyance of coal of a sum not exceeding one halfpenny per ton per 10 mile, with a minimum charge of twopence per ton in respect of every ton of coal for every transit and for goods of a sum not exceeding one penny halfpenny per ton per mile in respect of every ton of goods for every transit, if the party seeking transit supply the locomotive 15 power as well as the trucks and waggons:

Provided that so long as the promoters shall be willing to supply locomotive power no other person shall use locomotive power on the line other than the Railway Commissioners Chief Commissioner for Railways and 20 Tramways:

Provided that if the railway shall be damaged by the parties who shall themselves use the railway for transit and supply locomotive power, the promoters shall be entitled to compensation for such damage, to be 25 recovered either by action in the Supreme Court of New South Wales, or, if such damage do not exceed the sum of twenty pounds summarily before two justices; and in estimating such damages the promoters shall be entitled not only to compensation for the cost of requential damage (if any) sustained by reason of the suspension of transit or otherwise.

4. It shall be lawful for the owners or occupiers of Branch the lands adjoining thereto or traversed by the said railways.

35 railway to lay down upon their own lands any collateral branches or railway to communicate with the said railway for the purpose of bringing carriages, trucks, and waggons to or from or upon the said railway, and the promoters shall, if required, at the expense of such 40 owners or occupiers, make openings in the rails and such

such additional lines of railway as may be necessary for effecting such communications in places where the communication can be made with safety to the public and without injury to the said railway and without inconvenience to the traffic thereupon, and the promoters 5 shall not take any rate, toll, or other moneys for the passing of any passengers, coal and goods, or other things along any branch so to be made by any such owner or occupier or other person. The promoters shall not be bound to make any such openings in any place 10 which they shall have set apart for any specific purpose with which such communication would interfere, nor upon any inclined plane or bridge nor in any tunnel. For the purposes and subject to the provisions hereinafter contained it shall be lawful for the promoters, their deputies, agents, servants, and workmen, 25 and all other persons by them authorised and empowered, to divert or alter the course of any road or way crossing the railway or to raise or sink any road or way in order the more conveniently to carry the same over or under or by the side of the railway:

Provided always that any such work shall be carried out to the satisfaction of the Tarro shire council, and all such diversions, alterations, and crossings, and the approaches thereto, shall hereafter be maintained and repaired by the promoters at their own expense, and to 35

the satisfaction of the said Tarro shire council.

Penalty for not substituting a road.

Provisions in cases where roads are crossed on a level.

10. If the railway cross any public highway or parish road on a level, the promoters shall erect or construct and at all times maintain to the satisfaction of the said Tarro shire council, cattle-stops or good and sufficient 40 gates across such railway on each side of the road where the

the same shall communicate therewith, and shall employ proper persons to open and shut such gates, and such gates shall be kept constantly closed across such railway on both sides of the road, except during the time when 5 engines or railway vehicles, passing along the same, shall have to cross such road, and such gates shall be of such dimensions and so constructed as when closed to fence in the road and prevent cattle or horses passing along the road from entering upon the railway, and the person 10 entrusted with the care of such gates shall cause the same to be closed as soon as such engines or railway vehicles shall have passed through the same, under a penalty not exceeding forty shillings for every default therein, to be recoverable before any two justices in a

15 summary way.

11. Provided also that such works shall be as little injurious to the said adjoining lands as the nature of the accident or apprehended accident will admit of, and 35 shall be executed with all possible despatch, and full compensation shall be made to the owners and occupiers of such lands for the loss or injury or inconvenience sustained by them respectively by reason of such works, the amount of which compensation in case of any 40 dispute about the same shall be settled by arbitration in the manner hereafter mentioned; and provided also

that

that no land shall be taken permanently for any such works otherwise than is herein provided with respect to the lands originally taken for the purpose of making the said railway.

Construction of bridges over roads.

12. Every bridge to be erected for the purpose of 5 carrying the railway over any road shall be built in conformity with the following regulations, that is to say:-

The width of the arch shall be such as to leave thereunder a clear space of not less than thirty 10 feet, if the arch be over a public highway, and of twenty feet if over a parish road, and of twelve feet if over a private road.

The clear height of the arch from the surface of the road shall not be less than sixteen feet for 15 space of twelve feet if the arch be over the main road, and fifteen feet for a space of ten feet if over a public carriage road; and in each of such cases the clear height at the springing of the arch shall not be less than twelve feet, 20 the clear height of the arch for a space of nine feet shall not be less than fourteen feet over a private road.

The descent made in the road in order to carry the same under the bridge shall not be more than one foot in 25 thirty feet if the bridge be over a public highway, one foot in twenty feet if over a parish road, and one foot in sixteen feet if over a private road, not being a tramroad or railroad; or if the same be a tramroad or railroad, the descent shall not be greater than the ruling 30

gradient of such tramroad or railroad:

Provided always that every such bridge shall be erected to the satisfaction of the Railway-Commissioners Chief Commissioner for Railways and Tramways and the Engineer in Chief for Railway Construction. Director- 35 General of Public Works.

Construction of bridges over railways

13. Every bridge erected for carrying any road over the railway shall be built in conformity with the fol-

lowing regulations, that is to say:—

There shall be a good and sufficient fence on each 49 side of the bridge of not less height than four feet and on each side of the immediate approaches of such bridge of not less than three feet. The

The road over the bridges shall have a clear space between the fences thereof of thirty-five feet if the road be a public highway, and twenty-five feet if a parish road, and twelve feet if a

private road.

The descent shall not be more than one foot in thirty feet if the road be a main road, one foot in twenty feet if a parish road, and one foot in sixteen feet if a private road, not being a tramroad or railroad, or if the same be a tramroad or railroad, the ascent shall not be greater than the ruling gradient of such tramroad or rail-

Provided always that every such bridge shall be 15 erected to the satisfaction of the said Tarro shire council and the said Engineer in Chief for Railway Construction Director-General of Public Works:

Provided also, that if at any time after the construction of the railway the average available width of any such road shall be increased beyond the width of 30 such bridge on either side thereof, the promoters shall be bound at their own expense to increase the width of the said bridge at such extent as they may be required by the said Tarro shire council, not exceeding the width of such road as so widened, or the maximum width 35 herein prescribed for a bridge in the like case over or under the railway:

Provided also that if the mean inclination of any road Existing within two hundred and fifty yards of the point of inclination of crossing the same, or the inclination of such portion of or diverted 40 any road as may be preserved to be altered, or for which need not be another road shall be substituted, shall be steeper than the inclination hereinbefore required to be preserved by

the promoters, then the promoters may carry any such road over or under the railway, or may construct such altered or substituted road at an inclination not steeper than the said mean inclination of the road so to be crossed, or of the road so requiring to be altered, or for which another road shall be substituted.

Works for benefit of owners. 14. The promoters shall make, and at all times thereafter maintain, the following works for the accommodation of the owners and occupiers of lands adjoining the railway, that is to say:—

Gates, bridges, &c. Such and so many convenient gates, bridges, arches, culverts, and passages over, under, or by the sides of or leading to, or from the railway, as shall be necessary for the purpose of making good any interruptions caused by the railway 15 to the use of the lands through which the railway shall be made. And such works shall be made forthwith after the part of the railway passing over such lands shall have been laid out or formed, or during the formation thereof. 20

Fences.

All sufficient posts, rails, hedges, ditches, mounds, or other fences for separating the land taken for the use of the railway from the adjoining lands not taken and protecting such lands from trespass, or the cattle of the owners or occupiers 25 thereof from straying thereon, by reason of the railway, together with all necessary gates made to open towards such adjoining lands, and not towards the railway. And all necessary stiles and such posts, rails, and other fences shall be 30 made forthwith after the taking of any such land, if the owners thereof shall so require, and the said other works as soon as conveniently may be.

Drains.

Also all necessary arches, tunnels, culverts, drains, or other passages, either over or under or by 35 the sides of the railway, of such dimensions as will be sufficient at all times to convey the water as clearly from the lands lying near or affected by the railway as before the making of the railway, or as nearly so as may be, and such 40 works shall be made from time to time as the railway work proceeds.

Also

Also proper watering places for cattle or compen-watering-sation in lieu thereof, where by reason of the places.

railway the cattle of any person occupying any lands lying near thereto shall be deprived of access to their former watering-places. And such watering-places shall be so made as to be at all times sufficiently supplied with water as theretofore, and as if the railway had not been made, or nearly so as may be. And the said promoters shall make all necessary watercourses and drains for the purpose of conveying water to the said watering-places:

Provided always that the promoters shall not be required to make such accommodation works in such 15 manner as would prevent or obstruct the working or using of the railway nor to make any accommodation works with respect to which the owners and occupiers of the land shall have agreed to receive, and shall have been paid compensation instead of the making of them.

20 **15.** If any person omit to shut and fasten any gate Penalty on set up either side of the railway for the accommodation persons of the owners or occupiers of the adjoining lands so soon fasten gates, as he and the carriage, cattle, or other animals under his care have passed through same, he shall forfeit for

25 every such offence a sum not exceeding *five* pounds, to be recoverable in a summary way before any two justices.

16. The promoters shall not be entitled to any Minerals not minerals under any land whereof the surface is vested in to pass.

30 them by virtue of this Act except only such parts thereof as shall be necessary to be dug or carried away in the construction of the works hereby authorised; and such mines shall not be deemed to vest in the said promoters.

If, within ninety days after the passing of this Appointment Act, the said persons through whose lands the railway of arbitrators, shall pass, or any of them, and the promoters shall not agree as to the amount of compensation to be paid by them for the said lands belonging to the said parties, 40 and any or them, or for any damage that may be sustained by them, or him, by reason of the execution of

the works, or if any other question as to compensation shall arise under this Act, the amount of such compensation shall be settled by arbitration in manner hereinafter mentioned, that is to say, unless both parties shall concur in the appointment of a single arbitrator, each 5 party on the request of the other party shall nominate and appoint an arbitrator to whom such dispute or other matter shall be referred, and every appointment of an arbitrator shall be under the hand of such party; and such appointment shall be delivered to the arbitrator or 10 arbitrators and shall be deemed a submission to arbitration on the part of the party by whom the same shall be made. And after any such appointment shall have been made neither party shall have power to revoke the same without the consent of the other, nor shall the 15 death of either party operate as a revocation. And if, for the space of fourteen days after any such dispute or other matter shall have arisen, and after a request in writing shall have been served by the one party on the other party to appoint an arbitrator, such last 20 mentioned party failed to appoint such arbitrator, then upon such failure it shall be lawful for the Attorney-General, on application of the party who has himself appointed an arbitrator, to appoint such arbitrator to act on behalf of both parties, and such 25 arbitrator may proceed to hear and determine the matters which shall be in dispute; and in such case the award or determination of such single arbitrator shall be final and conclusive.

Vacancy of arbitrator.

18. If, before the matter so referred shall be deter-30 mined, any arbitrator appointed by either party shall die or become incapable or refuse or for fourteen days neglect to act as arbitrator, the party by whom such arbitrator was appointed may nominate and appoint in writing some other person to act in his place. And if, 35 for the space of seven days after notice in writing from the other party for that purpose, he fail to do so, the remainder or other arbitrators may proceed alone; and every arbitrator so to be substituted as aforesaid shall have the same powers and authorities as were vested in 40 the former arbitrator at the time of such his death, refusal, neglect, or disability as aforesaid. 19.

Where more than one arbitrator shall have been Appointment appointed, such arbitrators shall, before they enter upon of umpire. the matters referred to them, nominate and appoint by writing under their hands an umpire to decide any 5 matters on which they shall differ or which shall be referred to them under the provisions of this Act. And if such umpire shall die or refuse or for seven days neglect to act after being called upon to do so by the arbitrators, they shall forthwith, after such death, 10 refusal, or neglect, appoint another umpire in his place, and the decision of every such umpire on the matters so referred to him shall be final.

23. If where more than one arbitrator shall have If arbitrators 35 been appointed, and where neither of them shall refuse fail to make their award or neglect to act as aforesaid, such arbitrators shall fail within to make their award within twenty-one days after the twenty-one days, the day on which the last of such arbitrators shall have matter to go been appointed, or within such extended time (if any) to the umpire.

40 as shall have been appointed for that purpose by both of such arbitrators under their hands, the matters referred to them shall be determined by the umpire to be so appointed as aforesaid.

Powers of arbitrators to call for books, &c.

24. The said arbitrators, or their umpire, may call for the productions of any documents in the possession or power of either party which he or they may think necessary for determining the question in dispute, and may examine the parties or their witnesses on oath, and 5 administer the oaths necessary for that purpose.

Arbitrator or umpire to make a declaration for faithful discharge of duty. **25.** Pefore any arbitrator or umpire shall enter into the consideration of any matters referred to him he shall, in the presence of a justice of the peace, make and subscribe the following declaration, that is to say:—

I do solemnly and sincerely declare that I will faithfully and honestly, and to the best of my skill and ability, hear and determine the matters referred to me under the provisions of the Ashtonfields Coal-mines Railway Act of 1915.

Made and subscribed in the presence of

Penalty of misconduct.

And such declaration shall be annexed to the award when made, and if any arbitrator or umpire having made such declaration shall wilfully act contrary thereto, he shall be guilty of a misdemeanour.

Costs of arbitration, how to be borne.

26. All the costs of any such arbitration and incident thereto to be settled by the arbitrators, shall be borne by the promoters, unless the arbitrators shall award the same or a less sum than shall have been offered by the promotors, in which case each party shall 25 bear his own costs incidental to the arbitration, and the cost of the arbitrators shall be borne by the parties in equal proportions, unless the amount awarded shall be one-fourth less than the amount, in which case the whole costs shall be paid by the claimant: Provided 30 that if either party shall be dissatisfied with the costs allowed by the arbitrators as aforesaid, the costs may be taxed by the Prothonotary or other proper officer of the Supreme Court, and the amount allowed by such officer shall be the amount of costs to be paid.

Awards to be delivered to the promoters.

27. The arbitrators shall deliver their award in writing to the promoters, who shall retain the same, and shall forthwith on demand at their own expense furnish a copy thereof to the other party, and shall at all times on demand produce the said award, and allow 40 the same to be inspected or examined by such party or

any

any person appointed by him for that purpose, and the amount awarded shall be paid within sixty days after the publication of such award.

In every case where the promoters shall take Compensatemporary possession of lands by virtue of the powers tion to be made for hereby granted, it shall be incumbent on them within temporary 25 one month after their entry upon such lands, upon being occupation. required to do so, to pay to the occupier of the said lands the value of any crop or dressing that may be thereon, as well as full compensation for any other damage of a temporary nature which he may sustain by reason of 30 their taking possession of such lands; and they shall

from time to time during their occupation of their said lands pay half yearly to such occupier or to the owners of the lands, as the case may require, a rent, to be fixed by two justices in case the parties differ, and shall also 35 within six months after the completion of the railway

Power for Government to purchase railway.

32. It shall be lawful for the Secretary for Public Works on behalf of the Government, at any time, by 5 notice in writing, to require the said promoters to sell, and thereupon the said promoters shall sell to the Government the said railway, upon the terms of paying the then value (exclusive of any allowance for compensation for compulsory sale) of the said railway and all 10 lands, buildings, works, materials, and plant of the said promoters suitable to and used by them for the purposes of the said railway; such value in case of difference to be ascertained by arbitration in the manner provided by the Lands for Public Purposes Acquisition Act Public 15 Works Act, 1912, for settling cases of disputed compensation and subject to the terms and conditions therein contained. And when any such sale shall have been made to the said Government, the said railway, lands, buildings, works, materials, plant, and premises shall 20 vest in the Railway Commissioners Chief Commissioner for Railways and Tramways, who shall have all the rights, powers, and authorities of the said promoters in respect of the said railway so sold:

Provided that the sum to be paid by way of purchase 25 shall in no case exceed the total cost of the construction of the railway and related works, land, and buildings.

33. For the purpose of regulating the conduct of the officers and servants or the promoters, and for providing for the due management of the affairs of the 30 promoters in all respects, it shall be lawful for the promoters, subject to the provisions herein mentioned, from time to time to make such by-laws and regulations

as they shall think fit:

Provided that such by-laws be not repugnant to the 35 laws of the state or to the provisions of this Act; and such by-laws shall be reduced into writing and shall have affixed thereto the names of the promoters, and a copy of such by-laws shall be given to every officer and servant of the promoters affected thereby, and such 40 by-laws may specify a maximum and a minimum penalty for any breach thereof, such penalty to be proceeded for and recovered under the provisions of the Provided Justices Act, 1902:

A BILL

To enable William Longworth and Thomas Longworth, of Sydney, in the State of New South Wales, to construct a railway from coal lands at Buttai, in the parish of Maitland, county of Northumberland, to the Great Northern Railway at Thornton, in the parish of Alnwick.

WHEREAS William Longworth and Thomas Preamble.
Longworth, both of Sydney, in the State of
New South Wales, are owners of coal mines upon the
lands situated at Buttai, in the parishes of Alnwick,
Maitland, and Stockrington, in the county of Northumberland, near Thornton, and in order to facilitate communication between the said coal mines and the Great
Northern

Northern Railway the said William Longworth and Thomas Longworth, hereinafter designated the promoters, are desirous of constructing a railway from their said coal mines to the Great Northern railway at or about the Thornton railway station; but as part of such 5 railway and sidings are intended to be made upon and pass through land believed to be the property of the Crown, bodies corporate, and private persons respectively, the same cannot be made without Legislative authority: And whereas the said coal mines are likely 10 to prove beneficial to the State, and the public are concerned in promoting such increase in and facilities for the supply of coal for local consumption, steam navigation, and export, as would result from the construction of the said proposed railway and sidings, and traffic on 15 the Great Northern railway would be increased thereby, it is therefore desirable to authorise by Legislative enactment the construction of the said railway and sidings, subject to the provisions hereinafter contained, upon payment of compensation to the several parties through 20 whose land the same shall pass for such portion of their respective lands as may require to be taken and occupied thereby: Be it therefore enacted by the King's most excellent Majesty, by and with the consent of the Legislative Council and Legislative Assembly of New 25 South Wales in Parliament assembled, and by the authority of the same as follows:-

Authority to construct Northern Railway.

1. It shall be lawful for the said promoters to make and construct a railway which shall be of the same gauge connect same as the Government Railways, namely, four feet eight 30 and a half inches, from a point commencing in the lands of the promoters bearing north-east ten chains from the south-west corner of portion twenty-five in the parish of Maitland, county of Northumberland, and bearing thence about north-east to a point about eight 35 chains south from the north-east corner of the said portion, thence through lands of John Farrell, the trustees of the will of the late Henry Osborne, the trustees or beneficiaries in the estate of the late William Fane de Salis, across the main northern road, Newcastle 40 to Maitland, lands of said trustees or beneficiaries of the

late William Fane de Salis, and land of promoters, to a point on the Great Northern railway, connecting therewith at a point about fourteen miles north of Newcastle and adjacent to the Thornton railway station, and 5 which lands and route are particularly described in the Schedule hereto, such railway to be in the direction described in the Schedule, but so that the same shall not occupy at any part thereof a greater space in breadth than sixty-six feet, and to make and construct such loop

10 lines, stations, and sidings as may be necessary for the safe and convenient use of the railways to be constructed as aforesaid, and to take and use so much of the lands of private persons mentioned in the Schedule as the promoters may require for their said railway, loop lines,

15 stations, and sidings, but so that the same shall not occupy at any part thereof a greater space in breadth than sixty-six feet. The said railway shall be constructed in a proper and workmanlike manner, to the satisfaction of the Engineer-in-chief for Railway Con-20 struction and the Railway Commissioners.

2. The ground and soil of so much of the site of the railway and sidings as passes over or includes the lands of the said owners of lands, together with such rights of ingress, egress, and regress upon the adjacent land as

25 may be necessary for the making and repair of such railway shall, so far as is necessary for the purpose of this Act, be vested by virtue of this Act and without the necessity of any conveyance in the promoters for the purposes of the railway:

Provided that no lands vested in the Railway Commissioner shall by virtue of this Act be vested in the promoters, and nothing herein contained shall prevent the said owners from carrying on any mining operations beneath the said railway which shall not interfere with

35 the safety of the said railway and the traffic thereon; and the promoters shall have no further rights to the soil of the said lands beneath the surface than shall be requisite for the formation and repairs of the said road by cutting, embanking, sinking wells, or otherwise:

40 Provided that the said railway shall be constructed and brought into use within five years after the passing of

this

this Act, and that in default thereof, or if after its completion the said railway shall cease to be used for three years continuously, all the said lands and all the said promoters' interest and estate therein shall revert without any conveyance to the original owners thereof, their heirs 5

and assigns respectively:

Provided also that if in the exercise of the powers hereby granted it be found necessary to cross-cut through, sink, raise, or use any part of any road so as to render it impassable for or dangerous or inconvenient to the 10 persons entitled to the use thereof, the promoters shall before the commencement of any such operations at their own expense cause a sufficient road to be made instead of any road interfered with, and shall at their own expense maintain such substituted road in a state as convenient as 15 the road interfered with, or as nearly as may be. And the promoters before they use the said lands of the owners of the land for the purposes aforesaid, shall, if required so to do, separate the same by a sufficient fence from the land adjoining thereto, with such gates as may be 20 required for the convenient occupation of such land, and shall also to all private roads used by them as aforesaid, put up fences and gates in like manner in all cases, where the same may be necessary, to prevent the straying of cattle from or upon the lands traversed by such 25 roads; and in case of any difference between owners or occupiers of such roads and lands and the promoters as to the necessity for such fences and gates, then the said promoters shall put up and erect such fences and gates as any two justices of the peace after inquiry shall deem 30 necessary for the purpose aforesaid on application being made to them.

Railways open to the public.

3. The railway shall be open to the public use for the conveyance of coal and goods upon payment of a toll to the promoters for the conveyance of coal of a sum 35 not exceeding one penny per ton per mile, with a minimum charge of threepence per ton in respect of every ton of coal for every transit, the person seeking transit supplying and loading his own trucks or on Government waggons, and the promoters or Govern-40 ment supplying locomotive power, and all trucks when emptied shall be conveyed on their return free of charge:

Provided

Provided always that it shall not be compulsory on the promoters to supply locomotive power unless the party seeking the transit guarantee and bring one hundred tons at least during the twelve working hours, 5 and give notice of same at least twenty-four hours previously. The railway shall at all times be open to the public for the conveyance of coal and goods upon payment of a toll to the promoters for the conveyance of coal of a sum not exceeding one halfpenny per ton per 10 mile, with a minimum charge of twopence per ton in respect of every ton of coal for every transit and for goods of a sum not exceeding one penny halfpenny per ton per mile in respect of every ton of goods for every transit, if the party seeking transit supply the locomotive

Provided that so long as the promoters shall be willing to supply locomotive power no other person shall use locomotive power on the line other than the Railway Commissioners:

15 power as well as the trucks and waggons:

20 Provided that if the railway shall be damaged by the parties who shall themselves use the railway for transit and supply locomotive power, the promoters shall be entitled to compensation for such damage, to be recovered either by action in the Supreme Court of New 25 South Wales or if such damage do not exceed the sum

25 South Wales, or, if such damage do not exceed the sum of twenty pounds summarily before two justices; and in estimating such damages the promoters shall be entitled not only to compensation for the cost of repairing and restoring the railway, but to the conse-30 quential damage (if any) sustained by reason of the

suspension of transit or otherwise.

4. It shall be lawful for the owners or occupiers of Branch the lands adjoining thereto or traversed by the said railways. railway to lay down upon their own lands any collateral 35 branches or railway to communicate with the said railway for the purpose of bringing carriages, trucks, and waggons to or from or upon the said railway, and the promoters shall, if required, at the expense of such owners or occupiers, make openings in the rails and such

such additional lines of railway as may be necessary for effecting such communications in places where the communication can be made with safety to the public and without injury to the said railway and without inconvenience to the traffic thereupon, and the promoters 5 shall not take any rate, toll, or other moneys for the passing of any passengers, coal and goods, or other things along any branch so to be made by any such owner or occupier or other person. The promoters shall not be bound to make any such openings in any place 10 which they shall have set apart for any specific purpose with which such communication would interfere, nor upon any inclined plane or bridge nor in any tunnel. The persons making or using such branch railways shall be subject to all by-laws and regulations of the promoters 15 from time to time made with respect to passing upon or crossing the railway and otherwise; and the persons making or using such branch railways shall be bound to construct and from time to time as need may require to renew the off-set plates and switches according to the 20 most approved plan adopted by the promoters under the direction of their engineer.

Power to divert and alter the roads.

5. For the purposes and subject to the provisions hereinafter contained it shall be lawful for the promoters, their deputies, agents, servants, and workmen, 25 and all other persons by them authorised and empowered, to divert or alter the course of any road or way crossing the railway or to raise or sink any road or way in order the more conveniently to carry the same over or under or by the side of the railway: 30

Provided always that any such work shall be carried out to the satisfaction of the Tarro shire council, and all such diversions, alterations, and crossings, and the approaches thereto, shall hereafter be maintained and repaired by the promoters at their own expense, and to £5

the satisfaction of the said Tarro shire council.

Penalty for

6. If the promoters do not cause another sufficient not substituting a road. road to be so made before they interfere with any such existing road as aforesaid, or if they fail to maintain all such diversions, alterations, crossings, and the 40 approaches thereto, they shall forfeit twenty pounds for

every

every day during which such substituted road shall not be made after the existing road shall have been interrupted, or during which such diversions, alterations, crossings, or approaches shall remain in a state of disrepair, and 5 such penalty shall be paid to the said Tarro shire council, if a public road, and shall be applied for the purposes thereof, or, in case of a private road, the same shall be paid to the owner thereof; and every such penalty shall be recoverable, with costs, by action in any court of 10 competent jurisdiction.

7. It shall be lawful for and, at the request of the Rightto carry Railway Commissioners, compulsory upon the said passengers.

promoters, from time to time, and at all reasonable times, to carry passengers, goods, and live stock, upon 15 the said railway, or any part thereof respectively, and to make, demand, take, receive, and recover such tolls or dues for carrying the same at such rate per mile, or other scale of charges, as shall be established from time to time by the promoters for or in respect of all 20 such passengers, goods, and live stock, which shall be conveyed or transported upon such railway, or any part

thereof respectively: And the promoters are hereby authorised to make such by-laws and regulations not inconsistent with this Act, and subject to the proposals 25 of the Railway Commissioners, as may be necessary for

the regulation of such traffic, and such by-laws or regulations shall be binding upon all persons using or travelling upon the said railway; and any persons offending against such by-laws or regulations shall be

30 liable to a fine not exceeding ten pounds for each offence, to be recoverable in a summary way before any two justices:

Provided always that if the rates, tolls, or dues that may be established as aforesaid, under and by virtue of 35 this Act, shall be found excessive, it shall and may be lawful for the Executive Council, on the petition of any person, to reduce the said rates, tolls, or dues, and to revise them in such a manner as may seem most proper and advisable.

40 8. If in the course of making the railway the Road repairs. promoters shall use or interfere with any road, they shall

shall, from time to time, make good all damage done by them to such roads to the satisfaction of the said Tarro shire council; and if any question shall arise as to the damage done to any such road by the promoters or as to the repair thereof by them, such questions shall be referred to the determination of two justices, and such justices may direct such repairs to be made in the state of the roads in respect of damage done by the promoters, and within such period as they may think reasonable, and may impose on the promoters for not carrying into 10 effect such repairs, any penalty, not exceeding ten pounds per day, as to such justices shall seem fit, and any such penalty shall be paid to the said Tarro shire council, if a public road, and be applied for the purposes of such road, or if a private road the same shall be paid to the 15 owner thereof.

Owner's crossing.

9. Until the promoters shall have made the bridges or other proper communications, which they shall, under the provisions herein contained, have been required to make between lands intersected and the railway, and no 20 longer, the owners and occupiers of such lands, and any other person whose right of way shall be affected by the want of such communications and their respective servants, may at all times freely pass and repass with carriages, horses, and other animals directly, but not 25 otherwise, across any part of the railway made in or through their respective lands solely for the purpose of occupying the same lands or for the exercise of such right of way and so as not to obstruct the passage along the railway or to damage the same. Nevertheless, if 30 the owner or occupier of any such lands have in his arrangement with the promoters received or agreed to receive compensenation for or on account of any such communications, instead of the same being formed, such owner, occupier, or those claiming under him shall 35 not be entitled so to cross the railway.

Provisions in cases where roads are crossed on a level. 10. If the railway cross any public highway or parish road on a level, the promoters shall erect or construct and at all times maintain to the satisfaction of the said Tarro shire council, cattle-steps or good and sufficient 40 gates across such railway on each side of the road where

the

the same shall communicate therewith, and shall employ proper persons to open and shut such gates, and such gates shall be kept constantly closed across such railway on both sides of the road, except during the time when 5 engines or railway vehicles, passing along the same, shall have to cross such road, and such gates shall be of such dimensions and so constructed as when closed to fence in the road and prevent cattle or horses passing along the road from entering upon the railway, and the person 10 entrusted with the care of such gates shall cause the same to be closed as soon as such engines or railway vehicles shall have passed through the same, under a penalty not exceeding forty shillings for every default therein, to be recoverable before any two justices in a

15 summary way.

11. In case of accidents or slips happening or being Power to apprehended to the cuttings, embankments, or other enter upon works of the said reilly it shall be level for the works of the said railway it shall be lawful for the lands to promoters and their workmen and servants to enter upon repair acci-20 the land adjoining thereto at any time whatsoever for to certain

the purpose of repairing or preventing such accidents, restrictions. and to do such works as may be necessary for the purpose, but in every such case the promoters shall within forty-eight hours of such entry make a report to

25 the Secretary for Public Works specifying the nature of such accident or apprehended accident, and of the works necessary to be done, and such powers shall cease and determine if the said Secretary shall after considering the said report certifying that their exercise is not

30 necessary for the public safety or for the repair and

maintenance of the said line:

Provided also that such works shall be as little injurious to the said adjoining lands as the nature of the accident or apprehended accident will admit of, and 35 shall be executed with all possible despatch, and full compensation shall be made to the owners and occupiers of such lands for the loss or injury or inconvenience sustained by them respectively by reason of such works, the amount of which compensation in case of any 40 dispute about the same shall be settled by arbitration in

the manner hereafter mentioned; and provided also that

that no land shall be taken permanently for any such works otherwise than is herein provided with respect to the lands originally taken for the purpose of making the said railway.

Construction of bridges over roads.

Construction of bridges

over railways.

12. Every bridge to be erected for the purpose of 5 carrying the railway over any road shall be built in conformity with the following regulations, that is to say:—

The width of the arch shall be such as to leave thereunder a clear space of not less than thirty 10 feet, if the arch be over a public highway, and of twenty feet if over a parish road, and of twelve feet if over a private road.

The clear height of the arch from the surface of the road shall not be less than sixteen feet for 15 space of twelve feet if the arch be over the main road, and fifteen feet for a space of ten feet if over a public carriage road; and in each of such cases the clear height at the springing of the arch shall not be less than twelve feet, 20 the clear height of the arch for a space of nine feet shall not be less than fourteen feet over a private road.

The descent made in the road in order to carry the same under the bridge shall not be more than one foot in 25 thirty feet if the bridge be over a public highway, one foot in twenty feet if over a parish road, and one foot in sixteen feet if over a private road, not being a tramroad or railroad; or if the same be a tramroad or railroad, the descent shall not be greater than the ruling 30 gradient of such tramroad or railroad:

gradient of such tramroad or railroad:

Provided always that every such bridge shall be erected to the satisfaction of the Railway Commissioners and the Engineer-in-Chief for Railway Construction.

13. Every bridge erected for carrying any road over 35 the railway shall be built in conformity with the following regulations, that is to say:—

There shall be a good and sufficient fence on each side of the bridge of not less height than four feet and on each side of the immediate ap-40 proaches of such bridge of not less than three feet.

The

The road over the bridges shall have a clear space between the fences thereof of thirty-five feet if the road be a public highway, and twenty-five feet if a parish road, and twelve feet if a

private road. 5

The descent shall not be more than one foot in thirty feet if the road be a main road, one foot in twenty feet if a parish road, and one foot in sixteen feet if a private road, not being a tram-10 road or railroad, or if the same be a tramroad or railroad, the ascent shall not be greater than the ruling gradient of such tramroad or rail-

Provided always that every such bridge shall be 15 erected to the satisfaction of the said Tarro shire council and the said Engineer-in-Chief for Railway Construction:

Provided always that in all cases where the average The width of available width for the passing of carriages of any the bridges need not existing road within fifty yards of the point of crossing exceed the 20 the same is less than the width hereinbefore prescribed width of the for bridges over or under the railway, the width of such certain cases. bridges need not be greater than such average available width of such roads but so, nevertheless, that such be not of less width in case of a public highway or parish 25 road than twenty feet:

Provided also, that if at any time after the construction of the railway the average available width of any such road shall be increased beyond the width of such bridge on either side thereof, the promoters shall 30 be bound at their own expense to increase the width of

the said bridge at such extent as they may be required by the said Tarro shire council, not exceeding the width of such road as so widened, or the maximum width herein prescribed for a bridge in the like case over or

35 under the railway:

Provided also that if the mean inclination of any road Existing within two hundred and fifty yards of the point of roads crossed crossing the same, or the inclination of such portion of or diverted any road as may be preserved to be altered, or for which improved. 40 another road shall be substituted, shall be steeper than

the inclination hereinbefore required to be preserved by

the

the promoters, then the promoters may carry any such road over or under the railway, or may construct such altered or substituted road at an inclination not steeper than the said mean inclination of the road so to be crossed, or of the road so requiring to be altered, or for 5 which another road shall be substituted.

Works for benefit of owners. 14. The promoters shall make, and at all times thereafter maintain, the following works for the accommodation of the owners and occupiers of lands adjoining the railway, that is to say:—

Gates, bridges, &c. Such and so many convenient gates, bridges, arches, culverts, and passages over, under, or by the sides of or leading to, or from the railway, as shall be necessary for the purpose of making good any interruptions caused by the railway 15 to the use of the lands through which the railway shall be made. And such works shall be made forthwith after the part of the railway passing over such lands shall have been laid out or formed, or during the formation thereof. 20

Fences.

All sufficient posts, rails, hedges, ditches, mounds, or other fences for separating the land taken for the use of the railway from the adjoining lands not taken and protecting such lands from trespass, or the cattle of the owners or occupiers 25 thereof from straying thereon, by reason of the railway, together with all necessary gates made to open towards such adjoining lands, and not towards the railway. And all necessary stiles and such posts, rails, and other fences shall be 30 made forthwith after the taking of any such land, if the owners thereof shall so require, and the said other works as soon as conveniently may be.

Drains.

Also all necessary arches, tunnels, culverts, drains, or other passages, either over or under or by 35 the sides of the railway, of such dimensions as will be sufficient at all times to convey the water as clearly from the lands lying near or affected by the railway as before the making of the railway, or as nearly so as may be, and such 40 works shall be made from time to time as the railway work proceeds.

Also

Also proper watering places for cattle or compen-watering-sation in lieu thereof, where by reason of the places.

railway the cattle of any person occupying any lands lying near thereto shall be deprived of access to their former watering-places. And such watering-places shall be so made as to be at all times sufficiently supplied with water as theretofore, and as if the railway had not been made, or nearly so as may be. And the said promoters shall make all necessary watercourses and drains for the purpose of conveying water to the said watering-places:

Provided always that the promoters shall not be required to make such accommodation works in such 15 manner as would prevent or obstruct the working or using of the railway nor to make any accommodation works with respect to which the owners and occupiers of the land shall have agreed to receive, and shall have been paid compensation instead of the making of them.

20 **15.** If any person omit to shut and fasten any gate Penalty on set up either side of the railway for the accommodation persons of the owners or occupiers of the adjoining lands so soon fasten gates. as he and the carriage, cattle, or other animals under his care have passed through same, he shall forfeit for every such offence a sum not exceeding *five* pounds, to be recoverable in a summary way before any two

16. The promoters shall not be entitled to any Minerals not minerals under any land whereof the surface is vested in to pass.

30 them by virtue of this Act except only such parts thereof as shall be necessary to be dug or carried away in the construction of the works hereby authorised; and such mines shall not be deemed to vest in the said promoters.

17. If, within ninety days after the passing of this Appointment Act, the said persons through whose lands the railway of arbitrators. shall pass, or any of them, and the promoters shall not agree as to the amount of compensation to be paid by them for the said lands belonging to the said parties, 40 and any or them, or for any damage that may be sustained by them, or him, by reason of the execution of

he

the works, or if any other question as to compensation shall arise under this Act, the amount of such compensation shall be settled by arbitration in manner hereinafter mentioned, that is to say, unless both parties shall concur in the appointment of a single arbitrator, each 5 party on the request of the other party shall nominate and appoint an arbitrator to whom such dispute or other matter shall be referred, and every appointment of an arbitrator shall be under the hand of such party; and such appointment shall be delivered to the arbitrator or 10 arbitrators and shall be deemed a submission to arbitration on the part of the party by whom the same shall be made. And after any such appointment shall have been made neither party shall have power to revoke the same without the consent of the other, nor shall the 15 death of either party operate as a revocation. And if, for the space of fourteen days after any such dispute or other matter shall have arisen, and after a request in writing shall have been served by the one party on the other party to appoint an arbitrator, such last 20 mentioned party failed to appoint such arbitrator, then upon such failure it shall be lawful for the Attorney-General, on application of the party who has himself appointed an arbitrator, to appoint such arbitrator to act on behalf of both parties, and such 25 arbitrator may proceed to hear and determine the matters which shall be in dispute; and in such case the award or determination of such single arbitrator shall be final and conclusive.

Vacancy of arbitrator.

18. If, before the matter so referred shall be deter-30 mined, any arbitrator appointed by either party shall die or become incapable or refuse or for fourteen days neglect to act as arbitrator, the party by whom such arbitrator was appointed may nominate and appoint in writing some other person to act in his place. And if, 35 for the space of seven days after notice in writing from the other party for that purpose, he fail to do so, the remainder or other arbitrators may proceed alone; and every arbitrator so to be substituted as aforesaid shall have the same powers and authorities as were vested in 40 the former arbitrator at the time of such his death, refusal, neglect, or disability as aforesaid.

19. Where more than one arbitrator shall have been appointment appointed, such arbitrators shall, before they enter upon of ampire. the matters referred to them, nominate and appoint by writing under their hands an umpire to decide any 5 matters on which they shall differ or which shall be referred to them under the provisions of this Act. if such umpire shall die or refuse or for seven days neglect to act after being called upon to do so by the arbitrators, they shall forthwith, after such death, 10 refusal, or neglect, appoint another umpire in his place, and the decision of every such umpire on the matters so

referred to him shall be final.

20. If in either of the cases aforesaid the arbitrators Attorneyshall refuse or for seven days after request of either General to appoint 15 party to such arbitration, neglect to appoint an umpire, umpire on it shall be lawful for the Attorney-General, on the neglect. application of either party to such arbitration, to appoint an umpire, and the decision of such umpire on the matters on which the arbitrators shall differ or which 20 shall be referred to him under this Act shall be final.

21. If when a single arbitrator shall have been In case of appointed, such arbitrator shall die, or become incapable, death of single arbior shall refuse, or for fourteen days neglect to act before trator matter he shall have made his award, the matters referred to begin de novo.

arbitrator had not been appointed.

22. If where more than one arbitrator shall have if either been appointed, either of the arbitrators shall refuse, or arbitrator refuse to act 30 for seven days neglect to act, the other arbitrator may the other to proceed alone, and the decision of such other arbitrator proceed exparte. shall be effectual as if he had been the single arbitrator appointed by both parties.

23. If where more than one arbitrator shall have If arbitrators 35 been appointed, and where neither of them shall refuse fail to make their award or neglect to act as aforesaid, such arbitrators shall fail within to make their award within twenty-one days after the twenty-one days, the day on which the last of such arbitrators shall have matter to go been appointed, or within such extended time (if any) to the umpire.

40 as shall have been appointed for that purpose by both of such arbitrators under their hands, the matters referred to them shall be determined by the umpire to be so appointed as aforesaid. 24.

Powers of books, &c.

24. The said arbitrators, or their umpire, may call arbitrators to for the productions of any documents in the possession or power of either party which he or they may think necessary for determining the question in dispute, and may examine the parties or their witnesses on oath, and 5 administer the oaths necessary for that purpose.

Arbitrator or umpire to make a declaration for faithful discharge of duty.

25. Before any arbitrator or umpire shall enter into the consideration of any matters referred to him he shall, in the presence of a justice of the peace, make and subscribe the following declaration, that is to say:—

I do solemnly and sincerely declare that I will faithfully and honestly, and to the best of my skill and ability, hear and determine the matters referred to me under the provisions of the Ashtonfields Coal-mines Railway Act of 1915. 15

Made and subscribed in the presence of

Penalty of misconduct.

And such declaration shall be annexed to the award when made, and if any arbitrator or umpire having made such declaration shall wilfully act contrary thereto, he shall be guilty of a misdemeanour. 20

Costs of arbitration, how to be borne.

26. All the costs of any such arbitration and incident thereto to be settled by the arbitrators, shall be borne by the promoters, unless the arbitrators shall award the same or a less sum than shall have been offered by the promotors, in which case each party shall 25 bear his own costs incidental to the arbitration, and the cost of the arbitrators shall be borne by the parties in equal proportions, unless the amount awarded shall be one-fourth less than the amount, in which case the whole costs shall be paid by the claimant: Provided 30 that if either party shall be dissatisfied with the costs allowed by the arbitrators as aforesaid, the costs may be taxed by the Prothonotary or other proper officer of the Supreme Court, and the amount allowed by such officer shall be the amount of costs to be paid.

Awards to be delivered to the promoters.

27. The arbitrators shall deliver their award in writing to the promoters, who shall retain the same, and shall forthwith on demand at their own expense furnish a copy thereof to the other party, and shall at all times on demand produce the said award, and allow 40 the same to be inspected or examined by such party or

any person appointed by him for that purpose, and the amount awarded shall be paid within sixty days after the publication of such award.

- 28. The submission to any such arbitration may be Submission 5 made a rule of the Supreme Court on application of may be made either of the parties.
- 29. No award made with respect to any question Award not referred to arbitration under the provisions of this Act void through shall be set aside for irregularity or error in matter of 10 form.
- 30. The promotors shall make compensation and Compensatisfaction to the said owners and occupiers (the sation for temporary or amount of such compensation and satisfaction to be permanent or ascertained and recovered in case of difference in the recurring 15 manner hereby provided) for temporary, permanent, or recurring injury, and all other damage, loss, costs, charges, and inconveniences which may in anywise be occasioned to the said owners or occupiers by the nonperformance by the said promoters of any of the matters 20 and things hereby required to be performed by them or otherwise.
- 31. In every case where the promoters shall take Compensatemporary possession of lands by virtue of the powers made for hereby granted, it shall be incumbent on them within temporary 25 one month after their entry upon such lands, upon being occupation. required to do so, to pay to the occupier of the said lands the value of any crop or dressing that may be thereon, as well as full compensation for any other damage of a temporary nature which he may sustain by reason of 30 their taking possession of such lands; and they shall from time to time during their occupation of their said lands pay half yearly to such occupier or to the owners of the lands, as the case may require, a rent, to be fixed by two justices in case the parties differ, and shall also 35 within six months after the completion of the railway pay to such owner or occupier, or deposit in a bank for the benefit of all parties interested, as the case may require, compensation for all permanent or other loss, damage, or injury that may have been sustained by them 40 by reason of the exercise as regards the said lands of the

powers hereby granted, including the full value of all clay, stone, gravel, sand, and other things taken from such lands.

Power for Government to purchase railway.

32. It shall be lawful for the Secretary for Public Works on behalf of the Government, at any time, by 5 notice in writing, to require the said promoters to sell, and thereupon the said promoters shall sell to the Government the said railway, upon the terms of paying the then value (exclusive of any allowance for compensation for compulsory sale) of the said railway and all 10 lands, buildings, works, materials, and plant of the said promoters suitable to and used by them for the purposes of the said railway; such value in case of difference to be ascertained by arbitration in the manner provided by the Lands for Public Purposes Acquisition Act for 15settling cases of disputed compensation and subject to the terms and conditions therein contained. And when any such sale shall have been made to the said Government, the said railway, lands, buildings, works, materials, plant, and premises shall vest in the Railway Com- 20, missioners, who shall have all the rights, powers, and authorities of the said promoters in respect of the said railway so sold:

Provided that the sum to be paid by way of purchase shall in no case exceed the total cost of the construction 25, of the railway and related works, land, and buildings.

Promoters may make by-laws. 33. For the purpose of regulating the conduct of the officers and servants or the promoters, and for providing for the due management of the affairs of the promoters in all respects, it shall be lawful for the 30 promoters, subject to the provisions herein mentioned, from time to time to make such by-laws and regulations as they shall think fit:

Provided that such by-laws be not repugnant to the laws of the state or to the provisions of this Act; and 35 such by-laws shall be reduced into writing and shall have affixed thereto the names of the promoters, and a copy of such by-laws shall be given to every officer and servant of the promoters affected thereby, and such by-laws may specify a maximum and a minimum 40 penalty

penalty for any breach thereof, such penalty to be proceeded for and recovered under the provisions of the Justices Act, 1902:

Provided always that any by-laws of the said 5 promoters relating to penalties must be first approved by the Executive Council, and published in the Government Gazette; and the productions of the Gazette containing such by-laws of the promoters shall be sufficient evidence of such by-laws in all proceedings 10 under the same.

34. The Railway Commissioners may from time to Railway Com. time appoint any person to be inspector for the purpose missioners may appoint of inspecting the railway, and of making any inquiry inspectors. with respect to the condition of works or into the cause 15 of any accident:

Provided that no person so appointed shall exercise any powers of interference in the affairs of the promoters, and every inspector under this Act shall, for the purpose of any inspection or inquiry which he is 20 directed by the Railway Commissioners to make or conduct, have the following powers, that is to say:—

(1) He may enter and inspect the railway and all stations, works, buildings, offices, stock, plant, and machinery belonging thereto.

25 (2) He may by summons under his hand require the attendance of any person who is engaged in the management, service, or employment of the promoters, and whom he thinks fit to call before him and examine for the said purpose, 30 and may require answers or returns to such inquiries for the said purpose as he thinks fit to make.

(3) He may require and enforce the production of all books, papers, and documents of the promoters which he considers important for the said purpose.

(4) If after any such inspection the Railway Commissioners deem the railway to be unsafe for the carriage of passengers, they may by notice in writing require the promoters to desist from

carrying

carrying passengers until any repairs or alterations mentioned in the notice are effected, and thereupon and until the requirements of such notice have been complied with, it shall not be lawful for the promoters to carry any passengers upon the said railway.

Accidents.

Where in or about the railway or any of the works or buildings connected with such railway or any buildings connected with such railway or any buildings or place, whether open or enclosed, occupied by the promoters, 10 any of the following accidents takes place in the course of working, that is to say,—

(1) any accident attended with loss of life or personal injury to any person whomsoever;

(2) any collision where one of the trains is a 15 passenger train;

(3) any passenger train or any part of a passenger train accidentally leaving the rails;

(4) any accident of a kind not comprised in the foregoing descriptions but which is of such a 20 kind as to have caused, or be likely to cause, loss of life or personal injury, and which may be specified in that behalf by any order to be made from time to time by the Railway Commissioners,

the promoters shall send notice of such accidents and loss of life or personal injury (if any) occasioned thereby to the Railway Commissioners. Such notice shall be in such form and shall contain such particulars as the Railway Commissioners may from time to time direct, 30 and shall be sent by the earliest practicable post after the accident takes place. The Railway Commissioners may from time to time by order direct that notice of any class of accidents shall be sent to them by telegraph, and may revoke any such order. While such order is 35 in force notice of every accident of the class to which the order relates shall be sent to the Railway Commissioners by telegraph immediately after the accident takes place. Failure to comply with the provisions of this section shall render the promoters liable for each offence 40 to a penalty not exceeding twenty pounds.

It shall be lawful for the promoters at any time Power to by any deed or instrument in writing to assign and assign. transfer all the rights, powers, privileges, benefits, and advantages conferred upon them by this Act to any 5 person or persons or to any duly registered company, and upon any such transfer or assignment being signed or executed the person or persons or duly registered company in whose favour such transfer or assignment is made shall then stand in the place of the said promoters, 10 and shall have all the rights, powers, benefits, privileges, and advantages conferred upon the said promoters by

41. This Act whenever cited shall be sufficiently described as "The Ashtonfields Coal-mines Railway 10 Act of 1915."
