- *7362 WEST CAMPSIE BYPASS—Ms Sophie Cotsis asked the Minister for Roads, Maritime and Freight—
 - (1) When is the expected start date of construction of the West Campsie Bypass that is proposed as part of the Sydenham to Bankstown Corridor Strategy?
 - (2) When is the expected conclusion date of construction?
 - (3) What is the projected total cost of the construction of the West Campsie Bypass?
 - (4) What is the projected cost of the construction of a new road coming off of Second Ave and running parallel with the Cooks River in the direction of Rudd Path?
 - (a) What will this new road connect to?
 - (5) What is the projected cost of the construction of a new road connecting Loch Street and Urissa Street?
 - (6) Which community groups were consulted with before the adoption of the Campsie Bypass policy?
 - (7) How will the Campsie Bypass affect public transport routes?
 - (8) Will bus stops be paced on the new streets proposed in the Sydenham to Bankstown Urban Renewal Corridor Map?
 - (9) In what ways will the Campsie Bypass lessen congestion on Canterbury Road?
 - (10) Will the section of the bypass that overlaps with a cycling route include a separate bike lane?
 - (11) What is the current traffic flow through the West Campsie Bypass?
 - (12) What is the projected traffic flow through the West Campsie Bypass in 2019?

Answer-

I am advised:

The West Campsie Bypass has been identified as a potential initiative for implementation by Local Government as part of work undertaken for the Department of Planning and Environment's Sydenham to Bankstown Urban Renewal Strategy.

Transport for NSW has not been engaged by Canterbury-Bankstown Council to prepare designs or cost estimates for the bypass.

- *7378 CHANGES TO STANDARD NON-PAROLE PERIOD SCHEME—Ms Jenny Aitchison asked the Attorney General—
 - (1) How many changes have been made to Standard Non-Parole Period scheme for child sexual assault offences since 2015 (as at 7 February 2018)?
 - (a) For each change, what was introduced or amended?

Answer-

I am advised:

On 29 June 2015 the Crimes Legislation Amendment (Child Sex Offences) Act 2015 amended the table to Division 1 A of Part 4 of the Crimes (Sentencing Procedure) Act 1999 and introduced standard non-parole periods for 13 child sexual assault and related offences.

- *7379 CONTAINERS COLLECTED IN NEW SOUTH WALES—Ms Jenny Aitchison asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) How many containers have been collected, in each electorate in New South Wales, in:
 - (a) December 2017;
 - (b) January 2018?

Answer-

I am advised:

150 million containers have been deposited across New South Wales since the scheme began.

*7381 CHILDREN'S CHAMPIONS AT COURTHOUSES—Ms Jenny Aitchison asked the Attorney General—

- (1) How many Children's Champions are currently employed as at 5 February 2018?
 - (a) Out of which courthouses do the Children's Champions operate?

Answer—

I am advised:

Children's Champions are not employed by the Department of Justice, rather they are appointed to a panel of persons who are suitable to be appointed as Children's Champions under Part 29 Clause 89(1) of Schedule 2 to the Criminal Procedure Act 1986. The District Court appoints Children's Champions in individual matters.

As at 5 February 2018, there were 42 appropriate persons appointed to the panel.

Children's Champions are one of the special measures in the Child Sexual Offence Evidence Pilot. The pilot is being conducted at the Newcastle District Court and the Sydney Downing Centre District Court.

- *7382 RETURN AND EARN COLLECTION POINTS IN THE WOLLONGONG ELECTORATE—Mr Paul Scully asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) Are any additional return and earn collection points planned to be rolled out in the Wollongong electorate?
 - (a) If so, what is the location of each additional return and earn collection point?
 - (2) How many complaints have been received from local residents living near collection points (as at 7 February 2018)?
 - (3) What steps are being taken to ameliorate noise from collection points affecting local residents?
 - (4) Which organisation is responsible for the conduct of community consultation relating to the site locations of return and earn reverse vending machines?
 - (5) Was community consultation undertaken prior to the decision to locate a reverse vending machine in the carpark of Woolworths, Fairy Meadow?
 - (a) If so:
 - (i) Who conducted this?
 - (ii) How was it conducted?
 - (iii) On which dates was it conducted?
 - (6) What is the acceptable noise level for operation of a reverse vending machine when located adjacent to residential properties?
 - (7) What is the number of returned containers from each current collection point in the Wollongong electorate since their installation (as at 7 February 2018)?
 - (8) What is the total value of refunds from each current collection point in the Wollongong electorate since their installation (as at 7 February 2018)?

Answer-

I am advised:

- (1) The network operator, TOMRA Cleanaway, is responsible for determining the location of collection points and deployment of the scheme.
- (2) This information is not available.
- (3) All collection points must be in line with the Design Guide for Container Recycling Equipment and Facilities under the NSW Container Deposit Scheme.
- (4) and (5) See Question 1.
- (6) See Question 3.
- (7) 150 million containers have been deposited across New South Wales since the scheme began.
- (8) Approximately \$15 million has been returned across New South Wales since the scheme began.
- *7383 TRAIN SERVICES ON THE SOUTH COAST LINE—Mr Paul Scully asked the Minister for Transport and Infrastructure—
 - (1) On how many occasions in each year from 2015 to 2017 were train services on the South Coast line considered to be at 'crush load'?
 - (2) Does the Government intend to take any steps to address overcrowding on South Coast rail services

prior to the introduction of the new intercity fleet?

- (a) If so:
 - (i) When will this be addressed?
 - (ii) How will its plans be implemented?
- (b) If not, why not?

Answer-

I am advised:

(1) In 2015, based on rail load survey and Rail Opal Assignment Model observation periods, one train was observed to be over the 135 per cent load during AM and PM peak periods.

In 2016 during the observed peak periods, five trains were observed to be over the 135 per cent load during the AM peak period. No trains were observed to be over the crush load in PM peak.

During the March 2017 observation period, no trains were observed to be over the crush load during the peak period.

- *7384 SAFETY OF EMERGENCY SERVICES PERSONNEL—Mr Philip Donato asked the Minister for Roads, Maritime and Freight—

Is consideration being given to implementing a 40 kilometres per hour, or other reduced speed, speed limit for vicinities of emergency service vehicles and personnel on roadways which are responding to emergencies, so as to improve safety?

Answer-

I am advised:

*7385 TAXI TRANSPORT SUBSIDY SCHEME ACCESS—Ms Jodie Harrison asked the Minister for Transport and Infrastructure—

Will access to the Taxi Transport Subsidy Scheme (TTSS) for Charlestown constituents over 65, and living with a disability, be inhibited by plans to have New South Wales disability funding transferred to the Commonwealth?

Answer-

I am advised:

The rollout of the National Disability Insurance Scheme (NDIS), and resulting transfer of funding to the Commonwealth, will have no impact on the operation of the Taxi Transport Subsidy Scheme.

- *7386 NURSING STAFF ROSTERED DURING THE CHRISTMAS AND NEW YEAR PERIOD—Mr Paul Scully asked the Minister for Health, and Minister for Medical Research—
 - (1) How many nursing staff were rostered for duty during the Christmas and New Year period in December 2017 at Wollongong Hospital?
 - (a) Is this an increase or decrease of rostered nursing staff from the same Christmas and New Year period in December 2016?
 - (b) If there was a decrease, what was the impact on patients during this period?
 - (2) How many nursing staff were rostered for duty during the Christmas and New Year period in December 2017 at Port Kembla Hospital?
 - (a) Is this an increase or decrease of rostered nursing staff from the same Christmas and New Year period in December 2016?
 - (b) If there was a decrease, what was the impact on patients during this period?

Answer-

Both Wollongong and Port Kembla Hospitals had an increase in nursing staff in the Christmas and New Year period in 2017, compared to the same period in 2016.

- *7388 NEW SCHOOLS IN THE MAITLAND ELECTORATE—Ms Jenny Aitchison asked the Minister for Education—
 - (1) Does the Government have any plans to build a new primary school or high school in the Maitland

electorate?

- (a) If not, why not?
- (b) If so:
 - (i) What type of school will be built?
 - (ii) Where will it be located?
- (2) Will I be consulted with in relation to the need and possible construction of a new school?
 - (a) If so, when?

Answer-

I'm advised:

There are 22 public schools across the Maitland electorate made up of 15 primary schools, 4 high schools, 1 infants school and 2 schools for specific purposes.

A major upgrade to Rutherford High School was recently completed, and further upgrade projects are underway at both Rutherford Public School and Bolwarra Public School. These projects will meet projected enrolment demand in the Maitland electorate.

Members of Parliament will be updated on the school infrastructure projects in their electorates as projects progress.

- *7390 BLUE MOUNTAINS EXPRESSWAY—Mr Philip Donato asked the Minister for Roads, Maritime and Freight—
 - (1) How will the economic benefits of constructing an expressway over or through the Blue Mountains be weighed or evaluated against the cost to the taxpayer in the final design solution?
 - (2) Will safety to human life be part of this equation?

Answer-

I am advised:

- (1) When considering investing in any initiative, the Government follows Treasury economic appraisal guidelines which include a Cost-Benefit analysis.
- (2) Economic Assessments of road projects in New South Wales include safety benefits as a standard consideration.
- *7391 NEWCASTLE TO SYDNEY TRAINS—Ms Jodie Harrison asked the Minister for Transport and Infrastructure—

Does the Government have plans to update train tracks from Newcastle to Sydney before the regional rail fleet is expected to arrive in 2020?

Answer-

I am advised:

The Newcastle to Sydney rail corridor is a high quality track with concrete sleepers, adequate drainage and heavy duty rail. Track maintenance on this rail corridor is regularly carried out overnight and on weekends.

- *7393 OVER-THE-COUNTER COLLECTION POINTS—Ms Jenny Aitchison asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) How many businesses in New South Wales, by electorate, were registered as Over-The-Counter Collection Points as at:
 - (a) 1 December 2017;
 - (b) 1 January 2018;
 - (c) 1 February 2018?
 - (2) How many reverse vending machines were operational in New South Wales, by electorate, as at:
 - (a) 1 December 2017;
 - (b) 1 January 2018;
 - (c) 1 February 2018?
 - (3) How many businesses, by electorate, have de-registered as Over-The Counter Collection Points as at 1 February 2018?

Answer—

I am advised:

There are currently 500 collection points across New South Wales.

- *7394 SMALL BIZ CONNECT ASSISTANCE—Ms Jenny Aitchison asked the Deputy Premier, Minister for Regional New South Wales, Minister for Skills, and Minister for Small Business—
 - (1) How many businesses in New South Wales have sought assistance from Small Biz Connect (please disaggregate data by electorate) in each financial year from 2015-16 to 2017-18 (as at 1 February 2018)?
 - (2) How is the Government measuring the efficacy of this program?

Answer-

(1) This data is not available by electorate.

The total number of businesses in New South Wales assisted by Small Biz Connect or Business Connect:

- 1 July 2015 to 31 June 2016: 10,800
- 1 July 2016 to 31 June 2017: 11,100
- 1 July 2017 to 31 June 2018 statistics not yet available.
- (2) Both programs are driven by client demand and success is measured through client satisfaction. Across the program, at least 70 per cent of support to be provided to small businesses in regional areas. Each provider has a specific and ongoing agreement to deliver on individual targets for; businesses supported, sustained and jobs created.
- *7396 WEST WOLLONGONG TAFE CAMPUS—Mr Paul Scully asked the Minister for Tourism and Major Events, and Assistant Minister for Skills—
 - (1) Does the Government have any plans to close the West Wollongong TAFE campus?
 - (2) What courses are currently offered from the West Wollongong TAFE campus? Please list all available courses.
 - (3) How many students were enrolled at West Wollongong TAFE campus in each year from 2015 to 2017?
 - (4) How many teaching staff are currently employed at West Wollongong TAFE campus (as at 7 February 2018)?
 - (5) How many administrative staff are currently employed at West Wollongong TAFE campus (as at 7 February 2018)?
 - (6) What is the current market valuation of the West Wollongong TAFE campus?
 - (a) When was this market valuation requested?
 - (7) Has TAFE NSW received any expressions of interest to purchase the land on the West Wollongong TAFE campus since March 2011 (to 7 February 2018)?
 - (a) If so, from which organisation or company?

Answer-

- (1) Courses offered at Wollongong West in 2018 include Visual Arts, Photography and Photo Imaging, Foundation Skills Support, Access to Work and Training, Career Preparation, Education Support, Information Digital Media and Technology, Information Technology Networking, Web-Based Technologies, Digital and Interactive Games, Website Development, Hairdressing, Beauty Therapy, Salon Assistant, Barbering, Beauty Services, Make-up and Meat Processing (Retail Butcher).
- (3) to (5) TAFE NSW operates in a competitive environment. Data is not provided by location. TAFE NSW does provide enrolment and staffing data as part of its annual reporting, which can be found at https://www.tafensw.edu.au/about-tafensw/annual-report and at http://www.dec.nsw.gov.au/about-us/how-we-operate/annual-reports
- (6) TAFE NSW does not have a current market value for the Wollongong West Campus.
- (7) TAFE NSW has not received any expressions of interest to acquire the Wollongong West site.
- *7397 REGULATION OF SHARE-BIKES IN NEW SOUTH WALES—Ms Jo Haylen asked the Minister for Roads, Maritime and Freight—
 - (1) What guidance or advice is the Government providing, or what role is the Government taking, in setting regulations around share bikes in New South Wales?
 - (2) Does the proliferation of share bikes put greater demands on existing cycling infrastructure?
 - (3) What projects will directly assist with improving cycling safety for riders using share bikes?
 - (4) Where are separated cycleways being constructed in New South Wales to improve cycling safety?

Answer-

I am advised:

This is a matter for the Minister for Transport and Infrastructure.

*7398 ANTI DISCRIMINATION ACT 1977—Ms Jo Havlen asked the Attorney General—

- (1) What plans does the Government have to address the exclusion of bisexual, gender diverse and intersex residents from the Anti Discrimination Act 1977?
- (2) What plans does the Government have to address the discrepancy in the statute of limitations and penalties applied in instances of vilification against gay, lesbian and transgender citizens as opposed to racial vilification?

Answer-

I am advised:

- (1) The Sex Discrimination Act 1984 (Commonwealth) already prohibits discrimination on the grounds of bisexual, gender diverse and intersex status.
- (2) There is no discrepancy in the limitation periods for vilification on grounds of homosexuality or transgender status, and vilification on grounds of race. At this time, the Government has no plans to change the penalties for serious vilification offences.

*7399 GENDER BALANCE IN SCHOOLS—Ms Jo Haylen asked the Minister for Education—

- (1) What is the Department of Education's approach to managing gender imbalances at co-educational schools where there is a significantly lower number of either boys or girls compared to members of the opposite sex?
- (2) Does the Department have a policy around promoting gender balance in enrolments at schools?
- (3) How does the Government respond to the instances where out-of-catchment enrolments at single-sex schools are creating gender imbalances in neighbouring schools?

Answer-

I'm advised that all schools are required to follow the Department of Education's enrolment policy. Every eligible student who wishes to attend a New South Wales government school will be given a place at their local school.

In primary and secondary schools across New South Wales, gender imbalances occur from time to time. In these circumstances principals make local arrangements to ensure the wellbeing of students.

Where non-local enrolment is possible and places exceed availability, a placement panel is formed. The placement panel considers non-local enrolment applications in line with the department's policy. A school able to take non-local students cannot refuse enrolments based on a child's age, race, religion or sex.

- *7400 NATIONAL PARKS AND WILDLIFE SERVICE IN NEW SOUTH WALES—Ms Jo Haylen asked the Minister for the Environment. Minister for Local Government, and Minister for Heritage—
 - (1) What has been the full-time equivalent (FTE) number of staff employed by the National Parks and Wildlife Service in New South Wales (NPWS) in each financial year since the 2011 State election (as at 7 February 2018)?
 - (2) What has been the FTE number of rangers employed by the NPWS in each financial year since the 2011 State election (as at 7 February 2018)?
 - (3) What has been the average yearly gross salary of a NPWS ranger in each financial year since the 2011 State election (as at 7 February 2018)?
 - (4) What parks previously managed by the NPWS are now being managed by local councils?
 - (5) How much did the Government spend celebrating the 50th Anniversary of the NPWS?

Answer-

I am advised:

- (1) National Parks and Wildlife Service (NPWS) new structure will increase staff by 119 additional full time roles.
- (2) Please refer to the 2017-18 Budget Estimates Supplementary Questions, Environment, Heritage, Local Government.

*7401 COME PLAY SUMMER PILOT PROGRAM—Ms Jo Haylen asked the Minister for Education—

- (1) How was the success of the Come Play Summer Pilot Program measured?
- (2) What was the rationale by which participating schools were selected?
- (3) What administrative assistance was provided to the principals of participating schools?
- (4) What was the average cost to participating schools of hiring security to monitor playgrounds during the trial?
- (5) What maintenance works were funded at Marrickville High School and Haberfield High School with funds from the program?
- (6) How was attendance and usage of school playgrounds monitored during the trial?
- (7) What was the attendance and usage at both participating schools in the Summer Hill electorate?
- (8) What was the total cost to the Government of conducting the program?
- (9) What future plans does the Government have for the program?

Answer—

I'm advised that:

A mix of primary and secondary schools were selected in consultation with principals.

Principals were not required to administer the program. School Infrastructure NSW was the primary contact for the public during the program. Schools did not fund security guard patrols that ran as part of the pilot.

Participating schools received a discretionary \$15,000 grant to help upgrade their facilities for community and school use.

The Department of Education is currently undertaking an evaluation of the pilot.

*7402 MOSQUITO INFESTATIONS AT ROYAL PRINCE ALFRED HOSPITAL'S MATERNITY WARD—Ms Jo Haylen asked the Minister for Health, and Minister for Medical Research—

- (1) How has the Government responded to mosquito infestations at Royal Prince Alfred (RPA) Hospital's Maternity Ward?
- (2) How many other wards are impacted at RPA?
- (3) What other New South Wales hospitals have reported similar issues with mosquitoes?
- (4) What has been the total cost of the mitigation measures introduced at RPA so far?
- (5) How will the Government and Department of Health monitor and gauge the success of these

measures in eradicating the problem at RPA?

Answer-

Royal Prince Alfred (RPA) has a contractual arrangement with a pest management company. Pest control management strategies are well implemented at RPA and control measures have been optimised to reduce mosquito populations.

RPA provides high quality and safe healthcare, including providing patients and visitors with a clean environment.

*7403 WORKS AT MARRICKVILLE PUBLIC SCHOOL—Ms Jo Haylen asked the Minister for Education—

- (1) What was the delay in repairing the degraded surface of the top playground at Marrickville Public School before the commencement of Term 1, 2018?
- (2) What is the proposed schedule and cost of work?
- (3) When is the work expected to be completed?

Answer-

I'm advised that:

The contractor was appointed for the project late last year.

The total estimated cost of the project is \$300,000.

Works are expected to be completed by the end of March 2018, subject to weather.

The area in question can still be used safely.

- *7404 REVERSE VENDING MACHINES—Ms Jo Haylen asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) How many businesses and organisations serving as manual collection points for the Return and Earn Scheme have withdrawn from the scheme since it began on 1 December 2017 (to 7 February 2018)?
 - (2) How many complaints has the Department received since the scheme was implemented?
 - (3) How many noise complaints has the Department received since the scheme was implemented?
 - (4) Who is responsible for managing broken glass around the Reverse Vending Machines, TOMRA or the operator/owner responsible for the location?
 - (5) What is the exact timetable for rolling out more Reverse Vending Machines at locations across New South Wales?

Answer-

I am advised:

The network operator, TOMRA Cleanaway, is responsible for deployment of the scheme. TOMRA Cleanaway is deploying teams daily across New South Wales to identify and establish reverse vending machines sites.

- *7405 CHILDCARE ASSISTANCE FOR REFUGEES AND ASYLUM SEEKERS—Ms Jo Haylen asked the Minister for Education representing the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education—
 - (1) Are refugees and asylum seekers awaiting their claims to be assessed and not eligible for the Commonwealth's Childcare Rebate (including those on the Status Resolution Support Services Payments) eligible for support under the Start Strong preschool program?
 - (2) What programs or support are available from the Government to assist the children of refugees settled in Australia but without Temporary Protection Visas or Safe Haven Enterprise Visas to attend preschool or access early childhood education?

Answer—

- (1) Children of refugees and asylum seekers awaiting their claims to be assessed are eligible for funding under Start Strong if they are at least four years old on or before 31 July in that preschool year and not in compulsory schooling.
- (2) Children of refugees settled in Australia may be supported to attend New South Wales community preschools through the Bicultural Support Program. The program provides access to bilingual staff and resources to support early childhood education services to enrol, settle and assist with the inclusion of children from culturally and linguistically diverse, refugee and Aboriginal backgrounds.

- *7406 TRAINS ON THE T5 AND T8 LINES—Mr Anoulack Chanthivong asked the Minister for Transport and Infrastructure—
 - (1) How many trains on the T5 and T8 lines were cancelled between 26 November 2017 and 31 December 2017?
 - (2) How many trains on the T5 and T8 lines were delayed between 26 November 2017 and 31 December 2017?
 - (3) How many trains on the T5 and T8 lines were cancelled between 1 and 31 January 2018?
 - (4) How many trains on the T5 and T8 lines were delayed between 1 and 31 January 2018?

Answer-

I am advised:

Sydney Trains performance is measured by punctuality. This information is available on the Sydney Trains website. Services that are cancelled are not considered on time for the purposes of punctuality reporting.
