- (5) What assessment has the Government made of the success of existing behaviour change programs and similar community initiatives including Hello Sunday Morning, Good Sports Febfast and Community Drug Action Teams?
- (6) What new alcohol and drug treatment programs will the Government provide or fund to help people with alcohol abuse problems, including SMART Recovery and Control Your Drinking?
- (7) How will the Government build on these programs or integrate new programs with existing community initiatives?
- (8) How will the Government work with academics, psychologists and community groups to support behaviour change programs?

Answer-

The Government is developing a major new public awareness campaign to drive changes in behaviour regarding excessive drinking and associated violent acts. The integrated multimedia campaign will draw on lessons from past effective behaviour change campaigns and the impact of the campaign will be monitored over time.
