*9263 CURBING HOUSING COSTS—Ms Sonia Hornery asked the Minister for Planning, Minister for Housing, and Special Minister for State—

Considering that cost of living pressures are keenly felt by Wallsend residents, what steps is this Government taking to curb increasing housing costs?

Answer-

The Government is committed to making housing in New South Wales more affordable.

First Home Buyers

• From 1 July 2017 to 30 June 2018, 8,948 First Home Owners' grants were distributed, worth a total of \$107 million and 32,685 first home buyers received stamp duty concessions, worth \$476 million.

Housing Supply

- The Government has boosted the supply of housing and is meeting the Premier's target of 61,000 new homes completed each year to 2020-21.
- Ensuring 90 per cent of housing approvals are determined within 40 days by 2019.

Regional and District Plans

• The Greater Sydney Commission has included measures to improve housing affordability in District Plans in Sydney and is also recommending Affordable Rental Housing Targets to deliver additional affordable housing.

State Environmental Planning Policies

- There are two State planning policies (SEPPs) that increase the supply of affordable housing -
 - The Affordable Rental Housing SEPP facilitates and encourages the delivery of affordable housing types such as boarding houses, secondary dwellings, supportive accommodation and group homes.
 - SEPP 70 (Affordable Housing) which allows councils to levy contributions from developers in areas subject to an up-zoning, for the purpose of affordable housing.

SEPP 70

- SEPP 70 identifies councils which have demonstrated a need for affordable housing and enables them to prepare affordable housing contribution schemes for certain areas in their local government areas.
- These schemes allow councils to require contributions to provide affordable housing when land is upzoned.
- *9282 CURBING ELECTRICITY PRICES—Ms Sonia Hornery asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

Considering the cost of living pressures are keenly felt by Wallsend residents, what steps is this Government taking to curb electricity price spikes?

Answer-

I am advised:

The Government has taken a number of steps to help households and businesses.

On 1 January this year, the Government prohibited exit fees, paper bill fees and fees for paying bills through Australia Post on electricity contracts, to help customers to save money and to remove barriers to switching to a better deal.

The Government has also acted to help some of the most vulnerable customers. Under changes to requirements, retailers are helping customers who receive a Government rebate to find a better deal.

In addition, the Government has recently announced:

- \$24.5 million for upgrades to more than 20,000 rental homes to enable low-income renters to benefit from energy efficient lighting, heating and hot water systems, saving renters up to \$400 each year;
- \$35 million for businesses to reduce their energy costs, including assistance for 250 manufacturing businesses to install energy efficient equipment, such as upgraded boilers, refrigeration and metering technology; and

• \$15 million for a trial to help up to 3,400 low-income households access solar power systems, saving them around \$300 each year.

The Government also provides a wide range of assistance measures to vulnerable customers to help with their energy costs, including the Low Income Household Rebate, NSW Gas Rebate, Family Energy Rebate, Life Support Rebate and Medical Energy Rebate.

Customers can call or visit Service NSW to identify which rebates and programs they are eligible for. The Service NSW 'Cost of Living' initiative helps customers by identifying eligibility for rebates and saving programs and comparing the best electricity and gas offers available so that they can switch to a better offer.

- *9303 DISABILITY CONFIDENT EMPLOYEES AND EMPLOYERS—Ms Liesl Tesch asked the Minister for Multiculturalism, and Minister for Disability Services—
 - (1) What is the Government's definition of 'disability confident' employer?
 - (2) Considering that the Department of Family and Community Services is a 'disability confident' employer, what percentage of people with disabilities were employed by the Department of Family and Community Services in each financial year from 2011-12 to 2016-17?
 - (3) What were the percentages of New South Wales government employees with a disability in each financial year from 2011-12 to 2016-17?
 - (4) What is the percentage increase in people with disabilities employed in the New South Wales public sector since 2011 (to20 September 2018)?
 - (5) Which are the websites and workplaces promoting the New South Wales government 'disability confident' employees schemes and promoting success of the New South Wales Government as 'disability confident' employees?
 - (6) Considering the National Disability Insurance Scheme Annual report 2015-16 stated vision is to optimise the social and economic independence and full participation of people with disabilities and full participation of people with disabilities, when will Government achieve 'disability confident' employer status?

Answer-

The Government has signed the 'Disability Confident Recruiter Charter' developed by the Australian Network on Disability, thus making a public commitment to be a Disability Confident Recruiter. - *9304 EMERGENCY DREDGING WORK IN THE ETTALONG CHANNEL—Ms Liesl Tesch asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) Considering the recent emergency dredging work taking place in the Ettalong channel, what is the cost per day to operate the dredge?
 - (2) How many days has the dredge operated since it has been in the water?

- (3) What is the estimated completion date of the emergency dredging?
- (4) How does the Minister intend to keep the local community informed on the ongoing status of the dredging?

Answer-

- (1) The Department of Industry Lands has a \$660,000 contract in place to see dredging completed in Ettalong Channel. This contract covers the entire project and is not paid daily.
- (2) As at 25 October 2018, 28 days.
- (3) Dredging is entirely weather dependent. Approximately 11 days of work remaining.
- (4) The status of the dredging is being updated through local media and the Department of Industry website.
- *9305 SMOKING IN PUBLIC HOUSING—Ms Jenny Leong asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—
 - (1) Does the Department of Family and Community Services have any policies in regards to smoking in and around residential buildings occupied by Housing NSW tenants?
 - (2) What recourse is available to Housing NSW tenants who are unhappy about being subjected to passive smoke from their neighbours?

Answer—

I am advised that the Department of Family and Community Services complies with the provisions of the Smoke Free Environmental Act 2000. This includes the banning of smoking in enclosed common areas.

- *9306 POLICE EVENT NUMBERS FOR NEIGHBOURS—Ms Jenny Leong asked the Minister for Police, and Minister for Emergency Services—
 - (1) How do neighbours who witness a situation where police are called, or live next door to an individual involved in a matter that involved the police, get access to the event number so that they can report further or follow-up information?
 - (2) Are police required to provide an event number to a member of the public who asks about an incident even if they didn't report it?

Answer—

I am advised:

People who believe they have information that can assist police in their inquiries into a matter should report this to police, which can be done in the absence of an event number. The NSW Police Force supply an event number to a victim of an incident. In some circumstances an event number may be provided to a witness.

- *9307 PROJECTED CONTAINER TRADE AT NSW PORTS—Mr Tim Crakanthorp asked the Minister for Roads, Maritime and Freight—
 - (1) What is the yearly projected container trade at Port Botany for each of the years from 2018 to 2056?
 - (2) What is the yearly projected container trade at Port Kembla for each of the years from 2018 to 2056?
 - (3) What is the yearly projected container trade at Port of Newcastle for each of the years from 2018 to 2056?

Answer-

*9310 EXTENSION OF AUDITOR-GENERAL'S FUNCTIONS—Ms Tania Mihailuk asked the Treasurer, and Minister for Industrial Relations—

Considering the Independent Commission Against Corruption's findings surrounding the mismanagement of public funds in non-government organisations by Eman Sharobeem, will the Treasurer now extend the Auditor-General's function across the non-government sector in receipt of Government funds?

Answer-

The Independent Commission Against Corruption's September 2018 Report 'Investigation into the conduct of a principal officer of two non-government organisations and others' addresses

recommendations relating to the Sharobeem Case. This Report did not recommend empowering the Auditor-General to 'follow the dollar' into non-government organisations that receive Government funds.

- *9311 SOCIAL AND COMMUNITY SERVICES EQUAL REMUNERATION ORDER SUPPLEMENTATION FUNDING—Ms Tania Mihailuk asked the Minister for Mental Health, Minister for Women, and Minister for Ageing—
 - (1) Did Combined Pensioners and Superannuants Association of NSW Incorporated (CPSA), which was eligible for Social and Community Services Equal Remuneration Order Supplementation funding from 2012, stop receiving this funding as of 30 June 2017?
 - (a) If so, why?

Answer-

I am advised the Government committed to paying Equal Remuneration Order supplementation to all organisations that had a contract in place in 2012, and employed staff under the Social and Community Services Modern Award (or had enterprise agreements in place that directly apply Social and Community Services Award pay rates). New funding agreements established after 2012–13 are not eligible for Equal Remuneration Order supplementation.

I am advised the Combined Pensioners and Superannuants Association is not eligible for Social and Community Services Equal Remuneration Order supplementation under its new three-year funding agreement, which commenced on 1 July 2017.

- *9312 AUDITOR-GENERAL'S AUDIT FUNCTION STATUS—Ms Tania Mihailuk asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—
 - (1) Considering the August report to the Legislative Council regarding the Implementation of the Government's response to the Inquiry into Child Protection states that a regulatory impact analysis was undertaken into whether nongovernment child protection related services should be subject to the Auditor-General's performance audit function, will the finding of the regulatory impact analysis be made public?
 - (2) As these findings have been referred to the NSW Treasury is there an expected timeframe for a decision on the Auditor-General's audit function status?

Answer-

I am advised the Department of Family and Community Services (FACS) has undertaken a regulatory impact analysis into whether child protection related services should be subject to the Auditor-General's performance audit function. The analysis includes input from Auditor-General offices across Australia, regulatory bodies, non-government agencies and New South Wales government departments. NSW Treasury is conducting further work to investigate opportunities to improve public accountability and transparency with relation to government finances. FACS has referred the findings of its regulatory impact analysis to NSW Treasury.

*9313 CASELOAD TARGETS FOR CASEWORKERS—Ms Tania Mihailuk asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—

As it was recommended that the Department of Family and Community Services set caseload targets for caseworkers, could the Minister please provide details of the monitoring process and which key statistics are being looked at?

Answer—

I am advised that the Department of Family and Community Services (FACS) undertakes ongoing monitoring of workload of caseworkers. Caseworker workloads are managed in collaboration with Casework Managers.

*9314 CHILD PROTECTION ASSESSMENT RESPONSE DATA—Ms Tania Mihailuk asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—

Why is data on child protection assessment response not included on the Department of Family and Community Services Caseworker Quarterly Dashboard for March 2018 despite ChildStory being active for some time?

I am advised that data for 2017-18 will be published in Family and Community Services annual statistical report and will be available online.

*9315 RESPECTFUL RELATIONSHIPS EDUCATION—Ms Jodie Harrison asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—

As domestic violence has been highlighted as a major issue in Charlestown and my constituents would greatly benefit from Government investment into respectful relationships education from an early age, what alternative to Our Watch is available for the constituents of Charlestown?

Answer_

I am advised since 2016, all secondary school students in Years 7 to 10 have been learning about family and domestic violence as part of their Personal Development, Health and Physical Education (PDHPE) Syllabus. I am further advised in April 2018, the NSW Education Standards Authority released a new mandatory PDHPE K to 10 syllabus which has strengthened content relating to respectful relationships.

This new syllabus is due for implementation in Years 7 and 9 in 2019 and for all students in Kindergarten to Year 10 in 2020.

*9317 STAFF DATA PROTECTION MEASURES—Ms Jodie Harrison asked the Minister for Finance, Services and Property—

What measures are in place to protect the data of staff when the payroll and finance functions of Revenue NSW are handed over to GovConnect which is run by overseas companies?

Answer-

- (1) Three key measures are enforced to ensure staff data is protected when these functions are handed over to GovConnect.
 - Data Sovereignty: Hard copy personnel files are stored at Government Records Storage and digital copies are managed in New South Wales.
 - Access control: Systems operated by GovConnect are owned by the state and are located in New South Wales. GovConnect staff access these systems via secure 'Citrix' connection which is configured to prevent data from being captured in any way.
 - Physical Security: Offshore GovConnect sites are certified to industry standards (ISO27001).

 - (1) How many leaks have been reported to Sydney Water by residents in the Macquarie Fields electorate from 20 September 2017 to 20 September 2018?
 - (a) Of these leaks, what is the average number of days to fix the leaks?
 - (i) How many of these leaks took more than:
 - (i) A week to fix;
 - (ii) 2 weeks to fix;
 - (iii) 3 weeks to fix;

(1) Leaks and repair timeframes for the Macquarie Fields electorate are not available as figures are not collected or collated per electorate.

(2) Sydney Water's leakage rate for the financial year 2017-18 was 129.5 megalitres per day.

Will the Government cap rideshare operators to prevent further congestion, infrastructure costs and illegal parking in suburban streets?

Answer-

I am advised:

Transport for NSW has no evidence that rideshare vehicles contribute to congestion, infrastructure costs and illegal parking in suburban streets.

Should the Member be aware of illegal activities, I urge the Member to ensure that this information is promptly referred to the appropriate enforcement authority.

- *9321 NATIONAL DISABILITY INSURANCE SCHEME GAPS—Ms Kate Washington asked the Minister for Health, and Minister for Medical Research—
 - (1) What is the longest period an National Disability Insurance Scheme participant has been forced to remain in a New South Wales public hospital because there was no suitable alternative accommodation available?
 - (2) How many National Disability Insurance Scheme participants are currently residing in public hospitals because there isn't alternative, suitable accommodation available?

Answer-

The Ministry of Health, Local Health Districts and Speciality Health Networks are working cooperatively with the National Disability Insurance Agency (NDIA) to identify and resolve issues that are preventing individuals from leaving hospital when they are clinically ready to do so.

NSW Health continues to work intensively with all stakeholders to resolve these issues to ensure that the people of New South Wales can realise the significant benefits that the Scheme is bringing.

- *9322 URBANGROWTH FISHERMANS BAY LAND—Ms Kate Washington asked the Minister for Planning, Minister for Housing, and Special Minister for State—
 - (1) What is the Government's plan for the land owned by UrbanGrowth NSW at Fishermans Bay (Lot WP 1184315)?
 - (2) Why was a fence installed at this site in September 2018?
 - (3) Was the Rural Fire Service consulted prior to the installation of this fence in September 2018?

Answer—

This question is a matter for the Premier.

- *9323 ADDITIONAL ASSISTANCE PAYMENT SCHEME—Mr Philip Donato asked the Minister for Transport and Infrastructure—
 - (1) How can the Government justify the amount of Additional Assistance Payment Scheme for the Taxi industry?
 - (2) Why has only \$92 million of the \$250 million offered been paid out to those who were approved for the Additional Assistance Payment Scheme?
 - (3) How does the Government justify the delay of the compensation package and the time of only thirteen weeks for those eligible applicants to apply?

Answer—

I am advised:

- (1) As the Member is aware, the Government was one of the first governments in Australia to reform the point to point transport industry to allow ridesharing companies to operate legally. The NSW Government's legalisation of ridesharing in New South Wales in December 2015, and other point to point transport reforms, have delivered greater choice and flexibility for customers. However, the changes have not been easy for many in the taxi and traditional hire car industries. As such, a temporary Passenger Service Levy was introduced from 1 February 2018. The \$1 per trip levy applies to all point to point transport service providers in New South Wales, including taxis, hire cars and rideshare services. The levy funds an industry adjustment assistance package of up to \$250 million, helping people who have put their life savings into the industry and are now doing it tough. The levy will be in place for no more than five years or until the maximum of \$250 million is reached.
- (2) The premise of your question is wrong. More than \$92 million has been paid out to the industry to date
- (3) The premise of your question is wrong. There has been no delay. It was determined by the Taxi and Hire Vehicle Indust'ry Assistance Panel (which includes representatives of the NSW Taxi Council) that a period of three months was considered an appropriate period of time for persons to lodge applications for additional assistance under the Scheme.

 - (1) Is it true that the 2016 Census reported that the number of older women who are homeless in New South Wales increased by 31 per cent between 2011-16, and that older single women are the fastest growing group of people facing homelessness?
 - (2) What assessment has the Government made about the causes of this increase?
 - (3) What data does the Government have on the impact of homelessness on health and welfare outcomes for older women in New South Wales?
 - (4) What programs does the Government provide to specifically address the housing needs of older

women?

- (5) What consideration has the Government given to the recommendations in the National Older Women's Housing and Homelessness Working Group's 2018 'National Plan for Change: Increasing Housing Security for Older Women Report'?
- (6) What plans does the Government have to increase housing support for older women living in poverty?

One of the ways the Government is addressing the increase in the number of older people at risk of homelessness is through the record \$1.1 billion investment in the Social and Affordable Housing Fund (SAHF). The Government has committed to a target of 3,400 new social and affordable dwellings that will increase the amount of suitable housing available to vulnerable people, including older women in housing stress.

I am advised the Government has also invested \$7.7 million for a new social housing complex specifically for older women in Woolloomooloo, which will be run by the Women's Housing Company.

- (1) Yes. The Government funds and provides a range of late night public transport services, including bus, ferry, light rail, and train services.
- (2) to (5), (7) and (8). The Government is committed to delivering the best public transport system possible for the people of New South Wales and is always looking at ways to improve services.
- (6) d on current demand, there are no plans to expand the current operating hours on the Inner West Light Rail. We will continue to monitor demand on the Inner West Light Rail and for the CBD and South East Light Rail once operational.

I am advised:

Roads and Maritime Services is considering a number of options for the sites at 100-128 Palmer Street and 114-132 William Street, Woolloomooloo and, once complete, consultation with stakeholders will be undertaken.

The land is inspected monthly and maintained, as required, with weeding, graffiti and litter removal. The site was last inspected on 25 September 2018. The site was last cleaned on 9-11 July 2018.

Answer—

I am advised the Department last inspected the property on 3 October 2018.

No orders have been issued to date however the Department identified breaches of the lease and is taking action as a result. The Department confirms there are no approved sub-tenancy arrangements so current use of the site is under review.

All holders of Crown land leases are required to comply with lease conditions and the reserve purpose. Compliance is assessed by site inspections, audits and reviews of information provided by members of the public.

I am advised the Department is satisfied that clauses 39 and 86 of the lease conditions are being met. Clauses 65, 66, 67 and 71 are not being met.

I am advised the bowling green contains weeds and is unable to be used for bowling in its present state. The Department observed window damage, minor waste litter and degraded paint. I am advised the site has no outdoor furniture.

I am advised a business plan for the site was received on 12 July 2017. The next business plan will be due on 1 December 2020. The Department advises the site has not been used for recreation purposes and/or community access since June 2015.

The current rent for the site is \$66,331.10 (including GST) per annum. This market rent was determined on 1 December 2010 following advice of an independent valuer. Rent payments are not in arrears and no rebates are provided.

Current bus services that cross the Newcastle Light Rail system will be changed to start and end in King and Bolton Streets, following consultation with the Newcastle City Council Traffic Committee.

Committee members act and provide advice that is in the interests of the community of Newcastle.

- *9337 SALE OF NEWCASTLE PORT AND SAND EROSION—Mr Tim Crakanthorp asked the Treasurer, and Minister for Industrial Relations—
 - (1) Does the Minister consider that the business case presented for the sale of Newcastle Port to a private consortium and a foreign government was flawed, and made no mention of the Port's role in creating severe beach erosion adjacent to the Harbour at Stockton, or any plan to remediate that erosion?

- *9338 DREDGING—Mr Tim Crakanthorp asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—

Can sand be dredged offshore for environmental rehabilitation purposes under the Fisheries Management Act 1994?

Answer-

NSW Department of Primary Industries (NSW DPI) administers the Fisheries Management Act 1994 (FM Act) and associated Regulations. The objects of the FM Act are to conserve, develop and share the fishery resources of New South Wales for the benefit of present and future generations. To meet the primary objectives, Part 7 of the FM Act deals with the protection of aquatic habitats.

Sediment or sand extraction is considered 'dredging' for the purposes of Part 7 of the FM Act. Such activities can be conducted with the specific intent of depleting an area of sediment or to supply another area with sediment. Often these types of extraction works are conducted on a large-scale and involve extensive excavation. As such, the potential impacts on fish stocks and key fish habitat may be far greater than more discrete dredging activities.

Permit or consultation requirements are required under the FM Act by proponents. Depending on the scale of the extraction project and the location of the works, extraction may have substantial impacts on native fish (including threatened fish species, populations and communities) and their habitats.

Permits may be required for dredging of sand, gravel or other materials for private or commercial use under Sections 200-201 of Part 7 of the FM Act. A permit is required for dredging or reclamation work carried out by a local government authority or person respectively, unless these works are authorised by a relevant public authority (other than a local government authority) or under the Crown Lands Management Act 2016.

Further, under s199 of the FM Act, the Minister for Primary Industries is required to be consulted over any dredging or reclamation works carried out, or proposed to be authorised, by a public authority (other than a local government authority).

NSW DPI will assess dredging proposals on their merits with consideration for the following in accordance with the Department's Policy and Guidelines for Fish Habitat Conservation and Management (2013):

- essential remediation works of contaminated sites and other hazardous situations;
- maintenance of existing essential navigation channels for public use;
- stream and estuary rehabilitation purposes;
- · flood mitigation and asset protection for public purposes;
- non-remediation extraction for private purposes including oyster production, flood control, drainage, navigation, and sale of materials.

With regard to environmental rehabilitation, NSW DPI will require extraction proposals for rehabilitation or remediation works to demonstrate that the environmental outcomes are positive and that environmental harm does not result.

- *9339 ABALONE—Ms Jenny Leong asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—

I am advised:

Transport for NSW works with ALTRAC to minimise night works. When work must be done at night to minimise disruption to traffic, transport and the wider community, ALTRAC offers alternative accommodation to affected residents via letter.

In line with planning conditions, ALTRAC offers alternative accommodation to residents who would otherwise be affected by high noise works scheduled out of hours (after 10:00 pm Monday to Saturday, or after 6:00 pm Sunday), for more than two consecutive nights. It also offers alternative accommodation to residents of Surry Hills and the South-East suburbs for high noise works after midnight.

ALTRAC advises it offered alternative accommodation to residents of 567 properties in Surry Hills for work that occurred on 40 nights between August 2017 and August 2018. Of those offers, 156 residents accepted accommodation.

- *9341 MISSING PERSONS WEEK EVENT—Ms Jenny Leong asked the Minister for Police, and Minister for Emergency Services—
 - (1) Did the NSW Police host an event for family and friends of missing persons during Missing Persons Week this year as it has done in previous years?
 - (a) If not, can the Minister explain why this event was not held and who made this decision?
 - (b) If it did happen, were there changes to who was invited and how families and friends were notified about it?
 - (2) Are there any plans to reinstate the event, which is so important to families of missing persons, in 2019 and therefore so that everyone is able to participate?

The NSW Police Force (NSWPF) adopted a new approach to National Missing Persons Week 2018 focussing on a digital campaign. This decision aligned with and supported the approach taken by the National Missing Person Coordination Centre through the Australian Federal Police (AFP). The decision was driven by a desire to deliver a campaign that had a greater reach and effect. The Families and Friends of Missing Persons Unit was advised of this digital media approach.

The NSWPF is reviewing the outcomes of the 2018 National Missing Persons Week campaign and will continue to coordinate with the National Missing Person Coordination Centre through the AFP to maximise awareness and to achieve the most effective outcomes for the families and friends of missing persons.

- *9342 AFFORDABLE TAFE EDUCATION—Ms Liesl Tesch asked the Deputy Premier, Minister for Regional New South Wales, Minister for Skills, and Minister for Small Business—
 - (1) What is the Government doing to make TAFE education more affordable for students?
 - (2) Is the Government considering a Higher Education Contribution Scheme (HECS) like system to allow students to defer upfront costs and reduce barriers to accessing education?
 - (a) If not, why not?

- (1) The introduction of Smart and Skilled in 2015 has resulted in a simpler, fairer system for fees for the hundreds of courses that are eligible for government subsidies. The Government subsidises all Smart and Skilled qualifications delivered by TAFE NSW, and other registered training organisations, to ensure qualifications are affordable and provide students the greatest opportunity to get into work, whilst supporting New South Wales' strong economy.
- (2) There is an existing Commonwealth Government Vocational Education and Training Student Loans scheme (VSL).

- (3) Yes.
- (a) (i) Business advisory services.
- (a) (ii) On a quarterly basis as stated in the contract for the Business Connect Program.

Service NSW is still defining the requirements of the Digital Hub, including the number of staff.

*9348 COMBINED ENERGY REBATE—Ms Liesl Tesch asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

What was the dollar value of the combined energy rebates distributed in the Gosford electorate in each financial year from 2011-12 to 2016-17?

Answer-

I am advised:

The Department of Planning and Environment (the Department) is not aware of the dollar value distributed in the Gosford electorate for the period in question for all electricity and gas rebates. This is because retailers process the majority of applications in New South Wales and, up until recently, they did not provide information on the location of their customers to the Government.

From October 2018, the Department can provide spatial information on rebate customers per local government area for the period of 2017-18. This is due to a change in the Social Programs for Energy Code, which requires retailers to report information on energy rebate customers, including their postcode as of 1 July 2017.

The Department estimates eligible customers in the Central Coast Council local government area received rebates valued at more than \$18 million in 2017-18.

- *9349 OFFICE OF PLANNING AND ENVIRONMENT IN GOSFORD—Ms Liesl Tesch asked the Minister for Planning, Minister for Housing, and Special Minister for State—
 - (1) Considering the office of Planning and Environment in Gosford, how many staff are employed at this office?

 - (3) What is the cost of the staff employed at the office?

 - (5) How many staff have utilised the new New South Wales Government shared workspace in Gosford

Answer-

- (1) The Gosford office at the Department of Planning and Environment employs 12 staff.
- (2) The office was established in 2002 and has from that time maintained a permanent staff presence including a public enquiries counter during business hours. Since the introduction of a Coordinator General for the Central Coast in April 2017, the office has been advertised to residents through the establishment of an Information Centre with updated signage on Mann Street Gosford, interviews between the Coordinator General and local broadcast (TV and radio) and print outlets, social media, the GoGosford and the Department websites, and as an exhibition venue for several development applications and draft plans.
- (3) The cost of staff at the Gosford office is \$1,558,346 for the 2018-19 financial year.
- (4) The total cost of the GoGosford program to date is \$58,949.
- (5) Use of the shared workspace is tracked as occupancy per week. The shared workspace in Gosford has been used by 24 NSW State Agency staff. Usage is consistently growing and is currently averaging at 60 per cent occupancy per week.
- *9351 COASTCONNECT—Ms Liesl Tesch asked the Minister for Transport and Infrastructure—
 - (1) What is the patronage of the CoastConnect on-demand buses trial by week since 21 May 2018?

I am advised:

- (1) From the start of the pilot on 31 May 2018, to 31 August 2018, 1,637 passenger trips were delivered. Weekly patronage has grown to over 200 in August 2018, with more than double the patronage in late June/early July.
- (2) and (3) Marketing and advertising activities include letter box drops, social media, promotional videos, on-platform marketing at Woy Woy Station, signage and banners, and printed collateral available at the station.

The contract is available on the Government's eTendering website.

Answer-

The Residential Tenancies Act 2010 is silent on what information potential tenants are required to submit to real estate agents or landlords when making a rental application.

The Property, Stock and Business Agents Act 2002 provides a licensing regime to regulate the conduct of real estate agents and requires that agents only use information they collect for the primary purpose for which it was collected, and may not disclose it unless:

- the client or customer authorises the disclosure, or
- the agent is permitted or compelled by law to disclose the information.

The application process for a rental property, including the use of data provided in that process, is subject to the Privacy Act 1988, administered by the Office of the Australian Information Commissioner (OAIC), and which regulates the way an individuals' personal information is collected and managed by some private sector organisations. Tenants concerned about the use of their information can lodge a complaint with NSW Fair Trading in the first instance.

*9354 NEWCASTLE LIGHT RAIL SCHOOLS PROGRAM—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—

What is the average wait time for the Child Protection Helpline?

I am advised that call wait times to the Child Protection Helpline are influenced by a variety of factors. The Helpline actively monitors the issues that arise from a fluctuating environment and accordingly implements mitigation strategies including the recruitment of additional staff.

*9356 WAITING TIMES FOR CATARACT SURGERY—Ms Tania Mihailuk asked the Minister for Health, and Minister for Medical Research—

What mechanisms and systems will the Minister put in place to decrease waiting times for cataract surgery given that the Bankstown - Lidcombe Hospital waiting time has grown to 307 days?

Answer-

100 per cent of patients at Bankstown – Lidcombe Hospital received their cataract surgery on time in April to June 2018, compared to 77.2 per cent in April to June 2010 under Labor.

- *9357 TIME FRAME FOR EXTENSION OF AUDITOR-GENERAL FUNCTIONS—Ms Tania Mihailuk asked the Treasurer, and Minister for Industrial Relations—
 - (1) Considering the August report to the Legislative Council regarding the Implementation of the Government's response to the Inquiry into Child Protection states that a regulatory impact analysis was undertaken into whether non-government child protection related services should be subject to the Auditor-General's performance audit function.
 - (a) Is there an expected timeframe for a decision on the Auditor-General's audit function status?
 - (b) Will the Auditor-General's functions be extended?

Answer—

The Government has recently demonstrated its commitment to improving the management of all public funds. Earlier this year, the Government introduced the Government Sector Finance Bill and the Government Sector Finance Legislation (Repeal and Amendment) Bill. These Bills include many reforms to improve management and accountability for public funds.

As I stated on the 27 September, 2018, The NSW Labor Party's legislation to introduce Follow the Dollar Laws would have increased the size of Government without proper consideration of whether there are ways to drive better performance. It also risked squeezing out smaller non-government organisations from being able to deliver services on behalf of the Government. It would have discouraged smaller organisations from applying to provide government services at the risk of being burdened by over-regulation and additional paperwork.

*9358 GOVERNMENT'S AGEING STRATEGY—Ms Tania Mihailuk asked the Minister for Mental Health, Minister for Women, and Minister for Ageing—

Considering that the Government announced the Ageing Strategy, has any additional funding been

allocated to community services to assist with implementing these initiatives?

Answer—

In 2018-19, \$8.8 million is budgeted for the Ageing Strategy, including the ageing and advocacy organisations and multiple other activities in the implementation of the Strategy.

This includes:

- The NSW Elder Abuse Helpline and Resource Unit
- A case coordination trial for the NSW Elder Abuse Helpline and Resource Unit
- Expansion of the NSW Seniors Card program
- The Tech Savvy Seniors program.
- NSW Seniors Festival, including the Premier's Gala Concerts and Seniors Festival Expo
- Liveable Communities grants.

The Ageing Strategy Action plans also identify efforts to understand more about the priorities of older people through consultation, research and supporting the operation of advocacy organisations with both in kind and financial resources. Subsequently, new three year Agreement for Funding of Services were approved on 15 February 2017 for the Council on the Ageing NSW (COTA NSW), the Combined Pensioners and Superannuants Association (CPSA), the Older Women's Network NSW (OWN NSW) and the Seniors Rights Service (SRS).

As above additional funding is also provided to other community managed organisations to deliver specific projects under the NSW Ageing Strategy, which are reported in NSW Ageing Strategy Progress Report.

These include:

- Cooking for One or Two project contracted by The Benevolent Society to deliver and program.
- The Getting Active Plan an accessible sports and modified programs led by Family and Community Services and rolling out across New South Wales by partner sporting organisations.
- Global Access Partners taskforce on productive ageing creating innovative projects to retain workers aged 45 to 64.
- Home Modifications Australia and the Healthy Homes information series partnership with Bunnings for home modifications and renovations.
- The Benevolent Society Grandparent Connection intergenerational program.
- *9359 BELMONT TEMPORARY DESALINATION PLANT—Ms Jodie Harrison asked the Minister for Planning, Minister for Housing, and Special Minister for State—

On what date will the Department of Planning provide an outcome for Hunter Water's application to build a temporary desalination plant at Belmont?

Answer-

Hunter Water (the Proponent) has not yet lodged its Environmental Impact Statement (EIS) to enable the assessment of its application for the proposal.

*9360 HUNTER STATE CONTRIBUTION PLAN—Ms Jodie Harrison asked the Minister for Planning, Minister for Housing, and Special Minister for State—

On what date will the Hunter State Contribution Plan be released?

Answer-

The Department is reviewing submissions and undertaking additional studies in response to consultation on the Hunter Region Special Infrastructure Contribution Plan earlier in 2018. Release of the Plan will occur after the Minister for Planning has had an opportunity to consider the submissions.

*9361 FREIGHT NOISE ATTENUATION PROGRAM—Ms Jodie Harrison asked the Minister for Roads, Maritime and Freight—

Considering constituents in the Charlestown electorate who have been approved for the Freight Noise Attenuation Program are yet to have their noise reduction treatments installed, can a more specific timeline for the rollout than "within the next twelve months" be provided?

Answer-

The three remaining homes in the Charlestown electorate that are currently scheduled for treatment will

be completed by the end of 2018.

*9362 PSYCHIATRIC NURSES—Ms Jodie Harrison asked the Minister for Health, and Minister for Medical Research—

What is the Government doing to retain psychiatric nurses in the Public Health System?

*9363 EMERGENCY ACCOMMODATION BUILDING SAFETY—Ms Jodie Harrison asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—

What controls does Housing NSW have to ensure that the buildings providing emergency accommodation for Housing NSW clients are safe, and that Government money is not provided to landlords of "death traps"?

I am advised Family and Community Services (FACS) regularly inspects all of its Temporary Accommodation providers to ensure they are appropriate for clients and seeks the views of police and Domestic and Family Violence service providers regarding the appropriateness of facilities for women and children.

How many people in the Charlestown electorate discharged from the Mater Hospital following a serious attempt of self- harm are followed up by medical staff within 48 hours?

- *9366 GROWTH OF INFILL AREAS—Ms Julia Finn asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—
 - (1) Considering the \$71 million to accommodate growth in infill areas such as Canterbury Town Centre, St Marys and the Greater Parramatta to Olympic Peninsula for infrastructure projects over four years from 2016-17 to 2019-20 in Sydney Water's Growth Servicing Plan, what amount is forecast to be spent in the Granville electorate?
 - (2) From the amount spent in the Granville electorate, what proportion is for:
 - (a) Water supply;
 - (b) Wastewater;
 - (c) Rrecycled water;
 - (d) Stormwater?
 - (3) What additional network infrastructure is forecast to be constructed to support growth in the Greater Parramatta to Olympic Peninsula area?

Sydney Water's existing trunk drinking water, wastewater, and stormwater systems within the Granville electorate generally have sufficient capacity to support the areas' forecasted population growth.

Minor drinking water network augmentation needs have been identified in Wentworthville, at an estimated cost of \$1 million.

Sydney Water does not provide recycled water services to the Granville electorate.

Sydney Water delivers critical water-related infrastructure across Greater Sydney, Blue Mountains and the Illawarra to support the Government's plans for housing and job growth.

Beyond 2020, Sydney Water's long term strategic planning foreshadows investments to amplify drinking water and wastewater infrastructure across the Greater Parramatta to Olympic Peninsula (GPOP) corridor to support growth. Sydney Water is progressing its planning for the GPOP corridor and these investments are subject to further funding approval.

Future investments for GPOP are likely to take place outside the Granville electorate but given the nature of Sydney Water's network system, will similarly serve residents and businesses in the Granville electorate.

Sydney Water regularly reviews and updates its capital investment plan to support the city's growth and optimise timely and cost-effective service delivery.

- *9368 MOBILE PRESCHOOL FUNDING—Ms Kate Washington asked the Minister for Education representing the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education—

- (b) The Yass Service Centre opened on 28 September 2018. All remaining Service NSW locations are scheduled to be completed in 2019.
- (2) All Roads and Maritime Services (RMS) registry employees are invited to apply for all roles at new Service NSW service centres via a priority recruitment process, ensuring they have the first opportunity to secure roles. RMS staff are offered interview training to assist them through this process.

RMS employees who were not successful in obtaining a role with Service NSW were offered redeployment or voluntary redundancy by RMS. Of the employees substantially based at the above mentioned motor registries, 26 took a voluntary redundancy, six transitioned to Service NSW and one was redeployed.

Local resources are supplemented by specialist police who are managed centrally but can be deployed across boundaries to meet the changing community needs and emerging issues. The police will determine where and how their resources will be stationed and utilised to achieve public safety.

- *9393 FRUIT TAMPERING INCIDENTS—Ms Jenny Aitchison asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
