- \*1537 HONEYSUCKLE PRECINCT—Mr Tim Crakanthorp asked the Minister for Planning—
  - (1) How many square metres of land in the Honeysuckle Precinct have been developed?
  - (2) How many square metres of land have not been developed?
  - Answer—

I am advised:

- (1) The Honeysuckle project area consists of 52 hectares, or 520,000 square metres, in total. Of this, approximately 42.5 hectares, or 425,000 square metres has been developed.
- (2) Approximately 9.5 hectares, or 95,000 square metres is yet to be developed, including areas to be developed as open space.

## \*1538 NEWCASTLE AND HUNTER SPECIAL REPORT-Mr Tim Crakanthorp asked the Minister for Planning-

How much did it cost the Government to take part in The Australian Newspaper's 'Newcastle and Hunter Special Report' published on 6 October 2015?

Answer-

I am advised:

The cost for participating in the special report on the Newcastle and Hunter region published on 7 October 2015 was \$38,000 excluding GST. This cost is part of the overall budget for the Revitalising Newcastle community engagement program.

4,500 copies of The Australian are distributed each day to the Hunter region and 41,000 copies are distributed across New South Wales. 5,300 people accessed the online version of the special report in the first 10 days of its publication. Other organisations that participated in the special report included the Port of Newcastle, University of Newcastle and Newcastle Airport.

The exercise represented a value-for-money approach to informing people across the Hunter region of the

Government's efforts to revitalise Newcastle city centre. \*1539 REMEDIATION OF CONTAMINATION—Mr Tim Crakanthorp asked the Minister for Planning— (1) What is the Government doing to expedite the process of remediating the contaminated former AGL gasworks site at Hamilton? (2) What is the Government doing to inform local residents whether their groundwater is safe? Answer I am advised: That this question should be referred to the Minister for the Environment. \*1540 FORMER AGL GASWORKS SITE AT HAMILTON-Mr Tim Crakanthorp asked the Minister for Planning-What support will the Government provide to the families affected by the contamination of the former AGL gasworks site at Hamilton? Answer-I am advised: That this question should be referred to the Minister for the Environment. \*1541 NEWCASTLE LIGHT RAIL—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure-As part of the Government's consultation on the light rail in Newcastle proposed for January 2016: (1) Will the Government consult on whether the residents of the Hunter want the light rail to run down the current rail corridor or Hunter Street? (2) Will the Government listen and follow the preference of the community? Answer-

I am advised:

The light rail route was selected following community consultation and detailed planning. This route will travel east from the new transport interchange at Wickham along the existing rail corridor, before moving south to connect with Hunter Street and Scott Street to travel east to the beach. The route serves the city centre, while avoiding impact on Hunter Street Mall.

The selected light rail route allows for the delivery of connectivity and renewal as well as providing for extensive public amenity including parks, entertainment precincts and public squares.

\*1542 LIGHT RAIL ROLLING STOCK-Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure-

How will the Government best endeavour to obtain tenders from Hunter manufacturers to supply the light rail rolling stock?

Answer—

I am advised:

As stated this Government has committed to use our best endeavours to invite expressions of interest from New South Wales companies for any rolling stock or infrastructure related to the new Newcastle light rail project.

\*1543 EXTENSION OF LIGHT RAIL IN NEWCASTLE—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—

Will the Government be considering stops at the University of Newcastle, the Newcastle Airport, Broadmeadow Sports Precinct and local hospitals as part of the extension of light rail in Newcastle? Answer—

I am advised:

The Government is committed to the long overdue revitalisation of Newcastle. Since 2011, over \$1 billion has been committed to Newcastle and the broader Hunter region for vital new infrastructure, including \$650 million in funds from Restart NSW for projects including Newcastle light rail, urban renewal and the Newcastle Inner City Bypass, and \$350 million for the Hunter Infrastructure Investment Fund for a range of projects across the region.

The next step is to build a vibrant transport network throughout the region to improve connectivity, reduce travel times and support Newcastle's tourism sector. On 5 November, the Government announced it would create Transport for Newcastle and seek a 'world's best' multi-modal transport operator to plan and run Newcastle Light Rail, buses, ferries and interchanges.

The new operator will be based in Newcastle and work hand-in-hand with the community to design and run a better transport network. This will be public transport run in Newcastle, for Novocastrians, not run from Sydney like today.

## \*1544 AVERAGE MONTHLY PATRONAGE—Mr Ryan Park asked the Minister for Transport and Infrastructure—

- (1) What is the current average monthly patronage of the following ferry services:
  - (a) Cronulla and National Park Ferry Cruises;
  - (b) Church Point Ferry;
  - (c) Brooklyn Ferry;
  - (d) Palm Beach Ferry?

(2) When is it anticipated that these customers be able to use OPAL Card?

Answer-

I am advised:

- (1) The current average monthly patronage on those services is 12,393.
- (2) Customers that hold a private ferry pass are able to use their Gold Opal cards on these private ferry services.
- \*1545 LAW ENFORCEMENT REQUESTS-Mr Ryan Park asked the Minister for Transport and Infrastructure-
  - (1) On average, how many law enforcement requests are made to Transport for NSW each month by:(a) The NSW Police Force?
    - (b) The Department of Immigration and Border Protection?
  - (2) How long does it take for a determination to be made to release the information when a law enforcement request is received?

Answer-

I am advised:

TfNSW may only disclose information to a law enforcement agency that isnecessary for law enforcement purposes, for the investigation of an offence, for the enforcement of criminal law or to assist in locating a missing person. Personal information may also be disclosed to prevent or lessen a serious and imminent threat to the life or health of a person.

The vast majority of information requests have been to identify the owner of a stolen card, assist in finding a missing person, or to investigate an offence.

\*1546 TRIPLE ZERO CALLS—Mr Ryan Park asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

Considering that during the October long weekend there were over 70 rescues made on Illawarra beaches and calls to Triple Zero (000) increased:

- (1) What additional staffing allowances are made for holiday periods?
- (2) How many calls to Triple Zero (000) were received between 2 October 2015 and 6 October 2015?
  - (a) How many of these calls were from the Illawarra region?

Answer-

Telstra has responsibility for providing the service which answers calls to Triple Zero and transfers them, with relevant information, to the requested emergency service organisation. Questions about the Triple Zero call service should be addressed to the Federal Minister for Communications.

\*1547 TAXI TRANSPORT SUBSIDY SCHEME—Mr Ryan Park asked the Minister for Transport and Infrastructure—

What is the projected cost for the implementation of the electronic payment system for the Taxi Transport Subsidy Scheme?

Answer-

I am advised:

The release of cost estimates for the Taxi Transport Subsidy Scheme electronic payment system is not possible at this time as this could prejudice the procurement process.

- \*1548 REVENUE FROM PRIVATE ADVERTISING—Mr Ryan Park asked the Minister for Transport and Infrastructure—
  - (1) How much revenue was collected from private advertising on train stations during the 2014-15 financial year?
  - (2) How much revenue was collected from private advertising on buses during the 2014-15 financial year?
  - (3) Was the money collected in (1) and (2) reinvested into the Transport portfolio?

Answer-

I am advised:

Sydney Trains and State Transit contract the rights for private advertising on their assets. The terms of the contracts are commercially sensitive. All revenue received is reinvested in public transport.

- \*1552 DOMESTIC VIOLENCE LIAISON OFFICERS—Ms Kate Washington asked the Minister for Mental Health, Minister for Medical Research, Assistant Minister for Health, Minister for Women, and Minister for the Prevention of Domestic Violence and Sexual Assault—
  - (1) Will one of the 24 extra domestic violence liaison officers (DVLOs) commence work at Port Stephens Local Area Command?
    - (a) If so, when is the additional DVLO expected to commence in Port Stephens?

The allocation and deployment of positions is a matter for the Commissioner of Police.

- \*1553 TRIAL OF DOMESTIC VIOLENCE HIGH RISK OFFENDER TEAMS—Ms Kate Washington asked the Minister for Mental Health, Minister for Medical Research, Assistant Minister for Health, Minister for Women, and Minister for the Prevention of Domestic Violence and Sexual Assault—
  - (1) In what areas will the two Domestic Violence High Risk Offender Teams be trialled in early 2016?
  - (2) How long are the trials expected to run?
  - (3) What assessment criteria will determine their success or not, and therefore their continuance or not?
  - (4) How will the Government determine the order of regions to roll out the Domestic Violence High Risk Offender Teams?

  - (1) Why were Oxley, Shoalhaven, Sutherland and St George Local Area Commands (LACs) chosen as the sites for initial rollout of the Domestic Violence Disclosure Scheme pilots in early 2016?
  - (2) How do the statistics for domestic and family violence offences in those LACs compare with the statistics in Port Stephens LAC?

\*1555 CONTAMINATION ISSUES AT WILLIAMTOWN—Ms Kate Washington asked the Minister for the Environment, Minister for Heritage, and Assistant Minister for Planning—

Why was the Minister made aware of contamination issues at Williamtown in September 2015, when the NSW Environment Protection Authority was made aware of these issues by the Department of Defence in 2012?

#### Answer-

I am advised as follows:

In 2013 the Department of Defence provided information to the EPA and other government agencies, including Port Stephens Council and Hunter Water, which suggested that there was offsite PFOS and PFOA contamination in drain surface water and drain sediments from the RAAF Williamtown site.

In the opinion of the EPA, the information provided to the EPA at that time did not indicate a likely exposure pathway (a route by which the contaminants could find their way to humans) and was not sufficient to draw conclusions from or to raise alarm in the community.

However, the EPA considered that information was of sufficient concern to ask for further testing by the Department of Defence to determine the nature and extent of offsite

contamination and any actual or potential exposure pathways. The EPA requested the Department of Defence to undertake this testing as a matter of priority.

In August 2015, the Department of Defence provided the EPA and other agencies with a draft report confirming that contamination from the Williamtown RAAF base was found in offsite groundwater and biota.

Since this time the EPA has sought to work collaboratively with other Government agencies to respond to the offsite contamination. The Government has also moved quickly to set up an Expert Panel of technical experts in contamination and health to examine the nature and extent of contamination from the Williamtown RAAF base and recommend next step.

\*1556 FULLERTON COVE AND TILLIGERRY CREEK—Ms Kate Washington asked the Minister for the Environment, Minister for Heritage, and Assistant Minister for Planning—

What immediate support and long-term compensation is the Government providing to businesses and families affected by the NSW Environmental Protection Agency's closure of Fullerton Cove and Tilligerry Creek for commercial and recreational fishing which has been extended until 31 October 2015?

Answer—

I am advised as follows:

On the advice of the Williamtown Contamination Independent Expert Panel, the NSW Department of Primary Industries- Fisheries has extended the commercial and recreational fishing suspension in Tilligerry Creek and Fullerton Cove until 30 June 2016. This extension has been put in place pending completion of a comprehensive human health risk assessment by the Department of Defence, which will include extensive sampling and testing of fish, water, meat, fruit and vegetables, dairy, eggs, honey and other crops.

I understand that the Department of Primary Industries supports the waiving of licences while the fishing suspension is in place. The Department is also contributing to a seafood brand building campaign for commercial species and farmed oysters.

In accordance with the polluter pays principle, the EPA advised the Department of Defence of the NSW Government's expectations that it will expeditiously act to compensate NSW communities, businesses and government agencies for the costs arising from this contamination issue.

On 4 November 2015 the Assistant Minister for Defence, the Han Darren Chester MP announced a financial assistance package for commercial fishers adversely affected as a result of contamination from the Williamtown RAAF base. The Business Assistance Payment gives eligible businesses a \$5,000 lump sum to assist with immediate costs. Affected businesses may also be eligible for further hardship payments of up to \$20,000. Commercial fishers affected by the closure may also be eligible for an Income Recovery Subsidy equivalent to the Newstart allowance.

The Government welcomes this initial step to support commercial fishers most affected by this event.

  - (2) Will a study be conducted at Birrong Station to base the approval for upgrade upon as part of the consideration process?
    - (a) If not, why not?
    - (b) If yes, when?

Answer-

I am advised:

In 2012, the Government announced the Transport Access Program which delivers accessible, modern, secure and integrated transport infrastructure where it is needed most. This includes station upgrades, better interchanges, ferry wharf upgrades and commuter car parks.

As part of the 2015-16 Budget, the Government announced it would invest a further \$890 million over the next four years. This includes accessibility upgrades, safety improvements and more commuter car parks.

Stations across the network are currently being assessed to see which ones will be delivered under this program. This assessment process uses evidence-based criteria including current and future patronage, the needs and demographics of customers who use the station, the location of important services such as hospitals or schools and the accessibility of other transport interchanges. A commuter car park at Birrong Station will be considered as part of this process.

\*1560 ADDITIONAL LIGHTING AT BIRRONG STATION—Ms Tania Mihailuk asked the Minister for Transport and Infrastructure—

When will the provision of additional lighting at Birrong Railway Station be considered?

\*1562 ADDITIONAL COMMUTER CAR PARKING—Ms Tania Mihailuk asked the Minister for Transport and Infrastructure—

With reference to the Government's announcement that another 36,000 apartments will be built near train stations on the Bankstown rail line over the next 20 years:

- (1) How much additional commuter car parking will be built around the train stations on Bankstown rail line to accommodate the increase in patronage of these stations?
- (2) Where will the additional commuter car parking be built?

Answer-

I am advised:

I am pleased to advise that as part of the 2015-16 Budget, the Government announced it would invest a further \$890 million in the Transport Access Program over the next four years. Since the program began in 2012, more than 450 projects have been completed or are underway. This includes accessibility upgrades such as lifts and ramps, improved interchanges and new commuter car parks. These improvements make it easier for customers to access public transport and provide a more comfortable travel experience.

Stations across the network are currently being assessed to see which projects will come next. Bankstown Station will be considered as part of this assessment process.

The Transport Access Program is part of the Government's commitment to provide modern, accessible and integrated transport infrastructure across NSW.

\*1563 ADDITIONAL INFRASTRUCTURE ALONG THE BANKSTOWN RAIL LINE CORRIDOR—Ms Tania Mihailuk asked the Minister for Planning—

With reference to the Government's announcement that another 36,000 apartments will be built near train stations on the Bankstown rail line over the next 20 years:

(1) Has the Minister had detailed discussions with the relevant Councils and Members of Parliament to determine the additional infrastructure needs required to support the increase in population along the Bankstown rail line corridor?

Answer—

I am advised:

The Department of Planning and Environment has worked with the three local councils, Government agencies and utility providers to determine the additional infrastructure requirements to support growth in the corridor. The Department undertook a community survey receiving over 700 responses.

A detailed transport investigation has been undertaken for the corridor outlining recommended improvements to public transport and road networks. The Government is investing heavily in the Sydney Metro which will extend along the Bankstown line and provide increased services and capacity.

The strategy is out for public consultation until 22 November 2015. The exhibition material includes an infrastructure schedule for each station precinct.

The Government is investigating a range of funding sources for infrastructure to support the Strategy. This will include mechanisms which enable the Government to share the value uplift created by increased development density and investment in better infrastructure and services.

\*1567 ROSEMEADOW FIRE STATION—Mr Greg Warren asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

Can the Minister confirm that the Rosemeadow Fire Station will not be closed?

Answer-

Fire & Rescue NSW has advised me that currently Rosemeadow Fire Station will remain open.

\*1568 GOVERNMENT SERVICES IN CAMPBELLTOWN—Mr Greg Warren asked the Minister for Finance, Services and Property—

Can the Minister confirm that Campbelltown will not lose any further government services?

Answer—

Services to the Campbelltown community will be directly enhanced as a result of the expansion of the Service NSW network.

Service NSW was established more than two years ago to make it easier for citizens to do business with the Government. More and more customers are transacting online at their convenience. Service NSW is increasing the number of transactions available on its digital service – website and mobile App. Advice and assistance for many transactions is also available on the 24/7 phone number 13 77 88.

When customers do have to transact face-to-face, Service NSW offers a one-stop service with access to more transactions from agencies across Government including Fair Trading licences, birth and marriage certificate applications, NSW Housing rental payments and many more. Before Service NSW, customers in the Campbelltown area would have had to travel to other locations for services that are now available at the Macarthur Service Centre that opened 13 November. I am confident it will be a major success just as centres in Liverpool, Parramatta, Wetherill Park, Blacktown and many more have been.

In addition, to support customers during the transition, a staffed Service NSW Digital Store opened for business on 3 November in the Campbelltown LGA at Macarthur Square.

\*1569 REDEVELOPMENT OF CLAYMORE—Mr Greg Warren asked the Minister for Family and Community Services, and Minister for Social Housing—

What plans remain with timeline for the staged redevelopment of Claymore?

Construction of Stages 1 and 2 commenced in 2015 with planning for further stages underway.

How many of the 24 new domestic violence specialist police officer positions (announced in June 2015) have now been filled?

Answer-

On 14 October 2015 the Government announced a \$60 million package to target perpetrators and support women, men and children who have experienced domestic and family violence. As part of this package, funding has been earmarked to advance the roll out of all Domestic Violence Liaison Officer positions.

- (2) Western Sydney Institute will continue to provide limited delivery of Panel Beating and Spray Painting at Mount Druitt College through TAFE delivered vocational education and training (TVET) in Schools, Indigenous programs and niche commercial activities.

There are a number of factors impacting upon the delivery of Panel Beating and Spray Painting including the downturn in the Automotive Body Repair industry. One of the most influential factors has been the national grading of shops and training standards within the Automotive Body Repair sector by peak industry bodies and insurance companies. This has played a significant role in the decline in the number of independent repairers in the business, which is leading to less employment in the industry.

Whilst there are skill shortages in the automotive industry, there has been a statewide and national decrease in the number of apprentices commencing in the vehicle body repair industry over the past five years. The 2015 Autoskills Australia Environmental Scan indicated that of the respondents to the survey, 57 percent did not employ any apprentices, which is an increase on 2014's 53 percent. Furthermore, only 25 percent of all respondents reported any intention of hiring apprentices over the next 12 months, with the majority of these (60 percent) indicating they intended to hire only one apprentice. This data reinforces the decline in the industry's appetite to emplo pprentices, or upskill existing workers, due to financial constraints.
