\*3989 BANKSTOWN AMBULANCE STATION-Ms Tania Mihailuk asked the Minister for Health-

Are there any plans to sell the site occupied by the Ambulance Station at the corner of Meredith Street and Rickard Road, Bankstown?

#### Answer-

NSW Ambulance sold the Bankstown ambulance station site in 2002 with a lease back arrangement currently in place.

\*3990 PENSIONER REBATES ON COUNCIL RATES—Ms Julia Finn asked the Minister for Local Government—

- (1) What is the annual value of rebates on pensioner's rates from Cumberland Council?
- (2) What was the annual value of rebates for the former Holroyd City Council in 2014-15 and 2015-16?
- (3) What is the annual value of rebates on pensioner's rates from City of Parramatta Council?
- (4) What was the annual value of rebates for the former Parramatta City Council in 2014-15 and 2015-16?
- (5) Will the Minister commit to retaining pensioner rebates at their current level, including any additional rebates by councils?

#### Answer-

The pensioner rebate policies of Cumberland and the City of Parramatta councils are outlined in each council's 2016/17 Operational Plan. It is understood that each council provides the same level of rebates as pensioners were receiving in each former local government area. The general rebate amount available to pensioners is prescribed by section 575 of the Local Government Act 1993.

- \*3991 CTP GREENSLIP INSURANCE-Mr Jamie Parker asked the Minister for Innovation and Better Regulation-
  - (1) Under the proposed changes to Green Slip Insurance:
    - (a) Will motorcycle and scooter riders pay increased premiums compared to the current system?
    - (b) Will premiums reflect the degree of risk to other road users, so that smaller vehicles like motorcycle and scooter riders pay less than large vehicles such as trucks and four wheel drives?

Answer-

(1) (a) The final scheme design is yet to be finalised, however the Government has stated its intention to introduce a risk equalisation mechanism that will ensure a balance between affordability and risk based pricing. This means that the cross-subsidisation of motorcycles by other types of motor vehicles, which exists in the current scheme, will continue in the new scheme.

(b) Green Slip prices are set by the licensed CTP insurers within guidelines set by the State Insurance Regulatory Authority (SIRA), and reflect the cost and frequency of injury claims against a particular vehicle class. While the total number of claims against motorcycles is not high, those claims (which are often made by pillion passengers, other riders or pedestrians) involve more serious injuries than passenger vehicle claims and in turn result in more costly CTP claims.

For example, the average cost of claims involving an at-fault motorcycle rider (all classes) is \$182,000. For motorcycles over 1125cc engine capacity, the current estimated average claims cost is \$220,000. In contrast, the average cost of claims involving an at-fault passenger vehicle is \$107,000.

The Government recognises that, as the CTP scheme is compulsory, there is an obligation to ensure that Green Slips are affordable for all motor vehicle owners in the community. Currently, the CTP scheme uses a community-rating system, which means that lower risk groups pay additional premiums to allow a reduced cost for higher risk groups, such as motorcycle riders.

Without this cross-subsidisation, the cost of Green Slips for motorcycles would be unaffordable. It is estimated that if the Green Slip premium reflected the actual cost of injuries caused by motorcycles, they would pay about 6 to 8 times the price that other motorists pay.

- \*3992 KANGY ANGY RAIL MAINTENANCE FACILITY—Mr David Mehan asked the Minister for Transport and Infrastructure—
  - (1) Has the Minister visited the location of the proposed Kangy Angy Rail Maintenance Facility?

- (2) Has the Minister walked through the wetland located at the site of the Rail Maintenance Facility to experience the depth of water located there?
- (3) How much wetland will be displaced by the Rail Maintenance Facility?
- (4) What arrangements will be put in place, should the facility proceed at Kangy Angy, to protect wildlife located there?
- (5) Does the Minister consider the proposed location of the facility the best place to locate it on the Central Coast?

Answer-

Kangy Angy was selected as the preferred location after a multi criteria assessment including noise, heritage, ecology, engineering, contamination flooding and operational requirements. The Review of Environmental Factors discusses the options development and site selection process.

The proposed site at Kangy Angy is not classified as wetland under the State Environment Planning Policy No 14—Coastal Wetlands.

Wildlife protection is included in the Review of Environmental Factors and Species Impact Statement, available on the Transport for NSW website.

- \*3993 TUGGERAH PUBLIC SCHOOL-Mr David Mehan asked the Minister for Education-
  - (1) Did the Department of Education make a contribution to the road works and street signage associated with the provision of the 'kiss and ride' zone on Fowler Road?
  - (2) Were any undertakings made by Council in relation to the future of the 'kiss and ride' zone?(a) If so, what contributions were made by Council to the 'kiss and ride' zone?
  - (3) Is the Minister satisfied with the pedestrian safety arrangements in place for students attending the school?

Answer-

The Department of Education made a contribution of land for the 'Kiss and Ride' zone.

\*3995 ELECTRONIC SCHOOL SIGNAGE—Mr David Mehan asked the Minister for Education—

- (1) How many public schools in The Entrance electorate have electronic signage displaying the school name and other information?
  - (a) Which schools are these?
- (2) How many use LED type electronic signs?
- (3) How many have been paid for by the Department of Education?
- (4) How many have been paid for by the school community or the Parents and Citizens Association (P&C)?
- (5) How many were partly funded by the Department of Education?
- (6) How many were partly funded by the school community or P&C?

(7) What is the Department of Education policy on provision of school signage and funding of same? Answer—

(1) to (6) The Department of Education does not hold this information centrally.

(7) Under the Department's Educational Facilities Standards and Guidelines, a school sign is to include the name of the school in a prominent position at the main entrance.

- \*3996 LAND OWNED BY ROADS AND MARITIME SERVICES ON BERESFORD AVENUE—Ms Tania Mihailuk asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
  - (1) Will the parcel of land owned by the Roads and Maritime Services (RMS) on Beresford Avenue across from Bankstown North Public School be maintained for operational purposes as a compound site for the foreseeable future?
  - (2) Has the RMS identified this site conversion to any other purpose?
    - (a) If so, what details are available?

Answer-

I refer you to my previous response LA Q1204.

\*3997 PEDESTRIAN COUNTDOWN TIME DISPLAY TRIAL IN THE BANKSTOWN ELECTORATE—Ms Tania Mihailuk asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council(1) Will the Government extend the pedestrian countdown time display trial to locations within the Bankstown electorate, such as the pedestrian crossings outside St Felix Primary School and Bankstown North Public School (crossing the Hume Highway), to improve pedestrian safety during peak school pick up and drop off times?(a) If not, why not?

Answer—

A trial of pedestrian countdown timers was conducted at key high pedestrian locations in Sydney in 2014-15. The trial found that the timers work best at particular types of intersections, and this informed the rollout program.

So far, the Centre for Road Safety has installed pedestrian countdown timers at 36 locations. A further phase of pedestrian countdown timers is currently being developed.

The pedestrian countdown timer program is about keeping pedestrians safe and helping them cross the road in busy built up areas, by telling pedestrians how long they have to cross the road safely.

Pedestrian countdown timers are not generally used in school zones because they have not been trialled and evaluated for their safety effect in locations where there are high numbers of child pedestrians. It is important to get this right as children act differently around the road environment because they have more limited decision making and physical abilities.

The Government is committed to enhancing child pedestrian safety around schools through a comprehensive school based education program, school zones and engineering works.

All schools in New South Wales are now protected by flashing lights, and the Government recently announced 400 schools with multiple entrances that will receive extra set of flashing lights at an estimated cost of \$5 million.

A further \$5 million has been announced for a school zone safety infrastructure program to install raised zebra crossings, safe drop off zones, pedestrian refuges and better signage in school zones.

- \*3998 CLEANERS EMPLOYED AT BANKSTOWN-LIDCOMBE HOSPITAL—Ms Tania Mihailuk asked the Minister for Health—
  - (1) In each of the last 5 years to 14 September 2016, how many full-time equivalent cleaners were employed at Bankstown-Lidcombe Hospital?
    - (a) For each of the above, how many were in 'acting' positions?

Answer—

Local health districts and hospitals vary staffing profiles and numbers to appropriately meet operational needs at any point in time.

At Bankstown-Lidcombe Hospital, cleaning staff are appointed as either permanent, temporary, or casual. Cleaners are never appointed in an 'acting' capacity.

Cleaning responsibilities are not restricted to cleaners. For example, Ward Assistants assist with cleaning beds in addition to their other roles, for example ordering stock.

- \*3999 FLASHING SCHOOL ZONE SIGNS IN THE BANKSTOWN ELECTORATE—Ms Tania Mihailuk asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
  - (1) How much funding under the 2016-17 Road Safety Grants programs will be offered to schools in the Bankstown electorate to install flashing school zone signs?
    - (a) What is the name of each school which will be receiving a new flashing school zone sign under this grant?

Answer-

- (1) The Government has ensured that all schools in NSW, including those in the Bankstown electorate, have at least one set of school zone flashing lights. School zone flashing lights are not eligible for funding under the Road Safety Grants program. However, the Government recently announced a \$5 million program for the installation of additional sets of flashing lights outside at least 400 schools with multiple busy entrances.
  - (a) This information is available on the Centre for Road Safety's website.

\*4000 SCHOOLS IN THE BANKSTOWN ELECTORATE—Ms Tania Mihailuk asked the Minister for Education—

- (1) How does the Government intend to address over utilisation issues at the following schools in the Bankstown electorate:
  - (a) Bankstown South Infants School;
  - (b) Bankstown North Public School;
  - (c) Bankstown Public School;
  - (d) Bankstown South Infants School;
  - (e) Bankstown West Public School;
  - (f) Chester Hill High School;
  - (g) Chester Hill North Public School;
  - (h) Chester Hill Public School;
  - (i) Sefton Infants School;
  - (j) Wattawa Heights Public School;
  - (k) Yagoona Public School?

#### Answer—

The Department of Education monitors population and development trends so that it can plan to meet enrolment needs in schools across New South Wales. To do so, the Department regularly consults with the Department of Planning and Environment, local Councils, Urban Growth NSW and local developers.

The Department uses numerous strategies to manage fluctuating enrolment demands in the short to medium term including enforcing the Department's school enrolment policy to restrict out of area enrolments, reviewing school catchment boundaries to improve utilisation across schools in a local area, and providing additional facilities- classrooms and specialist spaces as required.

# \*4001 BANKSTOWN LIDCOMBE HOSPITAL SHUTTLE BUS—Ms Tania Mihailuk asked the Minister for Health—

- (1) What was the outcome of a proposal by the South Western Sydney Local Health District to commence a shuttle bus between Bankstown-Lidcombe Hospital and the Bankstown Paceway to address parking concerns?
- (2) When will this shuttle service commence?
  - (a) If it is not to commence, why not?

#### Answer-

The availability of car parking spaces for patients, visitors and staff of Bankstown-Lidcombe Hospital is a priority for the South Western Sydney Local Health District. The District is currently investigating other off site car parking options around Bankstown-Lidcombe Hospital.

The SWSLHD is investigating other offsite parking options around Bankstown-Lidcombe Hospital to address the car parking limitations at the Hospital.

Other measures have included;

In 2014, the Hospital increased the number of spaces reserved for people with disabilities.

A dedicated five minute set down and pick up zone at the main entrance to the Hospital.

Regular spot checks conducted by security staff in relation to car park access for both staff and patients. This is to ensure that special parking zones ie disabled and five minute, are correctly utilised.

\*4002 CAPACITY OF SCHOOLS IN THE MAITLAND ELECTORATE—Ms Jenny Aitchison asked the Minister for Education—

Answer-

Every student who wishes to attend a New South Wales government school will be given a place at their local school. Accordingly, the Department of Education does not have fixed enrolment capacities at New South Wales government schools.

- \*4008 PORT OF NEWCASTLE—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
  - (1) Has the operator of the Port of Newcastle entered into an agreement for the development of a container terminal at the Port of Newcastle?
  - (2) If a container terminal was developed in Newcastle during this term of Government, does the Government plan to charge the port operator, or the operator of the container terminal, a fee for container movements?
  - (3) Did the Government claim immunity from the Commonwealth Competition and Consumer Act 2010 in respect of the Term Sheets with Newcastle Stevedores Consortium?

Answer—

- (1) This is a matter for the operator of the Port of Newcastle.
- (2) and (3) No.
- \*4009 START STRONG IMPLEMENTATION—Ms Kate Washington asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, and Assistant Minister for Education—
  - (1) Under the Start Strong funding model, has the Department conducted modelling on the impact of this funding change?
    - (a) If so, how many centres would receive equal or less funding than they currently receive if their enrolment remains at current levels?
    - (b) If so, how many centres would receive additional funding than they currently receive if their enrolment remains at current levels?

Answer-

(1) Yes.

- (1) (a) and (1) (b) Service-level funding outcomes will vary according to enrolment profiles in 2017.
- \*4010 SUPPORT FOR PRESCHOOLS—Ms Kate Washington asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, and Assistant Minister for Education—
  - (1) When will the full details of the new Start Strong funding model be released?
  - (2) How will these details be released?
  - (3) What support will the Department be offering to preschools to adapt to the new Start Strong funding model?
  - (4) How many preschools have requested support or advice from the Department regarding the new funding model?

Answer-

(1) and (2) Full details of Start Strong were released on the Department's website on the 14 September 2016.

(3) In addition to the website, the following resources are available:

- A dedicated Start Strong enquiries telephone hotline and email address.
- A Start Strong e-hub on the Preschools NSW website (http://www.preschoolsnsw.org.au/).
- A new funding calculator so services can estimate their funding under Start Strong.

(4) As at 21 September 2016, thirteen emails had been received and over 100 phone calls taken on the Start Strong enquiries telephone hotline.

- \*4011 FUNDING CHANGES—Ms Kate Washington asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, and Assistant Minister for Education—
  - (1) How many preschool funding announcements has the Department or Minister made since the launch of the Preschool Funding Model in 2013?
  - (2) How many changes have been made to the Preschool Funding Model since its announcement in 2013?

(3) Was the Preschool Funding Model based on funding models in other jurisdictions?

Answer-

- (1) Six.
- (2) There have been no substantial changes to the PFM since its announcement in 2013.
- (3) The PFM was developed in response to the recommendations of Professor Brennan's review of NSW Government Funding for Early Childhood Education.
- \*4013 START STRONG FUNDING—Ms Kate Washington asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, and Assistant Minister for Education—
  - (1) Of the \$115 million allocated under the Start Strong policy:

Answer—

- (1) The \$115 million allocated under Start Strong is funded from the National Partnership Agreement on Universal Access to Early Childhood Education.
- (2) All funding received from the Commonwealth under the National Partnership Agreement on Universal Access to Early Childhood Education has been fully allocated.
- (3) Stakeholders from the Community Preschool sector and Long Day Care sector.

Answer—

(1) and (2) Employee related and administration costs are funded from the operational expenses budget allocated each year to the Department of Education Early Childhood Education Directorate.

- \*4015 WENTWORTHVILLE RAILWAY STATION UPGRADE—Ms Julia Finn asked the Minister for Transport and Infrastructure—
  - (1) What progress has been made in upgrading Wentworthville Railway Station since LA Question on Notice 1447 (December 2015)?
  - (2) When will the following works be completed:
    - (a) Roofing works to station concourse;
    - (b) Platform canopy installation;
    - (c) Works to station buildings including waiting rooms and family accessible toilet;
    - (d) Resurfacing works to Platforms One and Four?
  - (3) What ongoing consultation with commuters is being undertaken while construction is progressing?
  - (4) How many construction-related complaints have been received since the commencement of construction?
  - (5) When will the upgraded Wentworthville facilities be operational?

Answer-

- (1) Information on the progress of the upgrade is available on the Transport for NSW website.
- (2) Works will be opened in stages as they are completed.
- (3) Monthly notifications are distributed to the local community about upcoming works. Further, community engagement representatives regularly meet with local residents, businesses and other key stakeholders to discuss the progress of construction.
- (4) Five.
- (5) Late 2017, weather permitting.
- \*4016 TRANSPORT HERITAGE NSW BROADMEADOW SITE—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—
  - (1) Why have none of the recommendations from the 2013 report relating to the Broadmeadow Transport Heritage NSW site been implemented?
  - (2) The report recommended increasing community engagement through increased training and education programs, can the Minister advise when this will be implemented?
  - (3) Why is the Government considering the sale of the former railway land surrounding the current heritage area at Broadmeadow?
    - (a) Why has this process been conducted without community consultation?
  - (4) Is the Government currently considering the demolition of the large Administration and Amenities Building at the site?
    - (a) If so, why?
  - (5) Are the requests from third parties to visit the site being provided to the Transport Heritage team at the Broadmeadow site?

Answer—

- (1) A staged review of relevant government heritage rail assets is currently underway. This review will determine the current and future needs of the heritage assets in the custody of rail heritage organisations, and the opportunities presented by the Broadmeadow site to complement those needs. Site-specific master planning will take place once this review is complete.
- (2) Community engagement with the State's rail heritage sector is being pursued through a number of strategies, including training and education. Transport Heritage NSW was established, as a non-government entity, as a result of the Report to work with and support heritage transport organisations to promote understanding of heritage activities and train volunteers in their local areas. Transport Heritage NSW has recently appointed a Volunteer Program Coordinator, who will also overview training activities.

- (3) The residual railway land was approved for disposal in October 2012. This land does not form part of the Broadmeadow Locomotive Depot heritage precinct covered under the Master Custody Management Agreement with Transport Heritage NSW. Any future development on this land would be subject to standard planning consultation.
- (4) Yes. The Administration and Amenities building is not heritage listed and is in a very dilapidated and vandalised condition. In addition, the building contains asbestos insulation and debris and other hazardous materials.
- (5) If Transport Heritage NSW received a direct request to access the site then subject to the purpose of the access and any safety requirements being met, access would be granted. However, the site is not suitable for general public access.
- \*4017 START STRONG LONG DAY CARE FUNDING—Ms Kate Washington asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, and Assistant Minister for Education—

Is the \$30 million allocated to Long Day Care centres announced as part of the Start Strong policy in addition to the funding currently received by Long Day Care centres, or does it replace the current funding arrangements?

Answer-

Funding for Long Day Care (LDC) centres under Start Strong complements the payments made under the LDC National Partnership Grants Program, and is in addition to the not-for-profit LDC Grants program.

- \*4018 BEES AND PESTICIDES—Mr Alex Greenwich asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—
  - (1) What assessment has the Government made of the health of bee colonies in New South Wales since 2013?
  - (2) What assessment has the Government made of the dangers of neonicotinoids?
  - (3) Is it true that the evidence shows that low doses of these pesticides have been shown to kill honeybee larvae and affect bees' navigation abilities?
  - (4) What is the current evidence about the impacts of long-term pesticide exposure on bee populations from nectar and/or pollen?
  - (5) Is it true that industry research on these pesticide impacts has been questioned?(a) What assessment has the Government made of its validity?
  - (6) What assessment has the Government made about these risks since the response to LA Q3884 in June 2013?
    - (a) What action has the Government taken to ensure that pesticides do not impact on bees and crop pollination since then?
  - (7) What liaison has been carried out with other states and territories and the Commonwealth about the safety of neonicotinoids?
  - (8) What further action will the Government take to protect bees and crop pollination?

Answer-

- (1) NSW Department of Primary Industries (DPI) contributed to a report published by the Australian Pesticides and Veterinary Medicines Authority (APVMA) in 2014 titled Neonicotinoids and the Health of Honey Bees in Australia.
- (2) In 2014, NSW DPI contributed to a report published by APVMA titled Neonicotinoids and the Health of Honey Bees in Australia.
- (3) There is some evidence in international research that suggests sub-lethal effects on larvae and disorientation of old bees.
- (4) There is limited evidence available but it can be assumed that cumulative exposure would be deleterious.
- (5) The Government is not aware of such accusations.

Three preliminary options have been developed for the proposed marina. They are currently on display for community consultation which closes on Sunday, 16 October 2016.
