- *6342 BUSES REPLACING TRAINS INTO NEWCASTLE—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—
 - (1) How many car parks will be lost at Hamilton to accommodate the buses transporting passengers following the truncation of the rail line into Newcastle?
 - (2) How long will the trip from Cardiff to Newcastle Railway Station take under the new train and bus system?
 - (a) How long did this trip previously take by train alone?
 - (3) How long will the trip take from Maitland to Newcastle Railway Station under the new train and bus system?
 - (a) How long did this trip previously take by train alone?
 - (4) How often will buses run from Hamilton Railway Station in off peak times?

Answer-

I am advised:

- (1) No commuter car parking will be lost at Hamilton.
- (2) and (3) Customers will be able to plan their journey, including travel times, by visiting transportnsw.info or calling 131 500.
- (2) (a) and (3) (a) Current timetable information is available at transportnsw.info or by calling 131 500.
- (4) Buses will run every 10 to 15 minutes to meet every train.
- *6343 2014 HUNTER REGIONAL TRANSPORT PLAN—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—
 - (1) What is the current status and cost of the project in the Lake Macquarie LGA with the description "Fernleigh Track extension: strategic concept development of cycleway provisions connecting the Fernleigh Track and the Pacific Highway cycleway (Belmont)", listed in the 2014 Hunter Regional Transport Plan under the Traffic Management and Road Safety Program with the status "commenced October 2013" and a cost of \$100,000?
 - (2) What is the current status and cost of the project in the Newcastle LGA with the description "Griffiths Road and Lloyd Road, Lambton", listed in the 2014 Hunter Regional Transport Plan under the Traffic Management and Road Safety Program with the status "commenced July 2013" and a cost of \$1,000,000?
 - (3) What is the current status and cost of the project in the Newcastle LGA with the description "Install incident response shed Hexham on Pacific Highway", listed in the 2014 Hunter Regional Transport Plan under the Traffic Management and Road Safety Program with the status "commenced August 2013" and a cost of \$100,000?

Answer-

I am advised:

- (1) Lake Macquarie City Council has completed design work and has not yet submitted a proposal for construction to Roads and Maritime Services.
- (2) and (3) This is a matter for the Minister for Roads and Freight.
- *6344 WICKHAM BUS TIMETABLES—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—
 - (1) Has the Minister determined the timetables for buses that will replace trains following the truncation of the rail line at Wickham?
 - (a) If not, when will these timetables be available?

Answer-

The replacement bus plan was released on 21 October.

- *6345 MEDIAN WAITING TIMES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) Why is the median waiting time for New South Wales hospital patients for key procedures considerably longer than the national median waiting time?

(2) What action is being taken to improve waiting times for key procedures such as knee replacement, tonsil removal, cataract removal, ear, nose and throat surgery, and general orthopaedic surgery at the John Hunter, Belmont and Maitland Hospitals?

Answer-

I am advised:

(1) and (2) The Australian Institute for Health and Welfare's report into 2012-13 elective surgery waiting times revealed New South Wales was the best performing state for the total combined percentage of surgeries performed on time.

The Hunter New England Local Health District is implementing a number of strategies to further reduce wait times for patients requiring surgery.

- *6346 JOHN HUNTER HOSPITAL EYE CLINIC—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) Is the eye clinic at the John Hunter Hospital now fully operational?
 - (a) If so, how many days per week does it operate?
 - (2) How many ophthalmologists are working at the eye clinic?
 - (3) How many patients have been seen by the eye clinic since it re-opened?

Answer-

I am advised:

- (1) The John Hunter Hospital outpatient ophthalmology clinic reopened on 26 August 2014.
- (2) Eight ophthalmologists are currently providing services.
- (3) Since it's reopening, 627 patients have been seen.
- *6347 FUTURE LOWER HUNTER HOSPITAL—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) Will the future Lower Hunter Hospital be a public hospital fully funded by the New South Wales and Federal Governments?
 - (a) If not, how will it be funded?

Answer-

I am advised:

The Government will make a determination on the procurement model once the final business case has been submitted.

- *6348 TAFE FEES—Ms Sonia Hornery asked the Minister for Education—
 - (1) Will the Government support capping TAFE fees at the 2014 rate?
 - (a) If not, why not?

Answer-

- (1) From 1 January 2015, Smart and Skilled will introduce new fees for students enrolled in government subsidised qualifications. All approved training organisations delivering government subsidised training, including TAFE NSW, will charge the same fees.
- *6349 NATIONAL DISABILITY INSURANCE SCHEME TRIAL SITES—Ms Sonia Hornery asked the Minister for Family and Community Services representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—
 - (1) Has all of the funding previously allocated under the Home and Community Care program via the Community Care Support Program now been allocated to the National Disability Insurance Scheme (NDIS) trial sites?
 - (a) If so, why?
 - (2) What funding or programs are now available at the trial sites for the NDIS for those under 65 that need support for showering and house cleaning?

Answer—

I am advised:

(1) and (2) As individuals transition to the NDIS in the Hunter, the funding associated with the services accessed by that individual, including services under the Community Care Supports Program

(CCSP), will be used to contribute to the Scheme. There is no change in funding arrangements for people in receipt of CCSP funded supports who have not yet transitioned to the NDIS.

The NDIS is based on the principle of each person with disability being able to have full choice and control over their life. The types of supports provided through the CCSP will form a key part of the NDIS.

As people with disability transition into the NDIS they will be able to access the reasonable and necessary supports that they require.

- *6350 DRIVER LICENCE TESTING OFFICERS—Ms Sonia Hornery asked the Minister for Finance and Services—
 - (1) Has there been a reduction in the number of testing officers conducting driving tests for P1 licences at the Roads and Maritime Services (RMS) centres in the Newcastle, Charlestown and Wallsend electorates?
 - (2) Has the reduction in full-time equivalent (FTE) RMS staff from 3900 in 2011-12 to 3074 in 2013-14 resulted in a reduced number of testing officers?
 - (a) If so, is this reduction in testing officer numbers a result of efficiency savings?

Answer—

There has been some natural attrition in driver tester ranks in the Hunter region. Importantly customers have not been impacted.

*6351 RESPONSE TO OMBUDSMAN'S REPORT—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What is the Attorney General's response to the recommendations in the Report of the Ombudsman dated August 2014 entitled "Policing Intoxicated and Disorderly Conduct: Review of Section 9 of the Summary Offences Act"?

Answer-

I am advised:

The Government is currently considering these recommendations.

*6352 LIVERPOOL LOCAL COURT—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

When will five magistrates sit at the Local Court at Liverpool thus utilising the five court rooms there?

Answer—

I am advised:

The sittings of the Local Court are a matter for the Chief Magistrate pursuant to the Local Court Act 2007.

- *6353 JOHN MORONY CORRECTIONAL CENTRE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) Will the new fence at John Morony Correctional Centre be completed?
 - (a) If so, when?

Answer—

I am advised:

There is no plan for a new fence at the John Morony Correctional Centre. Installation of an additional maximum security fence with anti-climb barrel top is currently underway at the Outer Metropolitan Multi-Purpose Correctional Centre, located within the John Morony Correctional Complex near Windsor. This fencing is due to be completed shortly.

- *6354 PROTECTION FROM CONVICTED TERRORISM OFFENDERS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) What steps have been taken by Corrective Services NSW in relation to convicted terrorism offenders to protect staff from any special risks arising from such offenders?
 - (2) What special steps, if any, will Corrective Services NSW take to ensure the secure imprisonment of convicted terrorism offenders?

Answer-

I am advised:

- (1) Inmates received into Corrective Services NSW custody who have been charged or convicted of an offence connected with terrorist activities are initially classified and managed under the regime developed for that classification (AA male or Category 5 female). The management regime, which was developed to ensure the safety of staff and the security of the correctional centre, places strict controls on the inmate's cell placement, movements, mail and telephone contact and visits.
- (2) Inmates convicted of terrorism related activities who are classified as AA or Category 5 are at all times confined in special facilities within a secure physical barrier that includes towers or electronic surveillance equipment.
- *6355 COMPUTERISED OPERATIONAL POLICING SYSTEM—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Why don't Sheriff's Officers have access to the Computerised Operational Policing System (COPS) where appropriate to enable them to carry out their duties?

Answer_

I am advised:

Although COPS is the property of the NSW Police Force, Sheriff's Officers can receive relevant information from COPS through the NSW Police Force regarding a person of interest.

- *6356 SHERIFF'S OFFICE BUDGET—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) Has the budget of the Sheriff's Office been reduced by \$3.2 million?
 - (a) What will this mean?

Answer-

I am advised:

(1) No.

*6357 SHERIFF'S OFFICERS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Why can't Sheriff's Officers be trained and sworn in as Special Constables?

Answer-

I am advised:

The Court Security Act 2005, the Uniform Civil Procedure Rules 2005, the Civil Procedure Act 2005 and the Sheriff Act 2005 provide Sheriff's Officers with sufficient powers and authorities appropriate to their functions.

- *6360 BARBED WIRE FENCING—Mr Ryan Park asked the Minister for Education—
 - (1) Do any schools in New South Wales have barbed wire fencing?
 - (a) If so, which schools?

Answer-

The Department does not hold this data centrally.

- *6361 COMPENSATION PAYMENTS—Mr Ryan Park asked the Minister for Education—
 - (1) How much did the Government pay in compensation to victims of bullying and other forms of harassment which occurred in New South Wales public schools in the 2013-14 financial year?
 - (2) How much did the Government pay for psychological injury compensation claims to current and former staff in the 2013-14 financial year?
 - (3) What was the largest monetary compensation payment awarded in the New South Wales public school system in the 2013-14 financial year?
 - (a) What incident led to this payment?

Answer-

- (1) Compensation paid does not necessarily correlate with substantiated complaints of bullying or harassment.
- (2) An accurate figure cannot be given as costs include the amount paid to date and an estimated future
- (3) The Department's largest monetary workers compensation payment was a lump sum whole person

impairment payment of \$265,000 paid on 16 December 2013.

- (a) This lump sum payment arose from an injury sustained by an employee while travelling to their place of employment.
- *6362 CAR SHARING APPLICATIONS—Mr Ryan Park asked the Minister for Transport, and Minister for the Hunter—
 - (1) When will the Minister undertake formal consultation with the community regarding car sharing applications such as Uber?
 - (2) How will the Government regulate these types of applications?

Answer-

I am advised:

Consultation will occur as part of the development of regulations for the Passenger Transport Act 2014.

- *6363 CANE TOADS IN THE SUTHERLAND SHIRE—Mr Barry Collier asked the Minister for the Environment, Minister for Heritage, Minister for the Central Coast, and Assistant Minister for Planning—
 - (1) What is the estimated size of the cane toad population at Taren Point in the Sutherland Shire?
 - (2) What is the estimated size of the area covered by the cane toad population at Taren Point in the Sutherland Shire?
 - (3) Are there any other known cane toad colonies in the Sutherland Shire?
 - (4) What action is the Government taking to eradicate the presence of cane toads in the Sutherland Shire?

Answer—

I am advised as follows:

- (1) It is not possible to provide a definitive size for the Taren Point population however I am advised that no cane toads have been detected in the eight monitoring events that have taken place since 30 July 2014. As such, the population of Cane Toads appears to be small and no breeding appears to have occurred in 2014.
- (2) The Cane Toads have been found within an area of approximately 1.5 square kilometers.
- (3) No
- (4) A Cane Toad Working Group was established in 2010 comprising specialists from relevant state government agencies and Sutherland Shire Council. The working group prepared a strategy for the containment and control of Cane Toads at Taren Point. Key actions include regular monitoring of potential shelter sites and breeding areas and the removal of any detected animals.
- *6364 SELECT COMMITTEE ON THE MOTOR VEHICLE REPAIR INDUSTRY—Ms Tania Mihailuk asked the Minister for Finance and Services representing the Minister for Fair Trading—
 - (1) What action has been taken to implement the recommendations of the Select Committee on the Motor Vehicle Repair Industry that reported on 2 July 2014?
 - (2) How much has been spent on the action taken, including the cost of staff time and other resources, as at 21 October 2014?

Answer-

The Government is currently actively considering the recommendations of the Select Committee on the Motor Vehicle Repair Industry. A Government's response to the Inquiry is due to be provided by 2 January 2015.

- *6365 SALE OF HERITAGE BUILDINGS IN MILLERS POINT—Mr Alex Greenwich asked the Minister for Family and Community Services—
 - (1) Are the Conservation Management Plans that apply to social housing properties being sold in Millers Point, Dawes Point and The Rocks legally binding?
 - (2) Do purchasers of these properties have a legal obligation to undertake specific heritage conservation works on individual properties?

- (3) What legal requirements apply for new owners of these properties to restore and conserve individual properties?
- (4) What provisions apply to prevent these properties from being purchased and left to fall into disrepair or be demolished?
- (5) Will the Government legislate against the sale of the registered freehold title of each of these properties to protect the heritage of the buildings?
- (6) What other action will the Government take to protect heritage buildings in Millers Point, Dawes Point and The Rocks?

Answer-

I am advised by the Department of Family and Community Services that the heritage properties in Millers Point are sold with approved Conservation Management Plans (CMPs). The CMPs, which are endorsed by the Heritage Council, are attached to contracts of sale and detail the restorations and improvements permissible to the properties. Any changes to properties outside that specified in the CMPs require the approval of the City of Sydney and the Heritage Council.

- *6366 INQUIRY INTO SOCIAL, PUBLIC AND AFFORDABLE HOUSING—Mr Alex Greenwich asked the Minister for Family and Community Services—
 - (1) Will the Government halt tenant relocations and property sales in the Millers Point, Dawes Point and The Rocks precinct until the development of the assets portfolio strategy recommended by the Inquiry into Social, Public and Affordable Housing?
 - (2) How will the Government ensure that sale decisions are consistent with strategic policy, make the best use of public assets and comply with obligations under the Housing Act to provide housing to those in need?
 - (3) How will the Government ensure all funds from the sale of these properties are used to buy or build additional social housing as recommended in the Inquiry?
 - (4) Will the Government retain community housing properties in this precinct as listed in recommendation 21 of the Inquiry report?
 - (5) Will the Government transfer management of social housing properties in this precinct to Community Housing providers?
 - (6) Will the Government retain multi-unit dwellings such as the Sirius building for social housing, as indicated in recommendation 3 of the Inquiry report?
 - (7) Will the Government retain purpose-built social housing such as the Cumberland and High Street properties, as indicated in recommendation 4 of the Inquiry report?
 - (8) What other action will the Government take to implement the recommendations resulting from the Inquiry into Social, Public and Affordable Housing report in Millers Point, Dawes Point and The Rocks?

Answer-

The Government's response to the Inquiry into Social, Public and Affordable Housing is due by March 2015. The Government is considering the Inquiry Committee's recommendations.

- *6367 DARLING HOUSE AGED CARE FACILITY—Mr Alex Greenwich asked the Minister for Family and Community Services—
 - (1) Will there be a substantial increase in rent for the Darling House Aged Care facility in Dawes Point?
 - (a) If so, what will be the size of the rent increase?
 - (b) If so, when will this rent increase apply?
 - (c) If so, what notice was given regarding this rent increase?
 - (2) When did the lease for the Darling House Aged Care facility expire?
 - (3) Will the rent increase make the service of the Darling House Aged Care facility unviable and thereby result in the closure of the facility?
 - (a) If so, what are the reasons for allowing the closure of this facility?
 - (4) How has the Government helped Darling House identify ways to continue to provide the service?
 - (5) How has the Government helped to ensure that the frail aged residents at Darling House retain their homes?
 - (6) Will the Government review this rent increase in order to allow the service to continue?
 - (7) What other action will the Government take to help the Darling House Aged Care facility?

Answer-

I am advised by the Department of Family and Community Services that Darling House intends to close its facility in early 2015. Further matters relating to Darling House should be directed to the Board of Darling House.

*6368 TAFE OUTREACH PROGRAMS—Mr Alex Greenwich asked the Minister for Education—

- (1) How many students in New South Wales took part in TAFE Outreach programs from 2010 to 2014?
- (2) How many students took part in TAFE Outreach programs through Ultimo TAFE from 2010 to 2014?
- (3) How many students are expected to participate in TAFE Outreach programs in 2015?
- (4) What changes will the Government make to these Outreach programs and the teaching of these courses?
- (5) How will the Government ensure continued operation of TAFE Outreach classes?
- (6) How will any changes made to the Outreach programs ensure continued access to TAFE for disadvantaged and marginalised groups and students who have previously been excluded from education?
- (7) What changes will be made to TAFE Outreach staffing?
 - (a) How will these changes impact on existing teachers and coordinators?
- (8) Has the minimum qualification for Outreach staff been downgraded from a degree to a Certificate 4 qualification?
 - (a) If so, what are the reasons for this change?
- (9) How will the Government ensure that qualified, experienced and expert Outreach staff are retained?
- (10) What plans does the Government have to contract Outreach programs outside of TAFE colleges?
- (11) What further action will the Government take to maintain second chance education through TAFE Outreach?

Answer—

(1) TAFE NSW data is recorded by the number of enrolments, not students.

The number of enrolments in TAFE NSW Outreach Programs is below:

- (2) TAFE NSW enrolments by campus are not publicly available.
- (3) The number of students expected to participate in TAFE NSW outreach programs in 2015 is unknown.
- (4) to (6) and (11) Under Smart and Skilled, disadvantaged learners will continue to be supported through provision of basic language, literacy, numeracy and computer skills (foundation skills training) and prevocational training delivered by TAFE NSW and approved Adult and Community Education providers.

TAFE NSW will receive community service obligation funding to support the Government's expectation that Institutes will provide additional support to meet the needs of disadvantaged students.

Approved training organisations, including TAFE NSW, will also receive additional funding to support training for their disadvantaged students.

Students from disadvantaged groups will also continue to be eligible for fee concessions and exemptions when Smart and Skilled reforms commence from 2015.

- (7) TAFE NSW is changing and becoming more responsive to the way students want to learn and what employers expect. TAFE NSW Institutes regularly review and adjust their training delivery and course offerings to meet the needs of students, industry and the community.
- (8) All TAFE NSW teachers, including those who teach Outreach programs must meet the standards for registered training organisations. As a minimum, teachers must hold the Certificate IV in Training and Assessment for the Training and Education Training package.
- (9) To ensure an adequate supply of teachers with the skills to meet its needs, TAFE NSW undertakes regular workforce planning, including initiatives to attract and retain teachers.
- (10) In 2015, foundation skills and pre-vocational training will be provided by TAFE NSW and approved Adult and Community Education providers.

- *6369 SEX EDUCATION FOR HIGH SCHOOL STUDENTS—Mr Alex Greenwich asked the Minister for Education—
 - (1) What programs does the Government provide for high school students to learn about sex and sexuality?
 - (2) How do these programs include information and skills for students to understand and negotiate safe sex?
 - (3) How do these programs include bisexuality?
 - (4) How do these programs include homosexuality?
 - (5) How do these programs include transgender identity?
 - (6) How do these programs include intersex status?
 - (7) What plans does the Government have to ensure these programs are inclusive and that students learn about the diversity of human sexuality?
 - (8) What further action will the Government take to provide a more inclusive sex education curriculum? Answer—
 - (1) In Year 11 and/or 12, students in government schools participate in Crossroads. Crossroads is a mandatory 25 hour course designed to help senior students address issues of health, safety and wellbeing, including sex and sexuality at a time when they face significant changes and challenges in their lives.
 - (2) Teachers implement the Crossroads course through the use of evidence based resources and teaching and learning materials, provided by key stakeholder groups, that enable students to understand and negotiate safe sex.
 - (3) to (6) The Crossroads course for students in Years 11 and/or 12 explores aspects of identity with a focus on gender and sexual identities. Students explore factors that influence gender and sexual identities including diversity, cultural values, discrimination and addressing homophobia and transphobia.
 - (7) In 2014, the Department of Education and Communities revised the content and delivery of the Crossroads course in consultation with key stakeholder groups. The revised content has a strengthened focus on inclusivity, sexuality and sexual health. This revised content will be implemented in government schools from 2015.
 - (8) In New South Wales, sex education for all students is included in the mandatory Personal Development, Health and Physical Education (PDHPE) curriculum. It is provided within the broader context of growth and development, positive relationships and safe and healthy choices.

In the PDHPE high school curriculum, an inclusive and age-appropriate approach to sex education includes learning about rights and responsibilities in relationships, planning and managing sexual health and strategies to support young people to keep safe, including specific reference to sex-based harassment and homophobic bullying, affirming sexual diversity and the impact of discrimination.

The PDHPE curriculum was developed following extensive consultation with education stakeholders and relevant health experts and agencies.

The Board of Studies, Teaching and Educational Standards (BOSTES) evaluates its syllabuses on an annual basis to ensure that they continue to meet the needs of all students in New South Wales schools.

BOSTES is committed to ensuring that any future New South Wales PDHPE syllabus incorporates the existing strengths of the current New South Wales PDHPE syllabus and through extensive consultation with education stakeholders and relevant experts and agencies will ensure that it is inclusive of all students.

- *6370 GAY HATE CRIMES—Mr Alex Greenwich asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—
 - (1) How many of the NSW Police Force's Unsolved Homicide Team cases relating to gay hate crimes from the 1980's and 1990's will be re-investigated?
 - (a) What new rewards have been offered for information contributing to these investigations?
 - (b) How many of these cases have had new evidence or information provided?
 - (c) What resources are available to the Unsolved Homicide Team for this work?
 - (2) How will the Government ensure a full review of possible gay hate crimes?
 - (3) What assessment has the Government made of allegations about the involvement at that time of some police officers in assaults of people perceived as homosexual?
 - (4) How will the Government ensure that the community can have full confidence that police officers will respond appropriately to anyone reporting crime or anti-social behaviour irrespective of gender, race, ethnicity, sexuality and disability?

(5) What other action will the Government take to ensure thorough investigation of these concerns? Answer—

The NSW Police Force has advised me:

- (1) All unsolved homicide matters are reviewed and prioritised according to police protocols, regardless of the characteristics of each matter. It is not possible to indicate how many cases will be reinvestigated. The Unsolved Homicide Team (UHT) has previously called for anyone with evidence relating to alleged 'gay hate' homicides to come forward.
 - The UHT has applied for a number of NSW Government rewards since its inception in 2008, including rewards for matters where it is believed that 'gay hate' bias or motivation may have been a contributory factor. The offer of a reward in a number of these cases has resulted in new information being received which has then been assessed for significance and validity.
- (2) A review is currently being conducted within the Operational Programs Command to determine if sexual orientation bias was a motivating factor in crimes reported during the 1980s and 1990s.
- (3) Surry Hills Local Area Command has conducted a thorough investigation into particular allegations made in 1989. No evidence was found to implicate police involvement in an assault. Any other such allegations will be investigated.
- (4) and (5) The NSW Police Force definition of a bias crime incident incorporates gender, culture, religion, sexuality and orientation, age and disability. Bias crime awareness is presently being delivered to frontline police and is incorporated in a range of training packages and courses.
 - The Corporate Sponsor for Bias Motivated Crimes is responsible for raising awareness of these crimes and related issues, and complements the work of the corporate Sponsor for Sexuality and Gender Diversity. The Bias Crimes Coordinator position in Operational Programs was established to manage the police response to bias crimes, provide investigative support and coordinate specialised training. These add to the work done by the Gay & Lesbian Liaison Officer program over the past 25 years.
- *6371 MARDI GRAS POLICING—Mr Alex Greenwich asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—
 - (1) What was the outcome of the court cases resulting from incidents involving police officers at the 2013 Mardi Gras festival and what charges were upheld?
 - (a) What action has been taken with the officers involved?
 - (b) What action has been taken to ensure that police officers do not behave in this way in future?
 - (2) What community feedback was obtained regarding the agreement made between the Government and LGBTI organisations for the 2014 Mardi Gras?
 - (3) Is the Government committed to renewing and maintaining this agreement and a community policing approach to the Mardi Gras festival?
 - (4) What further action will the Government take to ensure appropriate community policing for future Mardi Gras festivals?

Answer-

The NSW Police Force has advised me:

- (1) This question appears to refer to two incidents that took place during the 2013 Mardi Gras parade which were the subjects of complaints against police. One of these complaints was investigated and found to be not sustained, with no actions taken against the officer involved. The other complaint investigation has not yet been completed and is currently awaiting legal advice from the Office of the Director of Public Prosecutions.
- (2) to (4) Police are committed to working with the LGBTI community on an ongoing basis to ensure appropriate community policing, including future Mardi Gras festivals. Community feedback on the 2014 Mardi Gras is that police behaviour was friendly and courteous.

Police have worked productively during 2014 with key stakeholders, including Mardi Gras organisers, on successful collaborative campaigns for International Day Against Homophobia and Transphobia and Wear It Purple Day, as well as LGBTI Liaison Officer training and ongoing interagency work on domestic and family violence issues.

Measures to ensure a safe and successful 2015 Mardi Gras festival will include:

- Deployment of senior management personnel and appropriately briefed and trained officers;
- Logistical improvements to facilitate access across Oxford Street after the completion of the parade;

- Involvement of Mardi Gras and the LGBTI community in the briefing of police;
- Improved communications overall and a range of measures to ensure appropriateness of drug detection dog operations and associated policing.
- *6372 CANCER SERVICES—Mr Alex Greenwich asked the Minister for Health, and Minister for Medical Research—
 - (1) Has the Government reviewed the Cancer Council NSW "Vision for Change" report?
 - (a) If so, what action will be taken on the key recommendations of the report?
 - (2) How will the Government increase access to palliative care for people with cancer to at least one specialist per 100,000 people and create extra nursing positions?
 - (3) Has the Government reviewed the Palliative Care Home Support Program?

Answer—

I am advised:

(1) to (8) The Ministry of Health and Cancer Institute New South Wales have work in progress relevant to recommendations in the 'Vision for Change' report.

New and expanded cancer care centres across both metropolitan and rural New South Wales has provided greater access to comprehensive, quality cancer services. 95 per cent of New South Wales residents live within 100 kilometres of a comprehensive cancer care centre.

Palliative care in New South Wales is provided by a wide range of professions and organisations across the public and private sector. Palliative care has been identified as a priority for further growth for medical specialty training.

Since 1 January 2013, New South Wales chemotherapy patients have not paid a co-payment for repeat chemotherapy prescriptions.

Funding has been provided to local health districts for the coordination of cancer care especially for those groups within the community that have worse cancer outcomes: including Aboriginal communities, people from culturally and linguistically diverse communities, people from rural areas and the socio-economically disadvantaged.

Noting the lack of evidence in this area of tobacco retailing and regulation, the New South Wales Taskforce on Tobacco Retailing recommended that ongoing independent and peer reviewed research should continue.

Aboriginal employment in NSW Health has risen from 1.9 per cent in June 2013 to 2.1 per cent in June 2014.

This includes station upgrades, better interchanges, commuter car parks and ferry wharf upgrades. This program includes more than \$770 million for improvements over four years. The program has delivered seven wharf upgrades with five more upgrades currently underway.

The Government is investigating new wharves as part of the ongoing work on Sydney's Ferry Future.

The Commissioner of Police determines the allocation of officers and since May 2011 has allocated almost 700 probationary constables to west and southwest Sydney commands. 590 additional positions have been brought online since December 2011, including 62 in western and south western Sydney commands. These officers are supported by special region based squads and taskforces, Street Crime Units and Operation Talon targeting gun crime.

These specially trained officers assist victims to access appropriate support services, monitor repeat victims and perpetrators, assist investigating police, and coordinate compliance operations with both government agencies and non-government organisations to target domestic violence offenders.

In the 2013 school year more than \$2.36 million was allocated to the 17 public schools in the Fairfield Electorate, increasing to more than \$2.71 million in the 2014 school year to support students with disability and students with additional learning and support needs. All funding is not exclusively used to employ school learning support officers.

Principals are responsible for determining the most appropriate ways of using the funding which can be used flexibly to support students with additional teacher and/or school learning support officer (formerly teacher's aide) time.

- *6403 ASSISTANCE TO FAMILIES WITH DISABLED RELATIVES—Mr Guy Zangari asked the Minister for Family and Community Services representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—
 - (1) What support services are available to financially struggling families in the Fairfield Local Government Area to help them care for relatives suffering with a disability?
 - (2) Do any of these services have a cap on the frequency of assistance they are able to provide to a family?

Answer-

(1) and (2) Currently, the allocation of Ageing, Disability and Home Care disability support services is based on a system of prioritisation.

For this reason, the New South Wales Government is committed to a disability service system that increases choice and control for people with disability. In December 2012 the New South Wales

Government became the first state to sign a historic agreement with the Commonwealth to implement the National Disability Insurance Scheme (NDIS).

The NDIS will see the budget to support people with disability will increase from \$2.7 billion to a \$6.4 billion partnership between the NSW and Commonwealth governments. Importantly, the NDIS will benefit around 140,000 people with disability in NSW an increase of approximately 40,000 people.

The NDIS will provide all participants with an individual funding package, based on an assessment of what is reasonable and necessary support to meet their needs, goals and aspirations. Each person with disability will have full choice and control over their funding and the supports they choose to access.

Mascot and Green Square Stations are privately owned and operated by Airport Link Company (ALC). The Government has subsidised the Station Access Fee for these stations for fare paying customers only. The Government has no plans to alter contractual obligations with the ALC at this time as it would place a heavy burden on taxpayers.

*6405 SYDNEY TRAIN FARE BRACKETS—Mr Ron Hoenig asked the Minister for Transport, and Minister for the Hunter—

Will the Minister reassess the criteria for the 10-20 kilometre fare bracket for trains given that all City stations other than Central fall just outside the 10 kilometre range from Tempe Railway Station resulting in an additional \$25 per month for commuters from Tempe to the City?

Answer-

The Government is committed to improving public transport services and providing a world-class transport system people want to use. We have committed to keep fares low for customers as we continue to make improvements across public transport.

Pregnant women are managed collaboratively by Midwives and Diabetes Educators in the Antenatal Clinic and an Ambulatory Insulin Stabilisation Service is available.
- 1.37 FTE Diabetes Educators (Registered Nurses), 0.8 FTE Doctors (Staff Specialists), 1 FTE Visiting Medical Officer, 1 FTE Dietician, and a 0.5 FTE Administration officer are employed by NSW Health for the treatment and management of diabetes in the Sutherland Shire. In addition, generalist community nurses provide assistance to patients with diabetes upon discharge from hospital. An outpatient podiatry clinic is available for high risk patients with diabetes.

These include locating gaming machines in designated gaming areas/rooms where access by minors is prohibited and prohibiting the public or unsolicited advertising of gaming machines.
- (5) The regulation of child care providers and facilities in New South Wales is a matter for the Minister for Education.
- (6) Part 4 of the Gaming Machine Tax Act 2001 requires that ClubGRANTS expenditure be applied to community development and support purposes.

In relation to expenditure by registered clubs on projects and services under ClubGRANTS categories 1 and 2, the Independent Liquor and Gaming Authority must be satisfied that this expenditure has been applied by registered clubs in accordance with ClubGRANTS Guidelines issued by the responsible Minister. These guidelines are available on the Office of Liquor, Gaming and Racing website at www.olgr.nsw.gov.au/reg clubs sect clubgrants.asp.

In relation to expenditure under category 3 on projects or services associated with sport, health or community infrastructure, the responsible Minister approves such expenditure in accordance with the requirements of section 17 of the Gaming Machine Tax Act and the above mentioned ClubGRANTS Guidelines.
