#### 11 SEPTEMBER 2014

- \*6126 NEW GROWTH BUSES—Mr Clayton Barr asked the Minister for Transport, and Minister for the Hunter—
  - (1) When will orders for the 91 new growth buses, which were funded as part of the 2014-15 Budget, be finalised?
  - (2) How many of these buses will be built in New South Wales?
  - (3) How many tenders have been received for the building of these buses?
  - (4) Have tenders been received from other Australian states or from other countries for the building of these buses?
    - (a) If so, from where?

Answer-

I am advised:

Transport for NSW is in the process of finalising orders for the new growth buses through the Bus Procurement Panel.

- \*6127 OPAL CARDS IN THE HUNTER—Mr Clayton Barr asked the Minister for Transport, and Minister for the Hunter—
  - (1) At how many sites across the Hunter can customers use an Opal card?
  - (2) How many Opal cards have been sold to Hunter residents?
  - (3) How much money was spent on the Opal card capacity rollout in the Hunter during 2013-14?
  - (4) How much money is budgeted to be spent on the Opal card rollout in the Hunter during 2014-15?
  - (5) What will be the total cost of the design, manufacture, installation and rollout of the Opal card system across New South Wales?

Answer-

I am advised:

(1) - (5) The Opal card is available on all Sydney Trains, NSW TrainLink Intercity and Sydney Ferries services, as well as on more than 3,000 buses.

More than 850,000 Opal cards have been issued.

The cost of the design, implementation and maintenance of the Opal electronic ticketing system is \$1.2 billion.

- \*6128 TAFE NSW CAPITAL WORKS PROJECTS—Mr Clayton Barr asked the Minister for Education—
  - (1) How much money was allocated to TAFE NSW Capital Works projects in 2013-14?
  - (2) How much of the allocated Capital Works funding allocated in 2013-14 was spent?
  - (3) Which projects scheduled for construction during 2013-14 were not completed?
  - (4) Which projects scheduled for construction during 2013-14 were completed?
  - (5) Does the 2014-15 TAFE NSW Capital Works Budget include any new projects or only the completion of previously announced projects from the 2013-14 Budget?

Answer—

- (1) TAFE NSW Capital Works funding for 2013-14 is available in Budget Paper 4 2013-14.
- (2) The 2013-14 TAFE NSW Financial Accounts are not yet available.
- (3) Major Capital Works are scheduled for planning and construction over a three year period. All Major Capital Works projects are progressing and reported in Budget Paper 4, 2014-15.
- (4) The projects completed in 2013-14 included:
- · Maitland Centre for Dry Wall Plastering and Associated Trades.
- Tamworth New Indigenous Learning Centre.
- Refurbishment of Kingscliff campus.
- · Connected learning facilities at Albury.
- Refurbishment of heritage infrastructure at Ultimo campus.
- Enmore Design Studios.
- · Orange Aboriginal Training Centre.

- (5) 2014-15 TAFE NSW new and work in progress Major Capital Works were presented to Parliament by the Treasurer in Budget Paper 4 on 17 June 2014.
- \*6129 EARLY CHILDHOOD EDUCATION SERVICES—Mr Clayton Barr asked the Minister for Education—

With regard to Early Childhood Education services provided on page 2-8 of Budget Paper No.3, 2014-15:

- (1) Does the Department of Education and Communities collect and maintain data that reflects the number of children eligible for funded child care places?
  - (a) If so, is this data publicly available?
    - (i) If so, where?
- (2) How has the number of funded child care places changed, as a percentage of the numbers of eligible children, during the past 5 years?
- (3) Are the projections for future funding of child care places based on a set "cap" on positions?
  - (a) If not, are the projections based on maintaining a minimum percentage of eligible children positions being funded?
- (4) Why was the target of 49,800 funded child care places per day not realised in 2013-14?
- (5) Why was the decision made to cut the number of funded child care places from the projected 49,800 in 2013-14 to 47,700 in 2014-15?
- (6) How many funded child care places were available in the Cessnock Electorate during 2013-14?
- (7) How many of the total number of funded child care places in the Cessnock Electorate during 2013-14, on a daily average, were accessed and used?

#### Answer-

- (1) (9) No. The Department of Education and Communities collects data relating to a small number of not-for-profit long day care services funded under a historic grants program and community preschools funded under the Preschool Funding Model. This reflects only a portion of funded childcare places. The Federal Government has primary responsibility for funding and collecting data on childcare.
- \*6130 EAR NOSE AND THROAT SURGEONS—Mr Clayton Barr asked the Minister for Health, and Minister for Medical Research—
  - (1) What is the expected waiting time for an appointment to see an Ear, Nose and Throat (ENT) surgeon at John Hunter Hospital?
  - (2) How many ENT surgeons are available to see public hospital patients at John Hunter Hospital?

Answer-

I am advised:

(1) - (2) Waiting times depend on the acuity of a patient's condition as appointments are scheduled according to clinical need.

There are currently six surgeons available at John Hunter Hospital. An additional surgeon is on maternity leave.

- \*6131 ORTHOPAEDIC SURGERIES—Mr Clayton Barr asked the Minister for Health, and Minister for Medical Research—
  - (1) How many orthopaedic surgeries were performed at the John Hunter Hospital during each financial year from 2009-10 to 2013-14?
  - (2) What other hospitals across New South Wales perform this type of surgery?
  - (3) How many orthopaedic surgeries were performed at other hospitals in New South Wales during each financial year from 2009-10 to 2013-14?

Answer-

I am advised:

Orthopaedic surgeries performed in John Hunter Hospital in the requested years are as follows:

- In 2009-10 4306.
- In 2010-11 4197.
- In 2011-12 4181.
- In 2012-13 4135.
- In 2013-14 4337.

\*6132 CITIZENSHIP AND COMMUNITIES BUDGET—Mr Clayton Barr asked the Minister for Citizenship and Communities, Minister for Aboriginal Affairs, Minister for Veterans Affairs, and Assistant Minister for Education—

With regard to Citizenship and Communities on page 2-15 of Budget Paper No.3, 2014-15:

- (1) How many jobs were transferred from the Children's Guardian and Working With Children Check services to another service within the Family and Communities Service Cluster?
- (2) Why were workforce figures included in the 2013-14 Budget for Citizenship and Communities given that there was a pre-existing decision, as of 1 July 2013, to transition workers from these services to the Family and Communities Cluster?
- (3) Do all of these transferred positions still exist and are they occupied in the Family and Communities Cluster in 2014-15?
- (4) What capital works were proposed and allocated \$1.47 million in funding in 2013-14?
- (5) Why wasn't the capital works project completed in 2013-14?
  - (a) Where has that funding been re-allocated to for 2014-15?

#### Answer-

- (1) (3) The Office of the Children's Guardian sits within the portfolio of the Minister for Family and Community Services. Questions regarding the Office of the Children's Guardian should be referred to the Minister for Family and Community Services.
- (4) (5) Capital funding for the Children's Guardian totalling \$1.47 million was transferred from the Education and Communities Cluster to the Family and Community Services Cluster during 2013-14. This transfer included the major works project listed at page 4-19 of the 2013-14 Budget Paper 4, along with minor works funding for the Office of the Children's Guardian.
- \*6133 ABORIGINAL AFFAIRS—Mr Clayton Barr asked the Minister for Citizenship and Communities, Minister for Aboriginal Affairs, Minister for Veterans Affairs, and Assistant Minister for Education—

With regard to Aboriginal Affairs on page 2-14 of Budget Paper No.3, 2014-15:

- (1) Why have 22 positions been cut from this service since 2011-12?
- (2) Why types of roles and positions have been eliminated from this service?
- (3) Are people of Aboriginal identity, or requiring assistance with Aboriginal issues, able to access similar services to those no longer offered from other Departments?
  - (a) If so, where?

#### Answer-

There has been no reduction in the State's budget commitment to Aboriginal Affairs in 2014/15. There has been a net increase in Aboriginal Affairs spending.

The reduction in the number of full time equivalent positions shown in Budget Paper Number 3 between 2011-12 and 2014-15 is due to the cessation of the former government's Partnership Community program, COAG programs, and other Commonwealth funded temporary positions.

Aboriginal Affairs is being realigned to deliver OCHRE, the Government's Plan for Aboriginal Affairs.

The realignment will enable Aboriginal Affairs to work more effectively with other agencies and the Federal Government to deliver evidenced-based policy. Oversight will be provided by the new Deputy Ombudsman responsible for Aboriginal Programs who will work closely with the agency.

The structural changes to Aboriginal Affairs commenced in June and are expected to be finalised by the end of October 2014.

Aboriginal Affairs is a central point of contact for Aboriginal people within the Government. It will continue to represent and advocate for the needs of Aboriginal people in New South Wales.

- \*6135 INNER CITY HIGH SCHOOL—Mr Alex Greenwich asked the Minister for Education—
  - (1) What information does the Government have about current public high school places and demand?
  - (2) Is there an adequate number of public high school places in the inner city until 2017?
  - (3) How many places remain available for new students at the following schools as at 11 September 2014:
    - (a) Rose Bay Secondary College;
    - (b) Sydney Secondary College Blackwattle Bay; and
    - (c) Alexandria Park Community School?

- (4) What capacity do these schools have to provide additional teaching spaces?
- (5) What changes are planned for catchment areas for 2016 in order to manage demand for high school places?
- (6) What changes are planned for school transport services to match current needs at these schools?
- (7) Will the Government respond to the "Inner Sydney high school community consultation" report completed by consultants Straight Talk?
  - (a) If so, when?
- (8) Will the Government act urgently to identify a new inner city high school site as deemed necessary in this report?
- (9) What further action will the Government take to fast track an inner city high school?

#### Answer-

- (1) The Department of Education and Communities has data on 2014 enrolments and forward year projections.
- (2) Yes.
- (3) Capacity is outlined below:
- (a) Rose Bay Secondary College currently has spare capacity.
- (b) At Sydney Secondary College, Blackwattle Bay, has space for additional capacity.
- (c) Alexandria Park Community School currently has spare capacity.
- (4) A number of options are possible and are being considered by the Inner City Schools Working Party and the Department.
- (5) There are no current plans to change secondary school boundaries for the 2016 intake.
- (6) Local schools and the Department will continue to liaise with Transport for NSW to provide the best possible public transport for public school students.
- (7) Yes.
- (8) (9) The Government will consider the advice delivered by the Inner City Schools Working Party.
- \*6136 THE ENTERTAINMENT QUARTER—Mr Alex Greenwich asked the Minister for the Environment, Minister for Heritage, Minister for the Central Coast, and Assistant Minister for Planning—
  - (1) To what extent will the Government commit to retaining existing open space requirements at the Entertainment Quarter following the changeover of leasehold?
  - (2) How will the Government ensure any changes do not further alienate the 1995 commitment that the site be used only for film, television and radio production with other retail and entertainment activities ancillary to this purpose?

## Answer—

I am advised as follows:

- (1) The Government will continue to comply with the relevant State Environmental Planning Policy that applies to the Entertainment Quarter.
- (2) The current developments on site are consistent with the 1995 commitment.
- \*6137 LATE NIGHT TRANSPORT AT KINGS CROSS—Mr Alex Greenwich asked the Minister for Transport, and Minister for the Hunter—
  - (1) What action will the Government take to increase patronage on the Kings Cross NightRide bus services on Friday and Saturday nights?
  - (2) Will the Government replace bus services with late night train services given Kings Cross NightRide patronage is low?

#### Answer-

I am advised:

- (1) The Government provides a range of late-night transport options including NightRide buses, Plan B buses and secure taxi ranks to get customers safely from Kings Cross.
- (2) The solution to low patronage is not additional capacity.
- \*6138 PUBLIC HOUSING PROPERTIES—Mr Alex Greenwich asked the Minister for Family and Community Services—

- (1) What plans are there for the Land and Housing Corporation to review public housing properties (ref Q.5431) in the following areas in 2014-15 and 2015-16:
  - (a) Surry Hills;
  - (b) Paddington;
  - (c) Woollahra;
  - (d) Darlinghurst;
  - (e) Pyrmont;
  - (f) Potts Point;
  - (g) Ultimo;
  - (h) Chippendale; and
  - (i) Woolloomooloo?
- (2) What plans does the Government have to sell public housing properties in the following areas in 2014-15 or 2015-16;
  - (a) Surry Hills;
  - (b) Paddington;
  - (c) Woollahra;
  - (d) Darlinghurst;
  - (e) Pyrmont;
  - (f) Potts Point;
  - (g) Ultimo;
  - (h) Chippendale; and
  - (i) Woolloomooloo?

#### Answer—

I refer the Honourable Member to Q.5431.

- \*6139 NON-ACUTE MENTAL HEALTH SERVICES—Mr Alex Greenwich asked the Minister for Mental Health, Assistant Minister for Health—
  - (1) What proportion of funding for mental health services in New South Wales is allocated to acute care in hospitals?
    - (a) What is the trend in this funding proportion over the past 10 years?
  - (2) What proportion of funding for mental health services covering the Sydney electorate is allocated to hospital based acute care?
    - (a) What is the trend in this funding proportion over the past 10 years?
  - (3) What is the Government's plan for non-acute mental health services?
  - (4) What non-acute programs does the Government fund or run that provide help for people with a mental illness?
  - (5) What non-acute mental health programs covering the Sydney electorate are currently being expanded?
  - (6) What plans does the Government have to increase the proportion and amount of funds for self-care, community support and other non-government organisation programs?

#### Answer-

### I am advised:

(1) - (6) Mental Health funding and expenditure is not provided or reported at an electorate level.

Local Health Districts provide a range of acute and non-acute mental health services. Information regarding the services provided by the Sydney Local Health District can be found at http://www.slhd.nsw.gov.au/mhealth.

- \*6140 UNREGISTERED BOARDING HOUSES—Mr Alex Greenwich asked the Minister for Finance and Services representing the Minister for Fair Trading—
  - (1) What research has the Government carried out into online advertisements for boarding houses and roomshares, in light of the Tenants' Union review which identified that only two per cent of online "roomshare" advertisements are registered although 26 per cent are likely to be registrable?
  - (2) What assessment has the Government made of the effectiveness of the 2012 legislative reforms and their implementation?
  - (3) How will the Government educate those who are required to register?
  - (4) How will the Government educate residents about their legal rights in registrable boarding houses?
  - (5) How will the Government enforce registration requirements to ensure safe accommodation?

(6) What further action will the Government take to address this concern?

Answer-

(1) - (6) Enforcement of the requirement to register a registrable boarding house on the Boarding House Register is the responsibility of individual local councils. The Government is open to suggestions from the public in relation to the effectiveness of the Boarding Houses Act 2012 and any additional actions that may be required. The Act will be subject to a comprehensive statutory review in 2017.

NSW Fair Trading engages with both boarding house residents and landlords to distribute information about boarding houses as part of its ongoing community engagement activities. An example is that Fair Trading produces a brochure 'Living in a boarding house?' which is distributed widely to boarding houses and community organisations. Furthermore, NSW Fair Trading further provides over \$9.7 million per annum to the Tenants' Advice and Advocacy Program which provides information, education and advocacy for tenants, including boarding house and other vulnerable tenants.

- \*6141 ELIZABETH BAY MARINA—Mr Alex Greenwich asked the Minister for Transport, and Minister for the Hunter representing the Minister for Roads and Freight, and Vice-President of the Executive Council—
  - (1) What strategy for the future management of the Elizabeth Bay Marina has been developed (ref Q.5849) and how will this be made public?
  - (2) What protections will be provided to ensure the safety and amenity of adjacent precincts and residents?
  - (3) How will the Government ensure that the Elizabeth Bay Marina is not enlarged and subject to inappropriate development?
  - (4) How will public access to the Marina be protected?
  - (5) What community consultation will be carried out on the future of this site and its lease (ref Q.5849)?
  - (6) When will the Government call for tenders or expressions of interest for the lease of the Elizabeth Bay Marina?
  - (7) What further plans does the Government have for the Elizabeth Bay Marina?

Answer-

I am advised:

(1) - (7) Roads and Maritime Services is currently developing a strategy for Elizabeth Bay Marina.

Any future use of the existing facilities or any proposals for improved facilities will need to satisfy all relevant planning and regulatory approvals.

To ensure public access to the Marina is continued, any new lease will contain provisions to allow public access to the site during approved operating hours.

The strategy for Elizabeth Bay Marina will involve a communication plan including consultation with key stakeholders and the community prior to the Expression of Interest being released.

It is proposed that an Expression of Interest process will start in late 2014 or early 2015.

- \*6142 COMPUTER ACCESS TO PRISONERS—Mr Alex Greenwich asked the Attorney General, and Minister for Justice—
  - (1) What is the Government's policy regarding access to computers in prison cells?
  - (2) Has the Government researched the benefits of computers in cells?
    - (a) If so, what was the outcome of this research?
    - (b) If not, why not?
  - (3) What information does the Government have about the experience of computers in cells from the ACT, Victoria and Norway?
  - (4) What benefits are there for prisoners who have access to computers in prison cells regarding online counselling to help address substance problems, smoking habits, anxiety and other mental health concerns?
  - (5) What benefits are there for prisoners who have access to computers in prison cells regarding education, training and employment?
  - (6) What benefits are there for prisoners who have access to computers in prison cells regarding reducing recidivism and increasing rehabilitation?
  - (7) What action will the Government take to introduce computers to prison cells with appropriate safeguards?

Answer-

I am advised:

- (1) Corrective Services NSW strongly supports inmate access to computers, to facilitate education and training delivery, to gain post-release employment, and increase their capacity to function in a computer-dependent world on release.
- (2) As Corrective Services NSW supports increasing inmate access to computers, it was not necessary to research the matter. Officers from Corrective Services have visited facilities in other Australian correctional jurisdictions where in-cell access to computers is available, to assess their operation.
- (3) Corrective Services NSW is aware of the experience of in-cell computer access in the ACT (the Alexander Maconochie Centre), Victoria (the Metropolitan Remand Centre) and Norway (the Skien High Security Prison).
- (4) Corrective Services NSW considers it would be a breach of its duty of care to replace its current methods for providing counselling and psychological services to inmates with on-line counselling.
- (5) In-cell access to computers will enable inmates to make productive use of cell time in areas such as computer literacy; education and training; access to legal advice; and preparation for post-release employment.
- (6) As inmates do not have access to computers in cells it is not possible to know what these benefits will be.
- (7) The in-cell scheme will be closely monitored to ensure no security breaches occur.
- \*6143 PYRMONT BRIDGE—Mr Alex Greenwich asked the Minister for Planning, and Minister for Women—
  - (1) How many pedestrians and cyclists are estimated to use Pyrmont Bridge daily?
  - (2) What assessment of pedestrian and cyclist safety was carried out for the Pyrmont Bridge art project A-Maze?
    - (a) What consultation was carried out with bicycle users and pedestrian groups and what feedback did they provide?
    - (b) What consultation was carried out with the City of Sydney and Transport for NSW and what feedback did they provide?
  - (3) Will the Pyrmont Bridge art project put tourists in direct conflict with cyclists on the cycleway on the northern side of the bridge?
  - (4) Will this project obstruct cycling access during lunchtime and evening events?
  - (5) Will this project reduce usable space on Pyrmont Bridge by 5.8 metres and what strategies have been developed to prevent congestion?
  - (6) Will this project require cyclists to travel under 10 kilometres per hour?
  - (7) What other restrictions and obstacles will be removed to improve shared space on Pyrmont Bridge?
  - (8) What alternative cycling routes will the Government provide when Pyrmont Bridge is restricted?
  - (9) What long term plan does the Government have to prevent conflict between pedestrians, cyclists and tourists on Pyrmont Bridge?
  - (10) What long term plan does the Government have to improve pedestrian and cycling access through Darling Harbour?

Answer-

I am advised:

Regrettably, due to the delays of the City of Sydney in approving the development application, this sustainable, green initiative cannot proceed as planned.

\*6144 PARKING AT BANKSTOWN-LIDCOMBE HOSPITAL—Ms Tania Mihailuk asked the Minister for Health, and Minister for Medical Research—

What measures have been implemented to improve the parking arrangements at Bankstown-Lidcombe Hospital?

Answer—

I am advised:

The Government allocated funding of \$800,000 to facilitate a master planning process for Bankstown-Lidcombe Hospital, where the car park will feature as a high priority for redevelopment.

Interim measures have been implemented by Bankstown-Lidcombe Hospital to assist with parking such as updating the Transport Access Guide and conducting an audit of staff access to the car park. Improvements in public access to the car park have resulted from these initiatives.

\*6145 LACK OF AVAILABLE AMBULANCES—Ms Tania Mihailuk asked the Minister for Health, and Minister for Medical Research—

Following the recent report that a two month old infant was given mouth to mouth resuscitation by her parents whilst being driven to Bankstown-Lidcombe Hospital due to a lack of available ambulances:

(1) On how many occasions has a patient been turned away from emergency department treatment at Bankstown-Lidcombe Hospital due to a backlog of ambulances in each of the past 3 years?

Answer—

I am advised:

- (1) Zero.
- \*6146 ELECTIVE SURGERY WAIT TIMES—Ms Tania Mihailuk asked the Minister for Health, and Minister for Medical Research—
  - (1) What are the reasons for the increase in median wait time for elective ear, nose and throat surgery at Bankstown-Lidcombe Hospital from 255 days in the April-June quarter of 2013 to 277 days for the same period in 2014?
  - (2) Why is the median wait time at Bankstown-Lidcombe Hospital for elective ear, nose and throat surgery 277 days compared to 154 for the equivalent peer group?

Answer-

I am advised:

(1) - (2) Bankstown-Lidcombe Hospital is recognised as a Centre for Excellence for elective ear, nose and throat surgery which results in an increase in patient referrals. This has led to an increase in the median wait times for surgery.

In the April to June 2014 quarter, Bankstown-Lidcombe Hospital met the required target in each category and the benchmark for care being provided in a clinically appropriate timeframe.

\*6147 ELECTIVE CATARACT EXTRACTION SURGERY—Ms Tania Mihailuk asked the Minister for Health, and Minister for Medical Research—

What are the reasons for the difference in median wait time for elective cataract extraction surgery for the April-June 2014 quarter at Bankstown-Lidcombe Hospital (337 days) compared with the equivalent peer group (98 days)?

Answer-

I am advised that:

There are numerous reasons for differing waiting times between hospitals for elective surgery including the disease burden of the local community and recognition from local referrers in sending patients to centres of excellence.

In the April to June 2014 quarter, Bankstown-Lidcombe Hospital met the required target in each category and the benchmark for care being provided in a clinically appropriate timeframe.

- \*6148 CONCESSION AND PENSIONER OPAL CARDS—Ms Tania Mihailuk asked the Minister for Transport, and Minister for the Hunter—
  - (1) When will Bankstown commuters be able to purchase concession and pensioner Opal cards?
  - (2) Will these cards be made available for purchase from existing ticket booths along Bankstown line railway stations?
    - (a) If not, why not?

Answer—

I am advised:

(1) - (2) The Gold Opal Senior/Pensioner card will be available by the end of 2014. Fares for seniors and pensioners will remain at \$2.50 using the Opal card. Once it is introduced, seniors and pensioners will have the choice to use the Gold Opal card, or continue to purchase paper Pensioner Excursion Tickets (PETs). Customers will not need a credit card or the internet to use or obtain a Gold Senior/Pensioner Opal card.

PETs are still available to buy at more than 1,600 ticket sellers across Sydney, including newsagencies, 7-Eleven convenience stores, Australia Post, Transport Shops and some Woolworths supermarkets.

Other Opal card types will be available as the rollout continues. More than 20 paper ticket types are still
