\*1376 GENERAL MEDICAL WARD SPACE—Mr Edmond Atalla asked the Minister for Health—

What currently occupies the space previously used as the General Medical Ward at Mount Druitt Hospital?

Answer—

I am advised:

The Member is referred to the response to his earlier question on this subject, LA1231.

\*1377 MAINTENANCE OF MEDIAN STRIPS—Mr Edmond Atalla asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

Has Roads and Maritime Services engaged a head contractor to oversee and manage the contractors that have been awarded the tender for maintenance of median strips and roundabouts under its control?

Answer—

Roads and Maritime Services is responsible for planning and delivering asset maintenance.

Contracts for road maintenance and minor improvement works, including median strips and roundabouts, were awarded to private sector joint ventures starting in March 2014.

\*1378 HOMEPRIDE HINDU CENTRE INC—Mr Paul Lynch asked the Minister for Innovation and Better Regulation—

- (1) When will Fair Trading answer the letter dated 17 August 2015 from Raj Kumar regarding the Homepride Hindu Centre Inc. (Inc 9879028)?
- (2) What action will Fair Trading take in relation to the removal of Raj Kumar as Secretary of Homepride Hindu Centre Inc?
- (3) What action will Fair Trading take in relation to the removal of Kishore Kumar from the Homepride Hindu Centre Inc?
- (4) Has the current Secretary of the Homepride Hindu Centre Inc complied with the Notice to Produce issued by Fair Trading?

Answer—

- (1) NSW Fair Trading responded to Mr Kumar on 18 September 2015.
- (2) Fair Trading's Registry Services regulates over 36,000 incorporated associations registered under the Associations Incorporations Act 2009 (the Act). Fair Trading provides a Model Constitution, which covers the matters required by Schedule 1 of the Act. Matters that fall under an association's constitution, including the removal of committee members of an association, are dealt with by the association's constitution.
- (3) As above.
- (4) The Homepride Hindu Centre Inc has complied with the Notice to Produce issued by Fair Trading.

\*1381 POWERHOUSE MUSEUM—Mr Alex Greenwich asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—

- (1) Is the Powerhouse Museum collection worth around \$500 million?
- (2) Will moving the Powerhouse Museum collection to Western Sydney cost up to \$650 million?
- (3) Has the Government allocated \$6 million to the Powerhouse Museum for acquisitions since 1984, while private donor contributions and sponsored purchases total \$20 million?
- (4) What assessment has the Government made of the impact of moving the Powerhouse Museum on donations and beneficence?
- (5) How would a Western Sydney Powerhouse Museum work with inner city technology businesses and centres?
- (6) What assessment has the Government made of transport options for the Powerhouse Museum in Western Sydney that would equal access to the Ultimo site?
- (7) What assessment has been made of a specialist Western Sydney museum based on the history and local culture of that region?
- (8) What assessment has been made of an interactive science centre in Western Sydney similar to Museum Victoria's Scienceworks?

- (9) What progress has been made with the divestment strategy identified in LA Q.0058?
- (10) What options have been considered for developing and re-opening the Castle Hill Discovery Centre?
- (11) How will the Government consult the local community and council about the redevelopment of the Ultimo site?
- (12) What opportunities will the Government provide for the community to influence plans for the Ultimo site?
- (13) When will the Government make public plans for the museum and its current site?

Answer—

- (1) Information about the Museum of Applied Arts and Sciences (MAAS) collection is available in the Annual Report.
- (2) Costs of relocation will be determined as part of the Business Case.
- (3) As one of the State's Cultural Institutions the MAAS receives recurrent and capital funding from the NSW Government. In 2013/14 NSW Government funding represented more than 80 percent of MAAS total revenue. Information on philanthropic contributions and donations is available in the MAAS Annual Report.
- (4) This will be considered as part of the planning process for the relocation.
- (5) The MAAS partners with a diverse group of technology, start up, research and tertiary institutions across NSW, Australia and internationally.
- (6) Access and transport will be considered as part of the Business Case, and further assessed as part of the detailed Master-Planning for the preferred site.
- (7) The Business Case relates to the Museum's collection of applied arts and sciences.
- (8) The Business Case will include benchmarks with other institutions.
- (9) The Government remains in the early stages of developing a divestment strategy for the site.
- (10) The Discovery Centre will reopen in 2016, following completion of a \$33 million storage facility upgrade, to house collections from MAAS, the Australian Museum and Sydney Living Museums.
- (11) to (13) The Government remains in the early stages of developing a divestment strategy for the site that involves consultation with key stakeholders.

\*1382 TRANSGENDER CHILDREN SUPPORT UNIT—Mr Alex Greenwich asked the Minister for Health—

- (1) What analysis has the Government made of the effectiveness of the Children's Transgender Support Service at the Royal Children's Hospital in Melbourne in treating gender dysphoria?
- (2) What assessment has been made of the demand for such a unit in New South Wales considering the Melbourne unit has had its funding increased in response to long waiting lists?
- (3) What assessment has been made of the health and mental health benefits to children and adolescents with gender dysphoria and their families if New South Wales introduced a gender dysphoria unit for children?
- (4) What plans does the Government have to introduce a children's transgender support service in New South Wales (for example at Westmead Hospital)?
- (5) What further consideration will the Government give to this proposal?

Answer—

I am advised:

A number of services in NSW provide psychological and family support to children and young people with Gender Dysphoria and their families. These services include:

- Headspace, a Commonwealth funded program for 12 to 25 year olds.
- Twenty 10, a community-based, non-profit, state-wide organisation, working with and supporting people of diverse genders, sexes and sexualities, their families and communities.
- ACON, a health promotion organisation specialising in HIV prevention, HIV support and lesbian, gay, bisexual, transgender and intersex (LGBTI) health.
- The Gender Centre Inc., a Non-Government Organisation, providing accommodation and counselling services for gender questioning clients from the age of 16 and up, as well as providing education, support, training and a referral resource centre to other organisations and service providers.

\*1383 SOCIAL HOUSING STOCK—Mr Alex Greenwich asked the Minister for Family and Community Services, and Minister for Social Housing—

- (1) Has Government-owned social housing stock in New South Wales been decreasing at the rate of approximately two homes per day?
  - (a) If not, what is the correct figure?

- (2) How many properties have been sold as part of the Millers Point Sales Project since 19 March 2014?
- (3) What income has been received from these sales?
- (4) How many new homes have been built with these funds and where are they located?
  - (a) How many of these new homes are planned for the inner city?
  - (b) How many of these new homes are planned for postcode areas 2000, 2009, 2010, 2011 and 2021?
  - (c) How many of these new homes represent an increase in housing stock?
- (5) How many more homes are expected to be created from funds raised through this project?
- (6) How will the Government account for use of the funds from the Millers Point sales?

Answer—

(1) The Government intends that the social housing portfolio will add considerably more properties to the portfolio. This is a change of policy established under the former Labor government where approximately 900 homes a year were lost.

(2) to (4) As at 30 September 2015, 33 properties in Millers Point had been sold with over \$75 million in sales proceeds funding new dwellings in Lurnea, Condell Park, Padstow, Warilla, Mount Warrigal, Chester Hill, Yagoona, Gymea, Kingswood, Casula, Beverly Hills and Miranda. The building of future of dwellings are proceeding as further Millers Point properties are sold.

(5) and (6) The projected proceeds from the Millers Point property sales will be re-invested into some 1,500 new social housing dwellings. A separate bank account has been established for the Millers Point proceeds which will be spent on new dwellings.

\*1384 SIRIUS BUILDING—Mr Alex Greenwich asked the Minister for Family and Community Services, and Minister for Social Housing—

- (1) Is the Sirius building on Cumberland Street, The Rocks purpose built for public housing?
- (2) How many of the 79 units in the Sirius building meet the size and accessibility needs of people on the housing waiting list?
- (3) Which Department currently holds the title for the land on which Sirius building is built?
- (4) When and by what means was the title transferred from the Sydney Harbour Foreshore Authority?
- (5) What impact does the transfer of title have on the lease with the Land and Housing Corporation?
- (6) Given the transfer of title, which Government Department will receive the proceeds from the future sale of Sirius building?
- (7) When were you notified of the transfer of title?
- (8) When did you approve the transfer?
- (9) Has the Government received any unsolicited offers or proposals to purchase the Sirius building?
- (10) What recommendation has the Land and Housing Corporation made on listing the Sirius building on the State Heritage Register?

Answer—

(1) and (2) The building was originally built to accommodate social housing tenants but over time the housing needs of these residents has changed and the building is no longer considered fit for purpose, or of a standard that is acceptable for social housing today.

(3) to (10) Land on which the Sirius building is located was vested in Government Property NSW (GPNSW) on 26 June 2015. NSW Land and Housing Corporation retains leasehold for the building and will receive proceeds from sale. GPNSW manages the transfer process. The Sirius building will be sold by GPNSW through an open-market process. The NSW Land and Housing Corporation opposes heritage listing of the building.

\*1385 SENIORS CARDS—Ms Julia Finn asked the Minister for Family and Community Services, and Minister for Social Housing representing the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism—

- (1) How many Seniors Cards have been issued to residents of the Granville electorate?
- (2) What is the average monthly number of new applications for Seniors Cards from residents of the Granville electorate for the period 12 August 2014 to 12 August 2015?
- (3) How many applications for a Seniors Card for residents of the Granville electorate have been refused over the period 12 August 2014 to 12 August 2015?

Answer—

- (1) Since 1992, more than 27,500 Seniors Cards have been issued to residents in the Granville electorate.
- (2) 155.

(3) This information is not collected by NSW Seniors Card.

\*1387 COMPANION ANIMALS—Ms Tania Mihailuk asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—

How many companion animals such as cats and dogs are currently being used for medical research in New South Wales?

Answer—

Under the Animal Research Act 1985, statistics on animal use in research and teaching are collected on an annual basis. These statistics are published in the annual reports of the Animal Research Review Panel.
