- *3751 STRATA LAWS—Ms Julia Finn asked the Minister for Innovation and Better Regulation—
 - (1) On what date does the Government plan to commence the provisions of the:
 - (a) Strata Schemes Development Bill 2015?
 - (b) Strata Schemes Management Bill 2015?

Answer-

- (1) (a) The provisions of the Strata Schemes Development Act 2015 and Strata Schemes Development Regulation 2016 will commence on 30 November 2016.
- (b) The provisions of the Strata Schemes Management Act 2015, and the Strata Schemes Management Regulation 2016, except for Part 11 of the Act, will commence on 30 November 2016. Part 11 of the Act, which deals with strata building defects, will commence on 1 July 2017.
- *3752 OURIMBAH STATION MASTER'S COTTAGE—Mr David Mehan asked the Minister for Transport and Infrastructure—
 - (1) What maintenance has been undertaken on the Station Master's Cottage at Ourimbah since 2011?
 - (2) Is there a long term preservation plan for the Ourimbah Station Master's Cottage?

Answer-

The Heritage Council of NSW has endorsed a Conservation Strategy for railway residences. The Heritage Council did not consider the cottage at Ourimbah to be included within the scope of the strategy.

*3753 PACIFIC HIGHWAY WIDENING IN OURIMBAH—Mr David Mehan asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

Will there be sufficient parking available for customers of businesses located within the Ourimbah township after the Pacific Highway is widened in that location?

Answer-

The Government is investing \$70 million to widen the Pacific Highway between Glen Road, Ourimbah and Ourimbah Street, Lisarow.

Parking in the adjacent township is a matter for the Central Coast Council.

- *3754 REPLACEMENT OF MARITIME SAFETY SIGNAGE—Mr David Mehan asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
 - (1) When will Maritime replace safety signage in the vicinity of The Entrance Channel, Tuggerah Lakes which were lost or damaged during the April 2015 storms?
 - (2) Is Maritime coordinating its signage plan with the Central Coast Council?

Answer-

The sign will be replaced and positioned in a suitable location, it is expected to be installed by the end of September.

*3755 SOCIAL HOUSING FOR THE ENTRANCE—Mr David Mehan asked the Minister for Family and Community Services, and Minister for Social Housing—

What new social housing is planned for The Entrance electorate over the next twelve months (from 10 August 2016)?

Answer-

*3756 CAMPBELLTOWN AND MACARTHUR CRISIS CARE AND ACCOMODATION—Mr Greg Warren asked the Minister for Family and Community Services, and Minister for Social Housing—

Can the Minister advise what provisions, resources and measures are in place to provide 'crisis' care and accommodation for women who are victims of domestic violence in the Campbelltown and Macarthur region?

Answer-

Information on crisis care and accommodation for women who are victims of domestic violence in the Campbelltown and Macarthur region is available on the Department of Family and Community Services website at: www.facs.nsw.gov.au/shs.

*3757 CAMPBELLTOWN TRAIN STATION CAR PARK SPACES—Mr Greg Warren asked the Minister for Transport and Infrastructure—

Can the Minister advise the location, costings and timeline for the 450 car park spaces promised for the Campbelltown train station?

Answer-

The Government is working with Campbelltown City Council to find a suitable location for the proposed car park. Planning is now underway.

Customers in Campbelltown are already benefitting from the return of over 150 staff car parking spaces.

- *3758 OPERATING THEATRES AT CAMPBELLTOWN HOSPITAL—Mr Greg Warren asked the Minister for Health—
 - (1) Can the Minister advise how many operating theatres are at Campbelltown Hospital?
 - (a) How many of these are currently in use/operational?

Answer—

There are seven operating theatres at Campbelltown Hospital and all are operational.

*3759 SALE OF OPAL TICKETS AND CARDS—Mr David Mehan asked the Minister for Transport and Infrastructure—

Will Opal tickets/cards be sold at Tuggerah, Ourimbah, Lisarow, Niagara Park and Narara Railway Stations?

Answer—

Customers can obtain Opal cards from any Opal retailer. Details of retailers are available on the Opal website.

- *3760 MRI/CT SCANNER—Mr Greg Warren asked the Minister for Health—
 - (1) Is the Minister aware that the Campbelltown Hospital MRI/CT scanner continues to be repeatedly unserviceable?
 - (a) If so, can the Minister advise what plans are in place to rectify this issue?
 - (b) If not, will the Minister investigate and advise?

Answer-

(1) and (2) The MRI and CT scanners at Campbelltown Hospital are serviceable.

All medical imaging equipment is maintained and routinely serviced in accordance with the service contract between the facility and manufacturer.

- *3761 NEWCASTLE FREIGHT RAIL BYPASS—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
 - (1) The Government recently announced \$14 million for the Newcastle Freight Rail Bypass, what specifically will this \$14 million be spent on?
 - (2) What will it deliver for the people of Newcastle?

Answer—

\$14 million was allocated for the planning and pre-construction of the Lower Hunter Freight Corridor. Planning includes extensive consultation with the community and other key takeholders and route investigation over the next one to two years. Pre-construction includes identifying and securing potential environmental offset lands.

When built, this corridor will improve journey time and reliability for regional and interstate rail freight movements through the Newcastle region. It will divert freight services from sensitive suburban areas by providing a dedicated freight link that bypasses Newcastle. It would also allow most freight trains to avoid the Adamstown and Islington level crossings. This provides urban amenity and liveability improvements by reducing noise and road congestion in the Newcastle region

- *3762 CULTURAL COMPETENCY TRAINING—Ms Tania Mihailuk asked the Minister for Mental Health, Minister for Medical Research, Assistant Minister for Health, Minister for Women, and Minister for the Prevention of Domestic Violence and Sexual Assault—
 - (1) Considering recommendation 7.2.3 of the Living Well report, how many occasions were staff at the Banks House facility provided with cultural competency training in relation to the mental health needs of CALD communities in the Bankstown area in each financial year from 2014-15 to 2016-17 (as at 11 August 2016)?

Answer—

Banks House staff received an in-service from the South Western Sydney Local Health District Interpreter Services on 16 August 2016 regarding the use of interpreter services in mental health inpatient units. The training was delivered as an interactive in-service presentation which included nurses and allied health staff and it highlighted the importance of using professional interpreters as outlined in the NSW Health Policy Directive P02006_053: Interpreters - Standard Procedures for Working with Health Care Interpreters. Copies of the policy were provided to staff, as well as detailed information on how to book, and use, a Health Care Interpreter to facilitate communication between the patient and health care provider.

Additionally, a review of all training relating to culturally and linguistically diverse patients has been conducted by the Mental Health Service at the South Western Sydney Local Health District, which identified appropriate training for all Mental Health Service staff, including Banks House staff.

NSW Health allocates over \$20 million annually for health care interpreting, which provides half a million interpreting occasions of service in over 120 languages. NSW Health is also investing \$11 million in 2016-17 (\$32 million over four years) to extend and enhance specialised refugee health services. This will deliver appropriate and targeted health care to support the resettlement of refugees who are fleeing the humanitarian crisis in Syria and Iraq.

To enhance the cultural competency of health staff, the Health Education and Training Institute has developed training modules including:

- Working in culturally diverse contexts.
- Connecting with carers from CALD backgrounds in mental health settings.
- Meeting the healthcare needs of refugees.
- *3763 WOMEN IN SPORT—Ms Jo Haylen asked the Minister for Trade, Tourism and Major Events, and Minister for Sport—
 - (1) Has the Government conducted an audit of Government grants to sporting organisations and clubs, as well as funding partnerships with State Sporting Organisations, the Regional Academies of Sport and the NSW Institute of Sport to determine the allocation of funding directed towards supporting and encouraging women in sport versus men?
 - (a) If not, why not?
 - (2) If an audit has been conducted, what proportion of Government funding for Sport is directed towards supporting women in sport?

Answer-

The Office of Sport administers a number of grant programs to support participation opportunities, facility development and sporting events. Sport grants are not assessed based on gender as most sports, facilities and services are available to both males and females.

However, I am advised in 2015/16 over \$400,000 was provided to sports which identified strategies specifically targeting females. Also as of 1 September 2016 females made up 51 per cent of the current athletes on scholarship at the NSW Institute of Sport.

- *3764 RELOCATION OF OPEN HIGH SCHOOL—Ms Jo Haylen asked the Minister for Education—
 - (1) What is the budgeted cost for:
 - (a) Renovating the Petersham West Street TAFE campus to accommodate the Open High School?

- (b) Relocating the Open High School to the site?
- (2) What was the yearly rent paid to the Department of Education by the Department of Skills when the site was being used as a TAFE campus?
- (3) What will be the enrolment capacity at Randwick Public School after the relocation of Open High School to Petersham?

Answer-

- (1) (a) and (b) All budgeted costs are commercial in confidence until the tender process is complete.
- (2) The Department of Skills does not pay rent to the Department of Education for use of the campus.
- (3) Approximately 1,000 students.
- *3765 STATE EMERGENCY SERVICE HEADQUARTERS UPGRADES—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—
 - (1) Which State Emergency Service Headquarters are scheduled for priority upgrades within the next four years?
 - (2) How much has been allocated for each project?
 - (3) What is the projected total cost for each project?
 - (4) When is the expected completion date for each project?

Answer-

\$13.5 million in capital funds has been committed for the fit-out of the new State Emergency Service Headquarters in 2016-17. Works are due for completion in July 2017. There are no regional headquarters scheduled for priority upgrades.

Local councils provide facilities for NSW SES Units. The NSW SES provides grants to councils to support the ongoing maintenance of the infrastructure.

- *3766 UPGRADES OF RURAL FIRE STATIONS—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—
 - (1) Which Rural Fire Service Stations are scheduled for priority upgrades within the next four years?
 - (2) How much has been allocated for each project?
 - (3) What is the projected total cost for each project?
 - (4) When is the expected completion date for each project?

Answer-

Traditionally, Local Councils work with the NSW RFS annually to determine and apply for funds in respect of Fire Control Centres (FCCs), fire stations and infrastructure project initiatives. With the start of the revised Rural Fire Fighting Fund allocation methodology in 2016-17, the agency will move towards a Total Asset Management approach including the development of a strategic multi-year forecast infrastructure plan.

The NSW RFS is currently seeking input from local stakeholders as part of this process. Allocations vary depending on the nature of the proposed works; for 2016-17 this ranges from \$500 to \$2.5 million, with over \$19 million allocated in total. More than 250 infrastructure project allocations are planned for 2016-17 alone.

The NSW RFS provides infrastructure grants to Local Government on the basis that planning has been undertaken to facilitate timely construction, normally within the year of allocation. Completion dates are influenced by contractual arrangements, contingencies, variations and weather delays.

- *3767 TRAINING FOR NEW RECRUITS—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—
 - (1) What training is provided to new Prison Officers to combat fires in Correctional Centres?
 - (2) Are they trained to use the various fire fighting apparatus available in NSW Correctional Centres?

Answer—

- (1) Correctional officer primary training includes a fire fighting module on responding to a fire in a cell and instruction on the use of smoke hoods and hydrant hoses. These modules are:
 - Demonstrate First Attack Firefighting Equipment
 - · Maintain Security
 - · Contribute to Workplace Safety

- (2) Each correctional centre has a Fire Safety Manager who provides training to correctional officers in the use of smoke hoods, fire hose reels, hydrants and evacuation plans and procedures for fire and bomb threats.
- *3768 NEW PRISON OFFICERS—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

How many new recruit Prison Officers were trained in the each year from 2011 to 2016 (as at 11 August 2016)?

Answer-

The number of new prison officers enrolled in Correctional Officer Primary Training for the period between 2011 and 11 August 2016 was:

*3769 RESTRAINT METHODS IN JUVENILE JUSTICE CENTRES—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

What restraint methods are used in juvenile justice centres throughout New South Wales?

Answer-

As defined in the Children (Detention Centres) Regulation 2015, instruments of restraint include:

- · Handcuffs
- · Flexi-cuffs
- · Ankle cuffs
- · Restraining belts
- Riot shields (When deployed in a use of force)

Instruments of restraint are used by Juvenile Justice Centre staff for the safe and effective management of the detainee, staff and other detainees.

Juvenile Justice does not use restraint chairs, spit hoods or chemical agents.

*3770 LIQUOR GAMING AND RACING NEWCASTLE OFFICE—Mr Tim Crakanthorp asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—

How many days a week is the Newcastle Office of Liquor Gaming and Racing staffed (as at 11 August 2016)?

Answer-

There are currently no staff permanently based at the office in Newcastle. The office has been used on an as needs basis when Liquor & Gaming NSW officers have conducted operations in the Newcastle area.

The Government has implemented reforms to improve the liquor and gaming regulatory structures. Liquor & Gaming NSW is responsible for the regulation of the liquor, wagering, gaming and registered club industries in New South Wales.

Liquor & Gaming NSW is committed to servicing regional New South Wales. The future of the Newcastle office is being considered as part of accommodation arrangements going forward.

- *3771 SYDNEY METRO EXTENSION STUDY SUBMISSIONS—Ms Tania Mihailuk asked the Minister for Transport and Infrastructure—
 - (1) How many submissions were received with respect to the Sydney Metro Extension Study between Bankstown and Liverpool?
 - (2) When will these submissions be published?

Answer-

Submissions on the potential extension of the Sydney Metro from Bankstown to Liverpool will be considered as part of the Western Sydney Rail Needs Study. It is anticipated the study's final report will be released later this year.

- *3772 FULL-TIME EQUIVALENT STAFF AT BANKSTOWN SERVICE NSW—Ms Tania Mihailuk asked the Minister for Finance, Services and Property—
 - (1) How many full-time equivalent staff were employed at the Bankstown Service NSW shopfront in each of the financial years 2015-16 and 2016-17 (as at 11 August 2016)?
 - (2) Will the planned reduction in opening hours at the Bankstown Service NSW result in a decrease in full-time equivalent staff?

Answer-

- (1) As at 30 June 2015, the Bankstown Service Centre had 33.69 FTE staff. As at 11 August 2016, there was a total of 40.33 FTE staff.
- (2) No, the change in operating hours will not directly impact staff numbers at the Bankstown Service Centre. Service NSW staff will continue to be rostered according to their contract hours with more team members available to assist customers during peak periods.
- *3774 CONVERSION OF THE JUNIPERINA JUVENILE JUSTICE CENTRE—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—
 - (1) Were any of the juvenile female inmates from Juniperina transferred to Cobham juvenile remand centre whilst the centre was being converted to a 100 bed maximum security prison?
 - (a) If so, what was the cost to transfer and rehouse them in a male only centre?
 - (2) What additional measures have been taken to rehouse them in Cobham?

Answer-

No juvenile female detainees from Juniperina Juvenile Justice Centre were transferred to Cobham Juvenile Justice Centre whilst the centre was being converted to a 100 bed adult prison.

- *3777 STATUTORY CHILD PREOTECTION SERVICES JOBS—Ms Tania Mihailuk asked the Minister for Family and Community Services, and Minister for Social Housing—
 - (1) What specific effect will a forecasted cut of 56 full time equivalent employees, as indicated in the NSW Budget 2016-17 Budget Paper No. 3 pg 3 10, have on statutory child protection services, and whether that means job losses (reference LA Q3511)?
 - (2) What specific effect will a forecasted cut of \$10.8 million in employee expenses, as indicated in the NSW Budget 2016-17 Budget Paper No. 3 pg 3 10, have on statutory child protection services, and whether that means job losses?

Answer—

- *3778 SENIORS CARD APPICATIONS—Ms Jo Haylen asked the Minister for Family and Community Services, and Minister for Social Housing representing the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism—
 - (1) How many Seniors cards have been issued to residents of the Summer Hill electorate in the past two financial years?
 - (2) How many applications have been rejected from applicants in the Summer Hill electorate over the past two financial years?
 - (3) How has the need for Seniors Card applications to be made online impacted the number of applications received across New South Wales?
 - (4) What measures has the Government taken to make the application process accessible for the many elderly residents who do not have access to the internet or email?

Answer-

- (1) More than 2,500 have been issued to residents of the Summer Hill electorate in the past two financial years.
- (2) This information is not collected by Seniors Card.
- (3) Applications have increased since the phase out of paper applications.

- (4) For those without access to internet or email, applications can be lodged over the phone or at Service NSW centres across the state
- *3779 PORT WARATAH COAL SERVICES—Mr Tim Crakanthorp asked the Minister for Industry, Resources and Energy—
 - (1) Considering the lease of Port Waratah Coal Services Carrington site lease is due to expire in 2024, does the Government have any involvement in the lease extension process?
 - (a) If so, what involvement?

Answer-

This question would best be directed to my colleague the Treasurer.

- *3780 DOWNER EDI LIGHT RAIL CONTRACT—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—
 - (1) What is it that Downer EDI have been tasked with in relation to the Newcastle Light Rail? What is the contract for?
 - (2) What employment will be generated?
 - (3) What is the contract worth?

Answer-

Downer EDI Limited has been appointed as the Managing Contractor to design, construct and commission 2.7 kilometres of light rail track in Newcastle, six light rail stops, a stabling and maintenance facility, road works and associated precinct works. The contract commenced in August 2016 and is scheduled to be completed in 2019.

This contract is being delivered as part of the \$510 million Newcastle Urban Transformation and Transport Program, designed to bring people back to the city centre by strengthening connections between the city and the waterfront, creating job opportunities, providing more public places and spaces, and delivering better transport.

This program is supporting local businesses and jobs. Over 80 contractors and subcontractors with a local presence have been engaged so far to deliver work under the program, and it is expected that the project will generate employment for up to 100 people in peak construction periods and about 60 people during operation.

- *3781 GAYAA DHUWI DECLARATION—Ms Tania Mihailuk asked the Minister for Mental Health, Minister for Medical Research, Assistant Minister for Health, Minister for Women, and Minister for the Prevention of Domestic Violence and Sexual Assault—
 - (1) Considering the recommendations of the NSW Mental Health Commission in regards to Aboriginal and Torres Strait Islander mental health and suicide prevention outcomes, can the Minister provide a list of NSW Government agencies and services who have considered the Gayaa Dhuwi Declaration in the design and delivery of their services and programs?
 - (a) If not, why not?
 - (2) What action has the Minister undertaken to ensure that agencies and services are compliant with Gayaa Dhuwi Declaration?

Answer-

The Gayaa Dhuwi (Proud Spirit) Declaration is consistent with current NSW Health policies particularly the NSW Aboriginal Health Plan 2013-2023, the NSW Aboriginal Mental Health and Wellbeing Policy 2006-2010 and the Aboriginal Health Workforce Strategic Framework 2011-2015.

The NSW Ministry of Health is undertaking a review of the NSW Aboriginal Mental Health and Wellbeing Policy and is in the process of developing a new framework for 2017-2024.

The Ministry of Health will take account of the Declaration during development of the new policy framework.

- *3782 HOME CARE SERVICES JOBS—Ms Tania Mihailuk asked the Minister for Family and Community Services, and Minister for Social Housing—
 - (1) What specific effect will a forecasted cut of 35 full time equivalent employees, as indicated in the NSW Budget 2016-17 Budget Paper No. 3 pg 3 11, have on out of home care services, and whether that means job losses (reference LA Q5510)?

(2) What specific effect will a forecasted cut of 4.13 million in employee expenses, as indicated in the NSW Budget 2016-17 Budget Paper No. 3 pg 3 11, have on out of home care services, and whether that means job losses?

Answer—

I refer to the response to Question on Notice 3510. The 2016-17 Budget makes no cuts to out-of-home-care services.

- *3783 EARLY INTERVENTION AND SUPPORT PROGRAMS—Ms Tania Mihailuk asked the Minister for Family and Community Services, and Minister for Social Housing—
 - (1) What specific effect will a forecasted cut of 9 full-time equivalent employees, as indicated in the NSW Budget 2016-17 Budget Paper No. 3 pg 3 9, have on early intervention and support programs, and whether that means job losses (reference LA Q3509)?
 - (2) What specific effect will a forecasted cut of \$1.92 million in employee expenses, as indicated in the NSW Budget 2016-17 Budget Paper No. 3 pg 3 9, have on early intervention and support programs, and whether that means job losses?

Answer-

- *3784 OWNED HIRE CAR AND TAXI PLATES IN NEW SOUTH WALES—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—
 - (1) How many Owned Hire Car Plates or Taxi Plates are there in New South Wales?
 - (2) How much money has been put aside to assist Hire Car and Taxi Licence holders as a result of the reforms to Uber?
 - (a) Is this enough?
 - (3) Why isn't Uber paying all the levy to the Government instead of to the two established industries?

Answer-

There are almost 7,000 taxi licences and more than 750 hire car licences in New South Wales as at 16 August 2016.

The Government has established a \$250 million industry adjustment assistance package and removed restrictive regulation which will benefit all industry participants.

*3785 BANKSTOWN SERVICE NSW—Ms Tania Mihailuk asked the Minister for Finance, Services and Property—

Why is the Government reducing access to Government services in Bankstown by cutting the extended trading hours at the Bankstown Service NSW shopfront outside of normal business hours (reference LA Q0455)?

Answer-

An analysis of customer data has shown that there is limited customer demand for services before 8.30am and after 5.30pm weekdays. Service NSW's hours of operation are being adjusted to ensure resourcing levels are aligned to when the majority of customers choose to visit, which is between 11.00am and 2:30pm.

Operation Fabian, now concluded, was conducted by metropolitan Highway Patrol police and targeted 16 critical intersections.

It should be noted that additional intersections may have been monitored and subject to enforcement action by police.

A range of considerations are taken into account when determining target locations. These include crash histories; severity of crashes or injuries; road user volumes; location audits to confirm suitability for enforcement; and local police knowledge.

The Traffic and Highway Patrol Command works closely with the Centre for Road Safety to identify and respond to road safety issues. As at the end of July 2016, Millers Point sales have delivered \$263 million in gross proceeds which has been used to fund the construction of 650 new homes in the Southern, Western, South West Sydney and the Illawarra areas in NSW, aligned to areas of social housing need. Over 1,500 new social housing dwellings are planned to be built from Millers Point proceeds in metropolitan Sydney and regional NSW. The timing and location of these new homes is dependant on the timing of sale proceeds. Through the Communities Plus program, the NSW Government will deliver 23,000 new replacement social housing dwellings, with the location and timing of the new homes to be determined over the ten year program. Already the Government has announced major new social housing projects at Ivanhoe, Telopea, Riverwood and Waterloo. During the past six years the share of renewables in the New South Waleseenergy mix has more than doubled. Renewables, including Snowy Hydro and small scale generators such as rooftop solar PV systems, contributed around 14 per cent of the New South Wales energy mix in 2015.

Recent Government initiatives include the launch of the NSW Renewable Energy Resource Map and GreenPower Connect, to encourage large-scale investment opportunities by providing access to free data and more cost-effective accreditation.

The Government has also asked its electricity retailer, ERM Power, to issue a competitive tender to purchase up to 92 gigawatt hours of electricity generated from largescale solar farms that are seeking Commonwealth funding under the Australian Renewable Energy Agency's national \$100 million competitive round for large-scale solar. This will be used to meet the Government's electricity needs.

Residents and businesses were advised by letterbox drop on 13 July 2016 that geotechnical investigations would occur in Applebee Street, near May Street and Short Street, from Thursday, 28 July 2016 for up to a two week period.

There were no lane closures associated with WestConnex works on the Princes Highway between Short and May streets around 8.30 on 1 August 2016.

All roadworks on the WestConnex are carried out in accordance with the State Environmental Planning Policy (Infrastructure) 2007 and the Roads Act 1993.

All Road Occupancy Licences in the Sydney region and the M1 Corridor up to Beresfield are approved by the Transport Management Centre under the delegation of operational functions from Roads and Maritime Services in accordance with the Roads Act 1993. Work carried out on the Princes Highway from Canal Road, St Peters to Goodsell Street, Alexandria on 1 August and 2 August 2016 was carried out under a Road Occupancy Licence.
