#### **15 SEPTEMBER 2020**

(Paper No. 76)

- \*3890 SCHOOL ZONE ROAD LINE MARKING MAITENANCE—Ms Jodie Harrison asked the Minister for Transport and Roads—
  - (1) Considering a number of schools in the Charlestown electorate are expected to soon require school zone road line marking maintenance, how is this maintenance prioritized?
  - (2) What was the budget for this maintenance for school zones in the Charlestown electorate in each financial year from 2014-15 to 2019-20?
  - (3) What was the average cost per school to maintain road line markings?

Answer-

I am advised:

- (1) Priorities are determined based on the asset maintenance guideline Traffic Facility Measurement Criteria for Condition Rating. According to this criteria, once a deteriorating school zone patch reaches a condition rating of 4, it is due for renewal. State Road school zone patches are inspected by Transport for NSW Signs and Markings Inspectors. Regional and local road school zone patches are inspected by Regional Safety Around Schools officers.
- (2) Maintenance expenses on 40 km/h school zone patches in the Charlestown electorate for

2014-15 and 2015-16 are not available.

2016-17: \$42,500

2017-18: \$96,200

2018-19: \$51,300

2019-20: \$95,200.

- (3) Approximately \$10,000. This is calculated based on an average of three school zone patches/dragons teeth per school. The current cost per patch including dragon teeth is \$3,250.00.
- \*3891 SCHOOL ZONE FLASHING LIGHTS—Ms Jodie Harrison asked the Minister for Transport and Roads—
  - (1) Considering a number of schools in the Charlestown electorate are expected to soon require replacement of school zone flashing lights, how is replacement of these assets prioritised?
  - (2) What was the budget for replacing school zone flashing lights in each financial year from 2014-15 to 2019-20?
  - (3) What was the average cost to replace one set of school zone flashing lights?

Answer-

I am advised:

(1) The Government is committed to improving the safety of all road users, especially the most vulnerable members of our community, our children. The Government has ensured that every school in New South Wales has at least one set of school zone flashing lights, and there are now more than 6,500 flashing lights in place across New South Wales .

Transport for NSW maintains school zone flashing lights to a high standard. Flashing lights that reach the end of their lifecycle are planned for and replaced within the flashing lights maintenance program. Specific maintenance works can also be required to upgrade flashing lights technologies, for example to align with the upgrade of mobile communications networks.

(2) School zone flashing lights maintenance expenditure across New South Wales:

\$2,653,000	\$3,000,000	\$3,856,000	\$4,313,000	\$5,812,000	\$5,153,000

- (3) The cost to replace one set of school zone flashing lights is dependent on a variety of factors around the relevant site, other maintenance works and which components require replacement. As such, an average cost is not always indicative of the overall expenditure to replace or otherwise maintain of a specific set of school zone flashing lights.
- \*3892 SCHOOL KISS AND RIDE ZONE APPLICATIONS—Ms Jodie Harrison asked the Minister for Transport and Roads—

What steps must be undertaken by a school when applying for a kiss and ride zone?

Answer-

I am advised:

School communities can work with their local council to manage their Pick-up and Drop-off initiative.

- \*3893 GREEK-SPEAKING HEALTH EDUCATION OFFICER—Ms Jo Haylen asked the Minister for Health and Medical Research—
  - (1) Why has the Greek-speaking health education officer at the NSW Multicultural Health Communication Service ceased providing health services to the Greek-speaking community, including in the Marrickville and Canterbury communities?
  - (2) What planning is taking place to restore or replace the services provided by the Greek-speaking health education officer at the NSW Multicultural Health Communication Service?
  - (3) Why have the following programs offered through the Service been cancelled:
    - (a) Tuesday Greek Seniors Service?
    - (b) Thursday Greek Carers and Frail Aged Service?
    - (c) Gentle exercise classes for Seniors?
    - (d) Thursday Greek men's only program?
  - (4) What planning is taking place to restore or replace these services and programs?
  - (5) Why are these critically important position and programs servicing a vulnerable community being cut during a health emergency?

#### Answer-

I am advised that the NSW Multicultural Health Communication Service (MHCS) does not employ a 'Greek-speaking health education officer', and does not deliver the specific services referred to in the question.

Sydney Local Health District continues to support a suite of programs targeting vulnerable, culturally and linguistically diverse seniors. The focus of these programs includes healthy ageing, falls prevention, pain management, and diabetes prevention and management.

Greek speaking workers have been trained in the delivery of 'Get Connected & Stay Connected', a telephone based social connection program supporting vulnerable seniors from culturally and linguistically diverse backgrounds.

The Sydney Local Health District has suspended some face-to-face community education groups due to the potential public health risk, noting that many are attended by people who are over 65 years of age and vulnerable to COVID-19 transmission.

- \*3894 NSW AGED CARE RESPONSE CENTRE—Ms Jo Haylen asked the Minister for Health and Medical Research—
  - (1) What work has been undertaken to prepare for the establishment of a NSW Aged Care Response Centre in the event of further outbreaks of COVID-19 in New South Wales aged care facilities as at 15 September 2020?
  - (2) What is the threshold of infections in New South Wales aged care facilities at which a NSW Aged Care Response Centre would commence operations?
  - (3) Would the NSW Aged Care Response Centre be established within NSW Health?
  - (4) How many staff would be allocated to the NSW Aged Care Response Centre?
  - (5) Where would staff associated with the NSW Aged Care Response Centre be located?
  - (6) What funding would be available to the NSW Aged Care Response Centre?

#### Answer-

NSW Health has established a dedicated Aged Care team within the State Health Emergency Operations Centre (SHEOC) to lead response preparedness. This team monitors suspected cases as well as local clusters. Staffing will be scaled according to need.

There are a number of scenarios which may trigger the activation of the SHEOC Aged Care Emergency Response capability, including:

- A single case of COVID-19 is confirmed in a resident, staff member or frequent attendee of a residential aged care facility (RACF)
- There is widespread, or "hot spots" of, community transmission which escalates the risk to RACFs
- · Capacity to respond is under significant stress

• There is a confirmed outbreak in one or more RACFs.

\*3895 NSW LGBTI HEALTH STRATEGY—Ms Jo Haylen asked the Minister for Health and Medical Research—

When will the NSW LGBTI Health Strategy be publicly released?

Answer-

The strategy is expected to be released in the first half of 2021.

- \*3896 LEGAL PATHWAYS PROGRAM—Ms Jo Haylen asked the Attorney General, and Minister for the Prevention of Domestic Violence—
  - (1) Why has the Government decided to cease funding for the Legal Pathways Program, jointly run by Legal Aid and the Council for the Ageing (COTA)?
  - (2) How does the Government plan to ensure that the 800 vulnerable older people in the community who access the service each year will continue to have access to advice in relation to preparing wills, powers of attorney, and enduring guardianship documentation?
  - (3) How does the Attorney General justify this reduction considering that financial abuse accounts for roughly 38 per cent of calls to elder abuse helplines and the increased risk of elder and financial abuse caused by social isolation during the COVID-19 pandemic?

Answer-

I am advised:

The Minister for Skills and Tertiary Education and Acting Minister for Sport, Multiculturalism, Seniors and Veterans has confirmed that the Legal Pathways Program will continue to be funded.

- \*3897 NEW SOUTH WALES STATE SUPER SCHEME—Ms Jo Haylen asked the Treasurer—
  - (1) Does the Government intend to proceed with a 1 per cent reduction to pensions paid out by the New South Wales State Super Scheme?
    - (a) If so, why?
  - (2) What support is planned for the vulnerable seniors who will be impacted by this cut during the economic downturn caused by COVID-19?

Answer-

On 16 September 2020, the Government introduced the Superannuation Legislation Amendment Bill 2020 to amend the relevant pension's legislation to ensure that the pensions of nearly 67,000 retired New South Wales public servants, who are members of the schemes managed by State Super would not fall in October.

The Bill received unanimous support in both houses and received Royal Assent on 23 September 2020.

- \*3898 PROCLAMATION OF THE MODERN SLAVERY ACT 2018—Ms Jo Haylen asked the Premier—
  - (1) Why has the Premier and Government not yet advised the Governor of New South Wales and Executive Council to proclaim the Modern Slavery Act 2018?
  - (2) When will the Premier and Government do so?

Answer—

- On 24 September 2020, the Government tabled its response to the Legislative Council's Standing Committee on Social Issues inquiry into the Modern Slavery Act 2018 (NSW).
- \*3899 OUT OF SCHOOL HOURS CARE SERVICES—Ms Jo Haylen asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
  - (1) Is it Government policy to mandate Out of School Hours Care (OOSH) services to be Child Safe Organisations?
  - (2) What plans does the Government have to mandate that OOSH services register as a Child Safe Organisation?
  - (3) What work has been conducted to ensure OOSH services are aware of the benefit of registering as a Child Safe Organisation and complying with their obligations if they have registered as one?
  - (4) How many OOSH services in New South Wales are currently registered as Child Safe

## Organisations?

#### Answer-

Questions regarding the Child Safe Standards should be directed to the Minister for Families, Communities and Disability Services.

I can advise that the Department of Education regulates early childhood education and care services, including Outside School Hours Care services in New South Wales, under the National Quality Framework (NQF) and in accordance with the Children Education and Care Services National Law, and Education and Care Services National Regulations.

The Department works closely with the sector and with other jurisdictions to review and refine processes that ensure effective regulation with the health, safety and wellbeing of children as our primary consideration. Authorised Officers from the Department regularly monitor services to check compliance with Working with Children Checks, and irregularities are reported immediately to the responsible agency, which is the Office of the Children's Guardian.

The Department also assesses applicants to ensure they meet strict requirements in order to operate an early childhood education and care service under the NQF.Applicants for new services and new providers, or any changes to persons with management or control, must clearly understand their responsibilities under the National Law and National Regulations in order to operate a service.

## \*3900 INFORMATION BREACH—Ms Jo Haylen asked the Minister for Police and Emergency Services—

- (1) Did the NSW Police Force or the Law Enforcement Conduct Commission send an email to a complainant/complainants containing the email addresses of over 150 people who registered objections to the actions taken by the NSW Police Force at a Black Lives Matter protest at Central Station on 6 June 2020?
  - (a) If so:
    - (i) What was the cause of the breach?
    - (ii) What actions have been taken to rectify the breach?
- (2) Did the Minister, the Government or the NSW Police Force refer the matter to the Information and Privacy Commission NSW?
  - (a) If not, why not?
  - (b) If so, what is the outcome of the referral?

### Answer-

## I am advised:

- (1) Yes.
- (a) (i) Administrative error.
- (ii) An apology and explanation of the circumstances will be provided to those affected by the disclosure, and the Privacy Commissioner will be informed of all actions taken.
- (2) On 14 August 2020, one of the complainants whose email address was disclosed lodged a complaint via the Customer Assistance Unit. The complaint has been referred to the Administrative Officer Conduct Unit, Professional Standards Command. On the same day the Privacy Commissioner wrote to the Police Commissioner regarding the breach. The NSW Police Force has provided information to the Privacy Commissioner concerning the breach and an internal review is currently underway.
- \*3901 BREACHES OF THE CHILDREN (EDUCATION AND CARE SERVICES) NATIONAL LAW (NSW)
  —Ms Jo Haylen asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
  - (1) How many confirmed breaches of the Children (Education and Care Services) National Law (NSW), Section 165, occurred in Out of School Hours services from 1 July 2018 to 15 September 2020?
    - (a) How many of these breaches have resulted in criminal charges being laid against:
      - (i) Out of School Hours operators?
      - (ii) Out of School Hours staff?
  - (2) How many confirmed breaches of the Children (Education and Care Services) National Law (NSW), Section 167, occurred in Out of School Hours services from 1 July 2018 to 15 September 2020?
    - (a) How many of these breaches have resulted in criminal charges being laid against:
      - (i) Out of School Hours operators?
      - (ii) Out of School Hours staff?

Answer-

- (1) From 1 July 2018 to 15 September 2020 there were 136 confirmed breaches of section 165 of the Children (Education and Care Services) National Law (NSW) in Outside School Hours Care services in New South Wales.
  - (a) Three approved providers and two nominated supervisors have been charged in relation to these breaches.
- (2) From 1 July 2018 to 15 September 2020 there were 150 confirmed breaches of section 167 of the Children (Education and Care Services) National Law (NSW) in Outside School Hours Care services in New South Wales.
  - (a) Two approved providers and one nominated supervisor have been charged in relation to these breaches.
- \*3902 WALLSEND ELECTORATE HOUSING NSW PROPERTIES—Ms Sonia Hornery asked the Minister for Water, Property and Housing—
  - (1) How many maintenance repairs and upgrades to Housing NSW properties in the Wallsend electorate were undertaken in the 2018-19 and 2019-20 financial years?
  - (2) What was the cost for in the 2018-19 and 2019-20 financial years?

Answer-

I am advised:

- (1) In 2018-19, 1,555 properties in Wallsend received maintenance repairs and upgrades. In 2019-20, 1,562 properties in Wallsend received maintenance repairs and upgrades
- (2) The cost in the 2018-19 and 2019-20 financial years was \$4,762,558 and \$5,749,208 respectively.
- \*3903 MEAT PROCESS WORKERS—Ms Sonia Hornery asked the Treasurer—

Why were food workers, specifically meat process workers, such as those at Baiada in the Wallsend electorate, excluded from the COVID-19 Legislation Amendment (Emergency Measures - Miscellaneous) Bill 2020?

    - (b) Newcastle City and Lake Macquarie Local Government Areas?

- \*3911 GRIFFITH TAFE WASTE DISPOSAL SERVICES—Mrs Helen Dalton asked the Minister for Skills and Tertiary Education—
  - (1) Why did the Government terminate Griffith Recycling's contract for waste disposal services at Griffith TAFE after 24 years of loyal service?
  - (2) How does the decision to replace a local family business with a Melbourne-based multinational benefit the Griffith economy and community?
  - (3) Considering community outrage, will consideration be given to reverse this decision?

#### Answer-

I am advised that TAFE NSW, as a government agency, is required to leverage whole of Government contracts to ensure the best value for the taxpayers of New South Wales and consistency of service delivery across the State. I understand that in line with this whole of Government approach, TAFE NSW approached the market in September 2019 seeking to contract a single supplier for the provision of Waste Management Services across more than 160 TAFE NSW locations.

I am further advised that following evaluation, TAFE NSW awarded a five-year contract to the successful bidder, Cleanaway, in February 2020. I am informed that Cleanaway is required to comply with the Government's Small and Medium Enterprise and Regional Procurement Policies, and that there are contractual obligations placed on Cleanaway to ensure opportunities continue to exist for local businesses to provide sub-contracted services.

I am also advised that in carrying out the contracted services for TAFE NSW, Cleanaway employ a number of Griffith residents and subcontract to a number of local businesses in the region. Additionally, I understand that that Cleanaway have proactively engaged with Griffith Recycling to provide the opportunity to continue to provide services to TAFE NSW as a subcontractor.

\*3912 RESPONSES TO MEMBERS OF PARLIAMENT—Mr Anoulack Chanthivong asked the Minister for Planning and Public Spaces—

- (1) Considering the response to LA Q3793, does the Minister's office capture a member's party affiliation when determining the sign-off for Ministerial correspondence?
  - (a) If so, is this the criteria used to determine if you or a Departmental officer sign-off on Ministerial correspondence?
- (2) Are any replies to letters from Members of the Government signed by anyone other than you?

- \*3914 HOUSING STOCK IN THE MACQUARIE FIELDS ELECTORATE—Mr Anoulack Chanthivong asked the Minister for Water, Property and Housing—
  - (1) How many new residential Housing NSW properties were added to the housing stock in the Macquarie Fields electorate in the 2019-20 financial year?
  - (2) How many Housing NSW properties are being considered for construction in the Macquarie Fields electorate in the 2019-20 financial year?
  - (3) How many Housing NSW properties have been removed from the housing stock in the Macquarie Fields electorate in the 2019-20 financial year?
    - (a) Of these removed residential units, how many were:
      - (i) Demolished;
      - (ii) Sold;
      - (iii) Declared unfit for use?

### Answer—

In the list of public schools provided, two specialist support classes have been established for the 2020-21 financial year; one at Ajuga School and one at Curran Public School. Both support classes were accommodated in existing spaces with capacity to support up to 17 students in total.

- \*3919 DEFIBRILLATOR AT LEPPINGTON STATION—Mr Anoulack Chanthivong asked the Minister for Transport and Roads—
  - (1) Is there a defibrillator at Leppington Station?
    - (a) If not, why not?

Answer-

I am advised:

- (1) No, there is currently not a defibrillator located at Leppington Station. The nearest installed defibrillator is four kilometres from Leppington Station at Leppington Stabling Yard.
- (a) The primary reason a defibrillator is not installed at this station is low customer patronage.

As the Leppington area continues to develop/expand and more residents use the station, a reassessment of this decision may occur in the future.

NSW Ambulances carry defibrillators and would be the primary responders to a 000 call for a medical emergency at the station. A NSW Ambulance paramedic response point is located 2.4 kilometres from the Station on Cowpasture Road.

- \*3920 INSTALLATION OF TRAFFIC LIGHTS AT MACDONALD ROAD AND ARTHUR ALLEN DRIVE, BARDIA—Mr Anoulack Chanthivong asked the Minister for Transport and Roads—
  - (1) When did Dahua Group submit a design for the traffic lights at the intersection of Macdonald Road and Arthur Allen Drive, Bardia?
  - (2) Has the installation of the traffic lights been approved?
    - (a) If so, when will the traffic lights be installed?
  - (3) What is the average time between approval of a traffic light design and installation?

Answer-

I am advised:

- (1) Transport for NSW is awaiting Dahua Group's traffic signal design package to be submitted for review. Transport for NSW wrote to Dahua Group's representative on 13 July 2020 requesting it.
- (2) Transport for NSW has not approved the installation of these traffic lights, as the design package has not yet been received from Dahua Group or its representative.
- (3) The average time is dependent on a design being approved and the developer entering into a Works Authorisation Deed with Transport for NSW to construct the traffic lights.
- \*3921 ECONOMIC STIMULUS MACQUARIE FIELDS ELECTORATE—Mr Anoulack Chanthivong asked the Treasurer representing the Minister for Finance and Small Business—
  - (1) Has the department or agency responsible for administering the fees and charges waiver for small businesses under the COVID-19 stimulus package been in direct contact with small businesses in New South Wales to advise of the waiver?
    - (a) If not:
      - (i) Why not?
      - (ii) Will the Government directly contact small businesses now?

Answer—

The Government is waiving a range of licence and permit fees for small businesses for 12 months as part of the New South Wales COVID-19 stimulus package. Licence and permit fee waivers are being administered by several New South Wales government agencies.

The Government is communicating with small business using a mix of print, media, online and direct communications, and engaging business groups and industry associations to further extend the reach of our messaging into the business community.

The Government and Service NSW websites provide information for small business and individuals to support their COVID-19 recovery. Direct measures such as emails to registered New South Wales businesses have been used to inform small businesses of the licence and permit fee waivers available.

A COVID-19 business advertising campaign has been underway since June 2020 to inform small business owners of the range of financial assistance available to them. This information has been communicated through television, radio, digital display, social media, email, printed collateral and website content.

The Service NSW Business Concierge service helps small businesses find assistance to support their COVID-19 business recovery. Its dedicated phone consultation service provides one-on-one communication with small business owners to help them access the support that they need.

- \*3922 SAFEGUARDING FUTURE EXTENSIONS TO SYDNEY METRO—Ms Tania Mihailuk asked the Minister for Transport and Roads—
  - (1) Considering Transport for NSW's response at item 7.1 of Table 1: Response to issues raised in the submissions for the Sydney Metro Sydenham to Bankstown Mod 1 Bankstown Station, which states "the approved project and proposed modification supports the opportunity for other extensions to the metro network and the design has safeguarded for future extensions in the future", how has the design safeguarded these potential future extensions to the Metro?
    - (a) What options for the future extension of the Metro from Bankstown to Liverpool have been "safeguarded"?
    - (b) When will residents be informed of which future Metro extension options have been "safeguarded"?

### Answer—

#### I am advised:

- (1) (a) The design of the proposed works at Bankstown Station do not preclude any type of future metro extension past Bankstown.
- (b) Stakeholders, including the community, are kept informed of progress of projects at the appropriate time.
- \*3923 LOCAL PLANNING PANELS APPROVALS—Ms Tania Mihailuk asked the Minister for Planning and Public Spaces—
  - (1) Since Local Planning Panels were first mandated in the Greater Sydney and Wollongong regions in March 2018, how many planning proposals to triple or more than triple the maximum permissible building height have been approved to proceed to Gateway by Planning Panels (as at 15 September 2020)?
    - (a) Of this number, how many were ultimately approved:
      - (i) By the Gateway process?
      - (ii) With a variation reducing the increase in maximum permissible building?

#### Answer-

## I am advised:

Local planning panels do not approve planning proposals, but provide advice to the council to consider before council decides if the proposal should proceed to Gateway.

- \*3924 REVISED DESIGN OF BANKSTOWN STATION—Ms Tania Mihailuk asked the Minister for Transport and Roads—
  - (1) Considering Table 3.1 of Sydney Metro's Sydney Metro City & Southwest, Bankstown Station Modification Report, which grades the two options being considered for the revised design of Bankstown Station as 'Exceeds requirements/excellent outcomes' for the 'Complexity of work for future Liverpool Extension' criteria, how was this criteria assessed?

- (a) Will this criteria contemplate an underground metro extension or at grade metro extension to Liverpool?
- (b) Is the Bankstown Arts Centre being considered as a site for an at grade metro extension, or a dive site for an underground metro extension to Liverpool?
  - (i) If not, how will the Bankstown Arts Centre be preserved in the event an extension of the South West Metro to Liverpool proceeds?

#### Answer-

I am advised:

No decision has been made by the Government.

The Government will update the community on our plans as soon as we have more to say.

- \*3925 BANKSTOWN-LIDCOMBE HOSPITAL SITE SELSECTION PROCESS—Ms Tania Mihailuk asked the Minister for Health and Medical Research—
  - (1) Considering the Request for Information, which closed on 28 August 2020 for the site selection process for the Bankstown-Lidcombe Hospital, how many total submissions were received?
    - (a) How many of these submissions were:
      - (i) Greenfield sites?
      - (ii) Brownfield sites?
      - (iii) Council-owned sites?

#### Answer-

- (1) Six Request for Information (RFI) submissions were received.
  - (a) The submissions to the RFI process are subject to Commercial in Confidence.
- \*3926 PARTIAL RESTORATION SERVICES—Ms Tania Mihailuk asked the Minister for Transport and Roads—

Considering Transport for NSW's proposed rail options for stations west of Bankstown in 2024, which propose the partial restoration of the Liverpool/Bankstown via Regents Park services, and that they can be implemented with existing infrastructure, will the Government consider an earlier starting date for the partial restoration of the Liverpool/Bankstown via Regents Park services?

## Answer—

I am advised:

It is not feasible to implement the preferred option any earlier than 2024 (when Sydney Metro and Southwest is operational). This is because in peak periods, rail tracks running through the City Circle are at capacity.

Transport for NSW is reviewing all feedback received on the proposed rail service options for west of Bankstown stations. The results of its consultation process will be published in a report later this year.

- \*3927 ASSESSMENT CRITERIA FOR BANKSTOWN-LIDCOMBE HOSPITAL SITE SELECTION—Ms
  Tania Mihailuk asked the Minister for Health and Medical Research—
  - (1) What criteria is the Government using to assess the submissions made through the Request for Information for the site selection of the Bankstown-Lidcombe Hospital?
    - (a) Is the comparable suitability of each nominated site against the option of redevelopment of the existing Bankstown-Lidcombe Hospital location at Eldridge Road one of the assessment criteria?

#### Answer—

The site selection process includes comprehensive evaluation criteria and will be informed by assessments undertaken by expert independent advisers. The process will also be informed by clinical services planning which is underway to determine the future health needs of the community.

Sites being assessed are commercial-in-confidence.

- \*3928 AVAILABILITY OF THE REQUEST FOR INFORMATION SUBMISSIONS—Ms Tania Mihailuk asked the Minister for Health and Medical Research—
  - (1) Will the submissions to the Request for Information for the site selection process for the Bankstown-Lidcombe Hospital be made publicly available?

- (a) If so, when will the submissions be made publicly available?
- (b) If not, why will they not be made publicly available?

#### Answer-

The submissions to the Request for Information process are subject to Commercial in Confidence.

- \*3929 INDEPENDENCE AND CREDIBILITY OF REPORTS—Ms Tania Mihailuk asked the Minister for Planning and Public Spaces—
  - (1) What measures are taken by the Department of Planning, Industry and Environment to ensure the independence and credibility of reports, such as assessments of planning proposals, prepared and provided by Councils to Local Planning Panels?
    - (a) How has this process been evaluated by the Department of Planning?

#### Answer-

#### I am advised:

Councils are responsible for the reports provided to Local Planning Panels (LPP) on their planning proposals.

The LPPs are comprised of independent experts and are able to decide for themselves about the independence and credibility of the reports provided to them.

The Department of Planning, Industry and Environment (the Department) has no involvement in the individual reports councils provide to the LPP on their planning proposals.

The Department provides best practice advice to councils in guidelines on the preparation and assessment of planning proposals. The Department also holds regular engagement sessions with LPP Chairs to share feedback on a range of issues like these.

- \*3930 CONSIDERATION OF RESTORATION OF SERVICES—Ms Tania Mihailuk asked the Minister for Transport and Roads—
  - (1) Considering Transport for NSW's proposed rail options for stations west of Bankstown in 2024, which propose the partial restoration of the Liverpool/Bankstown via Regents Park services, was consideration was given to the full restoration of the Liverpool/Bankstown via Regents Park services when devising the proposed options?
    - (a) If so, why was the full restoration of the Liverpool/Bankstown via Regents Park services not included as an option?
    - (b) If not, why not?

#### Answer-

## I am advised:

Planned changes to rail services need to balance the needs of customers and working within the confines of a constrained network. Based on these considerations, three feasible rail options were developed using available infrastructure to provide services for west of Bankstown customers in 2024.

The full restoration was not included as part of these options as it would impact thousands of southwest customers through:

- overcrowding and longer journey times.
- limited frequency on the T5 Cumberland and T2 Inner West lines.

Transport for NSW's preferred option includes a service running between Liverpool and the City Circle via Lidcombe which would ensure the vast majority of west of Bankstown customers continue to receive direct access to the Sydney CBD.

- \*3931 BURRENDONG DAM OPERATING CAPACITY—Mr Roy Butler asked the Minister for Water, Property and Housing—
  - (1) Has the proposal to lift the effective holding and operating capacity of Burrendong Dam from 100 per cent to 120 per cent been submitted to the Commonwealth as part of Basin Water Resource Plans?
  - (2) Would this change require a change in the Baseline Diversion Limit to allow the increased storage capacity benefits to Water Sharing Plan reliability to be included in Sustainable Diversion Limit?
  - (3) Does the Government support this proposal?

## Answer-

- (1) Reviewing the full supply level of Burrendong Dam is being considered in the draft Macquarie-Castlereagh Regional Water Strategy.
- (2) Changes to water sharing arrangements that cause diversions to exceed the Long Term Average Annual Extraction Limit (LTAAEL) or the Sustainable Diversion Limit (SDL) would trigger a reduction in access for other water users in order to maintain compliance with the plan limit and the SDL.
- (3) I am keen to see the Full Supply Level raised to improve drought resilience in the Macquarie.
- \*3932 PUBLIC AREA VANDALISM—Mr Roy Butler asked the Minister for Police and Emergency Services—

How is the increasing frequency of vandalism in public areas, such as the newly opened skate park and juvenile truancy in the outback town of Bourke, being addressed?

Answer-

I am advised:

The NSW Police Force is actively engaged in reducing public vandalism and juvenile truancy in the town of Bourke.

Police officers, Police and Community Youth Club (PCYC) Activities Officers and Aboriginal Community Liaison Officers conduct high visibility patrols of Central Park in Bourke, including the skate park. Police and PCYC staff also regularly attend the park to engage with young people in the area, working closely with several community groups through programs like Maranguka, which facilitates support and services to address Aboriginal social disadvantage and crime rates in Bourke; various school holiday programs; or through sport, such as the Blues Tag Competition.

Police have a range of options in dealing with young people who commit vandalism offences, including referral to youth case managers at the PCYC or diversion under provisions of the Young Offenders Act 1997.

The NSW Police Force has a significant role in addressing truancy in Bourke. Police attend schools weekly and speak with the staff about matters of concern and the Police Youth Liaison Officer engages daily with Home School Liaison Officers. Weekly joint anti-truancy operations are also conducted.

- \*3933 WEE WAA HIGH SCHOOL HEALTH ISSUES—Mr Roy Butler asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—
  - (1) How many reports has the Department received from staff and students who have experienced health episodes following attendance at Wee Waa High School?
  - (2) When did the Department of Education first start receiving reports expressing concerns around the safety of the school buildings?
    - (a) How many reports has the Department received?
  - (3) What investigations has the Department of Education undertaken at Wee Waa High School to determine the cause of these health episodes including:
    - (a) Type of investigation;
    - (b) Date investigation was undertaken;
    - (c) Investigation findings?
  - (4) Has the Department of Education been in contact with all former staff and students to alert them to potential health impacts stemming from their attendance at Wee Waa High School?
  - (5) What action is the Department of Education taking to ensure the safety of current staff and students at Wee Waa High School?

- (4) No. All actions taken by the Department were guided by the recommendations of qualified occupational hygienists.
- (5) Every room at the school has been tested to ensure the safety of students and staff, the areas of concern were closed and a temporary operational plan was put in place relocating Year 7 to 10 students to Wee Waa Public School and Year 11 and 12 students moving into unaffected spaces. Year 7 to 10 students will be accommodated in demountable spaces at the high school site from the commencement of Term 4, 2020 pending actions required by the occupational hygienist.
- \*3934 ORANGE CHILD AND ADOLESCENT MENTAL HEALTH SERVICE—Mr Philip Donato asked the Minister for Health and Medical Research representing the Minister for Mental Health, Regional Youth and Women—
  - (1) Has the 10-bed acute psychiatric inpatient Child and Adolescent Mental Health Service (CAMHS) based at the Orange Health Service been reclassified as a state-based facility?
    - (a) If so, will this mean that patients can be referred to the Orange CAMHS unit from metropolitan areas?

(2) Will additional funding, staffing and resources be directed to the CAMHS unit at Orange so that the unit can sufficiently cater for the additional metropolitan-based referrals and consequential workload, in addition to the existing services being provided to regional-based referrals?

#### Answer—

The Child and Adolescent Mental Health Service (CAHMS) Inpatient Unit has not been reclassified as a state-wide facility. All CAMHS inpatient units within New South Wales accept referrals from across the State.

Community based CAMHS teams provide comprehensive care, which reduces the need for hospitalisation for most young people. This is an evidence-based response, which when appropriate can result in the best outcomes for young people while helping them to remain connected to their community and engaged in education or work.

Western NSW Local Health District has begun building works and consultation processes for the CAMHS speciality Hub in Orange. The Hub model will facilitate improved outreach to young people in smaller communities and generate a critical mass of skilled clinicians for improved recruitment and retention.

\*3935 RURAL FIRE SERVICE PERSONAL PROTECTIVE EQUIPMENT—Mr Philip Donato asked the Minister for Police and Emergency Services—

Considering that NSW Rural Fire Service personnel are not classified as first responders and have been unable to acquire or be issued with chemical resistant coveralls and other personal protective equipment (PPE), will the supply of vital PPE be expedited for NSW Rural Fire Service units in the Orange electorate who respond to the scenes of motor vehicle accidents and must adhere to current NSW Rural Fire Service Standard Operating Procedures requiring use of disposable PPE?

## Answer-

I am advised:

NSW Rural Fire Service (NSW RFS) fire fighters are provided with Personal Protective Equipment (PPE) appropriate to their tasks and are well protected.

The NSW RFS provides operational support to Fire and Rescue NSW, the designated combat agency for hazardous materials incidents. Chemical-resistant PPE, in the form of disposable coveralls that provide a barrier to a broad range of chemicals and bio-hazards, is provided by the NSW RFS and is worn by members during operational support responses to hazardous material incidents.

Furthermore, I can advise the member that the Area Command has been made aware of the matter and has contacted the local brigade from where the matter arised.

- \*3936 SCHOOL CHILD SAFE STANDARDS—Mr Philip Donato asked the Minister for Families, Communities and Disability Services—
  - (1) Has the NSW Office of the Children's Guardian, as the State independent oversight authority responsible for implementing the Child Safe Standards, yet delegated to NSW Education Standards Authority (NESA) the responsibility for monitoring and enforcing Child Safe Standards in schools?
    - (a) If so, where can the relevant documentation and guidelines be accessed or viewed?
  - (2) When will NESA enact that enforcement?
    - (a) How is NESA enacting that enforcement?

### Answer—

I am advised, the Office of the Children's Guardian (OCG) undertook extensive consultation on the design of a scheme to support mandatory Child Safe Standards in 2019.

The mandatory child safe scheme will build on the existing requirement in the Children's Guardian Act 2019 that relevant entities have in place adequate systems to prevent and respond to child abuse. The OCG will undertake further consultation with stakeholders on these matters in late 2020.

\*3937 WESTERN NSW LOCAL HEALTH DISTRICT PROSTATE CANCER NURSES—Mr Philip Donato asked the Minister for Health and Medical Research—

Will the Government consider increasing the availability of specialist prostate cancer nurses to patients in the Western NSW Local Health District by increasing from the current single part-time position to a bare minimum of one full time equivalent prostate cancer specialist nurse position to service the many prostate cancer patients across the vast area of the Western NSW Local Health District?

#### Answer-

The Western NSW Local Health District has a partnership with the Prostate Cancer Foundation of Australia to employ Prostate Cancer Specialist Nurses at Orange and Dubbo. The Orange part time position commenced in 2016 and the Dubbo part time position commenced in September 2020.

- \*3938 PROPOSED PALLIATIVE CARE UNIT—Mr Philip Donato asked the Minister for Health and Medical Research—
  - (1) Will operational funding for the proposed 2-bed inpatient palliative care unit at the Orange Health Service be ongoing?
  - (2) Will the operation of this unit negatively impact financial operation for other services presently, or ordinarily, provided at the Orange Health Service?

#### Answer\_

I am advised the proposed two bed inpatient palliative care unit at Orange Hospital is at the concept stage of planning.

\*3939 SUICIDE REGISTER—Mr Philip Donato asked the Minister for Health and Medical Research representing the Minister for Mental Health, Regional Youth and Women—

Will the Government consider implementing a New South Wales Suicide Register drawing upon police, medical, coronial and other records to provide statistics and information which will enable funding, services and resources to be swiftly and strategically deployed to address trends and contemporary influencing factors?

#### Answer-

The Government has already announced that it will introduce a new suicide register. I refer the Member to this announcement from October 2018 https://www.health.nsw.gov.au/news/Pages/20181017\_00.aspx where the Government announced its Strategic Framework for Suicide Prevention in NSW 2018-2023.

The Register will provide timely data on suspected suicides allowing for identification or emerging trends and local responses to be initiated.

I have spoken many times in the House over the past 18 months about the need for accurate, real-time suicide data so that government, community service providers and other stakeholders can better respond to and ultimately prevent the tragedy of suicide in our communities.

Earlier this year I announced that the Government had fastracked the finalisation of the suicide register, which is anticipated to be ready in early November, ahead of schedule.

The Member should note that such a Register involves extensive cross-agency collaboration to align data collection, systems monitoring and reporting. I commend government agencies, including NSW Health, State Coroner, NSW Police Force and Department of Community and Justice for the extensive work they have put into this over the past two years.

- \*3940 FAMILY DOMESTIC VIOLENCE REVIEW TEAM EXECUTIVE SUMMARY—Ms Anna Watson asked the Attorney General, and Minister for the Prevention of Domestic Violence—
  - (1) How many of the 34 recommendations made by the Family Domestic Violence Review Team 2017-2019 has the Government implemented?
  - (2) Considering that family and domestic violence is a Premier's priority, when will the commentary and recommendations be made a priority by the Government?

## Answer-

## I am advised:

Of the 34 recommendations made by the Domestic Violence Death Review Team (DVDRT) in its 2017-2019 report, all have been supported either in full or in principle by the Government and are in various stages of implementation. The Government's response to the recommendations was provided to the Coroner on 23 September 2020 and is available on the Coroner's website, at: https://coroners.nsw.gov.au/documents/reports/NSW\_Government\_Response\_to\_the\_DVDRT\_2017-9\_Report\_Recommendations.pdf.

In accordance with the Premier's Memorandum M2017-04 Response to DVDRT Report Recommendations, the Government will provide an implementation update to the Coroner in late 2021.

In preparing its response to the Coroner, the Government reaffirms its commitment to keeping victims safe and holding perpetrators to account.

Implementation of the recommendations made by the DVDRT Report 2017-2019 broadly align with the activities under the NSW Domestic and Family Violence Blueprint for Reform 2016-2021: Safer Lives for Women, Men and Children, which sets out the policy framework, programs and service delivery to prevent domestic violence in New South Wales.

- \*3941 SHELLHARBOUR ELECTORATE JOB CREATION—Ms Anna Watson asked the Minister for Jobs, Investment, Tourism and Western Sydney—
  - (1) How many fulltime jobs have been created in the Shellharbour electorate in each year from 2018 to 2020 (as at 15 September 2020)?
    - (a) In which sectors have these jobs been created?
  - (2) What plans does the Government have to grow jobs in Shellharbour?

#### Answer-

- (1) Labour market figures for the Shellharbour electorate are not specifically published by the Australian Bureau of Statistics. The Shellharbour electorate falls in the Illawarra region reported by the Australian Bureau of Statistics. - (2) The Government has various plans to grow jobs in Shellharbour:

  - (b) As at 15 September, 324 businesses in the Shellharbour state electorate received the Small Business Support Grant and/or Small Business Recovery Grant (businesses who received both grants have only been counted once).
  - (c) In response to the COVID-19 pandemic, the Government has announced several economic stimulus packages, including a \$3 billion Infrastructure and Job Acceleration Fund, announced on 31 May 2020, to go towards job-creating projects. The new Fund will be used for smaller, shovel-ready projects, supporting jobs and providing economic stimulus.
  - (d) The Infrastructure and Job Acceleration Fund brings the Government's infrastructure pipeline to over \$100 billion over four years from 2019-20 to 2022-23. The delivery of this record infrastructure program supports jobs and provides a path to employment and economic recovery.
  - (e) As set out in the 2019-20 NSW Budget, infrastructure initiatives benefitting the Wollongong and South Coast region include road projects worth over \$1.3 billion, the major hospital redevelopment at Shellharbour and a new bridge over the Shoalhaven River.
  - (f) The 2020-21 NSW Budget will document the full details of major infrastructure projects across the State, including those in the Shellharbour electorate.
  - (g) The Government is supporting jobs growth in Shellharbour with programs to boost local businesses looking to new markets through exports. To aid in this, a regional Trade Export Advisor is based in Nowra to promote export opportunities, deliver export capability building program and promote new programs including the Governments' Going Global Export Program and Export Assistance Grant, announced in August and valued at \$12.8 million.
  - (h) In September 2020 the Government announced an increase to its contribution from \$250 million to \$570 million to deliver the Shellharbour hospital. The facility aims to attract clinicians and hospital staff to the region and deliver up to 2,800 jobs during construction to boost the local economy.
- \*3942 CORONER'S ACT—Ms Anna Watson asked the Attorney General, and Minister for the Prevention of Domestic Violence—

Will the Government in conjunction with the current review of the Coroners Act 2009 (NSW) amend the definition in s101B of the Act to a death which occurs in the context of domestic violence, as recommended in the Australian Domestic Violence Death Review Team report 2017-2019?

Answer-

I am advised:

The Government supports in principle Recommendation 33 in the Domestic Violence Death Review Team Report 2017-2019 to amend the definition of a 'domestic violence death' as defined in s 101B of the Coroners Act 2009 (NSW).

The Department of Communities and Justice will consult with stakeholders on any proposed change to the definition and, if agreed by Cabinet, will introduce amendments to Parliament.

- \*3943 DOMESTIC VIOLENCE DEATH PREVENTION—Ms Anna Watson asked the Attorney General, and Minister for the Prevention of Domestic Violence—
  - (1) Will the Government recognise and emphasise the importance of conceiving of domestic violence death prevention as an intergenerational issue?
  - (2) What support for children who are exposed to domestic and family violence has the Government implemented?
  - (3) Will the Government explore the opportunities of broad educational reforms that inform and enhance awareness of coercive controlling behaviours?
    - (a) If not, why not?

#### Answer—

#### I am advised:

(1) The Government, through the NSW Domestic and Family Violence Blueprint for Reform 2016-2021 (the Blueprint), is investing \$431 million over four years to tackle domestic and family violence, including intergenerational domestic violence. The Blueprint is available at www.women.nsw.gov.au.

In its response to the 2017-2019 Domestic Violence Death Review Team (DVDRT) Report, the Government supported (or supported in principle) all 34 recommendations. A number of recommendations address issues related to children and young people, with specific reference in selected recommendations to interrupt the intergenerational cycle of violence and abuse that can continue throughout children's lives, into their adult relationships. The government response is available at https://coroners.nsw.gov.au/documents/reports/NSW\_Government\_Response\_to\_the\_DVDRT\_2017-19\_Report\_Recommendations.pdf.

The Government's Youth Justice Domestic and Family Violence Strategy addresses the needs of children and young people who use violence in the home, engage in adolescent dating violence, and who are often victims of domestic and family violence themselves. Through this strategy, the Government seeks to ensure that young people who are victims and/or use domestic and family violence receive the specialist support they need.

The strategy is available at http://www.juvenile.justice.nsw.gov.au/Pages/youthjustice/about/corporate-information/youth-justice-domestic-and-family-violencestrategy.aspx.

- (2) The Government funds over 5,000 places across a range of tailored and evidence-informed family preservation programs for families with children who are at risk of significant harm to address causes of vulnerability and risk, including violence occurring within families. In addition, children who are exposed to domestic and family violence may be eligible for Victims Services support.
- (3) In March 2020, I indicated that the Government would consult on laws to address coercive and controlling behaviour. On 13 October 2020, the Government released an in-depth discussion paper to facilitate consideration of the complexities of this issue. On that same day, I announced the Government would move to establish a Parliamentary Joint Select Committee to inquire into coercive control. The Committee will be comprised of members from the Government, the Opposition and other parties, drawn from both Houses. The Committee will call for submissions from all interested stakeholders and will be able to convene public hearings to assist in its deliberations. This broad approach to consultation, while identifying opportunities to raise awareness and understanding about the nature and meaning of coercive or controlling behaviour, will ensure any recommendations it makes will reflect both the aspiration and the concerns of the community about this important issue.
- \*3944 SHELLHARBOUR ELECTORATE HOMELESS ASSISTANCE—Ms Anna Watson asked the Minister for Families, Communities and Disability Services—
  - (1) How many homeless people are there in the Shellharbour electorate as at 15 September 2020?
  - (2) What programs are currently available to homeless people within the Shellharbour electorate as at 15 September 2020?
  - (3) What percentage of new funding will be spent on homelessness accommodation as part of the Government's \$36 million announcement in June 2020?

#### Answer-

### I am advised:

(1) Estimates of the number of people experiencing homelessness are published by the Australian Bureau

of Statistics at www.abs.gov.au.

(2) The following non-government organisations receive funding from the Department of Communities and Justice to deliver services to people who are homeless or at risk of homelessness in the Shellharbour electorate:

Southern Youth and Family Services provide a broad range of services to young people including supervised accommodation, counselling, links to education and training and supporting them to live independently.

Lighthouse Community Care provide accommodation and support to homeless young people to develop living skills and transition to independent living.

SAHSSI (Supported Accommodation and Homelessness Services Shoalhaven and Illawarra) assist single homeless women and women with accompanying children who are escaping domestic and family violence and who are homeless or are at risk of homelessness.

Wollongong Homeless Hub provide front-line information, advice and referral services for homeless or at-risk clients in the Illawarra. They also conduct regular assertive outreach to homeless people who are rough sleeping across the Illawarra, which includes the Shellharbour electorate.

(3) The Government announced \$36 million in new funding in June 2020 for the new Together Home project in key locations across New South Wales, including Shellharbour.

Together Home uses the respected Housing First model to transition people from temporary accommodation into secure housing. It will provide access to the services people need to maintain their tenancy, improve their health and wellbeing and move towards training and employment.

Accommodation and wrap around supports are packaged together for each participant based on their needs. Additional funding is also available for participants with higher and complex needs. The percentage of the funding used to deliver the accommodation component is expected to vary by client and location.

- \*3946 COVID-19 BUSINESS SUPPORT PACKAGE—Ms Anna Watson asked the Treasurer representing the Minister for Finance and Small Business—
  - (1) How many businesses in the Shellharbour electorate have been successful in meeting the eligibility criteria for part of the \$136 billion COVID-19 support package as at 15 September 2020?
  - (2) How many businesses have benefited from the small business support fund in Shellharbour as at 15 September 2020?

#### Answer-

(1) As of 18 June 2020, the Government had announced more than \$13.6 billion in health and economic stimulus measures since the start of the COVID-19 pandemic to support people, businesses and communities and help create jobs.

Announced commitments now total almost \$16 billion.

The first priority has been support of the health system with an extra \$883 million in funding to ensure Intensive Care Unit capacity was doubled, frontline health workers were supported and health research and mental health support boosted.

### Other measures include:

- A \$1 billion Working for NSW fund which is supporting both direct employment and retraining opportunities including \$250 million, of which \$155 million had already been expended as at 31 July 2020, to employ additional cleaners for public infrastructure and over 1,000 new staff who have been employed by Service NSW.
- A \$3 billion Infrastructure and Job Acceleration Fund which is being used for smaller, shovel-ready projects throughout New South Wales, supporting up to an extra 20,000 jobs.
- Community support measures include \$60.5 million for maintenance works and upgrades on public housing properties; and \$20 million to accelerate pathways for existing clients and priority social housing applicants to secure stable housing in the private rental market.
- Relief funding for community preschools including for Term 4 of 2020.
- Small businesses impacted by COVID-19 with a payroll up to \$10 million have been given an automatic 25 per cent waiver on their 2019-20 payroll tax.
- A \$12.6 million support package for the taxi industry.

- A \$12.8 million Export Assistance Package including a \$10,000 Export Assistance Grant which is available for up to 1,000 export ready or export capable New South Wales businesses, helping them access new markets or re-enter old ones where business has ceased.
- A Small Business COVID-19 Support Grant of up to \$10,000 for eligible small businesses. As at 16 October 2020, over \$530 million has been paid or approved in grants for nearly 53,600 small businesses with nearly 151,000 employees and a further \$0.87 million in grants was still in progress.
- A Small Business Recovery Grant of \$3,000 to help small businesses, including nonemploying sole traders, to safely relaunch their operations. As at 16 October 2020, over \$110.2 million has been paid or approved for over 37,000 small businesses with around 105,500 employees and a further \$0.27 million in grants was still in progress.
- A Southern Border Small Business Support Grant of \$5,000 or \$10,000. As at 16 October 2020, over \$8.7 million had been paid or approved for 1,299 small businesses with a further \$1,5 million in progress.

There is no data breaking down the benefits of the overall health and economic stimulus package by State electorates. However, data on Small Business Grants is available by State electorate.

- (2) 268 small businesses in Shellharbour Electorate received a total of \$2,622,818 in Small Business COVID-19 Support Grants and 177 small businesses in Shellharbour electorate received a total of \$527,459 in Small Business COVID-19 Recovery Grants.
- \*3947 SCHOOL COUNSELLORS IN FAIRFIELD LOCAL GOVERNMENT AREA—Mr Guy Zangari asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—

How many additional school counsellors have been allocated for the Fairfield local government area during the COVID-19 pandemic as at 15 September 2020?

Answer-

New South Wales public schools are committed to providing safe, supportive and responsive learning environments for everyone. They have a range of well-defined processes and options for supporting students who may be experiencing mental health issues.

Every New South Wales public school has a learning and support team. The school learning and support team plays a key role in ensuring that the specific needs of students with additional learning and support needs are met. NSW Education's school counselling service works collaboratively with learning and support teams, parents and caregivers and other agencies, to provide timely mental health support for students.

Where the need for additional counselling support is identified, staff are provided on a case by case basis. Students have been offered continued counselling support during the COVID-19 pandemic, including for those students learning from home, through a secure on-line telepsychology platform. Where appropriate, students and/or their families and caregivers are referred to other local agencies such as headspace and Child and Adolescent Mental Health Services.

With these supports in place, there were no schools in the Fairfield Local Government Area that received additional counsellors during the COVID-19 pandemic as at 15 September 2020.

The Government has committed \$88.4 million to ensure every public high school in NSW has access to two dedicated full-time mental health professionals by 2023. This commitment is on track.

\*3948 CLASSROOM AIR CONDITIONING—Mr Guy Zangari asked the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—

How many classrooms in New South Wales schools in the Fairfield local government area are still waiting for an air conditioner as at 15 September 2020?

Answer—

As at 15 September 2020, 43 classrooms at Bonnyrigg High School are yet to have air conditioning installed under the Government's Cooler Classrooms Program.

\*3949 SMALL BUSINESS FINANCIAL ASSISTANCE—Mr Guy Zangari asked the Treasurer representing the Minister for Finance and Small Business—

What programs and financial assistance will be put in place by the Government to assist small businesses with the cost of running a COVID-safe business?

Answer-

The Government has provided a range of resources and guidance so businesses can complete a COVID-19 Safety Plan and register as a COVID-19 Safe Business.

Under the Public Health Orders, it is mandatory for some types of business to register as a COVID-19 Safe Business. For other types of business, it is mandatory to have a COVID-19 Safety Plan but optional to register.

COVID-19 Safety Plan templates are available for 36 different industries. For key industries, such as restaurants and cafes, the templates are also available in Arabic, simplified Chinese, Korean, Thai and Vietnamese.

An information and awareness campaign using a range of media has included communications in the top languages spoken as a second language in NSW: Mandarin, Cantonese, Vietnamese, Arabic, Korean, Hindi, Greek, Spanish, Thai, and Turkish.

As of 12 October 2020, some 92,580 businesses had registered as COVID-19 Safe Businesses.

This included 21,680 cafes and restaurants and 3,713 pubs, clubs, bars and breweries; more than 5,041 beauty, nail, waxing, tanning and hairdressing salons; and over 2,779 gyms.

As at 11 October, some 18,854 New South Wales businesses have been visited by New South Wales Inspectors empowered to enforce the COVID-19 public health orders as well as assist businesses with advice on compliance, with 8 per cent receiving a warning and 57 per cent given further COVID-19 Safe Business guidance

The Small Business COVID-19 Recovery Grant of up to \$3,000 was available to eligible small businesses from 1 July to 31 August 2020. The Recovery Grant aimed to support small businesses to safely re-open and scale up as restrictions eased.

The Recovery Grant helped eligible small businesses cover expenses, including fit-out changes, staff training and counselling, business advice and continuity planning, marketing, and digital solutions.

Of the \$110 million given to small businesses in \$3,000 COVID-19 Small Business Recovery Grants some 51 per cent or \$56 million has been used for COVID-19 safety measures including cleaning products and services; staff training in COVID-19 Safety Plans and fitouts and equipment to comply with COVID-19 Safety Plans.

Business Connect is offering free online workshops covering a range of topics to support small businesses affected by the COVID-19 pandemic, including digital solutions and online marketing. Small businesses can also seek free, personalised advice from a Business Connect advisor.

The Government continues to actively monitor the impact of COVID-19 on small businesses and will continue to respond with support measures as appropriate.

\*3950 DISABILITY OUTREACH SERVICES—Mr Guy Zangari asked the Minister for Families, Communities and Disability Services—

What outreach services have been offered to disabled clients during the COVID-19 pandemic?

Answer—

I am advised:

The Commonwealth Government, through the National Disability Insurance Agency (NDIA), the National Disability Insurance Scheme (NDIS) Quality and Safeguards Commission and the Department of Social Services, have primary responsibility to prepare the disability sector and NDIS participants for a COVID-19 response.

On 18 March 2020, State, Territory and the Commonwealth Ministers convened an extraordinary meeting of the Disability Reform Council to ensure a targeted response to COVID-19 for people with disability.

At the 18 March meeting Ministers agreed that the NDIA would contact over 21,000 vulnerable participants across NSW to check on their welfare during the pandemic. The NDIA has also instituted a number of additional supports including flexible use of NDIS plan funding to purchase personal protective equipment and other supports.

All people with disability can also access the Disability Information Helpline on 1800 643 787, which provides information and referrals for people with disability, their families and carers who need help because of COVID-19.

The Government is supporting these efforts and working closely with the NDIA to monitor the situation and take appropriate action where necessary.

This includes implementing the Australian Health Protection Principal Committee endorsed Management and Operational Plan for COVID-19 for People with Disability, found at: https://www.health.gov.au/resources/publications/management-and-operational-plan-for-people-with-disability.

The Plan provides high-level guidance on a range of factors that need to be considered in managing and preventing the transmission of COVID-19 for people with disability.

\*3951 SMALL BUSINESS RECOVERY GRANT APPLICATIONS—Mr Guy Zangari asked the Treasurer representing the Minister for Finance and Small Business—

How many applications for the Small Business Recovery Grant have come from businesses in the Fairfield local government area as at 15 September 2020?

Answer—

As at 14 October 2020, 688 applications for the Small Business COVID-19 Recovery Grant have been received from small businesses in the Fairfield local government area.

Of these, 667 applications have been approved to the value of \$1,982,950 with a further four applications still in progress. 17 applications were not approved.

\*3952 HOUSING NSW OUTREACH SERVICES—Mr Guy Zangari asked the Minister for Families, Communities and Disability Services—

What outreach services is Housing NSW providing to clients during the COVID-19 pandemic?

Answer-

I am advised:

The Government has taken action to prevent and respond to homelessness and support vulnerable people across the state during COVID-19.

On 27 March 2020 the Government released the second stage of its economic package in response to COVID-19, including \$34 million to prevent homelessness. This included \$14 million for emergency accommodation to enable people to self-isolate and \$20 million for private rental subsidies such as Start Safely and Rent Choice Youth.

The Government established a new Inner City Homelessness Taskforce to coordinate the response to COVID-19 for people experiencing street homelessness and people staying in large accommodation centres in the city. This includes the Department of Communities and Justice (DCJ), NSW Health, St Vincent's Health, the City of Sydney, NSW Police Force, Homelessness NSW, Yfoundations, the End Street Sleeping Collaboration and inner-city homelessness services.

Assertive outreach patrols for people experiencing street homelessness were rapidly escalated at the beginning of the COVID-19 pandemic. This included more frequent assertive outreach patrols in existing locations in Sydney, Tweed and Newcastle as well as the expansion of assertive outreach to new sites identified across the state.

The delivery of assertive outreach to locations across New South Wales is continuing to develop based on local knowledge about where people are and what they need. From an initial expansion of assertive outreach to 36 local government areas, I am advised that from April to June 2020 there were more than a thousand outreach patrols across 53 local government areas.

On 8 June 2020 the Government announced \$36 million for the new Together Home project, which will deliver housing and wrap around supports for hundreds of rough sleepers across the state.

Together Home will be a partnership between the Government, Community Housing Providers, Specialist Homelessness Services and health services to deliver permanent housing outcomes for people sleeping rough, including people with complex needs.

Since the start of the pandemic, DCJ has worked closely with social housing tenants to inform them of NSW Health advice. DCJ has communicated with social housing tenants across the state, either by letter, email or SMS, to provide advice on NSW Health guidelines as well as where they could access additional information. DCJ continues to provide advice to residents about hygiene and social distancing in both English and other languages.

DCJ staff also called tenants over the age of 70 to check on the welfare and offer support. This decision was made based on the increased vulnerability of older people to COVID-19.

NSW Health is running clinics (with testing available) for tenants in Waterloo, Surry Hills and Redfern. This information is available on the NSW COVID website.

\*3953 FAIRFIELD LOCAL GOVERNMENT AREA HOUSING STOCK—Mr Guy Zangari asked the Minister for Water, Property and Housing—

What plans does the Government have to increase housing stock in the Fairfield Local Government area?

Answer-

I am advised:

In the Fairfield local government area, there are currently 44 new social homes under construction and a further five new social homes are out to tender for construction.

The NSW Land and Housing Corporation (LAHC) is also working on other new social housing projects to provide around 100 new social housing dwellings in the areas of Villawood, Canley Heights, Canley Vale. Fairfield East and Fairfield.

\*3954 P1 DRIVER'S LICENCE TEST POSTPONEMENTS—Mr Guy Zangari asked the Minister for Customer Service—

How many P1 driver's licence tests have been postponed in the Fairfield Local Government area due to the COVID-19 pandemic as at 15 September 2020?

Answer-

In response to the COVID-19 virus, Service NSW and Transport for NSW (TfNSW) enacted measures to protect our customers and staff by postponing driver testing for a minimum period of 3 months from 30 March 2020.

956 driver tests booked at Wetherill Park Service Centre were cancelled, with all of these customers contacted and offered a booking when testing recommenced on 1 July 2020.

\*3955 MOBILE PHONE INFRINGEMENTS—Mr Guy Zangari asked the Treasurer representing the Minister for Finance and Small Business—

How many infringements from mobile phone detection cameras have been issued in the Fairfield local government area as at 15 September 2020?

Answer\_

Revenue NSW does not collect data by local government area.

As at 15 September 2020, a total of 82,797 mobile phone detection camera penalty notices have been issued in New South Wales.

\*3956 SOUTH WEST SYDNEY LOCAL HEALTH DISTRICT SPECIALIST POSITIONS—Mr Paul Lynch asked the Minister for Health and Medical Research—

Which specialist positions as at 14 August 2020 were unfilled in South West Sydney Local Health District?

Answer-

The data requested is not readily available.

Local Health Districts have mechanisms in place to identify vacancies and recruit to positions in accordance with service delivery needs and models of care.

- \*3957 LIVERPOOL HOSPITAL IMMUNE SUPPRESSED PATIENT PROTECTION—Mr Paul Lynch asked the Minister for Health and Medical Research—
  - (1) What steps does Liverpool Hospital take to protect patients who are immune suppressed?
  - (2) How can patients who are immune suppressed be protected when there are four patients to a room with only one bathroom/toilet?
  - (3) How can patients who are immune suppressed be protected in the discharge ward at Liverpool Hospital when there is only one toilet for a large number of patients?

Answer-

New South Wales public hospitals and health facilities maintain strict infection prevention and control practices as informed by NSW Health policies and guidelines.

I am advised the placement of immune suppressed patients at Liverpool Hospital is guided by the relevant Liverpool Hospital Compliance Notice.

- \*3958 BLACKTOWN LOCAL COURT SOCIAL DISTANCING—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—
  - (1) What steps are taken to ensure social distancing at the entrance outside the Local Court at Blacktown?
  - (2) What action is taken when social distancing requirements are not met outside of the entrance to the Local Court at Blacktown?

Answer-

I am advised:

Additional bollards and queue barriers have been erected outside Blacktown Local Court to separate the queue of court users from the queue for solicitors, barristers and interpreters, who receive priority entry into the building.

Signs and floor decals have been placed at the front of the building to indicate appropriate 1.5 metre distances.

A security contractor is employed as a COVID-19 marshal to oversee physical distancing between those queuing to enter the court building.

Where social distancing requirements are not being met, the COVID-19 marshal is required to immediately notify the Sheriff Officer on duty. Subsequent enforcement action is at the Sheriff Officer's discretion.

\*3959 AUDIO VISUAL LINK AT PENRITH LOCAL COURT—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—

Why are legal practitioners refused leave to appear by audio visual link in criminal matters by a Magistrate at the Local Court at Penrith?

Answer-

I am advised:

An application to appear via audio visual link may be made to the Court by a party to proceedings or their legal representative. It is a matter for the presiding magistrate to determine the application based on the individual circumstances of the matter.

\*3960 INTENSIVE CORRECTIONS ORDERS—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—

In light of the comments at page 7 of the Crime and Justice Bulletin no 230 (August 2020) on 'New South Wales sentencing reforms: results from a survey of judicial officers', will you extend the two year restriction on lengths of intensive corrections orders to three years?

Answer-

I am advised:

The Bureau of Crime Statistics and Research report, New South Wales sentencing reforms: results from a survey of judicial officers, is a valuable source of feedback on the 2018 sentencing reforms. The Department of Communities and Justice is currently considering the findings of that report.

\*3961 CORONER'S ACT STATUTORY REVIEW—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—

When will you release the statutory review of the Coroner's Act?

Answer-

I am advised:

The statutory review of the Coroners Act 2009 will be tabled in each House of Parliament in due course.

\*3962 BEGA PUBLIC DEFENDER—Mr Paul Lynch asked the Attorney General, and Minister for the Prevention of Domestic Violence—

In light of QON 3632, when did a Public Defender last permanently cover District Court proceedings in Bega?

Answer—

I am advised:

Public Defenders are allocated to locations around New South Wales based on demand. There is currently limited demand in Bega in comparison with other areas.

A Public Defender was last allocated permanently to the District Court circuit that includes Bega District Court, in the reporting period of 1 July 2015 to 30 June 2016.

- \*3964 TAMWORTH CORRECTIONAL CENTRE CELL HANGING POINTS—Mr Paul Lynch asked the Minister for Counter Terrorism and Corrections—
  - (1) Will a comprehensive audit of all cell hanging points at Tamworth Correctional Centre be conducted?
  - (2) Will all hanging points be urgently removed at Tamworth Correctional Centre?

Answer-

I am advised:

The recommendations from the Coronial Inquest into the Death of Tane Chatfield at Tamworth Correctional Centre have been referred to the Corrective Services NSW (CSNSW) Management of Deaths in Custody Committee for consideration and progression.

#### Answer-

- (1) High relative abundance populations of feral deer are also found in the Northern Tablelands, Central West, North West and Central Tablelands Local Land Services (LLS) regions. Parts of Murray and North Coast LLS regions have localised high relative abundance populations of feral deer.
- (a) and (b) All 11 Regional Strategic Pest Animal Management Plans in New South Wales list feral deer (of which there are six species in New South Wales) as priority pest animals. This means that all 11 LLS regions are engaged in some level of feral deer management. LLS, National Parks and Wildlife Service and other public land managers use core funding, rates and external funding opportunities to support their

feral deer management work. Under the NSW Biosecurity Act 2015, all public and private land managers have a general biosecurity duty to reduce feral deer impacts as much as is reasonably practicable.

- (2) (a) The feral deer mapping work conducted in 2005 and 2009 is based on expert opinion of 'relative abundance' (low, medium, high) rather than a quantitative density estimate (e.g. number of animals per square kilometre).
- (b) Further feral deer mapping was undertaken in 2016 and has recently been completed for 2020.
- (3) Preliminary analysis of 2020 data indicates that as a result of drought and coordinated control programs, there is decreased relative abundance of feral deer. This includes areas in the southern part of the North West LLS region, areas north of Tamworth and large areas of the Hunter LLS Region.

In accordance with the current advice from NSW Health, all students and staff who have flu-like symptoms are required to stay away from school while they have any symptoms and until they have a negative COVID-19 test result. Parents are required to confirm the student has received a negative result. Parents can provide the school with a screenshot of the text message confirming the negative test.

To minimise absence, schools are encouraging the immediate testing of anyone who has flu-like symptoms. This is so they can return to school once they receive confirmation of a negative COVID-19 test result and their symptoms are resolved.

Transport is a key part of New South Wales' plan for a COVID Safe economy, helping people move safely to jobs, schools and university.

The Government released the COVID Safe Transport Plan on 18 May 2020, which included clear guidance on physical distancing. Distinctive green dots are being used on all modes of public transport, including trains, buses and light rail, to show customers the safest places to sit and stand.

In line with NSW Health advice, physical distancing capacity across the public transport network increased from 1 July 2020, when customers saw more green dots to reflect the increase in capacity.

Long distance bus travel such as inter-regional services or charter buses and coaches are not currently restricted under the COVID-19 Public Health Orders. However, companies need to provide a safe environment for their customers and staff. Bus companies like other businesses should have a COVID-19 Safety Plan that addresses how they will protect their staff and customers.

The Government is not responsible for physical distancing measures for airlines or on associated aircraft.

As part of a range of measures to ease liquidity constraints and help businesses stay afloat throughout the COVID-19 pandemic, gaming machine tax payable by clubs was deferred for six months until 1 September 2020. The payment deferral period end date remains effective.

However, clubs facing difficulties in making these payments have the option of setting-up an extended instalment payment arrangement, with arrangements of up to 24-months available. Additionally, interest will not be applied to any payment arrangement for the first 12-months and will only begin to apply on the outstanding balance after 12-months.

Hotel gaming machine tax payments were also deferred for six months until 1 October 2020. Hotels facing difficulties in making these payments have the option of setting-up a similar payment arrangement to clubs.

69 small businesses located in the Broken Hill LGA received a total of \$689,993 in Small Business COVID-19 Support Grants and 40 small businesses located in the Broken Hill LGA received a total of \$119,998 in Small Business COVID-19 Recovery Grants.
