- \*1484 PLANNING—PRIORITY PRECINCTS—Mr Primrose asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Planning, Minister for Housing, and Special Minister for State—
  - (1) What are the locations of the eleven areas that the Government has earmarked as 'priority precincts' for residential development?
  - (2) What other locations are under consideration to become 'priority precincts'?
  - (3) What planning mechanisms will be used in making these determinations?
  - (4) What will be the role of local councils in deciding which areas become 'priority precincts'?

## Answer-

- (1) The eleven priority precincts currently in an advanced stage of investigation are:
  - (a) Kellyville
  - (b) Bella Vista
  - (c) Showground
  - (d) Arncliffe
  - (e) Banksia
  - (f) Rhodes East
  - (g) Vineyard
  - (h) West Schofields
  - (i) Marsden Park North
  - (j) Lowes Creek
  - (k) Wilton SE
- (2) Government is considering further priority precincts within the already identified growth areas such as:
  - (a) Urban renewal precincts within walking distance of some of the new Sydney Metro stations?
  - (b) Urban renewal within walking distance of the new Parramatta light rail iii. Land release areas such as Ingleside, Northwest, Southwest, Greater Macarthur and Wilton
- (3) The strategic planning work completed for the priority growth areas and urban renewal corridors sets out the objectives and ambition for each precinct. The Government is primarily focused on facilitation new homes and jobs and the delivery of the necessary infrastructure to support this growth. It is of secondary importance whether the planning process is led by:
  - (a) a local Council; or
  - (b) State Government; or
  - (c) if it is an appropriately assessed proposal by a private landowner.

All three options are relevant planning pathways for consideration.

- (4) The best planning outcomes will occur when landowners, Council and Government work together in consultation with the community towards a common goal. The Greater Sydney Commission is working with Councils to develop housing strategies that complement the District Plans, which will set the strategy. The implementation of Priority Precincts will proceed with relevant Councils invited to actively contribute to the process.

- (1) There are 169 showgrounds (including showgrounds with racecourses) on Crown reserves in NSW.

- (3) The Government has no plans to transfer Crown land showgrounds to councils.
- (4) The new Crown Land Management Act 2016 will enable Crown land to be transferred to Councils on a voluntary basis and by agreement, in accordance with 'local land criteria' which will be specified in the Regulations. Crown land will be transferred as community land under the Local Government Act 1993. The only exception would be to cover land that is truly operational such as waste depots, or where an operational categorisation is required to enable the current use to continue, for example cemeteries. Land transferred to Councils as community land cannot be changed without going through the rigorous processes under the Local Government Act 1993 that include community consultation.

The \$2.5M Environmental Trust grant will offset additional harvest and haulage costs incurred by Forestry Corporation of NSW in sourcing timber to meet the Eden Wood Supply Agreements from forests further afield.

TAFE NSW regularly assesses facility requirements in line with course delivery. Where vacant land or underutilised facilities are sold, the proceeds will be re-invested into modernising and improving TAFE facilities and learning platforms for the benefit of students.

Forestry Corporation works in line with these Wild Dog Management Plans to implement trapping programs where appropriate, in conjunction with a range of other wild dog management activities.
- (7) Forestry Corporation staff involved in feral animal control have all completed the Vertebrate Pest Management Course run by the Department of Primary Industries and the nationally accredited course AHCVPT203A Use firearms to humanely destroy animals.

#### Answer\_

I'm advised that more than \$3 million was spent on maintenance at Upper Hunter schools in 2015/16. An extra \$390 million has been allocated in 2016/17 and 2017/18 to address backlog maintenance in schools across the State.

I'm further advised this funding will continue to address the \$1 billion education maintenance backlog left by Labor when we came to government.

The Department of Education works directly with principals to develop a program of maintenance works for every school. The backlog maintenance at each school reflects the estimated cost of current and future repair work required to ensure buildings continue to perform at an acceptable level.

At any time, the maintenance liability will be a mixture of work that needs to be done immediately and forecast work that may need to be done in the future, depending on how the facility is performing. So, only a portion of the maintenance liability at any one time is work that is currently required.

Any maintenance issue that poses a safety risk to students or staff is addressed immediately. Any broken items in classrooms that impact on teaching and learning are addressed as a matter of priority by the school or the department.

- (1) No, under the NSW Government Guide to Better Regulation (October 2016) new and amended regulations are subject to Regulatory Impact Statements. It is appropriate to observe that FuelCheck was implemented through the Fair Trading Amendment (Fuel Price Transparency) Bill 2016, which was reviewed by both Houses during March 2016 and passed without amendment.
- (2) The Department of Finance, Services and Innovation is monitoring the impact of FuelCheck, including through the compliance and enforcement activities of NSW Fair Trading.
- (3) No
- (4) and (5) The Department of Finance, Services and Innovation determined that OneGov (an internal resource of the Department) would have the necessary skills, experience and capacity to provide all of the outcomes requested in the RFP and therefore the RFP was cancelled.
  - (6) Of the 52 parties who have signed up for FuelCheck API access, 25 have taken a feed at some point in the last 2 months. The frequency of access varies based on the type of use. For example, the NRMA uses this data daily as it directly feeds into their app.
  - (7) FuelCheck provides online access to real time price information to any person with an internet connected device. However, most of the feedback has been positive and has come from small independent operators who have been selling fuel cheaper than major service station franchisees for years. As most independents are not located on main thoroughfares, FuelCheck now allows them to advertise their price and location in direct competition with major operators who hold prime business locations on main roads or corner locations
  - (8) The FuelCheck Order 2016 requires fuel retailers to register with FuelCheck before they first sell fuel to retail customers, and notify all movements in their prices in real time via the online portal; however, Fair Trading advises that there has been one instance of a retailer showing a higher price on FuelCheck than the actual selling price.

- (12) The 'other costs' such as staffing and infrastructure were already in place and available to DFSI and no additional costs were incurred beyond the \$300,000 initial setup cost.
- (13) Three consumer protection staff during development, 10 for a period of two weeks whilst the data was first being collected and increasing to 23 during the implementation phase. All staff are now back to normal duties with operations being randomly conducted to ensure ongoing compliance.
- (14) All costs associated with FuelCheck are absorbed into the DFSI Budget. The annual cost to service and maintain the FuelCheck infrastructure is \$64,000. The annual staffing budget for FuelCheck is \$163,000. For staffing numbers see Question
- (15) Any calls relating to FuelCheck are answered by any of the staff working in the Customer Experience team. The number of calls and time spent equates to approximately 0.8 full time equivalent (FTE) staff. Therefore, across the Department of Finance, Services and Innovation, 1.8 FTE staff work or are involved in the operations of FuelCheck.

- (3) Given that the original 1998 council consent for the site approved remodelling of the Mangrove Mountain Golf Course involving a small amount of clean fill, with a limit of 80,000m3 of fill that was set in an area known as Area B and regulated by an environment protection licence (licence number 11395), can the Minister provide details of the reasons the EPA elected to renew this licence multiple times given there is now approximately 800,000m3 of waste on the site that is not all clean fill, which is approximately ten times the original planning proposal?
- (4) Did the EPA renew environment protection licence 11395 eight times since 2008 without taking into consideration sections 45(i) and 50 of the Protection of the Environment Operations Act 1997, which requires the EPA to take into consideration any relevant environmental impact statement (EIS) when reviewing such licences.
  - (a) Given the original EIS for the approved development application states that for Area B, 80,000m3 of fill material was permitted to be imported, and that each of the licence renewals since 2008 confirm there was more than 80,000m3 in Area B, in breach of the EIS, why was the licence renewed on these occasions?

  - (b) The review found no evidence that the landfill is having any negative impact on ground or surface water quality.
  - (c) The Environment Protection Authority (EPA) will implement the recommendations of the review.
  - (d) Yes.
- (2) After reviewing all available evidence there was not sufficient evidence to bring proceedings.
- (3) and (4) The total amount of waste permitted to be received and the final landform for the site are controlled by the development consent, administered and regulated by Central Coast Council as the consent authority. In 2012 the then Gosford City Council began proceedings against the operator in the Land and Environment Court for allegedly breaching the consent in relation to the amount of waste received and the final landform. In 2014 the Land and Environment Court made consent orders permitting an additional 1.3 million m3 of waste to be accepted at the site.
  - (5) SLR Consulting Pty Ltd assessed the landfill and found no evidence it is impacting ground or surface water quality.
  - (6) These are land use planning decisions for the local council as the consent authority.
  - (7) In 2014 the Land and Environment Court made consent orders permitting the increased capacity, with the agreement of the local council.

(1) to (7) The NSW Government is committed to reducing the environmental impact of plastic waste and litter in NSW. In the last Meeting of Environment Ministers (MEM) in November 2016, it was noted by Ministers that jurisdictions that have a ban on the supply of single-use plastic bags still allow the supply of biodegradable bags. It was also noted that there was a paucity of data on the environmental impacts of biodegradable plastics when they are released into the environment.

In light of this significant knowledge gap, the NSW Government requested the NSW Environment Protection Authority to commission the Commonwealth Scientific and Industrial Research Organisation (CSIRO) to undertake such work. The outputs from the CSIRO's work with be reported on at the next meeting of the Environment Ministers and will help frame NSW's future approaches to reduce the impact of plastic bags.

According to the Australian Energy Regulator the number of complaints from NSW consumers to Origin Energy has increased from 83,491 in 2013-14 to 192,837 in 2014-15 to 325,425 in 2015-16 and there have been 168,790 complaints in the first half of 2016-17.

## Answer-

These changes have resulted in greater self-reporting of complaints to the Australian Energy Regulator (AER), while at the same time Origin Energy has seen a decrease in complaints with the Energy and Water Ombudsman NSW (EWON). I understand that more recently, in consultation with the AER, Origin Energy has again revised its complaints process to align with that used by other retailers, and this is reflected in a lower number of reported complaints for February 2017 onwards.

I am pleased that Origin Energy is working with the Regulator to improve its service performance and management of customer complaints. I note that the Regulator has written to all retailers setting out 2017 priorities for compliance with the National Energy Retail Law. This includes establishing an audit program in the latter half of 2017 focusing on retailer business systems for monitoring their obligations.

In addition, on 16 May this year I held a Retailer Roundtable, inviting energy retailers in NSW including Origin Energy, to an open dialog discussing energy affordability and assisting vulnerable customers. Some issues discussed included:

- · Retailer communication to customers
- · Best practice payment plans Best practice hardship policies
- · Fees and charges
- Price/offer comparisons.

I am continuing to engage with retailers on these matters to ensure best outcomes for energy consumers.

Customers experiencing problems should first contact their energy retailer to discuss the matter. Where a customer is unable to resolve a complaint with their retailer, they can then contact the Energy and Water Ombudsman (EWON), which is the designated dispute resolution authority in NSW.

I encourage customers who are unhappy with their current retailer to take advantage of the benefits that competitive markets offer by shopping around for a better deal. Customers can compare offers at the free independent website www.energymadeeasy.gov.au.

#### Answer—

- (1) As medical practitioners, Independent Medical Examiners are required to comply with applicable medical legislation, which includes requirements for recording keeping. For example the Health Practitioner Regulation (New South Wales) Regulation 2016, requires medical practitioners to keep records of:
  - any information known to the medical practitioner who provides the medical treatment or other medical service to the patient that is relevant to the patient's diagnosis or treatment •
  - particulars of any clinical opinion reached by the medical practitioner
  - particulars of any medical treatment or other medical service that is given to or performed on the patient

The State Insurance Regulatory Authority (SIRA) also maintains Guidelines on Independent Medical Examinations and Reports. The Guidelines are issued under section 119 (4) and section 376 of the Workplace Injury Management and Workers Compensation Act 1998. The Guidelines covers matters including:

- Conduct of an Independent Medical Examination •
- Reporting an Independent Medical Examination •
- Corrections and Updating of Reports.
- (2) The precise legal status of an IME report would need to be determined on a case-by-case basis and in consideration of the specific circumstances of an individual report.
- (a) As medical practitioners, Independent Medical Examiners are required to comply with applicable medical legislation, which includes requirements for recording keeping. For example the Health Practitioner Regulation (New South Wales) Regulation 2016 includes requirements in relation to the retention of patient records, including that records relating to adults must be kept for at least 7 years.
- (3) The connection between IME reports and other reports is set out in the Guidelines on Independent Medical Examinations and Reports. The guidelines are published on the NSW Government Gazette website and the State Insurance Regulatory Authority website.

The guidelines note:

The independent medical examiner must be provided with all the information that is relevant to the questions to be addressed. Documents could include a claim form, medical certificates, witness reports, employer reports of injury, clinical notes/reports of treating doctors, medical reports, medical investigation reports, rehabilitation and functional assessment reports, job descriptions and duty statements, details of work with other employers and details of other settlements or awards...

Reports and/or electronic records of lay investigators are not to be provided with referrals for assessment of permanent impairment...

The [independent medical] examination report is to list the material reviewed, provided by the referrer and/or any material provided by the worker at the time of consultation, any facts relied upon, the relevant medical history, examination findings, and the medical reasons for their conclusions.

- (4) Depending on the individual circumstance there are a range of protections that might apply, including:
  - Parts 5 and 5A of the Crimes Act 1900, which set out various offences related to forgery of documents and production of false information.
  - Section 317 of the Crimes Act 1900, which makes it an offence to tamper with evidence. •
  - Schedule 4 of the Health Practitioner Regulation (New South Wales) Regulation 2016, which stipulates that medical practitioners must not alter a record of a patient, or cause or permit another person to alter a record, in a way that obliterates, obscures or renders illegible information that is already contained in the record. •
  - The Health Records and Information Privacy Act 2002 imposes requirements on those who collect health information to ensure its accuracy and store it securely. •
  - Individuals may also make a complaint about an IME to the Health Care Complaints Commission
    or the Medical Council of NSW.
